Report of Independent Auditors

To the Administrator of Johnson & Johnson Voluntary Employee Benefit Association Group Life Plan for Salaried Employees

Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed an audit of the accompanying financial statements of Johnson & Johnson Voluntary Employee Benefit Association Group Life Plan for Salaried Employees (the "Plan"), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). The financial statements comprise the statements of net assets available for plan benefits (modified cash basis) as of December 31, 2023 and 2022, and the related statement of changes in net assets available for plan benefits (modified cash basis) for the year ended December 31, 2023, including the related notes (collectively referred to as the "financial statements").

Management, having determined it is permissible in the circumstances, has elected to have the audit of the Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. As permitted by ERISA Section 103(a)(3)(C), our audit need not extend to any statements or information related to assets held for investment of the plan (investment information) by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA (qualified institution).

Management has obtained a certification from a qualified institution as of December 31, 2023 and 2022 and for the year ended December 31, 2023, stating that the certified investment information, as described in Note 4 to the financial statements, is complete and accurate.

Opinion

In our opinion, based on our audit and on the procedures performed as described in the Auditors' Responsibilities for the Audit of the Financial Statements section of our report

- the amounts and disclosures in the accompanying financial statements, other than those agreed to or derived from the certified investment information, are presented fairly, in all material respects, in accordance with the modified cash basis of accounting described in Note 2.
- the information in the accompanying financial statements related to assets held by and certified to by a qualified institution agrees to, or is derived from, in all material respects, the information prepared and certified by an institution that management determined meets the requirements of ERISA Section 103(a)(3)(C).



Basis for Opinion

We conducted our audit in accordance with auditing standards generally accepted in the United States of America (US GAAS). Our responsibilities under those standards are further described in the Auditors' Responsibilities for the Audit of the Financial Statements section of our report. We are required to be independent of the Plan and to meet our other ethical responsibilities, in accordance with the relevant ethical requirements relating to our audit. We believe that the audit evidence we have obtained is sufficient and appropriate to provide a basis for our ERISA Section 103(a)(3)(C) audit opinion.

Basis of Accounting

As discussed in Note 2 to the financial statements, the financial statements are prepared on the modified cash basis of accounting, which is a basis of accounting other than accounting principles generally accepted in the United States of America. Our opinion is not modified with respect to this matter.

Responsibilities of Management for the Financial Statements

Management is responsible for the preparation and fair presentation of the financial statements in accordance with the modified cash basis of accounting described in Note 2, and for determining that the modified cash basis of accounting is an acceptable basis for the preparation of the financial statements in the circumstances. Management is also responsible for the design, implementation, and maintenance of internal control relevant to the preparation and fair presentation of financial statements that are free from material misstatement, whether due to fraud or error. Management's election of the ERISA Section 103(a)(3)(C) audit does not affect management's responsibility for the financial statements.

In preparing the financial statements, management is responsible for the evaluation of whether there are conditions or events, considered in the aggregate, that raise substantial doubt about the Plan's ability to continue as a going concern for a reasonable period of time.

Management is also responsible for maintaining a current plan instrument, including all plan amendments, administering the plan, and determining that the plan's transactions that are presented and disclosed in the financial statements are in conformity with the plan's provisions, including maintaining sufficient records with respect to each of the participants, to determine the benefits due or which may become due to such participants.

Auditors' Responsibilities for the Audit of the Financial Statements

Except as described in the Scope and Nature of the ERISA Section 103(a)(3)(C) Audit section of our report, our objectives are to obtain reasonable assurance about whether the financial statements as a whole are free from material misstatement, whether due to fraud or error, and to issue an auditors' report that includes our opinion. Reasonable assurance is a high level of assurance but is not absolute assurance and therefore is not a guarantee that an audit conducted in accordance with US GAAS will always detect a material misstatement when it exists. The risk of not detecting a material misstatement resulting from fraud is higher than for one resulting from error, as fraud may involve collusion, forgery, intentional omissions, misrepresentations, or the override of internal control. Misstatements are considered material if there is a substantial likelihood that, individually or in the aggregate, they would influence the judgment made by a reasonable user based on the financial statements.



In performing an audit in accordance with US GAAS, we:

- Exercise professional judgment and maintain professional skepticism throughout the audit.
- Identify and assess the risks of material misstatement of the financial statements, whether due to fraud or error, and design and perform audit procedures responsive to those risks. Such procedures include examining, on a test basis, evidence regarding the amounts and disclosures in the financial statements.
- Obtain an understanding of internal control relevant to the audit in order to design audit procedures that are appropriate in the circumstances, but not for the purpose of expressing an opinion on the effectiveness of the Plan's internal control. Accordingly, no such opinion is expressed.
- Evaluate the appropriateness of accounting policies used and the reasonableness of significant accounting estimates made by management, as well as evaluate the overall presentation of the financial statements.
- Conclude whether, in our judgment, there are conditions or events, considered in the aggregate, that raise substantial doubt about the Plan's ability to continue as a going concern for a reasonable period of time.

Our audit did not extend to the certified investment information, except for obtaining and reading the certification, comparing the certified investment information with the related information presented and disclosed in the financial statements, and reading the disclosures relating to the certified investment information to assess whether they are in accordance with the presentation and disclosure requirements of the modified cash basis of accounting described in Note 2.

Accordingly, the objective of an ERISA Section 103(a)(3)(C) audit is not to express an opinion about whether the financial statements as a whole are presented fairly, in all material respects, in accordance with the modified cash basis of accounting described in Note 2.

Notes to Financial Statements

1. The Plan, Contributions and Benefits

The Johnson & Johnson Voluntary Employee Benefit Association Group Life Plan for Salaried Employees (the "Plan") is an employee contributory welfare benefit plan which provides additional life insurance benefits to salaried employees of Johnson & Johnson and its affiliated companies (the "Company" and "Plan Administrator") who are full-time or qualified part-time employees and certain hourly employees. It is subject to the provisions of ERISA, as amended. These benefits are in addition to basic life insurance benefits that are fully funded by the Company. Employee contributions are based upon salary level, age, optional dependent coverage, and benefits chosen. Employer contributions represent contributions from the Company when employees' contributions are not sufficient to pay premiums to the insurance company.

Eligibility to participate in the Plan begins on the employee's first day of work.

Participants should refer to the Plan document for a more complete description of the Plan's provisions and benefits.

2. Summary of Significant Accounting Policies

Basis of Accounting

The financial statements of the Plan are presented on a modified cash basis of accounting. The accounting methods used in preparing these statements differ from accounting principles generally accepted in the United States of America in that contributions are recorded when received rather than when earned and administrative expenses are recorded when paid rather than when incurred. Under the accrual method, the Plan's obligation for insurance premiums at December 31, 2023 and 2022 would have been \$1,432,744 and \$1,559,384, respectively.

Investment Valuation and Income Recognition of the Trust

The investment in the Johnson & Johnson Group Life Benefit Trust (the "Trust" or the "Master Trust") represents the share of assets owned by the Plan and the Johnson & Johnson Voluntary Employee Benefit Association Group Accident Plan for Salaried Employees. The assets of the Plan are held in Institutional Money Market Funds in which NAV approximates fair value, as determined by Bank of America (the "Trustee"), of the Plan. The Plan's share of assets is based on the value of the assets specified for the Plan.

The Plan's interest in the Trust's investment income represents the Plan's share of the net investment income in the Trust. The net investment income reflected in the Statement of Changes in Net Assets Available for Plan Benefits (Modified Cash Basis) includes interest income, dividend income, net gains or losses realized upon disposition of investments and the net change in unrealized appreciation or depreciation of investments. The specific identification method is used to determine each Plan's share of the net investment income.

For investments in the Trust, purchases and sales of securities are recorded on a trade-date basis. Gains and losses on the sale of investment securities are determined on the average cost method. Interest income, dividend income and administrative expenses are recorded on a modified cash basis.

Use of Estimates

The preparation of the Plan's financial statements in conformity with the modified cash basis of accounting requires the Plan Administrator to make estimates and assumptions that affect the reported amounts in the Statements of Net Assets Available for Plan Benefits (Modified Cash Basis), disclosure of contingent assets and liabilities at the date of the financial statements and the reported amounts in the Statement of Changes in Net Assets Available for Plan Benefits (Modified

Cash Basis) during the reporting period. Actual results could differ from those estimates.

Risks and Uncertainties

The Trust can invest in any combination of stocks, bonds, fixed income securities, mutual funds, and other investment securities. Investment securities are exposed to various risks, such as interest rate, market, and credit risk. Due to the level of risk associated with certain investment securities and the level of uncertainty related to changes in the value of investment securities, it is possible that changes in risks in the near term could materially affect the amounts reported in the Statements of Net Assets Available for Plan Benefits (Modified Cash Basis) and the Statement of Changes in Net Assets Available for Plan Benefits (Modified Cash Basis).

Fair Value Measurements

The Plan's valuation methodologies were applied to all of the Trust's investments carried at fair value. Fair value is based upon quoted market prices, where available. If listed prices or quotes are not available, fair value is based upon models that primarily use, as inputs, market-based or independently sourced market parameters, including yield curves, interest rates, volatilities, equity or debt prices, foreign exchange rates and credit curves.

While the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different estimate of fair value at the reporting date.

Valuation Hierarchy

FASB Accounting Standards Codification (ASC) 820, Fair Value Measurements and Disclosures, provides the framework for measuring fair value. That framework provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1 measurements) and the lowest priority to unobservable inputs (Level 3 measurements). The three levels of the fair value hierarchy under FASB ASC 820 are described as follows:

- Level 1 – Quoted prices in active markets for identical assets and liabilities.
- Level 2 – Significant other observable inputs.
- Level 3 – Significant unobservable inputs.

A financial instrument's categorization within the valuation hierarchy is based upon the lowest level of input that is significant to the fair value measurement.

The following is a description of the valuation methodologies used for the investments measured at fair value:

- Short-term investment funds – The assets are generally comprised of cash and quoted short-term instruments are valued at the closing price or the amount held on deposit by the custodian bank where quoted prices are available in an active market and are classified as Level 1. Other investments are through investment vehicles valued using the Net Asset Value ("NAV") provided by the administrator of the fund. The NAV is based on the value of the underlying assets owned by the fund, minus its liabilities, and then divided by the number of shares outstanding. The NAV is a quoted price in a market that is not active and classified as Level 2.

Trust Investments Measured at Fair Value

The Trust has short-term investments (Institutional Money Market Funds) that are all classified as Level 2.

Investment income in the Trust for the year ended December 31, 2023 was \$149,199 and allocated to the respective plans based on the Plan's share of assets in the Trust.

4. Information Certified by Trustee

As permitted by Section 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA, information regarding the investment in the Trust and the Plan's interest in the Trust investment income presented in the accompanying financial statements was agreed to or derived from the information certified by the Trustee. The Plan Administrator has obtained certification from the Trustee that the information derived from the reports certified by the Trustee is complete and accurate.

5. Administrative Expenses

The expenses for the Trustee are paid by the Plan. The Company pays all other administrative expenses.

6. Tax Status

The Trust obtained its latest determination letter on August 16, 1994 from the Internal Revenue Service ("IRS"). The Plan Administrator believes that the Trust, as amended, continues to qualify and to operate as designed in compliance with the applicable requirements of the Internal Revenue Code ("IRC").

Accounting principles generally accepted in the United States of America require Plan management to evaluate tax positions taken by the Plan and recognize a tax liability (or asset) if the Plan has taken an uncertain tax position that more likely than not would not be sustained upon examination by the IRS. The Plan Administrator has concluded that as of December 31, 2023 and 2022, there are no uncertain tax positions taken or expected to be taken that would require recognition of a liability (or asset) or disclosure in the financial statements. The Plan is subject to audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

The Trust established under the Plan to hold the Plan's assets is qualified pursuant to the appropriate section of the Internal Revenue Code ("IRC") and, accordingly, the Trust's net investment income is exempt from income taxes, other than unrelated business income tax, if any.

7. General Termination Priorities

The Company has the right under the Plan to modify the benefits provided to, and contributions required of, participants, to discontinue its contributions at any time, and to terminate the Plan subject to the provisions set forth in ERISA. In the event of termination of the Plan, remaining assets would be distributed among its participants or their beneficiaries in the order and manner prescribed by ERISA. No assets of the Plan may revert to the Company or be used for purposes other than for the exclusive benefit of the Plan's participants.

Effective January 1, 2024, for administrative purposes, the Plan was merged into the Johnson and Johnson Health and Welfare Plan ("J&J H&W Plan"). In connection with this merger \$518,563 of assets were transferred from the Plan to the J&J H&W Plan (Note 8). The participant benefits under the new plan remain consistent with those described in Note 1.
