## **Report of Independent Auditors**

To the Administrator of Johnson & Johnson Medical Benefits Plan for Salaried Employees

### ***Scope and Nature of the ERISA Section 103(a)(3)(C) Audit***

We have performed an audit of the accompanying financial statements of Johnson & Johnson Medical Benefits Plan for Salaried Employees (the "Plan"), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). The financial statements comprise the statements of net assets available for plan benefits and of plan benefit obligations as of December 31, 2023 and 2022, and the related statements of changes in net assets available for plan benefits and of changes in plan benefit obligations for the year ended December 31, 2023, including the related notes (collectively referred to as the "financial statements").

Management, having determined it is permissible in the circumstances, has elected to have the audit of the Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. As permitted by ERISA Section 103(a)(3)(C), our audit need not extend to any statements or information related to assets held for investment of the plan (investment information) by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA (qualified institution).

Management has obtained a certification from a qualified institution as of December 31, 2023 and 2022 and for the year ended December 31, 2023, stating that the certified investment information, as described in Note 4 to the financial statements, is complete and accurate.

### ***Opinion***

In our opinion, based on our audit and on the procedures performed as described in the Auditors' Responsibilities for the Audit of the Financial Statements section of our report

- the amounts and disclosures in the accompanying financial statements, other than those agreed to or derived from the certified investment information, are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America.
- the information in the accompanying financial statements related to assets held by and certified to by a qualified institution agrees to, or is derived from, in all material respects, the information prepared and certified by an institution that management determined meets the requirements of ERISA Section 103(a)(3)(C).



### ***Basis for Opinion***

We conducted our audit in accordance with auditing standards generally accepted in the United States of America (US GAAS). Our responsibilities under those standards are further described in the Auditors' Responsibilities for the Audit of the Financial Statements section of our report. We are required to be independent of the Plan and to meet our other ethical responsibilities, in accordance with the relevant ethical requirements relating to our audit. We believe that the audit evidence we have obtained is sufficient and appropriate to provide a basis for our ERISA Section 103(a)(3)(C) audit opinion.

### ***Responsibilities of Management for the Financial Statements***

Management is responsible for the preparation and fair presentation of the financial statements in accordance with accounting principles generally accepted in the United States of America, and for the design, implementation, and maintenance of internal control relevant to the preparation and fair presentation of financial statements that are free from material misstatement, whether due to fraud or error. Management's election of the ERISA Section 103(a)(3)(C) audit does not affect management's responsibility for the financial statements.

In preparing the financial statements, management is required to evaluate whether there are conditions or events, considered in the aggregate, that raise substantial doubt about the Plan's ability to continue as a going concern for one year after the date the financial statements are available to be issued.

Management is also responsible for maintaining a current plan instrument, including all plan amendments, administering the plan, and determining that the plan's transactions that are presented and disclosed in the financial statements are in conformity with the plan's provisions, including maintaining sufficient records with respect to each of the participants, to determine the benefits due or which may become due to such participants.

### ***Auditors' Responsibilities for the Audit of the Financial Statements***

Except as described in the Scope and Nature of the ERISA Section 103(a)(3)(C) Audit section of our report, our objectives are to obtain reasonable assurance about whether the financial statements as a whole are free from material misstatement, whether due to fraud or error, and to issue an auditors' report that includes our opinion. Reasonable assurance is a high level of assurance but is not absolute assurance and therefore is not a guarantee that an audit conducted in accordance with US GAAS will always detect a material misstatement when it exists. The risk of not detecting a material misstatement resulting from fraud is higher than for one resulting from error, as fraud may involve collusion, forgery, intentional omissions, misrepresentations, or the override of internal control. Our audit did not extend to the certified investment information, except for obtaining and reading the certification, comparing the certified investment information with the related information presented and disclosed in the financial statements, and reading the disclosures relating to the certified investment information to assess whether they are in accordance with the presentation and disclosure requirements of accounting principles generally accepted in the United States of America.

Accordingly, the objective of an ERISA Section 103(a)(3)(C) audit is not to express an opinion about whether the financial statements as a whole are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America.

We are required to communicate with those charged with governance regarding, among other matters, the planned scope and timing of the audit, significant audit findings, and certain internal control-related matters that we identified during the audit.

#### 1. The Plan, Contributions and Benefits

The Johnson & Johnson Medical Benefits Plan for Salaried Employees (the “Plan”) is a contributory welfare benefit plan which provides health benefits (hospital, surgical, major medical, prescription drug, vision and dental) to employees (not including those employees located in Puerto Rico or Certain Retirees/Disabled Union Represented Employees) of Johnson & Johnson and its affiliated companies (the “Company” or “Plan Administrator”) who are full-time or qualified part-time employees, certain hourly employees and certain retirees. Effective January 1, 2018, all of the active Unions collectively bargained to be part of the Plan. As such, all employee contributions and claim payments for the active Union population are deposited/funded via the Johnson & Johnson Voluntary Employee Benefit Trust Fund (the “Trust” or the “Master Trust”).

Active Unions include:

- Certain Production & Maintenance Employees of Ethicon, San Angelo, Texas involving UTW, AFL-CIO, Local 514T (active Union)
- Wage Employees of Ethicon, Somerville, New Jersey; involving ACTWU Local 630 (active Union)
- Hourly Employees of DePuy Orthopedics, Warsaw, Indiana; involving ACTWU, AFL-CIO Local 809 (active Union)

The Plan is a cafeteria plan allowing employees and retirees to select from various levels of coverage. Certain HMO programs, which employees can elect, provide fully insured health and welfare benefits. For those fully insured programs, the Plan has no obligation for benefits covered by the arrangement other than the payment of premiums due to the insurance company. The Plan is subject to the provisions of ERISA, as amended.

Employee contributions are based upon the cost of the coverage option selected less the dollar amount of benefits granted by the Company. Employer contributions are premium or claim payments to the insurance companies in excess of employee contributions. Costs are based on the level of coverage selected, optional dependent coverage and salary level, if applicable, of the participant. Eligibility to participate in the Plan begins on the employee’s first day of work. Retirees are eligible to participate at the age of 55 and must have between five and ten years of pension credited service.

Effective January 1, 2016, the retiree contribution structure within the Plan was amended. The amendment included both in cost-sharing and level of future Company subsidy increase – for future Salaried/Non-Union retirees not eligible to retire (i.e., age 55 with 10 years of service) as of January 1, 2016.

Participants should refer to the Plan document for a more complete description of the Plan’s provisions and benefits.

#### 2. Summary of Significant Accounting Policies

##### Basis of Accounting

The financial statements of the Plan are prepared under the accrual method of accounting in accordance with accounting principles generally accepted in the United States of America.

##### Employer and Employee Contribution Receivables

These amounts represent employee and employer contributions withheld and remitted by the Company but not yet remitted to the Trust.

#### **Investment Valuation and Income Recognition of the Trust**

The Plan's interest in the Trust is stated at fair value. The Trust represents the share of assets owned by the Plan and the Johnson & Johnson Long Term Disability Plan for Salaried Employees. The specific identification method is used to determine each plan's share of assets.

The Trust invests in varying assets such as temporary investments (cash and short-term investments), and Common Collective Trusts ("CCT"). The Plan's balance is reported in units of participation, which allows for immediate transfer in and out of the Trust. The purchase or redemption price of the units is determined by State Street Bank and Trust Company ("Trustee" or "State Street"), based on the current fair value of the underlying investments. The Trust's net asset value for a single unit is computed by adding the value of the investments, cash and other assets, and subtracting liabilities, then dividing the result by the number of units outstanding.

Purchases and sales of securities are recorded on a trade-date basis. Gains and losses on the sale of investment securities are determined on the average cost method. Dividend income is recorded on the ex-dividend date. Interest income and administrative expenses are recorded on an accrual basis.

The Plan presents, in the Statement of Changes in Net Assets Available for Plan Benefits, the investment income for the Plan's interest in the Trust which consists of the Plan's allocated change in unrealized appreciation and depreciation of the underlying investments, realized gains and losses on sales of investments and investment income.

#### **Postretirement Benefit Obligation**

The postretirement benefit obligation represents the actuarial present value of those estimated future benefits that are attributed to employee service rendered to December 31, 2023 and 2022. Postretirement benefits include future benefits expected to be paid to or for (1) currently retired or terminated employees and their beneficiaries and dependents, and (2) active employees and their beneficiaries and dependents after retirement from service with the Company. Prior to an active employee's full eligibility date, the postretirement benefit obligation is the portion of the expected postretirement benefit obligation that is attributed to that employee's service rendered to the valuation date. The Plan's postretirement benefit obligations will be funded by employer contributions to the Plan.

The actuarial present value of the expected postretirement benefit obligation is determined by an actuary and is the amount that results from applying actuarial assumptions to historical claims-cost data to estimate future annual incurred claims cost per participant and to adjust such estimates for the time value of money (through discounts for interest) and the probability of payment (by means of decrements such as those for death, disability, withdrawal, or retirement) between the valuation date and the expected date of payment.

The Plan's postretirement benefit obligation does not reflect an amount associated with the Medicare subsidy allowed under the Medicare Prescription Drug Improvement and Modernization Act of 2003 because the Plan is not directly entitled to the Medicare subsidy. The Company has included the effects of the Medicare subsidy in measuring its postretirement benefit obligation; therefore, the Plan's postretirement benefit obligation differs from that of the Company.

Health care cost trends are projected at annual rates, for participants Pre-65, grading from 2.6% Medical / Rx to 4.0% Medical / Rx by the year 2048, Post-65 (non-Medicare Advantage) grading from 3.1% Medical / Rx to 4.0%, by the year 2048, and Medicare Advantage grading from (0.3%) Medical/Rx to 4.0% by the year 2048. The effect of a 1% annual increase in these assumed cost trend rates would increase the postretirement benefit obligation as of December 31, 2023 and 2022, by approximately \$169,315,694 and \$189,788,747, respectively.

The following were the other significant assumptions used in the valuations as of December 31, 2023 and 2022:

- Weighted-average discount rate: 5.15% - 2023; 5.42% - 2022
- Average retirement age: Assumed to occur at stratified rates between ages 55 and 71
- Mortality: The Pri-2012 mortality table with separate annuitant and non-annuitant rates, and with generational mortality improvements based on the Mercer developed Scale MMP-2021 for both the December 31, 2023 and December 31, 2022 valuations.

The foregoing assumptions are based on the presumption that the Plan will continue. Were the Plan to terminate, different actuarial assumptions and other factors might be applicable in determining the actuarial present value of the postretirement benefit obligation.

#### **Other Plan Benefits**

Plan obligations at December 31, 2023 and 2022 for health claims incurred by active participants but not reported at that date are estimated by the Plan's actuary in accordance with accepted actuarial principles. Such estimated amounts are reported in the accompanying Statements of Plan Benefit Obligations. Health claims incurred by retired participants but not reported at year end are included in the postretirement benefit obligations.

#### **Use of Estimates**

The preparation of financial statements in accordance with accounting principles generally accepted in the United States of America require the Plan Administrator to make estimates and assumptions that affect the reported amounts of assets, liabilities, benefit obligations and changes therein, and disclosure of contingent asset and liabilities. Actual results could differ from those estimates.

#### **Risks and Uncertainties**

Contributions to the Plan and the actuarial present value of benefit obligations are reported based on certain assumptions pertaining to interest rates, inflation rates, employee compensation and demographics. Due to the changing nature of these assumptions, it is possible that changes in these assumptions will occur in the near term and, due to the uncertainties inherent in setting assumptions, that the effect of such changes could be material to the financial statements.

The Trust can invest in any combination of stocks, bonds, fixed income securities, CCTs, and other investment securities. Investment securities are exposed to various risks, such as interest rate, market and credit risk. Due to the level of risk associated with certain investment securities and the level of uncertainty related to changes in the value of investment securities, it is possible that changes in risks in the near term could materially affect the amounts reported in the Statements of Net Assets Available for Plan Benefits and the Statement of Changes in Net Assets Available for Plan Benefits.

#### **Payment of Benefits**

Benefit payments are recorded upon distribution.

#### Fair Value Measurements

The Plan's valuation methodologies were applied to all of the Trust's investments carried at fair value. Fair value is based upon quoted market prices, where available. If listed prices or quotes are not available, fair value is based upon models that primarily use, as inputs, market-based or independently sourced market parameters, including yield curves, interest rates, volatilities, equity or debt prices, foreign exchange rates and credit curves.

While the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different estimate of fair value at the reporting date.

#### Valuation Hierarchy

FASB Accounting Standards Codification (ASC) 820, Fair Value Measurements and Disclosures, provides the framework for measuring fair value. That framework provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1 measurements) and the lowest priority to unobservable inputs (Level 3 measurements). The three levels of the fair value hierarchy under FASB ASC 820 are described as follows:

- Level 1 – Quoted prices in active markets for identical assets and liabilities.

- Level 2 – Significant other observable inputs.
- Level 3 – Significant unobservable inputs.

A financial instrument's categorization within the valuation hierarchy is based upon the lowest level of input that is significant to the fair value measurement.

The following is a description of the valuation methodologies used for the investments measured at fair value:

- Short-term investment funds – The assets are generally comprised of cash and quoted short-term instruments which are valued at the closing price or the amount held on deposit by the custodian bank where quoted prices are available in an active market and are classified as Level 1. Other investments are through investment vehicles valued using the Net Asset Value (“NAV”) provided by the administrator of the fund. The NAV is based on the value of the underlying assets owned by the fund, minus its liabilities, and then divided by the number of shares outstanding. The NAV is a quoted price in a market that is not active and classified as Level 2.
- Common Collective Trusts (CCTs) – The fair value of all CCT interests have been determined using NAV as a practical expedient. The NAV is based on the value of the underlying assets owned by the funds, minus its liabilities, and then divided by the number of shares outstanding. The CCT's are included in Investments measured at Net Asset Value. All of the CCTs are used for liquidity purposes for the Plan within the Trust. The CCTs are 100% invested in passive funds that provide daily liquidity with 2-day prior notice for Plan Sponsor transactions. At December 31, 2023 and 2022, 100% and 100%, respectively, of the CCTs are invested in passive strategies that mimic the indices. Additionally, at December 31, 2023 and 2022, 0% and 38%, respectively, of the CCTs are invested in U.S. equities; 100% and 54%, respectively, of the CCTs are invested in fixed income with the remainder of 2022's CCTs invested in global equities. There are no unfunded commitments for any of the CCTs that the Trust invests in.

#### 4. Information Certified by Trustee

As permitted by Section 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA, information regarding the investment in the Trust and the Plan's interest in the Trust investment income presented in the accompanying financial statements was agreed to or derived from the information certified by the Trustee. The Plan Administrator has obtained certification from the Trustee that the information derived from the reports certified by the Trustee is complete and accurate.

#### 5. Administrative Expenses

Administrative costs incurred by the Plan were for processing claims by independent service providers, custodian, trustee, investment advisor and management fees and actuarial and accounting services. The Company pays all other administrative costs other than those specified above.

#### 6. Tax Status

The Trust obtained its latest determination letter on June 30, 1989 from the Internal Revenue Service ("IRS"). The Plan Administrator believes that the Trust, as amended, continues to qualify and to operate as designed in compliance with the applicable requirements of the Internal Revenue Code ("IRC").

Accounting principles generally accepted in the United States of America require Plan management to evaluate tax positions taken by the Plan and recognize a tax liability (or asset) if the Plan has taken an uncertain tax position that more likely than not would not be sustained upon examination by the IRS. The Plan Administrator has concluded that as of December 31, 2023 and 2022, there are no uncertain tax positions taken or expected to be taken that would require recognition of a liability (or asset) or disclosure in the financial statements. The Plan is subject to audit by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

The Trust established under the Plan to hold the Plan's assets is qualified pursuant to the appropriate section of the Internal Revenue Code ("IRC") and, accordingly, the Trust's net investment income is exempt from income taxes, other than unrelated business income tax, if any.

Pursuant to certain provisions of the IRC and state tax statutes, a portion of the income generated by the Trust may be subject to an unrelated business income tax ("UBIT") due to the pre-funding of the Trust by the Plan Sponsor.

#### 7. General Termination Priorities

The Company has the right under the Plan to modify the benefits provided to, and contributions required of, participants, to discontinue its contributions at any time, and to terminate the Plan subject to the provisions set forth in ERISA. In the event of termination of the Plan, remaining assets would be distributed among its participants or their beneficiaries in the order and manner prescribed by ERISA. No assets of the Plan may revert to the Company or be used for purposes other than for the exclusive benefit of the Plan's participants.

Effective January 1, 2024, for administrative purposes, the Plan was merged into the Johnson and Johnson Health and Welfare Plan ("J&J H&W Plan"). In connection with this merger \$85,819,006 of assets were transferred from the Plan to the J&J H&W Plan (Note 9). The participant benefits under the new plan remain consistent with those described in Note 1.

#### 8. Related Party Transactions

The Trustee manages the Plan's entire investment in the State Street Institutional Treasury Money Market Fund and therefore, these transactions qualify as party-in-interest transactions.
