Scope and Nature of the ERISA Section 103(a)(3)(C) Audits

- the information in the accompanying financial statements related to assets held by and certified to by qualified institutions agrees to, or is derived from, in all material respects, the information prepared and certified by an institution that management determined meets the requirements of ERISA Section 103(a)(3)(C).

Basis for Opinion

We conducted our audits in accordance with auditing standards generally accepted in the United States of America (“GAAS”). Our responsibilities under those standards are further described in the Auditor’s Responsibilities for the Audits of the Financial Statements section of our report. We are required to be independent of the Plan and to meet our other ethical responsibilities, in accordance with the relevant ethical requirements relating to our audits. We believe the audit evidence we have obtained is sufficient and appropriate to provide a basis for our ERISA Section 103(a)(3)(C) audits opinion.

Responsibilities of Management for the Financial Statements

Management is responsible for the preparation and fair presentation of the financial statements in accordance with GAAP, and for the design, implementation, and maintenance of internal control relevant to the preparation and fair presentation of financial statements that are free from material misstatement, whether due to fraud or error. Management’s election of the ERISA Section 103(a)(3)(C) audits does not affect management’s responsibility for the financial statements.

In preparing the financial statements, management is required to evaluate whether there are conditions or events, considered in the aggregate, that raise substantial doubt about the Plan’s ability to continue as a going concern for one year after the date the financial statements are issued.

Management is also responsible for maintaining a current plan instrument, including all plan amendments, administering the Plan, and determining that the Plan’s transactions that are presented and disclosed in the financial statements are in conformity with the Plan’s provisions, including maintaining sufficient records with respect to each of the participants, to determine the benefits due or which may become due to such participants.

Auditor’s Responsibilities for the Audits of the Financial Statements

Except as described in the Scope and Nature of the ERISA Section 103(a)(3)(C) Audits section of our report, our objectives are to obtain reasonable assurance about whether the financial statements as a whole are free from material misstatement, whether due to fraud or error, and to issue an auditor’s report that includes our opinion. Reasonable assurance is a high level of assurance but is not absolute assurance and therefore is not a guarantee that an audit conducted in accordance with GAAS will always detect a material misstatement when it exists. The risk of not detecting a material misstatement resulting from fraud is higher than for one resulting from error, as fraud may involve collusion, forgery, intentional omissions, misrepresentations, or the override of internal control. Misstatements are considered material if there is a substantial likelihood that, individually or in the aggregate, they would influence the judgment made by a reasonable user based on the financial statements.

In performing an audit in accordance with GAAS, we:

Our audits did not extend to the certified investment information, except for obtaining and reading the certification, comparing the certified investment information with the related information presented and disclosed in the financial statements, and reading the disclosures relating to the certified investment information to assess whether they are in accordance with the presentation and disclosure requirements of GAAP.

Accordingly, the objective of ERISA Section 103(a)(3)(C) audits is not to express an opinion about whether the financial statements as a whole are presented fairly, in all material respects, in accordance with GAAP.

We are required to communicate with those charged with governance regarding, among other matters, the planned scope and timing of the audits, significant audit findings, and certain internal control-related matters that we identified during the audits.

Other Matters - Supplemental Schedule Required by ERISA

The supplemental schedule, schedule of assets (held at end of year) as of December 31, 2023, is presented for purposes of additional analysis and is not a required part of the financial statements but is supplementary information required by the DOL's Rules and Regulations for Reporting and Disclosure under ERISA. Such information is the responsibility of management and was derived from and relates directly to the underlying accounting and other records used to prepare the financial statements. The information included in the supplemental schedule, other than that agreed to or derived from the certified investment information, has been subjected to auditing procedures applied in the audits of the financial statements and certain additional procedures, including comparing and reconciling such information directly to the underlying accounting and other records used to prepare the financial statements or to the financial statements themselves, and other additional procedures in accordance with GAAS. For information included in the supplemental schedule that agreed to or is derived from the certified investment information, we compared such information to the related certified investment information.

In forming our opinion on the supplemental schedule, we evaluated whether the supplemental schedule, other than the information agreed to or derived from the certified investment information, including its form and content, is presented in conformity with the DOL's Rules and Regulations for Reporting and Disclosure under ERISA.

Notes to Financial Statements**December 31, 2023 and 2022****1. Summary of Significant Plan Provisions**

The following description of the Propak Logistics, LLC 401(k) Retirement Plan (the “Plan”) provides only general information. Participants should refer to the Plan agreement for a more complete description of the Plan’s provisions.

- a. **General** – The Plan is a defined contribution plan for the benefit of employees of Propak Logistics, LLC and ProPak Transport, LLC (the “Employer”). It is subject to the provisions of the Employee Retirement Income Security Act of 1974 (“ERISA”), as amended.
- b. **Eligibility** – Each employee, who is not a highly compensated employee, an employee eligible for the non-qualified deferred compensation plan offered by the Employer, or a non-managerial operational hourly employee, is eligible to participate in the Plan upon completion of two months of continuous service. Plan entry dates are the first of the month following the date the eligibility requirements are met.
- c. **Contributions** – Participants contribute through payroll deductions and eligible rollovers. Automatic enrollment contributions will begin as soon as administratively feasible on or after the participant’s entry date. On the employee’s entry date, unless the employee affirmatively elects otherwise, their compensation will be reduced by 3% each payroll period for salary deferrals. The automatic deferral amount will increase by 1% on the first day of each plan year up to a maximum of 10%. The Employer may make a matching contribution at its discretion. During the years ended December 31, 2023 and 2022, the Employer made matching contributions equal to 50% of a participant’s elective deferrals that did not exceed 4% of a participant’s eligible compensation. The Employer may also make a profit sharing contribution at its discretion. The Employer did not make a profit sharing contribution for the years ended December 31, 2023 or 2022. Contributions are subject to certain Internal Revenue Service (“IRS”) limitations.
- d. **Participant accounts** – Each participant’s account is credited with the participant’s and Employer contributions and allocations of Plan earnings/losses, and is charged with applicable withdrawals and an allocation of administrative expenses. Allocations are based on participant’s earnings, contributions, or account balances, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant’s vested account.
- e. **Vesting** – Participants are always fully vested with respect to their own contributions, plus earnings/losses thereon. With respect to Employer contributions, the benefits attributable to a participant shall be fully vested and nonforfeitable upon attainment of age 65, death, or disability. If a participant terminates employment for reasons other than death, retirement, or disability, they are entitled to the vested portion of contributions made by the Employer, plus earnings/losses thereon.

- f. **Investment options** – Upon enrollment in the Plan, a participant may direct contributions in any of the accounts offered under the Plan. Participants may change their investment selections at any time.
- g. **Forfeitures** – The portion of a participant’s account to which they are not entitled as a result of being less than fully vested shall be forfeited by the participant. Forfeitures may be used to pay Plan administrative expenses and offset Employer matching contributions. Forfeitures of \$1,112 and \$575 were used to pay Plan administrative expenses for the years ended December 31, 2023 and 2022, respectively. Forfeitures of \$83,147 and \$86,626 were used to reduce Employer matching contributions for the years ended December 31, 2023 and 2022, respectively. Forfeitures of \$776 and \$12,922 were available for future use at December 31, 2023 and 2022, respectively.
- h. **Payment of benefits** – Upon termination of service, a participant may elect to receive a lump sum payment of their vested account balance. Participants may elect to defer payment of their account balance if it exceeds \$5,000. If a participant’s account balance is equal to or less than \$5,000, the account will be automatically distributed. Any distribution that is made to a participant without the participant’s consent before the participant’s normal retirement age will be rolled over to an individual retirement plan designated by the Plan administrator. In-service withdrawals are allowed if the participant has attained age 59½ or qualifies for a hardship withdrawal.
- i. **Termination of the Plan** – Although it has not expressed any intent to do so, the Employer has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, participants will become 100% vested in their employer accounts.

Notes to Financial Statements**December 31, 2023 and 2022****2. Summary of Significant Accounting Policies**

- a. **Basis of accounting** – The financial statements of the Plan are prepared under the accrual method of accounting in accordance with accounting principles generally accepted in the United States of America (“GAAP”).
- b. **Estimates** – The preparation of financial statements in conformity with GAAP requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities and changes therein, and disclosure of contingent assets and liabilities. Actual results could differ from those estimates.
- c. **Investment valuation and income recognition** – Investments are reported at fair value, except for the fully benefit-responsive investment contract, which is reported at contract value as disclosed in Note 3. See Note 5 for discussion on fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net change in value of investments includes the Plan’s gains and losses on investments bought and sold, as well as held during the year.

- d. **Payment of benefits** – Benefits are recorded when paid.
- e. **Administrative expenses** – Administrative expenses charged to the Plan are allocated to participants’ accounts. Fees for distributions are charged directly to the participants’ account. Other plan expenses paid by the Employer are excluded from these financial statements.

3. Fully Benefit-Responsive Investment Contract

The Plan entered into a fully benefit-responsive guaranteed investment contract (“GIC”) with Empower Annuity Insurance Company of America (“Empower Annuity”). Empower Annuity maintains the contributions in a general account. The account is credited with earnings on the underlying investments and charged for participant withdrawals and administrative expenses. Empower Annuity is contractually obligated to repay the principal and a specified interest rate that is guaranteed to the Plan.

This contract meets the fully benefit-responsive investment contract criteria and therefore is reported at contract value. Contract value is the relevant measure for fully benefit-responsive investment contracts because this is the amount received by participants if they were to initiate permitted transactions under the terms of the Plan. Contract value, as reported to the Plan by Empower Annuity, represents contributions made under the contract, plus earnings, less participant withdrawals, and administrative expenses. Participants may ordinarily direct the withdrawal or transfer of all or a portion of their investment at contract value.

3. Fully Benefit-Responsive Investment Contract (cont.)

Certain events limit the ability of the Plan to transact at contract value with the issuer. Such events include any Employer originated transfer or distribution out of the contract. Plan management does not believe the occurrence of any such event, which would limit the Plan’s ability to transact at contract value with participants, is probable. Any Employer originated transfer or distribution, including termination of the contract, will be subject to either 12 months advance notice or a 5% surrender charge.

4. Investments

The Plan administrator has elected the method of compliance permitted by 29 CFR 2520.103-8 of the Department of Labor’s Rules and Regulations for Reporting and Disclosure under ERISA. Accordingly, as permitted under such election, the following information was certified by Empower Annuity and Empower Trust Company, LLC, the trustees of the Plan, and was not subjected to any audit procedures, except for comparing the information with the related information included in the financial statements and supplemental schedule:

- a. Total investments as shown on the accompanying statement of net assets available for benefits totaling \$4,654,559 and \$3,256,667 as of December 31, 2023 and 2022, respectively.
- b. Interest and dividends as shown on the accompanying statement of changes in net assets available for benefits of \$94,079 and \$64,555 for the years ended December 31, 2023 and 2022, respectively.
- c. Net change in value of investments as shown on the accompanying statement of changes in net assets available for benefits of \$538,259 and \$(812,795) for the years ended December 31, 2023 and 2022, respectively.
- d. All investment transactions that occurred during the years ended December 31, 2023 and 2022.
- e. All the information included in the supplemental schedule.

The Plan provides for investments in various investment securities which, in general, are exposed to various risks, such as interest rate, credit, and overall market volatility risk. Further, due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect the amounts reported in the financial statements.

Notes to Financial Statements**December 31, 2023 and 2022****5. Fair Value Measurements**

Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. Fair value is categorized based on a hierarchy that gives the highest priority to unadjusted quoted prices in active markets for identical assets (Level 1 measurements) and the lowest priority to unobservable inputs (Level 3 measurements). The three levels of the fair value hierarchy are described as follows:

Level 1 Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2 Inputs to the valuation methodology include:

- quoted prices for similar assets or liabilities in active markets;
- quoted prices for identical or similar assets or liabilities in inactive markets;
- inputs other than quoted prices that are observable for the asset or liability; and
- inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specific (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

Level 3 Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

The following is a description of the valuation methodology used for assets measured at fair value. There have been no changes in the methodology used at December 31, 2023 or 2022.

Mutual funds: These investments are valued at quoted market prices on the last business day of the Plan year.

The preceding method described may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, although the Plan believes its valuation method is appropriate and consistent with other market participants, the use of different methodologies, or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

6. **Tax Status**

The Plan is utilizing a non-standardized pre-approved plan document (the “Plan Document”), which received an opinion letter dated November 14, 2022, in which the IRS stated the Plan Document is designed in accordance with the applicable sections of the Internal Revenue Code (“IRC”). As allowed by the IRS, the Plan is relying on the opinion letter of the Plan Document for its own qualification. Although the Plan Document has been amended since receiving the opinion letter, the Plan administrator believes the Plan is designed and currently being operated in compliance with the applicable provisions of the IRC. Therefore, no provision for income taxes has been included in the Plan’s financial statements.

GAAP requires Plan management to evaluate tax positions taken by the Plan and recognize a tax liability (or asset) if the Plan has taken an uncertain position that, more likely than not, would not be sustained upon examination by the IRS. The Plan administrator has analyzed the tax positions taken by the Plan, and has concluded that, as of December 31, 2023, there are no uncertain positions taken or expected to be taken that would require recognition of a liability (or asset) or disclosure in the financial statements. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in process.

7. **Parties-in-Interest Transactions**

The Plan has a GIC with Empower Annuity. Empower Retirement, LLC (a subsidiary of Empower Annuity) serves as third-party administrator for the Plan. The Plan pays fees to Empower Retirement, LLC for their services. Empower Annuity and Empower Retirement, LLC are by definition parties-in-interest and, as a result, the Plan’s transactions pertaining to these investments were with parties-in-interest. All of these transactions were exempt from being prohibited transactions under ERISA.

8. **Subsequent Events**

Effective January 1, 2024, the Plan merged with the PLA 401(k) Plan.

Management of the Plan evaluated the events and transactions subsequent to its December 31, 2023 financial statement date and determined there were no additional significant events, other than disclosed above, necessary for disclosure through September 30, 2024, which is the financial statement issuance date.
