Independent Auditor's Report

Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We were engaged to perform audits of the financial statements of Colorado Academy Defined Contribution Retirement Plan, an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). The financial statements comprise the statements of net assets available for benefits as of December 31, 2023 and 2022, and the related statement of changes in net assets available for benefits for the year ended December 31, 2023, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of Colorado Academy Defined Contribution Retirement Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's (DOL) Rules and Regulations for Reporting and Disclosure under ERISA. As permitted by ERISA Section 103(a)(3)(C), our audits need not extend to any statements or information related to assets held for investment of the plan (investment information) by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the DOL's Rules and Regulations for Reporting and Disclosure under ERISA (qualified institution).

Management has obtained certifications from a qualified institution as of December 31, 2023 and 2022, and for the year ended December 31, 2023, stating that the certified investment information, as described in Note 4 to the financial statements, is complete and accurate.

Disclaimer of Opinion

We do not express an opinion on the accompanying financial statements of Colorado Academy Defined Contribution Retirement Plan. Because of the significance of the matters described in the Basis for Disclaimer of Opinion section of our report, we have not been able to obtain sufficient appropriate audit evidence to provide a basis for an audit opinion on the financial statements.

Basis for Disclaimer of Opinion

Colorado Academy Defined Contribution Retirement Plan has not maintained sufficient accounting records and supporting documents relating to certain annuity contracts and custodial accounts issued to current and former employees prior to January 1, 2009. Accordingly, we were unable to apply auditing procedures sufficient to determine the extent to which the accompanying financial statements may have been affected by these conditions.

Further, as described in Note 2 to the financial statements, the Plan has excluded from investments in the accompanying statements of net assets available for benefits certain annuity contracts and custodial accounts issued to current and former employees prior to January 1, 2009, as permitted by the DOL's Field Assistance Bulletin No. 2009-02, *Annual Reporting Requirements for 403(b) Plans*. The investment income and distributions related to such accounts have also been excluded in the accompanying statement of changes in net assets available for benefits. The amount of these excluded annuity contracts and custodial accounts and the related income and distributions are not determinable. Accounting principles generally accepted in the United States of America require that these accounts and the related income and distributions be included in the accompanying financial statements.

Emphasis of Matter – Plan Merger

As described in Note 9 to the financial statements, effective January 1, 2024, the Colorado Academy Defined Contribution Retirement Plan merged into The Independent School Group Retirement Plan. As control transferred over January 1, 2024, assets are in transit to successor plan at December 31, 2023. Our disclaimer of opinion is not modified with respect to this matter.

Responsibilities of Management for the Financial Statements

Management is responsible for the preparation and fair presentation of the financial statements in accordance with accounting principles generally accepted in the United States of America, and for the design, implementation, and maintenance of internal control relevant to the preparation and fair presentation of financial statements that are free from material misstatement, whether due to fraud or error. Management's election of the ERISA Section 103(a)(3)(C) audit does not affect management's responsibility for the financial statements.

In preparing the financial statements, management is required to evaluate whether there are conditions or events, considered in the aggregate, that raise substantial doubt about Colorado Academy Defined Contribution Retirement Plan's ability to continue as a going concern for one year after the date that the financial statements are available to be issued.

Management is also responsible for maintaining a current plan instrument, including all plan amendments, administering the plan, and determining that the plan's transactions that are presented and disclosed in the financial statements are in conformity with the plan's provisions, including maintaining sufficient records with respect to each of the participants, to determine the benefits due or which may become due to such participants.

Auditor's Responsibilities for the Audit of the Financial Statements

Our responsibility is to conduct an audit of Colorado Academy Defined Contribution Retirement Plan's financial statements in accordance with auditing standards generally accepted in the United States of America and to issue an auditor's report. However, because of the matters described in the Basis for Disclaimer of Opinion section of our report, we were not able to obtain sufficient appropriate audit evidence to provide a basis for an audit opinion on these financial statements.

We are required to be independent of Colorado Academy Defined Contribution Retirement Plan, and to meet our other ethical responsibilities, in accordance with the relevant ethical requirements relating to our audits.

Note 1 - Description of Plan

The following brief description of the Colorado Academy Defined Contribution Retirement Plan (the Plan) is provided for general information purposes only. Participants should refer to the Plan document for a more complete description of the Plan's provisions.

General

The Plan is a defined contribution plan covering qualified employees of Colorado Academy (the Employer or Plan Sponsor). The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (the ERISA).

The Board of Trustees determines the appropriateness of the Plan's investment offerings and monitors investment performance.

As noted in Note 9, the Plan merged into The Independent School Group Retirement Plan and assets are in transit at December 31, 2023.

Eligibility

Employees are eligible to participate in elective deferrals on their first day of employment, except for employees that elect less than \$200 to be deferred in a year, non-resident aliens, students performing services, part-time employees scheduled to work fewer than 20 hours per week and 1,000 hours per year and leased employees.

Employees are eligible for employer contributions on the first of the month after obtaining 2 years of eligible service and reaching the age of 21, except non-resident aliens, members of a collective bargaining agreement, students performing services, leased employees and independent contractors.

Entry Date

Employees may enter the Plan on the first day of the month following their date of hire unless their hire date is the first of the month. In this circumstance the employee may enter the Plan on their date of hire.

Contributions

Each year, participants may contribute up to 100% of their pretax annual compensation, as defined in the Plan. Contributions are subject to certain Internal Revenue Code (IRC) limitations. Participants who have attained age 50 before the end of the Plan year are eligible to make catch-up contributions. The Plan allows participants to designate contributions as Roth contributions. The participants may also contribute amounts representing distributions from other qualified plans (rollovers). The Employer contributes a percentage of the participant's base compensation based on the following schedule:

<u>Participant's Years of Service</u>	<u>Employer Contribution</u>
Less than or equal to 7	6%
8 but greater than 7	7%
9 but greater than 8	8%
10 but greater than 9	9%
Greater than 10	10%

Additional amounts may be contributed at the discretion of the Employer's Board of Trustees. No such additional discretionary contributions were made for the year ended December 31, 2023.

Participant Accounts

Each participant's account is credited with the participant's contributions and the Employer's contributions, as well as allocations of the Employer's discretionary contributions and Plan earnings. Participant accounts are charged with an allocation of administrative expenses that are paid by the Plan. Allocations are based on participant's compensation, account balances or specific participant transactions, as defined by the Plan document. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

Investment Options

Upon enrollment to the Plan, a participant may direct deferrals and employer contributions in any of the funds offered by the Plan. Participants may change their investment options daily.

Vesting

Participants are vested immediately in their contributions as well as employer contributions, plus actual earnings thereon.

Forfeitures

There were no forfeited accounts held by the Plan as of December 31, 2023 and 2022 or during the year ended December 31, 2023, as participants' accounts are fully vested at all times.

Contributions

Participant contributions and related Company nonelective contributions are recorded in the year in which the employee contributions are withheld from compensation.

Notes Receivable from Participants

The Plan allows for two different types of notes, participant notes and plan loans.

Participant notes:

Participants may borrow from their fund accounts, a minimum of \$1,000 up to a maximum equal to the lesser of \$50,000 or 50% of their account balance. If the loan is being taken from a TIAA-CREF annuity, the maximum loan is further reduced as defined in the Plan document. The notes are secured by the balance in the participant's account. The note interest rate varies depending on how a participant's balance is invested, as described in the Plan document. Principal and interest is paid ratably not to exceed five years, unless the proceeds of the note were used to acquire the participant's residence, in which case the note terms can range up to ten years. A participant may have no more than two outstanding notes at any one time.

Plan Loans:

A participant may also initiate a plan loan directly with TIAA-CREF using their account balance as collateral for the loan. In these circumstances, the participant's account balance is not reduced by the outstanding note balance. Plan loan repayments are made directly from the participant to TIAA-CREF. The collateral must be equal to or exceed 110% of the loan, and payments on the loan are made outside of the Plan.

Plan loans totaling \$29,858 during 2023 are part of the assets in transit to the Independent School Group Retirement Plan at December 31, 2023. Plan loans outstanding totaled \$62,466 at December 31, 2022. Plan loans transacted directly between the participant and TIAA-CREF are not considered an asset of the Plan and are not reported on the accompanying statements of net assets available for plan benefits. The collateral of the loans that have defaulted totaled \$0 as of December 31, 2023 and 2022, respectively.

Payment of Benefits

Participants may elect to receive a lump-sum amount equal to the value of their vested interest, annual installments, and partial payments or use their vested individual account balance towards the purchase of an annuity contract as defined in the Plan document upon retirement, termination, death or disability. A terminated employee is able to receive a lump sum distribution of their balance as of the date of termination or choose to have it be rolled into a qualified Individual Retirement Account. Distributions from the elective deferral portion of a participant's account may be made at the participant's election prior to termination as defined in the Plan document. Any participant who terminates with a cumulative balance of less than \$5,000 is required to take a cash distribution or rollover amounts to a different plan. Distributions may be made at the participant's election prior to termination upon attainment of age 59 ½ or hardship as defined in the Plan document.

Plan Termination

The Employer has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions set forth in the ERISA. As noted in Note 9, the Plan merged into The Independent School Group Retirement Plan as of January 1, 2024, and therefore assets are in transit to successor plan at December 31, 2023.

Note 2 - Significant Accounting Policies

Basis of Accounting

The financial statements of the Plan are prepared on the accrual basis of accounting.

Use of Estimates

The preparation of the financial statements in conformity with accounting principles generally accepted in the United States of America requires management to make estimates and assumptions that affect certain reported amounts of assets and liabilities and changes therein, and disclosures of contingent assets and liabilities. Actual results may differ from those estimates.

Excluded Contracts and Accounts

The Plan Administrator has elected to exclude certain contracts and accounts from Plan assets in accordance with Department of Labor Field Assistance Bulletin 2009-02 due to the following:

- The contract of account was issued to a current or former employee before January 1, 2009;
- The employer ceased to have any obligation to make contributions (including employee salary reduction contributions), and in fact stopped making contributions to the contract or account before January 1, 2009;
- All the rights under the contract or account are legally enforceable against the insurer, custodian, or trustee by the individual owner of the contract or account without any involvement by the employer.
- The individual owner of the contract is fully vested in the contract or account.

Investment Valuation and Income Recognition

Investments are reported at fair value except for the fully benefit-responsive investment contracts, which are reported at contract value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. Contract value is the relevant measure for the portion of the net assets available for benefits of a defined contribution plan attributable to fully benefit-responsive investment contracts because the contract value is the amount participants normally would receive if they were to initiate permitted transactions under the terms of the Plan. The Plan Sponsor determines the Plan's valuation policies utilizing information provided by the investment advisors and custodians. See Note 3 for discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Dividends are recorded on the ex-dividend date. Interest income is recorded on the accrual basis. Net appreciation includes the Plan's gains and losses on investments bought and sold as well as those held during the year.

The classification of investment earnings reported above and in the statement of changes in net assets may differ from the classification of earnings on Form 5500 due to different reporting requirements on Form 5500.

Notes Receivable from Participants

Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Interest income is recorded on the accrual basis. Related fees are recorded as administrative expenses and are expensed when they are incurred. Delinquent notes receivable are recorded as distributions based upon the terms of the Plan document.

Payment of Benefits

Benefit payments to participants are recorded upon distribution.

Expenses

The Plan's expenses are paid by either the Plan or the Employer as provided by the Plan document. Expenses that are paid directly by the Employer are excluded from these financial statements. Certain expenses incurred in connection with the general administration of the Plan that are paid by the Plan are recorded as deductions in the accompanying statement of changes in net assets available for benefits. In addition, certain investment related expenses are included in net appreciation of fair value of investments presented in the accompanying statement of changes in net assets available for benefits.

Note 3 - Fair Value Measurements

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1) and the lowest priority to unobservable inputs (Level 3). The three levels of the fair value hierarchy under FASB ASC 820 are described as follows:

- Level 1 - Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.
- Level 2 - Inputs to the valuation methodology include:
- Quoted prices for similar assets or liabilities in active markets;
 - Quoted prices for identical or similar assets or liabilities in inactive markets;
 - Inputs other than quoted prices that are observable for the asset or liability;
 - Inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

Level 3 - Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset's or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

The following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at December 31, 2023 and 2022.

Mutual funds: Valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-ended mutual funds that are registered with the Securities and Exchange Commission. These funds are required to publish their daily net asset value (NAV) and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.

Variable annuity contracts: Net asset value (NAV) of each of the CREF Accounts are calculated in a manner consistent with U.S. GAAP for investment companies and is determinative of their fair value and represents the price at which the Plan would be able to initiate a transaction. Accumulation units in CREF Accounts are available for transactions at the closing accumulation unit value on any day the New York Stock Exchange is open for business and is determined to be a readily determinable fair value.

Pooled separate account (TIAA Real Estate): Valued at fair value based on the NAV of units as determined by the insurance company. The NAV is based on the observable market prices of the underlying assets within the account less liabilities. The NAV for the underlying assets of the account is readily determinable measure of their fair value and is the basis for current transactions. The pooled separate account (PSA) generally invests in real estate properties and real estate-related investments. Accumulation units in the PSA are available for transactions at the closing accumulation unit value on any day the New York Stock Exchange (NYSE) is open for business. Transfers out of the PSA are limited to one per calendar quarter. Although the underlying assets of the PSA cannot be quickly sold and converted to liquid assets, the TIAA General Account provides the PSA with a liquidity guarantee.

Guaranteed investment contracts (TIAA Traditional Non-Benefit Responsive): The fair value of the non-fully benefit responsive fixed annuity contracts are measured using an income approach and discounting the related cash flows based on current yields of similar instruments with comparable durations considering the creditworthiness of the issuer.

For the year ended December 31, 2023, there was \$62,252,217 of investments disclosed as assets in transit to successor plan on the statement of changes in net assets available for benefits. \$3,563,142 of the investment balances are measured at contract value as Note 6 indicates. For the remaining \$58,689,075 of investments, \$48,614,521 are fair valued using level 1 inputs and \$10,074,554 are fair valued using level 3 as part of the guaranteed investment contracts.

In estimating fair value of the investments in level 3, the Investment Committee may use third-pricing sources or appraisers.

Note 4 - Certified Information

Certain information related to investments and notes receivable from participants disclosed in the accompanying financial statements, including investments and notes receivable from participants held at December 31, 2023 and 2022, and net appreciation in fair value of investments, interest and dividends, and interest income on notes receivable from participants for the year ended December 31, 2023, was obtained by management and agreed to or derived from information certified as complete and accurate by Teachers Insurance and Annuity Association (TIAA), the custodian of the plan, and Fidelity Management Trust Company (Fidelity), the trustee of the Plan. Certification at December 31, 2023 is before assets in transit in Note 9 are applied.

Note 5 - Tax Status

The Plan uses a pre-approved plan document sponsored by TIAA, which received an advisory letter from the Internal Revenue Service (IRS), dated August 7, 2017, stating that the pre-approved document satisfies the applicable provisions of the IRC. The Plan's management believes that the Plan is currently designed and being operated in compliance with the applicable requirements of the IRC.

Accounting principles generally accepted in the United States of America require plan management to evaluate tax positions taken by the plan and recognize a tax liability (or asset) if the plan has taken an uncertain tax position that more likely than not would not be sustained upon examination by the IRS. The plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

Note 6 - Contracts with Insurance Company

The Plan entered into traditional fully benefit-responsive fixed annuity contracts with TIAA. TIAA maintains the contributions in a general account, which is credited with earnings on the underlying investments and charged for participant withdrawals and administrative expenses. The fixed annuity issuer is contractually obligated to repay the principal and a specified interest rate that is guaranteed to the Plan. The crediting interest rate is based on a formula agreed upon with the issuer and varies based on when the contract was entered. The minimum guaranteed interest rate is between 1% and 3%. The fixed annuity does not permit the insurance company to terminate the agreement prior to the scheduled maturity date.

Because the fixed annuity contracts are fully benefit-responsive, contract value is the relevant measurement for the fixed annuity contracts. Contract value as reported to the Plan by TIAA represents contributions made under the contract, plus earnings, less participant withdrawals and administrative expenses. Participants may ordinarily direct the withdrawal or transfer of all or a portion of their investment at contract value. The contract value of the fixed annuity contracts at December 31, 2023 and 2022 at December 31, 2023 and 2022 was \$3,563,142 and \$3,761,377 respectively. The 2023 balances are included on the assets in transit to successor plan amount on the statement of changes in net assets available for benefits as of December 31, 2023.

The Plan's ability to receive amounts due is dependent on the issuer's ability to meet financial obligations. The issuer's ability to meet its contractual obligations may be affected by future economic and regulatory developments.

Certain events might limit the ability of the Plan to transact at contract value with the issuer. Such events include the following: (1) amendments to the Plan documents (including complete or partial Plan termination or merger with another plan), (2) changes to the Plan's prohibition on competing investment options or deletion of equity wash provisions, (3) bankruptcy of the Plan sponsor or other Plan sponsor events (for example, divestitures or spin-offs of a subsidiary) that cause a significant withdrawal from the Plan, (4) the failure of the trust to qualify for exemption from federal income taxes or any required prohibited transaction exemption under the ERISA, or (5) premature termination of the contracts. No events are probable of occurring that might limit the ability of the Plan to transact at contract value with the contract issuers that would limit the ability of the Plan to transact at contract value with the participants.

In addition, certain events allow the issuer to terminate the contracts with the Plan and settle at an amount different from contract value. Such events include (1) an uncured violation of the Plan's investment guidelines, (2) a breach of material obligation under the contract (3) a material misrepresentation, or (4) a material amendment to the agreement without the consent of the issuer.

Non-Fully Benefit-Responsive Contracts

The Plan has entered into investment contracts with TIAA. As part of the contracts, TIAA maintains a portion of the contributions in a guaranteed account. The account is credited with earnings on the underlying investments and charged for Plan withdrawals and administrative expenses charged by TIAA. The guaranteed accounts are included in the financial statements at fair value. See Note 3 above for further detail.

Note 7 - Related Party and Party-In-Interest Transactions

Certain Plan investments are shares of registered investment companies, pooled separate accounts and guaranteed investments contract managed by TIAA, the custodian, and Fidelity, the trustee as defined by the Plan. As described in Note 2, the Plan paid certain expenses related to Plan operations and investment activity to various service providers. These transactions are exempt party-in-interest transactions under the ERISA.

Note 8 - Risk and Uncertainties

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market, and credit risks. Market risks include global events which could impact the value of investment securities, such as pandemic or global conflict. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits.

Note 9 - Assets in Transit to Successor Plan

On September 13th, 2023, the Board of Colorado Academy voted to merge the Colorado Academy Defined Contribution Retirement Plan into The Independent School Group Retirement Plan (ISGRP), an IRS section 403(b) multi-employer retirement plan. The Plan ceased to exist with the ISGRP continuing effective January 1, 2024 as the surviving plan for Colorado Academy employees.

Assets in transit to successor plan disclosed on the statement of changes in net assets available for benefits of \$62,525,913 is made up of notes receivable from participants of \$81,112, employer contributions receivable of \$103,368, participant contributions receivable of \$89,216, and investments of \$62,252,217. TIAA and Fidelity manage \$58,350,642 of the investments in transit. Control of the plan assets are under the control of ISGRP effective January 1, 2024 and therefore in transit as of the end of the year.

Note 10 - Subsequent Events

As stated in Note 9, effective January 1, 2024, the Colorado Academy Defined Contribution Retirement Plan merged into the (ISGRP).

The Plan sponsor has evaluated subsequent events through October 2, 2024, the date which the financial statements were available to be issued.
