Independent Auditor's Report

To the Administrative Committee and Plan Participants of the Lancaster Colony Corporation Hourly Employees' Benefit Plan and Trust:

Opinion

We have audited the accompanying financial statements of the Lancaster Colony Corporation Hourly Employees' Benefit Plan and Trust, an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), which comprise the statements of net assets available for benefits and accumulated plan benefits – modified cash basis as of December 31, 2023 and 2022, and the related statement of changes in net assets available for benefits and changes in accumulated plan benefits – modified cash basis for the year ended December 31, 2023, and the related notes to the financial statements.

In our opinion, the financial statements referred to above present fairly, in all material respects, the net assets available for benefits and accumulated plan benefits – modified cash basis of the Lancaster Colony Corporation Hourly Employees' Benefit Plan and Trust as of December 31, 2023 and 2022, and the changes in net assets available for benefits and changes in its accumulated plan benefits – modified cash basis for the year ended December 31, 2023, in accordance with the modified cash basis of accounting described in Note 2.

Basis for Opinion

We conducted our audits in accordance with auditing standards generally accepted in the United States of America. Our responsibilities under those standards are further described in the Auditor's Responsibilities for the Audit of the Financial Statements section of our report. We are required to be independent of the Lancaster Colony Corporation Hourly Employees' Benefit Plan and Trust and to meet our other ethical responsibilities, in accordance with the relevant ethical requirements relating to our audits. We believe that the audit evidence we have obtained is sufficient and appropriate to provide a basis for our audit opinion.

Basis of Accounting

We draw attention to Note 2 to the financial statements, which describes the basis of accounting. These financial statements are prepared on the modified cash basis of accounting, which is a basis of accounting other than accounting principles generally accepted in the United States of America. Our opinion is not modified with respect to that matter.

Responsibilities of Management for the Financial Statements

Management is responsible for the preparation and fair presentation of these financial statements in accordance with the modified cash basis of accounting described in Note 2; this includes determining that the modified cash basis of accounting is an acceptable basis for the preparation of the financial statements. Management is also responsible for the design, implementation, and maintenance of internal control relevant to the preparation and fair presentation of financial statements that are free from material misstatement, whether due to fraud or error.

In preparing the financial statements, management is required to evaluate whether there are conditions or events, considered in the aggregate, that raise substantial doubt about the Lancaster Colony Corporation Hourly Employees' Benefit Plan and Trust's ability to continue as a going concern for one year after the date the financial statements are available to be issued.

Management is also responsible for maintaining a current plan instrument, including all plan amendments, administering the plan, and determining that the plan's transactions that are presented and disclosed in the financial statements are in conformity with the plan's provisions, including maintaining sufficient records with respect to each of the participants, to determine the benefits due or which may become due to such participants.

Auditor's Responsibilities for the Audit of the Financial Statements

- Evaluate the appropriateness of accounting policies used and the reasonableness of significant accounting estimates made by management, as well as evaluate the overall presentation of the financial statements.
- Conclude whether, in our judgement, there are conditions or events, considered in the aggregate, that raise substantial doubt about the Lancaster Colony Corporation Hourly Employees' Benefit Plan and Trust's ability to continue as a going concern for a reasonable period of time.

We are required to communicate with those charged with governance regarding, among other matters, the planned scope and timing of the audit, significant audit findings, and certain internal control-related matters that we identified during the audit.

Other Matter - Supplemental Schedule Required by ERISA

Our audits were conducted for forming an opinion on the financial statements as a whole. The supplemental schedule of Schedule H, Line 4j – Schedule of Reportable Transactions for the year ended December 31, 2023 is presented for the purpose of additional analysis and is not a required part of the financial statements but is supplementary information required by the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. Such information is the responsibility of the Lancaster Colony Corporation Hourly Employees' Benefit Plan and Trust's management and was derived from and relates directly to the underlying accounting and other records used to prepare the financial statements. The information has been subjected to the auditing procedures applied in the audits of the financial statements and certain additional procedures, including comparing and reconciling such information directly to the underlying accounting and other records used to prepare the financial statements or to the financial statements themselves, and other additional procedures in accordance with auditing standards generally accepted in the United States of America.

In forming our opinion on the supplemental schedule, we evaluated whether the supplemental schedule, including the form and content, are presented in conformity with the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA.

In our opinion, the information in the accompanying schedule is fairly stated, in all material respects, in relation to the financial statements as a whole, and the form and content is presented in conformity with the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA.

1. Description of the plan

The following description of the Lancaster Colony Corporation Hourly Employees' Benefit Plan and Trust (the "Plan"), a defined benefit health and welfare plan of Lancaster Colony Corporation and its affiliates (the "Employer") provides only general information. Participants should refer to the Plan document for a more complete description of the Plan's provisions.

Trust termination

Effective December 31, 2023, the Employer terminated the Lancaster Colony Corporation Hourly Employees' Benefit Trust (the "Trust"), which was the primary funding mechanism of the Plan. There were no assets in the Trust as of the termination date. Concurrent with this termination, the Employer changed the funding arrangement from trust and insurance, to general assets of the Employer and insurance. As the Plan is no longer funded through a trust, audited financial statements are not required to be prepared and filed with the Plan's Form 5500 Annual Return/Report of Employee Benefit Plan after December 31, 2023. Plan benefit obligations and benefits provided under the Plan were not changed in any way.

General

The Employer maintains several health and welfare benefit plans. This Plan provides benefits to hourly employees of the Employer, except certain collectively bargained groups. Benefits for health benefits (hospital, surgical, major medical, prescription drug, and dental) are self-insured. Benefits for life, short-term disability, accidental death and dismemberment, vision, voluntary benefits for critical illness, accident and hospital indemnity, and business travel are fully insured and the employee assistance program is contracted with an outside service provider. The Plan also provides continuation of certain benefits upon termination of employment through the Consolidated Omnibus Budget Reconciliation Act ("COBRA"). Benefits under the Plan are funded through the Trust. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974, as amended ("ERISA").

Trustee

Huntington National Bank & Trust Company (the "Trustee") and holds the Plan's investments.

Administration

The Employer has established the Administrative Committee that is responsible for the general operation and administration of the Plan.

Self-insured benefits

The Plan uses several third party administrators for the processing of benefit claims of active participants, retired participants, dependents, and beneficiaries, but the ultimate responsibility for payments to participants and providers is retained by the Plan.

The Plan maintains a stop-loss insurance arrangement in an effort to limit its exposure for self-insured benefits. The policy provides insurance claims reimbursements for individual participant claims over a specific dollar amount.

Contributions

Contributions are made to the Plan by participants and by the Employer through payroll withholdings and direct payments. The Employer's current funding policy is to contribute to the Plan as required to provide payment of Plan benefits and to meet the Plan's benefit obligations.

The Employer determines participant contribution levels for each benefit and coverage option under the Plan. The Employer will fund the benefit obligations over net assets as they become due and payable.

2. Summary of accounting policies

Basis of accounting

The accounts of the Plan are maintained, and the accompanying financial statements have been prepared, on the modified cash basis. Contributions and investment income are recognized when received, and disbursements are recognized when made. Additionally, securities investments are reflected at fair value. Accordingly, the financial statements are not intended to present the net assets available for benefits and changes in net assets available for benefits of the Plan in conformity with accounting principles generally accepted in the United States of America. However, benefit obligations payable are reflected as claims and premiums payable and claims incurred but not reported.

Cash

Cash consists principally of currency on hand and demand deposits at commercial banks. The Plan maintains demand accounts at a domestic bank. From time to time, account balances have exceeded the maximum available Federal Deposit Insurance Corporation ("FDIC") coverage limit. The Plan has not experienced any losses in these accounts.

Restricted cash

Restricted cash is cash held at a bank owned by a third-party administrator in an imprest account held for the purpose of funding benefit claims for the Plan. This amount is replenished either when depleted or at the beginning of each month.

Income recognition

Purchases and sales of securities are recorded on a settlement-date basis. Interest income is recorded when received.

Investment valuation

Investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date (See Note 3).

Risks

The plan investments are limited and therefore, as with any investment, are exposed to various risks, such as interest rate, market, and credit. These risks could result in a material effect on the net assets available for benefits.

Benefit and insurance premium payments

The Plan records health claims when paid by the third-party claims processor and premiums when paid by the Plan. Amounts due to claims processors that have yet to be reimbursed by the Plan and premiums due at year-end are reflected as part of the claims and premiums payable and claims incurred but not reported.

Stop-loss

Premiums for stop-loss insurance are included in premium payments in the accompanying

statement of changes in net assets available for benefits. Stop-loss reimbursements of \$1,463,099, are netted with health claims paid in the accompanying statement of changes in net assets available for benefits and changes in accumulated Plan benefits.

Pharmacy rebates

The Plan records pharmacy and pricing guarantee refunds when earned and are reported as a reduction of health benefits paid in the statement of changes in net assets available for benefits and changes in accumulated Plan benefits. During the year ended December 31, 2023, benefits paid have been reduced by \$453,102.

Estimates

The Plan prepares its financial statements on the modified cash basis, which requires management to make estimates and assumptions that affect certain reported amounts and disclosures. Accordingly, actual results could differ from those estimates.

Subsequent events

Effective January 1, 2024, the Plan and its operations merged into the Lancaster Colony Corporation Salaried Employee's Health Care Plan.

Subsequent events have been evaluated through October 7, 2024, the date the financial statements were available to be issued.

3. Fair value measurement

Accounting Standards Codification ("ASC") 820, *Fair Value Measurement*, establishes a framework for measuring fair value. The framework provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (level 1 measurements) and the lowest priority to unobservable inputs (level 3 measurements). The three levels of the fair value hierarchy under the guidance are described as follows:

Level 1	Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the plan has the ability to access.
Level 2	Inputs to the valuation methodology include; <ul style="list-style-type: none">• quoted prices for similar assets and liabilities in active markets;• quoted prices for identical or similar assets or liabilities in inactive markets;• inputs other than quoted prices that are observable for the asset or liability;• inputs that are derived principally from or corroborated by observable market data by correlation or other means. If the asset or liability has a specified (contractual) term, the level 2 input must be observable for substantially the full term of the asset or liability.
Level 3	Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques

used need to maximize the use of observable inputs and minimize the use of unobservable inputs. The following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at December 31, 2023 and 2022.

Money market mutual fund: Valued at the net asset value of shares held by the plan at the closing price reported on the active market on which the fund is traded.

The preceding methods described may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, although the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

4. Investments

The Plan's investments consist solely of shares of a money market mutual fund held by a bank-administered trust fund.

5. Benefit obligations

The Plan's benefit obligation at December 31, 2023 and 2022 were based on estimates developed by the Plan sponsor using the most current historical claims experience.

6. Tax status

The Trust funding the Plan has received an exemption letter from the Internal Revenue Service ("IRS") dated July 1, 1981, stating that the Trust is tax-exempt under the provisions of Section 501(c)(9) of the Internal Revenue Code (the "Code") as a Voluntary Employee Beneficiary Association. The Plan and the Trust are required to operate in conformity with the Code to maintain the tax-exempt status of the Trust. The Plan administrator believes the Plan is being operated in compliance with the applicable requirements of the Code and, therefore, believes that the related Trust is tax-exempt.

The Plan administrator has analyzed the tax positions taken by the Plan, and has concluded that as of December 31, 2023 and 2022, there are no uncertain positions taken or expected to be taken that would require recognition of a liability (or asset) or disclosure in the financial statements. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

7. Administrative expenses

The Plan pays administrative expenses that consist primarily of administrative fees paid to third-party claims administrators. These expenses are reported on the statement of changes in net assets available for benefits and changes in accumulated Plan benefits as claims processing and other administrative expenses. Other administrative fees if so elected are paid by the Employer.

8. Plan termination

Although the Employer has not expressed any intent, the Employer has the right, under the Plan, to modify the benefits provided to active employees, to discontinue its contributions at any time, and to terminate the Plan subject to the provisions set forth in ERISA.

In the event of Plan termination, the assets of the Plan would be applied to the satisfaction of all liabilities to participants and beneficiaries covered by the Plan. This would occur through making payments to participants and beneficiaries of Plan benefits or by making transfers to one or more other trust or entities that satisfy the requirements of Code Section 501(c)(9) and Section 403 of ERISA.

9. Party-in-interest

The Employer, which is a party-in-interest, provides certain administrative services to the Plan at no charge. The cost of providing these services constitutes exempt party-in-interest transactions under ERISA. The Trustee invests available cash of the Trust in money market funds for which affiliates of the Trustee receive fees for providing various services to the funds.
