We have performed audits of the financial statements of Brakebush Brothers, Inc. Employees Savings & Retirement Plan (the Plan), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). ## 1. Description of Plan

The following description of the Brakebush Brothers, Inc. Employees Savings & Retirement Plan (the Plan) provides only general information. Participants should refer to the plan agreement for a more complete description of the Plan's provisions.

### General

The Plan is a defined contribution plan established effective January 1, 1987. The Plan is established to provide retirement benefits to eligible employees of Brakebush Brothers, Inc. and its subsidiaries, Brakebush Transportation, Inc. and Brakebush Irving, Inc. (the Companies). The Plan covers all employees, excluding leased employees and employees of Cousins Enterprises, Inc. who have completed three consecutive months of service from their employment commencement date and are age 18 or older. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974, as amended (ERISA). The Plan's investment committee is responsible for determines the appropriateness of the Plan's investment offerings, monitors investment performance and reports to the Plan's 401(k) Committee.

### Contributions

An employee may elect to make contributions qualifying under Internal Revenue Code (IRC) Section 401(k) in the form of salary reductions up to the maximum limits of the IRC. Participants may also contribute amounts representing distributions from other qualified plans (rollover contributions). Participants may also designate all or a portion of their deferral contributions as after-tax contributions into an after-tax or Roth account. Participants who have attained age 50 before the end of the plan year are eligible to make catch-up contributions. Unless modified by the participant, the Companies will automatically withhold 3% of the participant's eligible compensation and deposit the amount into targeted retirement funds selected by the Companies. Participant deferral elections of less than 6% are subject to annual 1% automatic increases until a maximum deferral election of 6% is reached, unless a participant election to the contrary is made annually.

The Companies may also make a discretionary matching or profit sharing contribution as determined by the Companies' Board of Directors. The Companies did not make a discretionary matching or profit sharing contribution for the year ended December 31, 2023. The allocations of the profit sharing contributions and forfeitures are based on the plan year compensation. The Companies make a safe harbor matching contribution equal to 100% of the employee's salary reduction contribution on the first 1% plus 50% of the employee's salary reduction contributions on the next 5%, with a maximum match of 3.5% of eligible compensation. Contributions are subject to certain IRS limitations.

### Participant Accounts

Each participant's account is credited with the participant's salary reduction contributions, the Companies' matching contribution, an allocation of the Companies' profit sharing contributions, forfeitures of terminated participants' nonvested accounts and investment income (net of administrative expenses). Allocations are based on the participant's eligible compensation or account balances, as defined in the plan document. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

## Vesting

Participants are vested immediately in their salary reduction, safe harbor and rollover contributions plus actual earnings thereon. Participants who leave the Plan because of death, normal retirement or disability retirement, as defined in the plan document, are considered 100% vested. Discretionary matching and profit sharing contributions and earnings thereon vest based on years of continuous service. A participant is 20% vested in discretionary contributions and earnings thereon after two years of credited service and continues to vest in annual increments of 20% until 100% vested after six years of credited service.

## Notes Receivable From Participants

Participants may borrow from their fund accounts a minimum of \$500 up to a maximum equal to the lesser of \$50,000 or 50% of their vested account balance. The loans are secured by the balance in the participant's account. The loan interest rate, determined quarterly by the plan administrator, shall be set at a rate of interest similar to those charged for similar types of loans by other lenders, as defined. Principal and interest are paid ratably through monthly payroll deductions. Terms range up to five years or greater for the purchase of a primary residence. Participants may not have more than two loans outstanding at any time.

## Payment of Benefits

Benefits may be paid to the participant or beneficiary upon death, disability, retirement, termination of employment or as an in-service withdrawal, as defined in the plan document. The Plan provides for normal retirement at age 59 1/2. The total vested portion of a participant's account balance is distributed in the form of a rollover, lump-sum payment or installments. If the vested portion of the participant's account is less than \$5,000, the Plan will distribute the benefit in a lump sum payment. Participants experiencing financial hardship may withdraw a portion of the amount voluntarily contributed to their account as defined by the plan document.

## Forfeited Accounts

At December 31, 2023 and 2022, forfeited nonvested accounts totaled \$566 and \$0, respectively. These accounts can be used to pay administrative expenses, reduce employer contributions or allocated to participant accounts. During 2023, no amounts were applied to plan activities from forfeited nonvested accounts.

## 2. Summary of Accounting Policies

### Basis of Accounting

The financial statements of the Plan are prepared on the accrual basis of accounting.

### Use of Estimates

The preparation of financial statements in accordance with accounting principles generally accepted in the United States of America requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities and changes therein and disclosure of contingent assets and liabilities. Actual results could differ from those estimates.

## Investment Valuation and Income Recognition

Investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. The Plan's investment committee determines the Plan's valuation policies utilizing information provided by the investment advisers, custodians and insurance company, as applicable. See Note 3 for discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation includes the Plan's gains and losses on investments bought and sold as well as held during the year.

## Notes Receivable From Participants

Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Interest income is recorded on the accrual basis. Related fees are recorded as administrative expenses and are expensed as incurred.

## Payment of Benefits

Benefits are recorded when paid. Amounts allocated to withdrawing participants and approved for payment prior to year-end, but not yet paid as of December 31, 2023, totaled \$334,398.

## Expenses

Certain expenses of maintaining the Plan are paid by the Plan, unless otherwise paid by the Companies. Expenses that are paid by the Companies are excluded from these financial statements. Fees related to the administration of notes receivable from participants are charged directly to the participant's account and are included in administrative expenses. Investment related expenses are included in net appreciation in fair value of investments.

## Subsequent Events

Subsequent events were evaluated through October 2, 2024, the date the financial statements were available to be issued.

Effective January 1, 2024, the plan was amended to include Brakebush Hartwell, LLC (a subsidiary of Brakebush Brothers, Inc.) as a participating employer.

## 3. Fair Value Measurements

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1) and the lowest priority to unobservable inputs (Level 3). The three levels of the fair value hierarchy under authoritative guidance are described as follows:

Level 1 - Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2 - Inputs other than quoted prices included within Level 1 that are observable for the asset or liability, either directly or indirectly, such as:

- quoted prices for similar assets or liabilities in active markets;
- quoted prices for identical or similar assets or liabilities in inactive markets;
- inputs other than quoted prices that are observable for the asset or liability; and
- inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

Level 3 - Inputs to the valuation technique are unobservable and significant to the fair value measurement.

The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques maximize the use of relevant observables and minimize the use of unobservable inputs.

Following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at December 31, 2023 and 2022.

*Mutual funds:* Valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-end mutual funds that are registered with the U.S. Securities and Exchange Commission. These funds are required to publish their daily net asset value (NAV) and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.

*Collective trust funds:* valued at the NAV of units of a bank collective trust. The NAV, as provided by the trustee, is used as a practical expedient to estimate fair value. The NAV is based on the fair value of the underlying investments held by the fund less its liabilities. This practical expedient is not used when it is determined to be probable that the fund will sell the investment for an amount different than the reported NAV. Participant transactions (purchases and sales) may occur daily. Were the Plan to initiate a full redemption of the collective trust, the investment adviser reserves the right to temporarily delay withdrawal from the trust in order to ensure that securities liquidations will be carried out in an orderly business manner.

### 4. Concentrations

## 5. Related-Party and Party in Interest Transactions

The Plan issues loans to participants, which are secured by the participant's account balances. These transactions qualify as party in interest transactions.

Certain administrative functions of the Plan are performed by officers or employees of the Companies. No such officer or employee receives compensation from the Plan.

## 6. Plan Termination

Although it has not expressed any intent to do so, the Companies has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of plan termination, participants would become 100% vested in their employer contributions.

## 7. Tax Status

The Plan adopted a pre-approved plan offered by OneAmerica Financial Partners. The pre-approved plan received an IRS Opinion Letter dated August 19, 2020, that the Plan and related trust are designed in accordance with the applicable sections of the IRC. Although the Plan has been amended since receiving the IRS Opinion Letter, the plan administrator believes that the Plan is designed and is currently being operated, in compliance with the applicable requirements of the IRC and, therefore, believes that the Plan is qualified and the related trust is tax exempt.

Plan management is required to evaluate tax positions taken by the Plan and recognize a tax liability if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

## 8. Risks and Uncertainties

The Plan invests in various investment securities. Investment securities are exposed to various risks, such as interest rate, market and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the Statements of Net Assets Available for Benefits.

## 9. Information Certified by Trustee

The plan administrator has elected the method of compliance permitted by 29 CFR 2520.103-8 of the DOL's Rules and Regulations for Reporting and Disclosure under ERISA for 2023 and 2022. Accordingly, Matrix Trust Company, the Trustee of the Plan, has certified to the completeness and accuracy of all investments and notes receivable from participants reported in the accompanying Statements of Net Assets Available for Benefits as of December 31, 2023 and 2022 and the supplemental Schedule H, Line 4(i) - Schedule of Assets (Held at End of Year) as of December 31, 2023 and the related investment activity and interest income on notes receivable from participants reported in the Statement of Changes in Net Assets Available for Benefits for the year ended December 31, 2023.
