Emphasis of Matter – Plan Merger

As further discussed in Note 5, effective December 1, 2023, the Plan's governing body approved a merger into The Standard Pooled Employer Plan, a Pooled Employer Plan (PEP) sponsored by Standard Retirement Services, Inc. Accordingly, the Plan's assets were transferred into the PEP as of December 31, 2023.

Responsibilities of Management for the Financial Statements

Notes to Financial Statements

Note 1 – Description of plan

The following description of the Minerva Surgical Inc 401(k) Plan (the “Plan”) provides only general information. Participants should refer to the Plan agreement for a more complete description of the Plan’s provisions.

General

The Plan is a defined contribution plan covering all eligible employees of Minerva Surgical Inc (the “Company”). The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (“ERISA”). An employee becomes eligible for participation in the Plan upon the employment commencement date provided they are at least twenty-one years of age. Effective May 16, 2022, the Plan was amended and restated to bring the Plan into compliance with the legislative and regulatory changes set forth in IRS Notice 2017-37 as part of the 6-year pre-approved restatement cycle.

As noted in Note 5, the Plan was amended and subject to a merger effective December 1, 2023. All Plan provisions in this report pertain to Plan activity prior to this amendment and merger.

Contributions

Eligible employees (“participants”) may contribute a portion of their annual compensation subject to certain limitations as defined by the Internal Revenue Code. Participants who have attained age 50 before the end of the Plan year are eligible to make catch-up contributions. Participants direct the investment of their contributions into various investment options offered by the Plan.

The Plan does not allow Company discretionary matching or nonelective contributions.

Rollover contribution

The Plan provides for rollover contributions, which represent contributions by participants from other tax qualified retirement plans. The maximum amount of a participant’s rollover contribution is not affected by the limits otherwise applicable to participant contributions.

Participant accounts

Each participant’s account is credited with the participant’s contributions and allocations of Plan earnings and charged with an allocation of administrative expenses. The contributions are allocated within each participant account based upon the participant’s investment elections. All amounts in participant accounts are participant-directed. The benefit to which a participant is entitled is the benefit that can be provided from the participant’s vested account.

Vesting

Participants are immediately vested in their elective deferral contributions plus actual earnings thereon.

Notes receivable from participants

Participants may borrow from their fund accounts a maximum amount equal to the lesser of \$50,000 or 50% of their vested account balance. The notes are secured by the vested balance in the participant’s account and bear a reasonable rate of interest, which is commensurate with local prevailing rates of commercial U.S. banks and are determined at the time the note is made. Note transactions are treated as transfers to (from) the investment funds from (to) a participant’s note receivable. Note terms cannot exceed 5 years, unless the note qualifies as a residential mortgage in which case a note term may qualify for a period up to 30 years.

Notes to Financial Statements

Note 1 – Description of plan (continued)

Payment of benefits

Benefits are payable to participants or designated beneficiaries upon retirement, termination, death, hardship, disability, or in-service if the participant has attained age 59 ½. Distributions may be paid in a lump-sum amount equal to the value of the participant's vested interest in his or her account, payments over a fixed period, or they may be rolled over into another plan or an individual retirement account.

Hardship withdrawals

Participants may withdraw their elective deferral contributions in the event of hardship as defined by the Plan agreement.

Administrative expenses

Automatic Data Processing, Inc. ("ADP"), is the Plan's recordkeeper and their fees are paid directly by the Plan. All other administration costs of the Plan are paid for by the Company.

Note 2 – Summary of significant accounting policies

Basis of accounting

The financial statements of the Plan are prepared using the accrual method of accounting which is in accordance with accounting principles generally accepted in the United States of America (U.S. GAAP).

Estimates

The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires the Plan Administrator to make estimates and assumptions that affect the reported amounts of assets and liabilities and changes therein, and disclosure of contingent assets and liabilities. Actual results could differ from those estimates.

Notes receivable from participants

Principal and interest are paid ratably through payroll deductions. Notes to participants are reported at their unpaid principal balances plus any accrued but unpaid interest. Delinquent participant notes receivables are reclassified as distributions based upon the terms of the plan document. Plan management has evaluated the collectability of notes receivable from participants and, because they are secured by the participants' accounts, an allowance has not been recorded.

Investment valuation and income recognition

The Plan's investments are stated at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See Note 4 for discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation includes the Plan's gains and losses on investments bought and sold as well as held during the year.

Payment of benefits

Benefits are recorded when paid.

Note 2 – Summary of significant accounting policies (continued)

Subsequent events

Management evaluates events occurring subsequent to December 31, 2023, in determining the accounting for and disclosure of events that affect the financial statements. The Plan has no subsequent events that required recognition or disclosure in the financial statements for the year ended December 31, 2023. Subsequent events were evaluated through October 4, 2024, which is the date the financial statements were available to be issued.

Note 3 – Information prepared and certified by Trustee

The Plan Administrator has elected the method of compliance permitted by 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. Accordingly, Reliance Trust Company, the trustee of the Plan, has certified to the completeness and accuracy of:

- Investments and notes receivable from participants reflected on the accompanying statements of net assets available for benefits as of December 31, 2023 and 2022.
- Net appreciation in fair value of investments, interest and dividends, and interest on notes receivable from participants reflected on the accompanying statement of changes in net assets available for benefits for the year ended December 31, 2023.

Note 4 – Fair value measurements

The fair value measurements standard establishes a framework for measuring fair value. That framework provides a hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1) and the lowest priority to unobservable inputs (Level 3). The three levels of the fair value hierarchy under the standard are described below:

Level 1 – Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2 – Inputs to the valuation methodology include:

- Quoted market prices for similar assets or liabilities in active markets;
- Quoted prices for identical or similar assets or liabilities in inactive markets;
- Inputs other than quoted prices that are observable for the asset or liability; and
- Inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

Level 3 – Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

Note 4 – Fair value measurements (continued)

Following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at December 31, 2023 and 2022.

Mutual funds: Valued at the daily closing price as reported by the fund. Funds held by the Plan are open-end funds that are registered with the U.S. Securities and Exchange Commission. These funds are required to publish their daily net asset value (NAV) and to transact at that price. The funds held by the Plan are deemed to be actively traded.

Common Collective Trust funds: Valued at the NAV of units of a bank collective trust. The NAV, as provided by the trustee, is used as a practical expedient to estimate fair value. The NAV is based on the fair value of the underlying investments held by the fund less its liabilities. This practical expedient is not used when it is determined to be probable that the fund will sell the investment for an amount different than the NAV. Participant transactions (purchase and sales) may occur daily.

The methods described above may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, while the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

Note 5 – Plan merger

The governing body of the Minerva Surgical Inc. 401(k) Plan met and approved a plan merger. Effective December 1, 2023, the Plan was amended and restated to facilitate a plan merger and plan assets, including outstanding participant loans, under the Plan were transferred into The Standard Pooled Employer Plan provided by Standard Retirement Services, Inc. as of December 31, 2023. Net assets available for benefits in the amount of \$9,328,415 were transferred during the merger.

This new Plan is a Pooled Employer Plan (PEP). A PEP is sponsored by a Pooled Plan Provider (PPP), which is a financial institution or other type of entity that is approved by the Department of Labor (DOL). A PEP allows employers to pool retirement resources with those of other unrelated employers and delegate most administrative responsibilities to the PPP. The PEP plan document is a Non-standardized Pre-Approved Profit-Sharing/Money Purchase/CODA Plan with an Internal Revenue Service (IRS) opinion letter dated June 30, 2020, in which the IRS stated that the Plan, as then designed, was in compliance with the applicable requirements of the Internal Revenue Code (IRC).

Note 6 – Income tax status

The Plan document is an ADP Prototype Non-standardized Profit-Sharing Plan with an Internal Revenue Service (IRS) opinion letter dated October 6, 2020, in which the IRS stated that the Plan, as then designed, was in compliance with the applicable requirements of the Internal Revenue Code (IRC). The Plan has been amended since receiving the opinion letter. However, the Plan Administrator believes that the Plan is currently designed and being operated in compliance with the applicable requirements of the IRC and therefore believes that the Plan is qualified, and the related trust is tax exempt.

The Plan Administrator believes that the Plan is designed and is currently being operated in compliance with the applicable requirements of the IRC and has no income subject to unrelated business income tax. The Plan's annual return/ report of employee benefit plan filings for the past three years are subject to examination by tax authorities and may change upon examination.

Note 7 – Plan termination

Although it has not expressed intent to do so, the Company has the right under the Plan to discontinue contributions at any time and terminate the Plan subject to the provisions of ERISA.

Note 8 – Risks and uncertainties

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market, and credit risk. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statement of net assets available for benefits.

Note 9 – Related party and party-in-interest transactions

ADP, the Plan's recordkeeper, is a party-in-interest in accordance with the definition provided by the Employee Retirement Income Security Act of 1974 (ERISA). During the year ended December 31, 2023, fees totaling \$2,556 were paid by the Plan to ADP.
