We have performed audits of the accompanying financial statements of MCM Products USA 401(k) Plan (the “Plan”), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (“ERISA”), as permitted by ERISA Section 103(a)(3)(C). The financial statements comprise the statements of net assets available for benefits as of December 31, 2023 and 2022, and the related statement of changes in net assets available for benefits for the year ended December 31, 2023, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of the Plan’s financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of Department of Labor’s (“DOL”) Rules and Regulations for Reporting and Disclosure under ERISA. NOTES TO THE FINANCIAL STATEMENTS

DECEMBER 31, 2023 AND 2022

Note 1—Description of the Plan

The following description of the MCM Products USA 401(k) Plan (the “Plan”) is provided for general purposes only. Participants should refer to the Plan Agreement for a more complete description of the Plan’s provisions.

General – The Plan was established on March 1, 2015, and was most recently amended February 17, 2022. The Plan is a defined contribution plan covering substantially all employees of MCM Products USA Inc. (the “Company” or “Plan Sponsor”). The Plan is intended to qualify under Section 401(k) of the Internal Revenue Code (“IRC”) and is subject to the provisions of the Employee Retirement Income Security Act of 1974 (“ERISA”).

Administration – The Plan is administered by the Plan Sponsor. Certain administrative functions are performed by officers or employees of the Plan Sponsor. No such officer or employee receives compensation from the Plan. Administrative expenses are either paid directly by the Plan, Plan Sponsor, or by the account of the participant.

Participant Contributions – Employees of the Company who are at least 21 years of age and completed three months of continuous service are eligible to participate in the Plan. Participants may make salary-deferral contributions in any percentage up to their pretax annual compensation, up to a maximum of \$22,500. Participants who have attained age 50 before the end of the Plan year are eligible to make catch-up contributions up to \$7,500. Participants may also contribute amounts representing distributions from other qualified defined benefit or defined contribution plans, reflected as rollover contributions.

Employer Contributions – The Company contributes to the Plan through matching contributions in the form of safe harbor matching contributions. The Company’s safe harbor matching contribution during 2023 was 100% of participant contributions that are not over 3% of participant’s compensation plus 50% of participant contributions which are over 3% but are not over 5% of participant’s compensation. The safe harbor matching contribution for the year ended December 31, 2023 was \$228,658. The Company may also elect to contribute a discretionary-employer match to active participants on the last day of the Plan year if the participant earned at least 1,000 hours on or before that date. There were no discretionary employer match contributions for the year ended December 31, 2023. Contributions are subject to certain limitations.

Participant Accounts – Each participant’s account is credited with the participant’s contribution and allocations of: (a) the Company’s safe harbor matching contribution, (b) the Company’s discretionary employer match contribution, if any, and (c) Plan earnings (losses), and charged with benefit payments and an allocation of any administrative expenses paid by the Plan. Allocations are based on participant earnings or account balances, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant’s vested account.

Vesting – Participants are immediately vested in their salary deferral contributions, rollover contributions and safe harbor matching contributions, plus actual earnings (losses) thereon. Participants may direct the investment of contributions on a daily basis into various investment options offered by the Plan. A participant also becomes 100% vested upon death, becoming disabled, or reaching retirement age, as defined by the Plan. The discretionary employer match contribution vests as follows:

Forfeitures – Terminating participants forfeit nonvested discretionary employer match contributions. Forfeitures shall be used to pay Plan expenses or to offset safe harbor matching contributions in accordance with specific Plan provisions. At December 31, 2023 and 2022, there were no forfeited nonvested accounts. During the year ended December 31, 2023, forfeitures were not used to offset safe harbor matching contributions or pay Plan expenses.

Payment of Benefits – A participant may make a withdrawal at termination of the Plan, becoming disabled, for certain in-service withdrawals upon attainment of 59½, or attaining normal retirement age. Upon termination of service due to retirement, death, or disability, a participant or beneficiary may elect to receive the value of the vested interest in their account either by a lump-sum distribution or in monthly, quarterly, or annual installments over a period not to exceed the participant's or beneficiary's life expectancy at the time of distribution.

The Plan also allows, in certain hardship situations as defined in the Plan, participants to withdraw from their account balances while actively employed. These hardship withdrawals are subject to IRC restrictions and penalties.

Notes Receivable from Participants – Participants may borrow from their fund accounts a minimum of \$1,000 up to a maximum equal to the lesser of \$50,000 or 50% of their eligible account balance, reduced by any outstanding loan balance. Participants may have up to two loans outstanding during a period of 12 consecutive months. Loans must be repaid within five years unless it is for the purchase of a primary residence. The loans are secured by the balance in the participant's account and by any other adequate collateral deemed necessary by the Plan Sponsor. The loans bear interest at a rate determined by the Plan administrator. At December 31, 2023, interest rates ranged from 5.25% to 10.50%.

Investment Options – Participants may direct Principal Life Insurance Company (the "Trustee" or "Principal"), as to the investment of their account balances in accordance with guidelines established by the Plan. Participants may change their investment elections at any time. Transfers of account balances between elected investment options may also be made at any time.

Note 2—Summary of significant accounting policies

Basis of Presentation – The accompanying financial statements have been prepared on the accrual method of accounting in accordance with accounting principles generally accepted in the United States of America ("U.S. GAAP").

Investment Valuation and Income Recognition – Investments in the Plan are reported at fair value. U.S. GAAP defines fair value as the exchange price that would be received for an asset or paid to transfer a liability (an exit price) in the principal or most advantageous market for the asset or liability in an orderly transaction between market participants at the measurement date.

Purchases and sales of securities are recorded on a trade-date basis. Dividends are recorded on the ex-dividend date. Net appreciation includes the Plan's gains and losses on investments bought and sold, as well as held, during the year.

Notes Receivable from Participants – Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Interest income is recorded on the accrual basis. Related fees are charged directly to the borrowing participant's account and are included in the administrative expenses when incurred. As of December 31, 2023 and 2022, no allowance for credit losses has been recorded. If a participant does not make loan repayments and the Plan administrator considers the participant loan to be in default, the loan balance is reduced, and the delinquent participant note receivable is recorded as a benefit payment based on the terms of the Plan document.

Note 2—Summary of significant accounting policies (continued)

Payment of Benefits – Benefits paid to participants are recorded when paid.

Estimates – The preparation of financial statements in conformity with U.S. GAAP requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities at the date of the financial statements and the reported amounts of additions, deductions, and changes in net assets available for benefits during the reporting period, in particular assumptions related to the determination of the fair value of investments and investment income and expense. Actual results could differ from those estimates.

Risks and Uncertainties – The Plan provides for various investment fund options. Investments are exposed to various risks such as interest rate, market, and credit. Due to the level of risk associated with certain investment securities and the level of uncertainty related to changes in the value of investment securities, it is at least reasonably possible that changes in risks in the near term could materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits and the statement of changes in net assets available for benefits.

Fair Value Measurements – U.S. GAAP provides the framework for measuring fair value. That framework provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets and liabilities (Level 1 measurement) and the lowest priority to unobservable inputs (Level 3 measurements).

The three levels of the fair value hierarchy are described as follows:

Level 1 – Inputs to the valuation methodology are quoted prices available in active markets for identical investments as of the reporting date;

Level 2 – Inputs to the valuation methodology are other than quoted prices in active markets, which are either directly or indirectly observable as of the reporting date, and fair value can be determined through the use of models or other valuation methodologies; and

Level 3 – Inputs to the valuation methodology are unobservable inputs in situations where there is little or no market activity for the asset or liability and the reporting entity makes estimates and assumptions related to the pricing of the asset or liability, including assumptions regarding risk.

A financial instrument's level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. The following are descriptions of the valuation methodologies used for instruments measured at fair value, including the general classification of such instruments pursuant to the valuation hierarchy:

Common Collective Trusts – Common collective trusts ("CCT") invest in a collective trust fund as well as a variety of separate accounts and mutual funds. CCTs are valued using the net asset value ("NAV") which is not publicly quoted but is made available to investors through the qualified institution. The NAV is the basis for current transactions, and the CCT can be redeemed at NAV of a measurement date. Therefore, the CCTs have a readily determinable fair value and are classified within Level 1 of the valuation hierarchy.

Pooled Separate Accounts – Each of the pooled separate accounts invest in a single mutual fund. The fair value of these funds is a publicly quoted pricing input used to determine the net asset value of the pooled separate account, which therefore has a readily determinable fair value and is classified within Level 1 of the valuation hierarchy.

Note 2—Summary of significant accounting policies (continued)

The methods described above may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, while the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

Reclassifications - The Company has reclassified investments from NAV as a practical expedient to level 1 within the fair value hierarchy in Note 6 to conform with current year presentation. The reclassification has no effect on previously reported results on the statements of net assets available for benefits and changes in net assets available for benefits. The reclassification was made to improve the clarity and comparability of the financial statements.

Note 3—Information certified by qualified institution (unaudited)

The Plan administrator has elected the method of compliance as permitted by 29 CFR 2520.103-8 of Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. Accordingly, Principal Life Insurance Company, the Trustee of the Plan, has certified to the completeness and accuracy of the following data included in the accompanying financial statements and supplemental schedules as of December 31, 2023 and 2022 and for the year ended December 31, 2023.

- Investments, at fair value as shown in the statements of net assets available for benefits as of December 31, 2023 and 2022.
- Net appreciation in fair value of investments as shown in the statement of changes in net assets available for benefits for the year ended December 31, 2023.
- Schedule of Assets (Held at End of Year) – Form 5500, Schedule H, Part IV, Line 4i as of December 31, 2023.

The Plan's independent auditor did not perform auditing procedures with respect to the certified information, except for comparing such information to the related information included in the financial statements and supplemental schedule of assets (held at end of year).

Note 4—Plan termination

Although it has not expressed any intent to do so, the Plan Sponsor has the right under the Plan to terminate the Plan subject to the provisions of ERISA. In the event of the Plan's termination, participants will become fully vested in their accounts.

Note 5—Party-in-interest transactions

Certain Plan investments are managed by Principal and, therefore, these transactions qualify as party-in-interest transactions. Fees paid to Principal by the Plan amounted to \$2,349 for the year ended December 31, 2023. Notes receivable from participants also qualify as party-in-interest transactions.

Note 7—Tax status

The prototype plan adopted by the Plan obtained its latest opinion letter on June 30, 2020, in which the Internal Revenue Service ("IRS") stated the prototype plan, as then designed, was in compliance with the applicable requirements of the IRC. The prototype plan has been amended since receiving the opinion letter. The Plan has not received an opinion letter specific to the Plan itself; however, the Plan administrator believes the Plan is currently designed and being operated in compliance with the applicable requirements of the IRC and has no income subject to business income tax and, therefore, the Plan continues to be tax-exempt.

U.S. GAAP requires Plan management to evaluate the tax positions taken by the Plan and recognize a tax liability (or asset) if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS. Plan management has analyzed the tax positions taken by the Plan, and has concluded that as of December 31, 2023 and 2022, there are no uncertain positions taken or expected to be taken that would require recognition of a liability (or asset) or disclosure in the financial statements. The Plan is subject to audit by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.
