I am writing to request waiver of penalties associated with the late filing of the above-referenced form 5500-SF for Plan Year Ending 12/31/2022.

I sold my veterinary business on July 23, 2021, and there were no further additions to the plan after that date, but there were assets remaining in the plan into 2022. It was my understanding that ADP would file the final form 5500-SF, as had been done in the past for this plan. I wasn't aware that the Form 5500-SF for 2022 had not been filed until mid-2024, and have taken action to meet this obligation.

Based on the reasons above, I respectfully request that any penalties associated with the late filing of form 5500-SF for 2022 be waived.
