INDEPENDENT AUDITOR'S REPORT

To the Participants and Plan Administrator of the

Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed audits of the financial statements of Progeny Systems, LLC 401(k) Plan (the Plan), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). (1) Plan Description

The following description of the Progeny Systems, LLC 401(k) Plan (the "Plan") provides only general information. Participants should refer to the Plan agreement for a more complete description of the Plan's provisions. The Plan was effective as of December 31, 2003, and as amended December 31, 2023.

(a) *General*

The Plan was a defined contribution plan covering substantially all employees, except excluded employees, of Progeny Systems, LLC (the Company) who completed an elapsed service time of 45 days from the eligible employee's employment commencement date and were age twenty-one or older. The service requirement was 30 days. Union represented employees, nonresident aliens, leased employees and interns were not eligible to participate in this Plan.

The Company is a subsidiary of General Dynamics Mission Systems, Inc., a General Dynamics Corporation business unit. General Dynamics Corporation (the Plan Administrator, or the Plan Sponsor) was the Plan Sponsor. The Plan was subject to the provisions of the Employee Retirement Income Security Act (ERISA) of 1974.

Effective December 31, 2023, the Plan's assets were merged into the General Dynamics Corporation 401(k) Plan 6.0 (Plan 6.0). As a result of the merger, the Plan's participants, formerly eligible to participate in the Plan became eligible to participate in Plan 6.0 effective January 1, 2024.

(b) *Contributions*

An employee became eligible on the first day of the payroll period next following the date on which the requirements are satisfied. New participants to the Plan were subject to an automatic elective deferral percentage of 5%. Each year, participants could contribute up to 80% of annual compensation pre-tax deferrals and Roth deferrals allowable not to exceed the statutory limits under the Internal Revenue Code. Participants could also contribute amounts representing distributions from other qualified defined benefit or contributions plans (rollovers). The Company made a safe harbor match of 100% of the participant's elective deferrals up to 5% of compensation. Additional profit-sharing amounts could be contributed at the discretion of the Company's Board of Directors. Contributions were subject to certain limitations. There were no profit-sharing contributions made by the Company for the year ended December 31, 2023.

(c) *Participant Accounts*

Participants directed the investment of their contributions into various investment options offered by the Plan. Each participant's account was self-directed and credited with the participant's contribution and allocations of (a) the Company's contributions and (b) Plan earnings, and charged with an allocation of administrative expenses. Allocations were based on participant earnings or account balances, as defined. The benefit to which a participant was entitled was the vested balance of the participant's account.

(d) Vesting

Participants were 100% vested immediately in their elective deferral contributions and employer matching contributions, plus actual earnings thereon. Vesting in the Company's profit-sharing contributions portion of their accounts was based on years of continuous service. A participant was fully vested after five years of service.

(e) Notes Receivable from Participants

Participants were permitted to borrow from their fund accounts, amounts not to exceed 50% of their account balance or \$50,000, whichever was less. Only two loans were allowed to be outstanding at any time. Loan terms were not to exceed five years, except loans granted for the purchase of a primary residence, which were not to exceed 15 years as determined at the time of the loan. The loans were secured by the balance in the participant's account and bore interest at the prime rate plus 1%. Principal and interest were paid ratably through payroll deductions.

(f) Payment of Benefits

On termination of service due to death, disability, or retirement, a participant was eligible to receive a cash-only lump-sum amount equal to the value of the participant's vested interest in his or her account. No annuities were allowed. For distributions of \$5,000 or less, the Plan required an immediate lump sum distribution of the participant's account balance. Withdrawals from eligible accounts were allowed for participants who attained 59½ years of age or who had a qualifying hardship subject to the Plan Document. Hardship distributions were allowed at a minimum amount of \$1,000.

(g) Forfeited Accounts

Participants were 100% vested in elective deferrals. Forfeitures of Company contributions were used to reduce Plan expenses and then to the extent available added to Company's contributions under the Plan. At December 31, 2023, participants' forfeited nonvested accounts were not significant. Forfeitures used during 2023 to reduce Company contributions were not significant.

(h) Transfer Due to Merger

Effective December 31, 2023, the Plan was merged into Plan 6.0. The account balances and notes receivable from participants in the Plan were merged into Plan 6.0 in the amounts of \$181,839,657 and \$1,500,918, respectively.

(i) Risks and Uncertainties

The Plan invested in various investments. Investments are exposed to various risks such as interest rate, market, liquidity, and credit risks, as well as risk associated with global events. Due to the level of risk associated with certain investments, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the Statements of Net Assets Available for Benefits.

(2) Summary of Significant Accounting Policies

(a) *Basis of Accounting*

The accompanying financial statements are prepared on the accrual basis of accounting.

(b) *Use of Estimates*

The preparation of financial statements in accordance with U.S. generally accepted accounting principles (U.S. GAAP) requires Plan management to make estimates and assumptions that affect certain reported amounts of assets and liabilities and changes therein. Accordingly, actual results may differ from those estimates.

(c) *Notes Receivable from Participants*

Notes receivable from participants were measured at their unpaid principal balance plus any accrued but unpaid interest. Delinquent participant loans were reclassified as distributions based on the terms of the Plan document.

(d) *Investment Valuation and Income Recognition*

As of December 31, 2023, the Plan held no investments due to the merger, as discussed in Note 1(h). Prior to the merger, the Plan's investments were reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date.

Purchases and sales of investments are recorded on a trade date basis. Investment income consists of dividend income, interest income and net appreciation (depreciation) in the fair value of investments. Interest income is recorded on an accrual basis. Dividends are recognized on the ex-dividend date. Net appreciation (depreciation) includes the Plan's gains and losses on investments bought and sold as well as held during the year.

(e) *Payment of Benefits*

Benefits are recorded when paid.

(f) *Administrative Expenses*

The Plan Document provided that the Company was entitled to reimbursement for expenses paid by the Company on behalf of the Plan. The Company did not seek reimbursement for these expenses in 2023. Fees related to the administration of notes receivable from participants and participant distributions were charged directly to the participant's account and are included in administrative expenses. Investment related expenses are included in net appreciation (depreciation) of fair value of investments.

(3) Information Certified by the Trustee

The Plan Administrator has elected the method of compliance permitted by 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. Investments, at fair value, and notes receivable from participants at December 31, 2022, and interest and dividend income, interest on notes receivable from participants and net appreciation in fair value of investments for the year ended December 31, 2023, that are disclosed in the accompanying

financial statements and related Note 4 were obtained or derived from information supplied to the Plan Administrator and certified as complete and accurate by Reliance Trust Company, the Trustee of the Plan. This information has not been audited by independent accountants.

(4) Fair Value Measurements

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1 measurements), and the lowest priority to unobservable inputs (Level 3 measurements). The three levels of the fair value hierarchy are described below:

- Level 1 - Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.
- Level 2 - Inputs to the valuation methodology include:
 - Quoted prices for similar assets or liabilities in active markets;
 - Quoted prices for identical or similar assets or liabilities in inactive markets;
 - Inputs other than quoted prices that are observable for the asset or liability;
 - Inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

- Level 3 - Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset's or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques maximize the use of relevant observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at December 31, 2023 and 2022.

Registered investment companies: Valued at the closing price reported on the active market in which the individual securities are traded (Level 1).

Participant-directed brokerage accounts: Accounts primarily consist of mutual funds and common stocks. Mutual funds and common stocks are determined by obtaining quoted prices on nationally recognized securities exchanges (Level 1).

Stable value collective trust fund: The fair value of the participation units in the stable value collective trust fund is determined using the net asset value after adjustments to reflect all fund investments at fair value, including direct interests in fully benefit-responsive contracts, as of the financial statement date and recent transactions prices as provided by the fund manager (Level 2). Participation by the Plan in the stable value collective trust fund does not allow for the Plan to hold competing funds including other stable value funds or money market funds. The stable value collective trust fund generally provides for daily redemptions by Plan participants at the reported net asset value per share with no advance notice requirements or

restrictions. Plan withdrawals require 60-days advance notice and are redeemed based on the market value adjustment rate as defined in the Declaration of Trust. Due to the merger of the Plan into Plan 6.0, as discussed in Note 1(h), the Plan's investment in the stable value collective trust fund was liquidated and a market value adjustment was applied to the Plan's interest in the stable value collective trust fund. As a result, a loss of \$1,465,325 on the investment was realized and included in net appreciation on the statement of changes in net assets available for benefits.

Due to the merger of the Plan into Plan 6.0, the Plan's investments were liquidated and transferred to Plan 6.0. As a result, the Plan held no assets as of December 31, 2023. The following table sets forth by level, within the fair value hierarchy, the Plan's investments at fair value as of December 31, 2022:

(5) Tax Status

The Internal Revenue Service (IRS) issued an opinion letter on October 6, 2020, indicating that the volume submitter plan adopted by Progeny Systems, LLC, the plan sponsor prior to November 1, 2022, as then designed, was in compliance with the applicable requirements of the Internal Revenue Code (IRC). Although the Plan was amended from the original prototype document, the Plan Sponsor and the Plan's counsel believe the Plan was designed and being operated in compliance with the applicable requirements of the IRC.

U.S. GAAP requires Plan management to evaluate tax positions taken by the Plan and recognize a tax liability (or asset) if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS. The Plan Administrator has analyzed the tax positions taken by the Plan, and has concluded that as of December 31, 2023 and 2022, there are no uncertain positions taken or expected to be taken that would require recognition of a liability (or asset) or disclosure in the financial statements. The Plan is subject to routine audits by taxing jurisdictions. There are currently no audits in progress for any tax periods. Under the IRS statute of limitations, the Plan is no longer subject to income tax examinations for years prior to 2020.

(6) Plan Termination

Prior to the merger of the Plan with Plan 6.0, the Company had the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, participants would become 100% vested in their Company contributions.

(7) Party-in-Interest Transactions

Prior to the merger, the Plan invested in an investment fund managed by Reliance Trust Company, the Trustee of the Plan. The fund is considered a party-in-interest investment, and transactions in the investment fund qualify as exempt party-in-interest transactions. Fees and commissions paid by the Plan for the recordkeeping, administration, and investment management services amounted to \$124,543 also qualify as exempt party-in-interest transactions.

Notes receivable from participants are also considered exempt party-in-interest transactions.
