Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed an audit of the accompanying financial statements of Excelsior Integrated Management Corp. 401(k) Plan, an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) ("ERISA Section 103(a)(3)(C) audit"). The financial statements comprise the statements of net assets available for benefits as of December 8, 2023 (in liquidation) and December 31, 2022 (ongoing), and the related statement of changes in net assets available for benefits for the period from January 1, 2023 through December 8, 2023 (in liquidation), and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audit of Excelsior Integrated Management Corp. 401(k) Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. As permitted by ERISA Section 103(a)(3)(C), our audit need not extend to any statements or information related to assets held for investment of the plan ("investment information") by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA (qualified institution).

Management has obtained a certification from a qualified institution as of December 8, 2023 and December 31, 2022 and for the period from January 1, 2023 through December 8, 2023, stating that the certified investment information, as described in Note 3 to the financial statements, is complete and accurate.

Emphasis of Matter – Terminating Plan and Liquidation Basis of Accounting

As discussed in Note 1 to the financial statements, effective January 1, 2023, the Plan was formally amended and approved for merger into the Rendr Care Physicians 401(k) Plan. As a result, all Plan assets were transferred out of the Plan on December 8, 2023. In accordance with accounting principles generally accepted in the United States of America, the Plan has changed its basis of accounting from the ongoing plan basis used in presenting the 2022 financial statements to the liquidation basis used in presenting the 2023 financial statements. Our opinion is not modified with respect to this matter.

Responsibilities of Management for the Financial Statements

Management is responsible for the preparation and fair presentation of these financial statements in accordance with accounting principles generally accepted in the United States of America, and for the design, implementation, and maintenance of internal control relevant to the preparation and fair presentation of financial statements that are free from material misstatement, whether due to fraud or error. Management's election of the ERISA Section 103(a)(3)(C) audit does not affect management's responsibility for the financial statements.

In preparing the financial statements, management is required to evaluate whether there are conditions or events, considered in the aggregate, that raise substantial doubt about Excelsior Integrated Management Corp. 401(k) Plan's ability to continue as a going concern for one year after the date the financial statements are available to be issued.

Management is also responsible for maintaining a current plan instrument, including all plan amendments; administering the plan; and determining that the plan's transactions that are presented and disclosed in the financial statements are in conformity with the plan's provisions, including maintaining sufficient records with respect to each of the participants, to determine the benefits due or which may become due to such participants.

Note 1 Description of Plan

The following description of Excelsior Integrated Management Corp. 401(k) Plan (the “Plan”) is provided only for general information purposes. Participants should refer to the Plan agreement for a more complete description of the Plan’s provisions.

General

The Plan is a defined contribution plan covering all employees of Excelsior Integrated Management Corp. (the plan “Sponsor”) who are 21 years of age or older and have completed at least 1,000 hours and one year of service. The Plan, named EIMG 401(k) Plan, was established January 1, 2017 until officially renamed effective September 1, 2020, is a qualified defined contribution plan with a cash or deferred arrangement in accordance with the provisions of the Internal Revenue Code of 1986 (IRC). It is subject to the provisions of the Employee Retirement Income Security Act of 1974, as amended (“ERISA”).

Plan Termination and Merger

In November 2022, Excelsior Integrated Management Corp. merged with Triboro Administrative Services, LLC (dba Rendr). As a result of the merger, effective January 1, 2023 there was no payroll through Excelsior Integrated Management Corp, and no new participants admitted or participant contributions to the Plan. All employees of Excelsior Integrated Management Corp. became eligible to participate in the Rendr Care Physicians 401(k) Plan (“Successor Plan”), sponsored by Triboro Administrative Services LLC. All active employees of Excelsior Integrated Management Corp. were enrolled into the Rendr Care Physicians 401(k) Plan and contributions during 2023 were made to that plan. All of the participant accounts were distributed or transferred into the plan held by Triboro Administrative Services Holdings, LLC and the Plan was terminated and ceased operations as of December 8, 2023 upon full liquidation of assets.

Contributions

Prior to January 1, 2023, Participants could contribute up to 100% of their pretax annual compensation up to IRS limits for the year. Participants may increase or decrease the percentage of their compensation deferred to the Plan on the first day of the plan quarter. Participants who attained the age of 50 before the end of the Plan year are eligible to make catch-up contributions. Participants may elect to contribute after tax compensation as a Roth elective deferral. Participants may also contribute amounts representing distributions from other qualified defined benefit or defined contribution plans (rollovers).

The Sponsor makes contributions according to the safe harbor method. In order to maintain safe harbor status, the Sponsor may make an enhanced safe harbor matching contribution equal to match of 100% of the first 3% of salary deferral plus 50% of the next 2% of salary deferral. For the period from January 1, 2023 through December 8, 2023 there were no matching contributions made to the plan. For the year ended December 31, 2022, the Sponsor committed to a safe harbor matching contribution \$560,784 to the Plan.

Participant Accounts

Prior to termination of the Plan, each participant's account was credited with the participant's contributions, rollover and allocation of (a) the plan Sponsor's safe harbor contribution, and (b) plan earnings and charged with an allocation of administrative expenses paid by the plan. Allocations are based on participant earnings, account balances, or specific transactions as defined. The benefit to which a participant was entitled was the benefit that can be provided from the participant's vested account.

Vesting

Participants were immediately vested in their contributions and on the plan Sponsor's safe harbor matching contributions plus actual earnings thereon.

Investment Options

The Plan trustees determine and approve the investment option set up for the Plan. Upon enrollment in the Plan, a participant may direct contributions into investment options. The Plan's assets are held in trust. Equitable Life Insurance Company ("Equitable") is the trustee of the Plan. The trustee invests monies according to participant directions. Currently, the Plan offers various pooled separate accounts and guaranteed interest account.

Participant Loans

Participants were not permitted to borrow from any source of investment accounts.

Payment of Benefits

Upon termination of service due to death, disability, or retirement, a participant is eligible to receive a single lump-sum amount equal to the value of his or her vested account balance, or installments only for required minimum distributions. For termination of service for other reasons, a participant may receive the value of the vested interest in his or her account as a lump-sum distribution, either in cash, as a direct rollover, or a combination of both. The Plan permits for hardship withdrawals of the participant's vested account balance. Permissible circumstances for hardship withdrawals include education, purchase of a principal residence, medical expenses, to prevent eviction or foreclosure of a principal residence, payments for burial or funeral expenses, and expenses for the repair of damage to a principal residence.

Hardship Withdrawals

The Plan allows for distributions to participants for hardship from the participants vested account balance. Permissible circumstances for hardship withdrawals include education, purchase of principal residence, medical expenses, to prevent eviction or foreclosure of a principal residence, payments for burial or funeral expenses, and expenses for the repair of damage to a principal residence. Distributions cannot be in excess of amounts of immediate need, participant must have obtained all distribution under the plan before obtaining a hardship withdrawal. The participant cannot make a salary deferral for at least 6 months after receipt of hardship withdrawal.

Forfeited Accounts

There are no forfeitures, as employees are 100% vested in employer matching contributions.

Note 2 Summary of significant accounting policies

Basis of Accounting

For the period from January 1, 2023 through December 8, 2023, the financial statements have been prepared on the liquidation basis of accounting in accordance with accounting principles generally accepted in the United States of America. For the year ended December 31, 2022, the financial statements of the Plan have been prepared using the accrual basis of accounting in accordance with accounting principles generally accepted in the United States of America.

Use of Estimates

The preparation of financial statements in accordance with accounting principles generally accepted in the United States of America (“GAAP”) requires the plan administrator to make estimates and assumptions that affect the reported amounts of assets and liabilities and changes therein, and disclosures of contingent assets and liabilities. Accordingly, actual results may differ from those estimates.

Investment Valuation and Income Recognition

Investments are reported at fair value, except for fully benefit-responsive investment contracts, which are reported at contract value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See Note 4 for discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation includes the Plan’s gains and losses on investments bought and sold as well as held during the year. The pooled separate accounts’ fair value is estimated by using net asset value as a practical expedient. This is based on information reported by the trustee, using the audited financial statements of the pooled separate accounts at year-end. See Note 4 for discussion of fair value measurements.

Payment of Benefits

Benefits are recorded when paid.

Administrative Expenses

Certain expenses of maintaining the Plan are paid by the Sponsor and are therefore excluded from these financial statements. Investment-related expenses are included in net appreciation in fair value of investments. Participant initiated transaction fees are included in administrative expenses and charged directly to the participant’s account.

Note 3 Information Prepared and Certified by Trustee

No auditing procedures were performed by the independent auditor as permitted by ERISA Section 103(a)(3)(C) with respect to information certified as complete and accurate by Equitable Life Insurance Company (“Equitable”) (the “trustee”), except for comparing such information with the information reported in the financial statements. Based on the information provided and certified by the trustee, there are no fixed income obligations, leases, or debt instruments in default or deemed uncollectible, as defined by ERISA, as of December 8, 2023 and December 31, 2022.

Accordingly, the trustee of the Plan assets has certified to the completeness and accuracy of:

- Investments, at fair value as reflected on the accompanying statements of net assets available for benefits as of December 8, 2023 and December 31, 2022.
- Net appreciation of investments and interest income as reflected on the accompanying statement of changes in net assets available for benefits for the period from January 1, 2023 through December 8, 2023.

Note 4 Fair Value Measurements

Accounting Standards Codification (ASC) 820, Fair Value Measurement, provides for a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1) and the lowest priority to unobservable inputs (Level 3). The three levels of the fair value hierarchy under ASC 820 are described as follows:

Level 1 – This level consists of inputs to the valuation methodology that are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2 - This level consists of inputs to the valuation methodology that include:

- Quoted prices for similar assets or liabilities in active markets.
- Quoted prices for identical or similar assets or liabilities in inactive markets.
- Inputs other than quoted prices that are observable for the asset or liability.
- Inputs that are derived principally from, or corroborated by, observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

Level 3 - This level consists of inputs to the valuation methodology that are unobservable and significant to the fair value measurement.

A financial instrument's level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques maximize the use of relevant observable inputs and minimize the use of unobservable inputs.

The following is a description of the valuation methodology used for the Plan's assets measured at fair value. There have been no changes in the methodology:

Pooled Separate Accounts – Valued at Net Asset Value (“NAV”) for the number of units held by the Plan at year-end, much like a mutual fund, whose value is the result of accumulated values of the underlying investments, and with similar restrictions as a mutual fund regarding redemptions.

The preceding methods described may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, although the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

Note 5 Investments at Contract Value

The Plan invests in fully benefit-responsive traditional investment contracts through its investment in the Equitable Guaranteed Interest Account. Equitable maintains the contributions in a general account. The account is credited with contributions and earnings on the underlying investments and is charged for participant withdrawals and administrative expenses. The guaranteed investment contract issuer is contractually obligated to repay the principal and a specified interest rate that is guaranteed to the Plan. The crediting interest rate is based on an agreed-upon formula with the issuer and on the characteristics of the underlying fixed-income portfolio but cannot be less than 1.0%. The crediting rate at December 31, 2022 was 1.5%. The crediting interest rate takes into account yield forecasts from Equitable's asset advisory group and the margins required for Equitable's business. The crediting interest rate is declared in advance and is reset quarterly.

This contract meets the fully benefit-responsive investment contract criteria and is therefore reported at contract value. Contract value is the relevant measure for fully benefit-responsive investment contracts because this is the amount received by participants if they were to initiate permitted transactions under the terms of the Plan. Contract value, as reported to the Plan by Equitable, represents contributions made under the contract, plus earnings, less participant withdrawals and administrative expenses. Participants may ordinarily direct the withdrawal or transfer of all or a portion of their investment at contract value. Participants may not ordinarily direct the withdrawal or transfer of all or a portion of their investment at contract value.

Certain events, such as the premature termination of the contract by the Plan or the termination of the Plan, would limit the Plan's ability to transact at contract value with Equitable. The Plan administrator believes the occurrence of such events that would limit the Plan's ability to transact at contract value with Equitable is not probable. Both management of the Plan and Equitable can terminate the contract with a 30-day advance notice, although Equitable can terminate the contract only for reasonable cause.

Note 6 Plan Termination

In November 2022, the Plan administrator approved the termination of the Plan effective January 1, 2023. The Plan's termination ceased employee contributions into the Plan as all employees and their payroll were moved to the merging entity. Prior to the Plan merger, although it has not expressed any intent to do so, the Sponsor has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. All participants with account balances were fully vested as of January 1, 2023. Participants were provided the option to receive their distributions as a lump-sum payment or a direct rollover to an eligible retirement account (including an IRA). All net assets were distributed to participants by December 8, 2023.

Note 7 Tax Status

The Plan uses a pre-approved plan sponsored by its third-party administrator. The third-party administrator received a favorable opinion letter from the Internal Revenue Service (IRS) dated June 30, 2020, which states that the pre-approved plan, as then designed, satisfies the applicable provisions of the IRC. The Plan has since been amended; however, in the opinion of the Plan administrator, the Plan is designed and is currently being operated in accordance with the applicable requirements of the IRC and the Plan and related trust continue to be tax-exempt. Therefore, no provision for income taxes has been included in the Plan's financial statements.

GAAP requires Plan management to evaluate tax positions taken by the Plan and recognize a tax liability if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

Note 8 Risks and Uncertainties

The Plan invests in various investments securities. Investment securities are exposed to various risks such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statement of net assets available for benefits.

Note 9 Party-In-Interest Transactions

Certain Plan investments are in funds and accounts that are managed by Equitable Life Insurance Company. Equitable Life Insurance Company is the trustee as defined by the Plan and, therefore, these transactions qualify as party-in-interest transactions. Fees paid by the Plan for contract administrator fees amounted to \$26,007 for the period ended December 8, 2023.

All of these party-in-interest are exempt from prohibited transaction rules of ERISA.

Note 10 Subsequent Events

Plan management has evaluated subsequent events through September 25, 2024, the date which the financial statements were available to be issued. Based upon this evaluation, the Plan has determined that no subsequent events have occurred which require adjustment to or disclosure in the financial statements.
