NOTE 1 - DESCRIPTION OF PLAN

The following description of the Grimmway Enterprises 401(k) Plan for Hourly Employees (the "Plan") provides only general information. Participants should refer to the Plan document or Summary Plan Description for a more complete description of the Plan's provisions, which are available from the plan administrator.

General: The Plan was established January 1, 2018, and is a defined contribution plan sponsored by Grimmway Enterprises, Inc. (the "Company") for the benefit of its hourly employees including non-admin employees with prior service with any Grimmway company, including VegPro Management, King Pak Potato Company, LLC, Grimmway Management Company, LLC, and Crystal Organic Farms, LLC, who have three months of service. Employees may elect to participate in the Plan on the first day of the month following their eligibility date. The Plan is intended to satisfy all of the requirements for a qualified retirement plan under the appropriate provisions of the Internal Revenue Code ("IRC") and is subject to the provisions of the Employee Retirement Income Security Act of 1974 ("ERISA"). On December 23, 2020 the Company executed agreements whereby Teays River, LLC (Teays) acquired 100% of the Company. There was no significant change in the structure or operations of the Plan as a result of the sale.

The Plan is administered by the Company's Administrative Committee (the "Committee"), which is a committee of the board of directors of the Company. The Committee has overall responsibility for the operation and administration of the Plan, determines the appropriateness of the Plan's investment offerings, monitors investment performance and reports to the Company's Board of Directors.

Contributions: Participants may contribute up to 100% of annual compensation as pretax or Roth contributions, as defined in the Plan. Participants may also contribute amounts representing distributions from other qualified defined benefit or contribution plans. Additionally, participants age 50 or older who are making contributions to the Plan are allowed to make catch-up contributions as defined in the Plan. Company contributions are made on a discretionary basis determined annually by the Board of Directors. Contributions are subject to certain ("IRC") limitations.

Participant Accounts: Each participant's account is credited with the participant's contributions and allocations of the Company's contribution and plan earnings and is charged with his or her withdrawals and charged with an allocation of administrative expenses. Allocations are based on participant earnings or account balances, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account. Participants direct the investment of all contributions into various investment options offered by the Plan.

Vesting: Participants are immediately vested in their contributions plus actual earnings thereon. Employer contributions are subject to the following vesting schedule:

In the event of death, disability, or retirement, a participant's interest in Company contributions becomes fully vested.

Notes Receivable From Participants: Participants may borrow from their fund accounts a minimum of \$1,000 up to a maximum equal to the lesser of \$50,000 or 50% of their vested account balance. Loan payments are made through payroll deductions, and must be paid back within five years, unless the loan is used for the purchase of a principal residence. The loans are secured by the vested balance in the participant's account and bear interest at the prime rate on the date of the loan plus 1%. Principal and interest are paid ratably through payroll deductions.

Payment of Benefits: If the value of a participant's vested benefit is more than \$5,000, upon termination of service due to death, disability or retirement, a participant, participant's spouse, or designated beneficiary may elect to receive a lump-sum amount equal to the value of the participant's vested interest in his or her account. Upon termination due to death, a participant's vested account balance will be distributed to the participant's beneficiary as soon as practicable. Participants with vested benefits at date of termination of \$1,000 or less will receive a lump-sum distribution of their vested account balance. Participants with vested benefits between \$1,001 and \$5,000 and who do not elect to have the balance paid out or rolled into another qualified plan will have their vested balance automatically rolled over into an Individual Retirement Account designated by the plan administrator.

Forfeited Accounts: Forfeited accounts are used to reduce future employer contributions. At December 31, 2023 and 2022, there were \$2,524 and \$0, respectively, in forfeited non-vested accounts. No amounts were utilized to reduce employer contributions during the years ended December 31, 2023 and 2022.

Plan Termination: Although it has not expressed any intent to do so, the Company has the right under the plan agreement to discontinue contributions at any time and to terminate the Plan subject to provisions of ERISA. In the event of plan termination, participants would become 100% vested in their Company contributions and earnings thereon.

Administrative and Investment Management Expenses: Certain expenses of maintaining the Plan are paid directly by the Company and are excluded from these financial statements. Plan recordkeeping and trustee fees are paid by the Plan and are reflected in the financial statements as administrative expenses. Fees related to the administration of notes receivable from participants are charged directly to the participant's account and are included in administrative expenses. Investment management fees are charged to the Plan as a reduction of investment return and included in the investment income (loss) reported by the Plan.

Transfers to Other Plan: In addition to the Plan, the Company sponsors the Grimmway Enterprises Inc. 401(k) Plan for salaried and administrative employees ("Admin Plan"), a defined contribution plan. From time to time, hourly employee payroll status may change and qualify those employees to participate in the Admin Plan. When this occurs, participant investment and loan balances are transferred between plans. For the periods ended December 31, 2023 and 2022, participant accounts totaling \$49,015 and \$13,260, respectively, were transferred from the Plan to the Admin Plan.

Subsequent Events: Plan management has evaluated subsequent events for recognition and disclosure through October 4, 2024, which is the date the financial statements were available to be issued. On January 1, 2024 the Grimmway Enterprises Inc. 401 (k) Plan for Hourly Employees was merged with Grimmway Enterprises 401(k) Plan. For purposes of the Form 5500, the transfer was reflected as of December 31, 2023 and the final return was filed. Please see the reconciliation of activity in footnote 8.

NOTE 2 - SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES

Basis of Accounting: The financial statements of the Plan are prepared on the accrual method of accounting.

Use of Estimates: The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires the plan administrator to make estimates and assumptions that affect certain reported amounts and disclosures, and actual results may differ from these estimates.

Investment Valuation and Income Recognition: The Plan's investments other than fully benefit responsive investment contracts are reported at fair value as further described in Note 4. Fair value is the price that would be received by the Plan for an asset or paid by the Plan to transfer a liability (an exit price) in an orderly transaction between market participants on the measurement date in the Plan's principal or most advantageous market for the asset or liability. Contract value is the relevant measure for the Plan's fully benefit-responsive investment contracts, because contract value is the amount Plan participants generally receive when executing transactions under the terms of the contract and Plan provisions.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation (depreciation) includes the plan's gains and losses on investments bought and sold as well as held during the year.

Notes Receivable from Participants: Notes receivable from participants are reported at their unpaid principal balance plus any accrued but unpaid interest, with no allowance for credit losses, as repayments of principal and interest are received through payroll deductions and the notes are collateralized by the participants' account balances. Related fees are recorded as administrative expenses and are expensed when they are incurred.

Payment of Benefits: Benefits are recorded when paid.

Risks and Uncertainties: The Plan holds various investments. Investments are exposed to various risks such as interest rate, market, liquidity, global events and credit risks. Due to the level of risk associated with certain investments, it is at least reasonably possible that changes in the fair values of investments will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statement of net assets available for benefits.

NOTE 3 - CERTIFIED INVESTMENTS AND NOTES RECEIVABLE FROM PARTICIPANTS

Certain information related to investments and notes receivable from participants disclosed in the accompanying financial statements and ERISA required supplemental schedule, including investments and notes receivable from participants held at December 31, 2023 and 2022 and the net appreciation (depreciation) in fair value of investments, interest and dividends, and interest income on notes receivable from participants for the years then ended, was obtained by management and agreed to or derived from information certified as complete and accurate by Delaware Charter Guarantee and Trust Company d/b/a Principal Trust Company ("Principal"), the trustee of the Plan.

NOTE 4 - FAIR VALUE MEASUREMENTS

Fair value measurements are determined by maximizing the use of observable inputs and minimizing the use of unobservable inputs. The hierarchy places the highest priority on unadjusted quoted market prices in active markets for identical assets or liabilities (Level 1 measurements) and gives the lowest priority to unobservable inputs (Level 3 measurements). The three levels of inputs within the fair value hierarchy are defined as follows:

Level 1 - Quoted prices (unadjusted) for identical assets or liabilities in active markets that the Plan has the ability to access as of the measurement date.

Level 2 - Significant other observable inputs other than Level 1 prices such as quoted prices for similar assets or liabilities; quoted prices in markets that are not active; or other inputs that are observable or can be corroborated by observable market data.

Level 3 - Significant unobservable inputs that reflect the Plan's own assumptions about the assumptions that market participants would use in pricing an asset or liability.

In some cases, a valuation technique used to measure fair value may include inputs from multiple levels of the fair value hierarchy. The lowest level of significant input determines the placement of the entire fair value measurement in the hierarchy.

The following presents the valuation methods and assumptions used by the Plan to estimate the fair values of investments.

Mutual Funds: The fair values of mutual fund investments are determined by obtaining quoted prices on nationally recognized securities exchanges (Level 1 inputs).

NOTE 5 - GUARANTEED INVESTMENT CONTRACT WITH INSURANCE COMPANY

The Plan has a fully benefit-responsive guaranteed investment contract with New York Life Insurance Company. New York Life Insurance Company maintains the contributions in a general account. The account is credited with earnings on the underlying investments and charged for participant withdrawals and administrative expenses. The guaranteed investment contract issuer is contractually obligated to repay the principal and a specified interest rate that is guaranteed to the Plan. The crediting rate is based on a formula established by the contract issuer but may not be less than 1% percent. The crediting interest rate is reviewed on a quarterly basis for resetting. The guaranteed investment contract does not permit the insurance company to terminate the agreement prior to the scheduled maturity date.

Because the guaranteed investment contract is fully benefit-responsive, contract value is the relevant measurement for the guaranteed investment contract. Contract value, as reported to the Plan by New York Life Insurance Company, represents contributions made under the contract, plus earnings, less participant withdrawals and administrative expenses. Participants may ordinarily direct the withdrawal or transfer of all or a portion of their investment at contract value.

The Plan's ability to receive amounts due is dependent on the issuer's ability to meet its financial obligations. The issuer's ability to meet its contractual obligations may be affected by future economic and regulatory developments.

Certain events limit the ability of the plan to transact at contract value with the issuer. Such events include the following: (1) termination of the Plan, (2) any transfer of all of the Covered Funds of the Plan which causes the amounts to cease to be Covered Funds, (3) partial plan termination, a spin-off, or a combination or series of such partial plan terminations or spin-offs, or any other action or changes with regard to the Plan that causes a significant withdrawal from the Plan, or (4) termination of any recordkeeping arrangement, service agreement, or other contractual arrangements between or with regard to the Plan and New York Life Insurance Company or one of their affiliates or subsidiaries. As a result of the merger of the Plan discussed in Note 1, the contract was transferred in-kind, not impacting the Plan's ability to transact at contract value with Plan participants.

NOTE 6 - PARTY-IN-INTEREST TRANSACTIONS

Parties-in-interest are defined under DOL regulations as any fiduciary of the Plan, any party rendering service to the Plan, the employer, and certain others. Certain administrative functions are performed by officers or employees of the Company. No such officer or employee receives compensation from the Plan. Some administrative expenses of the Plan are paid directly by the Company. Principal is a service provider to the Plan and, therefore, the Plan's payment of fees to Principal qualify as party-in-interest transactions. New York Life Insurance Company is also a service provider and therefore, the Plan's payment of fees to New York Life Insurance Company and the investment in a guaranteed investment contract issued by New York Life Insurance Company qualify as party-in-interest transactions. Notes receivable from participants also reflect party-in-interest transactions.

NOTE 7 - TAX STATUS

The Internal Revenue Service ("IRS") issued an opinion letter dated June 30, 2020 indicating that the prototype plan adopted by the Plan, as then designed, was in compliance with applicable requirements of the IRC. Although the Plan has been amended from the original prototype document, Plan management believes that the Plan is currently being operated in accordance with the IRC.

U.S. GAAP requires plan management to evaluate tax positions taken by the Plan and recognize a tax liability (or asset) if the Plan has taken an uncertain tax position that more likely than not would not be sustained upon examination by the IRS. The plan administrator has analyzed the tax positions taken by the Plan, and has concluded that as of December 31, 2023 and 2022, there are no uncertain positions taken or expected to be taken that would require recognition of a liability (or asset) or disclosure in the financial statements. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress. The plan administrator believes it is no longer subject to income tax examinations for years prior to 2020.
