Independent Auditor's Report

To the Plan Administrator of the Cheshire Medical Center Employee Investment Plan:

Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed audits of the financial statements of the Cheshire Medical Center Employee Investment Plan ("the Plan"), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 ("ERISA"), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). The financial statements comprise the statements of net assets available for benefits as of December 31, 2023 and 2022, and the related statement of changes in net assets available for benefits for the year ended December 31, 2023, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of the financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's ("DOL") Rules and Regulations for Reporting and Disclosure under ERISA. As permitted by ERISA Section 103(a)(3)(C), our audits need not extend to any statements or information related to assets held for investment of the plan (investment information) by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the DOL's Rules and Regulations for Reporting and Disclosure under ERISA ("qualified institution").

Management has obtained certifications from qualified institutions as of December 31, 2023 and 2022, and for the year ended December 31, 2023, stating that the certified investment information, as described in Note G to the financial statements, is complete and accurate.

Opinion

In our opinion, based on our audits and on the procedures performed as described in the Auditor's Responsibilities for the Audit of the Financial Statements section of our report:

- the amounts and disclosures in the accompanying financial statements, other than those agreed to or derived from the certified investment information, are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America ("GAAP").
- the information in the accompanying financial statements related to assets which provide benefits under the plan and certified to by qualified institutions and assets held by and certified to by qualified institutions agrees to, or is derived from, in all material respects, the information prepared and certified by an institution that management determined meets the requirements of ERISA Section 103(a)(3)(C).

Emphasis of Matter – Plan Merger

As further discussed in Notes A and J, effective December 31, 2023, the Cheshire Medical Center Employee Investment Plan merged with and into the Dartmouth-Hitchcock Employee Investment Plan and ceased to exist as a separate plan as of that date. Our opinion is not modified with respect to this matter.

Basis for Opinion

We conducted our audits in accordance with auditing standards generally accepted in the United States of America (“GAAS”). Our responsibilities under those standards are further described in the Auditor's Responsibilities for the Audit of the Financial Statements section of our report. We are required to be independent of the Plan and to meet our other ethical responsibilities, in accordance with the relevant ethical requirements relating to our audits. We believe that the audit evidence we have obtained is sufficient and appropriate to provide a basis for our ERISA Section 103(a)(3)(C) audit opinion.

Responsibilities of Management for the Financial Statements

Management is responsible for the preparation and fair presentation of the financial statements in accordance with GAAP, and for the design, implementation, and maintenance of internal control relevant to the preparation and fair presentation of financial statements that are free from material misstatement, whether due to fraud or error. Management's election of the ERISA Section 103(a)(3)(C) audit does not affect management's responsibility for the financial statements.

In preparing the financial statements, management is required to evaluate whether there are conditions or events, considered in the aggregate, that raise substantial doubt about the Plan's ability to continue as a going concern within one year after the date that the financial statements are issued or available to be issued.

Management is also responsible for maintaining a current plan instrument, including all plan amendments, administering the plan, and determining that the plan's transactions that are presented and disclosed in the financial statements are in conformity with the plan's provisions, including maintaining sufficient records with respect to each of the participants, to determine the benefits due or which may become due to such participants.

Auditor's Responsibilities for the Audit of the Financial Statements

Except as described in the Scope and Nature of the ERISA Section 103(a)(3)(C) Audit section of our report, our objectives are to obtain reasonable assurance about whether the financial statements as a whole are free from material misstatement, whether due to fraud or error, and to issue an auditor's report that includes our opinion. Reasonable assurance is a high level of assurance but is not absolute assurance and therefore is not a guarantee that an audit conducted in accordance with GAAS will always detect a material misstatement when it exists. The risk of not detecting a material misstatement resulting from fraud is higher than for one resulting from error, as fraud may involve collusion, forgery, intentional omissions, misrepresentations, or the override of internal control. Misstatements are considered material if, there is a substantial likelihood that, individually or in the aggregate, they would influence the judgment made by a reasonable user based on the financial statements.

In performing an audit in accordance with GAAS, we:

- Exercise professional judgment and maintain professional skepticism throughout the audit.

Our audits did not extend to the certified investment information, except for obtaining and reading the certifications, comparing the certified investment information with the related information presented and disclosed in the financial statements, and reading the disclosures relating to the certified investment information to assess whether they are in accordance with the presentation and disclosure requirements of GAAP.

Accordingly, the objective of an ERISA Section 103(a)(3)(C) audit is not to express an opinion about whether the financial statements as a whole are presented fairly, in all material respects, in accordance with GAAP.

We are required to communicate with those charged with governance regarding, among other matters, the planned scope and timing of the audit, significant audit findings, and certain internal control-related matters that we identified during the audit.

NOTES TO FINANCIAL STATEMENTS

A. PLAN DESCRIPTION:

The following description of the Cheshire Medical Center Employee Investment Plan (previously the Tax Sheltered Annuity Plan for Employees of Cheshire Medical Center) (the "Plan") provides only general information. Participants should refer to the plan document for more detailed information.

General

The Plan is a defined contribution 403(b) plan sponsored by Cheshire Medical Center (the "Company"), covering substantially all employees of the Company. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974, as amended ("ERISA").

As further discussed in Note J, effective December 31, 2023, the Cheshire Medical Center Employee Investment Plan merged with and into the Dartmouth-Hitchcock Employee Investment Plan and ceased to exist as a separate plan as of that date.

Contributions

Participants may contribute up to 100% of their gross compensation, as defined by the Plan, on a pre-tax and Roth after-tax basis, subject to Internal Revenue Code ("IRC") limitations. All eligible employees are automatically enrolled in the Plan with a pre-tax deferral contribution of 2% unless the participant elects otherwise. Participant's deferral contributions will increase in increments of 1% each plan year, commencing on the anniversary of the participant's beginning contributions to the Plan, until reaching 10%. Participants who are at least age 50 may make an additional "catch-up" contribution subject to IRC limitations. Participants who have completed 15 years of service may make a special section 403(b) catch up contribution, as defined in the plan document. Participants may also contribute funds from another qualified retirement plan ("rollover contributions"), subject to certain requirements.

The Company matches participant contributions up to 50% of 4% of participant deferrals, for a maximum of 2% of compensation. The Company also makes a 4% nonelective employer contribution. Participants hired prior to September 23, 2019, who made a one-time election in 2019 are eligible to receive a nonelective employer contribution based on a formula which considers age and length of services in place of the Company matching contributions and 4% nonelective contribution. The Company may elect to make discretionary matching contributions. During 2023, the Company made no discretionary matching contributions. All employees shall be eligible for nonelective employer contributions as of the January 1st following their date of hire.

Participant Accounts

Each participant's account is credited or charged with contributions, investment income, and administrative expenses. Investment income, including realized and unrealized gains and losses, and expenses are allocated to participants' accounts based on each participant's account balance within each fund. Participants determine the percentage in which contributions are to be invested in each fund. Participants may change their investment options as set forth in the plan document. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

Vesting

Participants are immediately fully vested in that portion of their account which represents their contributions and the income earned thereon. Participants become 100% vested in all Company contributions and earnings thereon upon death, total and permanent disability, or attainment of normal retirement age. Participants hired prior to June 30, 2008 are fully vested in matching contributions. Otherwise, a participant's interest in the Company's matching contributions, nonelective contributions, transition contributions, and earnings thereon vests according to the following schedule:

Forfeitures

When certain terminations of participation in the Plan occur, the nonvested portion of a participant's account represents a forfeiture, as defined by the Plan. If a forfeiting participant is re-employed and fulfills certain requirements, as set forth in the Plan, the participant's account will be restored. Remaining forfeitures will be used to reduce employer matching contributions to the plan or to pay plan expenses. Forfeitures totaling \$238,993 were used to reduce employer contributions in 2023. Unallocated forfeitures were \$0 and \$83,815 at December 31, 2023 and 2022, respectively.

Unallocated Assets

The Plan holds assets in an unallocated account which receives contributions as a result of a revenue sharing agreement with Transamerica Financial Life Insurance Company, Inc. During 2023, contributions to the account totaled \$116,380, which is included in net appreciation (depreciation) in fair value of investments in the statement of changes in net assets available for benefits. Funds in the account are used to pay qualified plan expenses including investment management fees, trustee fees, audit fees, and legal fees or allocated to participants. During 2023, \$167,732 was used to pay plan expenses. Unallocated assets were \$0 and \$67,112 at December 31, 2023 and 2022, respectively.

Distribution of Benefits

Benefits may be distributed to participants upon termination of employment by reason of retirement, disability, death or other separation from service. Participants may leave their funds invested in the Plan or may elect a distribution in the form of a lump sum, installment payments, or partial payments.

A participant may also request a withdrawal upon attainment of age 59^{1/2} or upon demonstration by the participant to the plan administrator that the participant is suffering from "hardship", as defined in the plan document. Participant may withdraw from their rollover account at any time.

Notes Receivable from Participants

A participant with retirement assets at Transamerica Financial Life Insurance Company Inc. may request a loan. The loan amount is limited to the lesser of \$50,000 or 50% of the participant's vested account balance, subject to plan limitations. The minimum loan amount is \$1,000. No more than one loan may be outstanding at any time. Loans must bear a rate of interest of prime plus one percent. Loans are collateralized by the participant's nonforfeitable interest in the Plan and are supported by a promissory note. Loans must be repaid over a period not to exceed five years unless the loan proceeds are used for the purchase of a primary residence, in which case a longer repayment period is allowed. Principal and interest is generally paid ratably through payroll deductions each pay period.

B. SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES:

Basis of Accounting

The accompanying financial statements have been prepared using the accrual basis of accounting.

Use of Estimates

The preparation of financial statements in accordance with accounting principles generally accepted in the United States of America requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities and changes therein, and disclosure of contingent assets and liabilities. Actual results could differ from those estimates.

Investment Valuation and Income Recognition

Investments are reported at fair value (except for fully benefit-responsive investment contracts, which are reported at contract value). Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants on the measurement date. See Note C for discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation (depreciation) includes the Plan's gains and losses on investments bought and sold as well as held during the year.

Notes Receivable from Participants

Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Interest income is recorded on the accrual basis. No allowance for credit losses has been recorded as of December 31, 2023 or 2022. Delinquent participant loans are reclassified as distributions based upon the terms of the plan document.

Plan Expenses

Expenses related to the management of the Plan's investments and investment transactions and recordkeeping fees are paid by the Plan. Certain participants' expenses are paid by the participants. Expenses not paid by the Plan may be paid by the Company. Expenses that are paid by the Company are excluded from these financial statements. Investment related expenses are included in net appreciation (depreciation) in fair value of investments.

Payment of Benefits

Benefits are recorded when paid.

C. FAIR VALUE MEASUREMENTS:

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (level 1) and the lowest priority to unobservable inputs (level 3). The three levels of the fair value hierarchy under FASB ASC 820 are described as follows:

Level 1 - Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2 - Inputs to the valuation methodology include quoted prices for similar assets or liabilities in active markets; quoted prices for identical or similar assets or liabilities in inactive markets; inputs other than quoted prices that are observable for the asset or liability; inputs that are derived principally from or corroborated by observable market data by correlation or other means. If the asset or liability has a specified (contractual) term, the level 2 input must be observable for substantially the full term of the asset or liability.

Level 3 - Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement.

Following is a description of the valuation methodologies used by the Plan. There have been no changes in the methodologies used at December 31, 2023 and 2022.

Self-directed brokerage accounts – Invested in mutual funds.

Mutual funds – Valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-end mutual funds that are registered with the SEC. These funds are required to publish their daily net asset value (NAV) and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.

Variable annuity contracts – Valued at the net asset value of units of a variable annuity. The net asset value, as provided by the contract issuer, is used as a practical expedient to estimate fair value. The net asset value is based on the fair value of the underlying investments held by the fund less its liabilities. This practical expedient would not be used if it is determined to be probable that the fund will sell the investment for an amount different from the reported net asset value.

- (a) The growth variable annuity seeks a favorable long-term rate of return, mainly through capital appreciation, primarily from a diversified portfolio of common stocks that presents opportunity for exceptional growth.
- (b) The blend variable annuity pursues long-term capital appreciation by investing in undervalued companies that show strong potential for growth.
- (c) The moderate allocation variable annuities seek maximum aggregate rate of return over the long-term through controlled investment risk by adjusting investment mix among stocks, long-term debt securities and short-term money market securities.
- (d) Bond variable annuities seek total possible returns through current income and capital gains on investments in intermediate and long-term debt instruments and other income producing securities.
- (e) Value variable annuities seek capital growth by investing in common stocks. Income is a secondary objective.
- (f) International variable annuities seek high total return through long-term growth of capital and current income.
- (g) Health variable annuities pursue long-term capital appreciation by investing in foreign stock, and common stock of companies in health-related industries (a sector fund).
- (h) Money market variable annuity invests in high-quality debt securities and seeks to maximize current income consistent with liquidity and preservation of capital.
- (i) Technology variable annuities seek long-term capital appreciation by investing in foreign securities, and exchange traded funds.
- (j) Long government variable annuity invests primarily in direct government obligations, which are backed by the full faith and credit of the U.S. government.

D. INVESTMENTS AT CONTRACT VALUE:

The Plan has traditional investment contracts with Transamerica Financial Life Insurance Company ("TFLIC") through the TFLIC Guaranteed Investment Option Fund, VALIC through the Fixed Account Plus Fund and the Short-Term Fixed Account, Metropolitan Life Insurance Company ("MetLife") through the Fixed Interest Account and American General Life Insurance Company (SunAmerica) through the 1 Year Fixed Account and the Conversion Account.

TFLIC maintains the contributions in a separate account. VALIC, MetLife, and American General Life Insurance Company (SunAmerica) maintain the contributions in general accounts. The contracts meet the fully benefit-responsive investment contract criteria and therefore are reported at contract value. Contract value is the relevant measure for fully benefit-responsive investment contracts because this is the amount received by participants if they were to initiate permitted transactions under the Plan. Contract value represents contributions made under the contract, plus earnings, less participant withdrawals and administrative expenses. With traditional investment contracts, the Plan owns only the contract itself. These contracts are designed to accrue interest based on crediting rates established by the contract issuers.

For the TFLIC Guaranteed Investment Option Fund, participants may ordinarily direct the withdrawal or transfer of all or a portion of their investment at contract value. Interest rates are reviewed on an annual basis for resetting.

For the VALIC investments, participants may ordinarily direct the withdrawal or transfer of all or a portion of their investment at contract value ratably over five years. In the event a shorter redemption period is required a participant will receive the lesser of the contract value or fair value of their portion of the investment. Participant level withdrawals may be subject to a 5% surrender fee to any withdrawals that exceed 10% of the account balance. Interest rates are reviewed on an annual basis for resetting.

MetLife may delay paying any cash withdrawals from the Fixed Interest Account for up to six months. There are no surrender charges for withdrawals. Interest rates are reviewed on a quarterly basis for resetting.

For the American General Life Insurance Company (SunAmerica) contracts, participants may ordinarily direct the withdrawal or transfer of all or a portion of their investment at contract value. There are no surrender charges for withdrawals. Interest rates are reviewed on an annual basis for resetting.

The traditional investment contracts held by the Plan are guaranteed investment contracts. The contract issuers are contractually obligated to repay the principal and interest at specified interest rates that are guaranteed to the Plan. The contracts do not have a maturity date. There are no reserves against contract value for credit risks of the contract issuer or otherwise. The minimum crediting interest rates for the TFLIC, VALIC, MetLife and American General Life Insurance Company (SunAmerica) contracts are 1.50%, 2.0%, 3.0%, and 3.0% respectively.

The Plan's ability to receive amounts due in accordance with fully benefit-responsive investment contracts is dependent on the third-party issuer's ability to meet its financial obligations. The issuer's ability to meet its contractual obligations may be affected by future economic and regulatory developments.

Certain events might limit the ability of the Plan to transact at contract value with the contract issuer. Such events include the following: (1) amendments to the plan documents (including complete or partial plan termination or merger with another plan), (2) changes to the Plan's prohibition on competing investment options or deletion of equity wash provisions, (3) bankruptcy of the plan sponsor or other plan sponsor events (for example, divestitures or spin-offs of a subsidiary) that cause a significant withdrawal from the Plan, or (4) the failure of the trust to qualify for exemption from federal income taxes or any required prohibited transaction exemption under ERISA.

No events are probable of occurring that might limit the ability of the Plan to transact at contract value with the contract issuer and that would limit the ability of the Plan to transact at contract value with the participants. The Plan merger did not impact the ability to transact at contract value.

E. PARTIES-IN-INTEREST:

Section 3(14) of ERISA defines a party-in-interest to include, among others, fiduciaries or employees of the Plan, any person who provides services to the Plan or an employer whose employees are covered by the Plan. Accordingly, loans to participants and the management of investments held by the custodians are considered party-in-interest transactions.

F. TAX STATUS:

The Internal Revenue Service ("IRS") has determined and informed Transamerica Retirement Solutions, the sponsor of the volume submitter profit sharing plan document adopted by the plan, by a favorable opinion letter dated March 31, 2017 that the volume submitter 403(b) plan document is designed in accordance with applicable sections of the IRC. Although the Plan has been amended since receiving the opinion letter, the plan administrator believes that the Plan is designed and is currently being operated in compliance with the applicable requirements of the IRC.

Accounting principles generally accepted in the United States of America require plan management to evaluate tax positions taken by the plan and recognize a tax liability if the plan has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

G. CERTIFIED INVESTMENTS:

Certain information related to investments and notes receivable from participants disclosed in the accompanying financial statements, including investments and notes receivable from participants held at December 31, 2023 and 2022, and net appreciation (depreciation) in fair value of investments and interest and dividends for the year ended December 31, 2023, was obtained by management and agreed to or derived from information certified as complete and accurate by State Street Bank & Trust Company, Transamerica Financial Life Insurance Company Inc., Reliance Trust Company, The Variable Annuity Life Insurance Company, Fidelity Management Trust Company, Metropolitan Life Insurance Company, and American General Life Insurance Company, the custodians of the Plan.

H. PLAN TERMINATION:

Although the Plan was established with the intention that it will continue indefinitely, the Company retains the right to discontinue its contributions at any time or to terminate the Plan, subject to the provisions of ERISA. In the event of plan termination, all participants will become 100% vested in their accounts.

I. RISKS AND UNCERTAINTIES:

The Plan invests in various investment securities. Investment securities are exposed to various risks, such as interest rate, market and credit risks. Market risks include global events which could impact the value of the investment securities. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the value of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits.

J. PLAN MERGER:

Effective December 31, 2023, the Cheshire Medical Center Employee Investment Plan merged with and into the Dartmouth-Hitchcock Employee Investment Plan and ceased to exist as a separate plan as of that date. The total value of assets transferred to the Dartmouth-Hitchcock Employee Investment Plan was \$117,911,482.

K. SUBSEQUENT EVENTS:

The Company has evaluated subsequent events through September 27, 2024, the date these financial statements were available for issuance.
