Opinion

We have audited the financial statements of Pridgeon & Clay, Inc. Employee Stock Ownership Plan (the "Plan"), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), which comprise the statement of net assets available for benefits as of December 31, 2023 and 2022 and the related statement of changes in net assets available for benefits for the years then ended, and the related notes to the financial statements.

Responsibilities of Management for the Financial Statements

Management is responsible for the preparation and fair presentation of the financial statements in accordance with accounting principles generally accepted in the United States of America and for the design, implementation, and maintenance of internal control relevant to the preparation and fair presentation of financial statements that are free from material misstatement, whether due to fraud or error.

In preparing the financial statements, management is required to evaluate whether there are conditions or events, considered in the aggregate, that raise substantial doubt about the Plan's ability to continue as a going concern within one year after the date that the financial statements are issued or available to be issued.

Note 1 - Plan Description

The following description of Pridgeon & Clay, Inc. Employee Stock Ownership Plan (the "Plan") provides only general information. Participants should refer to the plan agreement for a more complete description of the Plan's provisions.

General

Pridgeon & Clay, Inc. (the "Company") established the Plan effective as of January 1, 1999. The Plan operates as an employee stock ownership plan (ESOP) and is intended to meet the requirements of Section 4975(e)(7) of the Internal Revenue Code of 1986. The Plan is a defined contribution plan covering substantially all full-time nonunion employees of the Company except nonresident aliens who have completed one year of service, with at least 1,000 hours worked; are employed on the last day of the plan year; and are age 21 or older. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA). Effective June 29, 2018, the Plan was frozen to new participants.

Contributions

The Company makes annual contributions to the Plan, as approved by the Company's board of directors. Starting in 2018, the Plan is no longer leveraged, and any contributions made to the Plan by the Company are discretionary.

The employer contribution to the Plan for each plan year shall not be less than the amount necessary for the Plan to discharge its obligations if applicable. On December 31 each year, each participant is credited with his or her allocable share of the employer's contributions for that year, shares released for allocations, account forfeitures, and dividends on stock already in his or her account. The net investment income from investments is also allocated on December 31 each year. Investment income and administrative expenses are allocated in the ratio of the balance in each participant's investment account at the preceding valuation date to that of all participants' investment accounts on that date. Contributions are allocated based on the ratio that the participant's compensation for the plan year bears to the total compensation of all eligible participants for the plan year. Participants are not required or permitted to make contributions to the Plan.

Vesting

Total disability, death, three years of service, or attainment of normal retirement age entitle the participant or beneficiary to be fully vested.

Forfeitures

If a participant is not fully vested on his or her termination date, the nonvested amount of the account is forfeited. The Company allocates forfeitures to participants based on the participant's compensation, as defined. Allocations of forfeitures are considered additional company contributions and are subject to the vesting provisions of company contributions.

Benefit Payments

Distributions are payable upon retirement, death, disability, or termination of employment in the form of a lump sum, a series of five annual installments over a period of no more than five years, or a combination of both, equal to the vested balance of the participant's account.

Voting Rights

Each participant is entitled to exercise, in certain matters, voting rights attributable to the shares allocated to his or her account as long as the trustee is notified prior to the time that such rights are to be exercised. The trustee is not permitted to vote for any allocated share for which instructions have not been given by a participant.

Note 1 - Plan Description (Continued)

Diversification

Participants who have attained the age of 55 and have completed at least 10 years of participation in the Plan are eligible to receive up to 25 percent of the value of the participant's account, less any prior diversification distributions for a 5-year period. At the end of the sixth year after the participant becomes eligible for diversification distributions, participants are eligible to receive up to 50 percent of the value of the participant's account, less any prior diversification distributions.

Put Option

Under federal income tax regulations, the employer stock that is held by the Plan and its participants and is not readily tradable on an established market, or is subject to trading limitations, includes a put option. The put option is a right to demand that the Company buy any shares of its stock distributed to participants for which there is no market. The put price is representative of the fair market value of the stock.

Party-in-interest Transactions

At December 31, 2023 and 2022, the Plan held 103,863 and 109,462 shares, respectively, of common stock of the Company. The shares had a cost basis of \$5,127,596 and \$5,615,753 for the years ended December 31, 2023 and 2022, respectively. During the years ended December 31, 2023 and 2022, the Plan recorded no dividend income on the stock. During 2023, the Plan sold 5,599 shares of company stock at \$95 per share to the Company for a total of \$531,905. During 2022, the Plan sold 9,305 shares of company stock at \$80 per share to the Company for a total of \$744,320.

Termination

While it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of the Plan. Upon termination of the Plan, the employee benefits administration committee shall direct the trustees to sell shares of financed common stock to the extent it determines such sale to be necessary in order to repay any outstanding loans. In no event will the Company receive any amounts upon termination of the Plan or upon a discontinuance of contributions. Starting in 2018, the Plan is no longer leveraged, and any contributions made to the Plan by the Company are discretionary.

Upon termination, all expenses properly chargeable to the Plan are to be satisfied out of proceeds from the sale of the Plan's assets, and all remaining assets are to be vested in the participants and distributed to them in the same proportion as the interests appear, as participants are 100 percent vested as of their termination date. Such distributions shall be made by the trustees, as directed by the plan administrator.

Note 2 - Summary of Significant Accounting Policies

Investment Valuation and Income Recognition

Investments held by the Plan are stated at fair value. Fair value is defined as the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See Note 5 for further discussion of fair value measurements.

Benefit Payments

Benefits are recorded when paid.

Administrative Expenses

Various administrative costs are paid by the Company.

Note 2 - Summary of Significant Accounting Policies (Continued)

Use of Estimates

The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities and disclosure of contingent assets and liabilities at the date of the financial statements and the reported amounts of additions and deductions during the reporting period. The most significant assumptions and estimates relate to the valuation of company common stock. Application of these assumptions requires the exercise of judgment as to future uncertainties, and, as a result, actual results could differ from those estimates.

Risks and Uncertainties

The Plan's primary investment is company stock. The company stock value is based on an independent appraisal as of year end. There are significant assumptions inherent in the appraisal of the company stock, and changes in these assumptions could have a significant impact on the financial statements. Due to the level of risk associated with the investment in company stock and the level of uncertainty related to changes in the value of such stock, it is at least reasonably possible that changes in the values of the company stock will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statement of net assets available for benefits.

Subsequent Events

The financial statements and related disclosures include evaluation of events up through and including September 18, 2024, which is the date the financial statements were available to be issued.

Note 3 - Tax Status

The Plan has received a determination letter from the Internal Revenue Service indicating that the Plan, as designed, is qualified for tax-exempt treatment under the applicable section of the Internal Revenue Code (IRC). Although the Plan has been amended since receiving the determination letter, management believes that the Plan is designed and is currently being operated in compliance with the applicable requirements of the IRC.

Note 5 - Fair Value Measurements

Accounting standards require certain assets and liabilities be reported at fair value in the financial statements and provide a framework for establishing that fair value. The framework for determining fair value is based on a hierarchy that prioritizes the valuation techniques and inputs used to measure fair value.

Level 1

Fair values determined by Level 1 inputs use quoted prices in active markets for identical assets that the Plan has the ability to access.

Note 5 - Fair Value Measurements (Continued)

Level 2

Fair values determined by Level 2 inputs use other inputs that are observable, either directly or indirectly. These Level 2 inputs include quoted prices for similar assets in active markets, quoted prices for identical or similar assets in markets that are not active, and inputs other than quoted prices that are observable for the asset.

Level 3

Level 3 inputs are unobservable inputs, including inputs that are available in situations where there is little, if any, market activity for the related asset. These Level 3 fair value measurements are based primarily on management's own estimates using pricing models, discounted cash flow methodologies, or similar techniques taking into account the characteristics of the asset.

The following valuation methodologies have been used to value the Plan's investments:

Common Stock

As of December 31, 2023 and 2022, company stock is classified as Level 3 in the fair value hierarchy. The company stock is classified as a Level 3 investment based on the fair value determined by an annual independent appraisal. The appraisal is based on the income and market approaches, including the capitalization of cash flow method and guideline transaction method. The appraiser took into account historical and projected cash flow; adjusted earnings before interest, taxes, depreciation, and amortization (EBITDA); appropriate discount rates; and comparable company transactions. Significant Level 3 inputs include the financial condition of the Company, the earnings capacity of the Company, the guideline company method, and the marketability of the stock.

Interest-bearing Cash

As of December 31, 2023 and 2022, interest-bearing cash is classified as Level 2 in the fair value hierarchy. The interest-bearing cash is valued at the outstanding balance, which is the best estimate of fair value.
