Management's estimate of the fair value measurements of investments is based on the information provided by Fidelity Management Trust Company, the trustee. We evaluated the key factors and assumptions used to develop the fair value measurements of investments in determining that it is reasonable in relation to the financial statements taken as a whole.

The financial statement disclosures are neutral, consistent, and clear.

### *Form 5500 Procedures*

We are required to obtain and read a substantially complete draft of Form 5500 prior to dating our auditor's report. The purpose of this procedure is to identify any material inconsistencies between the draft Form 5500 and the Plan's financial statements. We identified no material inconsistencies in performing and completing our audit.

### *Difficulties Encountered in Performing the Audit*

We encountered no significant difficulties in performing and completing our audit.

### *Corrected and Uncorrected Misstatements*

Professional standards require us to accumulate all misstatements identified during the audit, other than those that are clearly trivial, and communicate them to the appropriate level of management. Management has corrected all such misstatements.

### *Disagreements with Management*

For purposes of this letter, a disagreement with management is a disagreement on a financial accounting, reporting, or auditing matter, whether or not resolved to our satisfaction, that could be significant to the financial statements or the auditor's report. We are pleased to report that no such disagreements arose during the course of our audit.

### *Management Representations*

## 1. Description of Plan

The following brief description of the Progrexion Holdings, Inc. (the “Company”) 401(k) Plan (the “Plan”) is provided for general information only. Participants should refer to the Plan agreement for a more complete description of the Plan’s provisions.

*General.* The Plan is a defined contribution 401(k) plan covering all employees of the Company who are eighteen or older. Upon satisfying the eligibility requirements, employees are auto-enrolled at a 3% contribution level and may modify their contribution level or opt-out at their discretion. The Plan is subject to the provisions of ERISA. Plan management is responsible for oversight of the Plan. The Investment Committee determines the appropriateness of the Plan’s investment offerings, monitors investment performance and reports to Plan management.

*Contributions.* Each year, participants may elect to make contributions of up to 100% of their eligible compensation, as defined by the Plan. Participants who have attained age 50 before the end of the Plan year are eligible to make catch-up contributions. Participants may also contribute amounts representing distributions from other qualified defined benefit or defined contribution plans (rollovers). Participants direct the investment of their contributions to various investment options offered by the Plan.

The Company makes a Safe Harbor Matching Contribution on behalf of each eligible participant in an amount equal to 100% of a participant’s elective deferrals up to 3% of their eligible compensation, plus 50% of the amount of the elective deferral that exceeds 3% of their eligible compensation but does not exceed 5% of the participant’s total eligible compensation. Employees must have attained age eighteen and completed six months of service to be eligible for the Safe Harbor contributions. For the year ended December 31, 2023, Safe Harbor matching contributions totaling \$1,277,682 were made.

The Company may also make a discretionary contribution to the Plan on the behalf of the participants. For the year ended December 31, 2023, no discretionary Company contributions were made.

All contributions are subject to certain IRS limitations.

*Participant Accounts.* Each participant’s account is credited with the participant’s contribution and Company matching contributions, as well as allocations of the Company’s profit-sharing contributions and Plan earnings. Participant accounts are charged with an allocation of administrative expenses that are paid by the Plan. Allocations are based on participant earnings, account balances, or specific participant transactions, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant’s vested account.

## 1. Description of Plan (continued)

*Vesting.* Participants are fully vested at all times in their own contributions and Safe Harbor Matching contributions, and the related earnings on those contributions. Vesting in the Company's discretionary contributions is based on years of continuous service and a participant is 100 percent vested after four years of credit service.

*Notes Receivable from Participants.* Participants may borrow up to 50 percent of their vested account balance with a maximum of \$50,000. The loans are secured by the balance in the participant's account and bear interest of prime plus 1 percent. Principal and interest is paid ratably through payroll deductions.

*Distributions and Withdrawals* – On termination of service due to death, total disability, or retirement, a participant is eligible to receive either a lump sum distribution equal to the participant's vested account balance, or installments (annually, quarterly, or monthly) over a specified period of time, not exceeding the life expectancy of the participant of the designated beneficiary. Prior to the normal retirement age, as defined by the Plan, a participant who is 59 ½ or older is eligible to receive an in-service distribution. A participant may also withdraw in a lump sum up to 100% of their vested balance in their elective deferral account to pay for any financial hardship as defined in the Plan.

*Forfeited Accounts.* Forfeitures on unvested portions of Company matching contributions may be used to pay Plan expenses or offset future employer contributions. As of December 31, 2023 and 2022, the Plan had \$65,099 and \$103,704, respectively, of unallocated forfeitures. During the year ended December 31, 2023, \$34,077 of unallocated forfeitures were used to fund company matching contributions.

## 2. Summary of Significant Accounting Policies

### *Basis of Accounting*

The financial statements of the Plan are prepared on the accrual basis of accounting.

### *Use of Estimates*

The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities and changes therein, and disclosure of contingent assets and liabilities. Actual results could differ from those estimates.

## 2. Summary of Significant Accounting Policies (continued)

### *Investment Valuation and Income Recognition*

Investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. The Plan's Investment Committee determines the Plan's valuation policies utilizing information provided by the investment advisers, custodians, and insurance company. See Note 4 for discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation/depreciation includes the Plan's gains and losses on investments bought and sold as well as held during the year.

### *Notes Receivable from Participants*

Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Interest income is recorded on the accrual basis. Related fees are recorded as administrative expenses and are expensed when they are incurred. No allowance for credit losses has been recorded as of December 31, 2023 and 2022.

### *Payment of Benefits*

Benefits are recorded when paid.

### *Administrative expenses*

Certain expenses of maintaining the Plan are paid by the Plan, unless otherwise paid by the Company. Expenses that are paid by the Company are excluded from these financial statements. Fees related to the administration of notes receivable from participants are charged directly to the participant's account and are included in administrative expenses. Investment related expenses are included in net appreciation/depreciation of fair value of investments.

### *Subsequent Events*

The Plan has evaluated subsequent events through August 7, 2024, the date the financial statements were available to be issued. During 2022, due to a negative outcome from a litigation matter, the plan sponsor has made significant changes to their business that resulted in the loss of revenue and the need to restructure the organization. As a result of the changes, on June 4, 2023, the plan sponsor filed for Chapter 11 bankruptcy protection. During 2023, the Company began operating under a new entity, Credit.com Holdings, LLC. The Plan, as then constituted, was adopted by this new entity. A new 401k/Profit Sharing Plan was created, effective January 1, 2024, and all assets were transferred to the new plan, resulting in the termination of the Progrexion Holdings, Inc. 401(k) Plan.

### 3. Information Certified by the Plan’s Trustee

Certain information related to investments and notes receivable from participants disclosed in the accompanying financial statements and ERISA-required supplemental schedule, including investments and notes receivable from participants held at December 31, 2023 and 2022, and net depreciation in fair value of investments, interest and dividends, and interest income on notes receivable from participants for the year ended December 31, 2023, was obtained by management and agreed to or derived from information certified as complete and accurate by Fidelity Management Trust Company, the Plan’s Trustee.

### 4. Fair Value Measurements

Financial Accounting Standards Board (FASB) *Accounting Standards Codification (ASC) 820, Fair Value Measurements and Disclosures*, provides the framework for measuring fair value. That framework provides a fair value hierarchy that prioritizes inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1 measurements) and the lowest priority to unobservable inputs (Level 3 measurements).

The three levels of the fair value hierarchy under FASB ASC 820 are described as follows:

Level 1	Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the plan has the ability to access.
Level 2	<p>Inputs to the valuation methodology include:</p> <ul style="list-style-type: none"> <li>• quoted prices for similar assets or liabilities in active markets;</li> <li>• quoted prices for identical or similar assets or liabilities in inactive markets;</li> <li>• inputs other than quoted prices that are observable for the asset or liability;</li> <li>• inputs that are derived principally from or corroborated by observable market data by correlation or other means.</li> </ul> <p>If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.</p>
Level 3	Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset or liability’s fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used maximize the use of observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at December 31, 2023 and 2022.

#### 4. Fair Value Measurements (continued)

*Interest-bearing cash:* Valued at cash balance at the Plan’s year end.

*Common/collective trusts:* Valued at the dollar value of one mutual fund’s share, excluding any sales charges or redemption fees. The NAV is calculated by subtracting liabilities from the value of a funds’ total assets and dividing it by the number of fund’s shares outstanding.

*Mutual Funds:* Valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-end mutual funds that are registered with the Securities and Exchange Commission. These funds are required to publish their daily net asset value (NAV) and to transact at the price. The mutual funds held by the Plan are deemed to be actively traded.

#### 5. Party-in-Interest Transactions

Certain plan investments are shares of funds managed by Fidelity Management Trust Company, the trustee, and therefore, these transactions qualify as party-in-interest transactions. Any purchases and sales of these funds are open market transactions at fair market value. Consequently, such transactions are permitted under the provisions of the Plan and are exempt from the prohibition of party-in-interest transactions under ERISA. The Plan also issues loans to participants which are secured by the vested balance of the participants’ accounts.

## **5. Party-in-Interest Transactions (continued)**

Certain accounting and administrative functions are performed by officers or employees of the Company. No such officer or employee receives compensation from the Plan. In addition, the Company pays certain outside administrative expenses of the Plan.

## **6. Plan Termination**

The Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, participants would become 100 percent vested in their employer contributions. As described in footnote two, subsequent events, the plan terminated effective December 31, 2023 and all assets were transferred to a new plan named Credit.com Holdings 401(k) Plan, effective January 1, 2024.

## **7. Tax Status**

In an opinion letter dated June 30, 2020, the Internal Revenue Service ruled that the Plan Volume Submitter Document qualifies under Section 401(a) of the Internal Revenue Code (“IRC”) and is, therefore, not subject to tax under present income tax laws. Once qualified, the Plan is required to operate in conformity with the IRC to maintain its qualification. The Plan Administrator is not aware of any course of action or series of events that have occurred that might adversely affect the Plan’s qualified status.

Accounting principles generally accepted in the United States of America require Plan management to evaluate tax positions taken by the Plan and recognize a tax liability if the Plan has taken an uncertain position that more likely than not would be sustained upon examination by the Department of Labor (“DOL”). The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress. The Plan administrator believes it is no longer subject to income tax examinations for the years prior to 2020.

## **8. Risks and Uncertainties**

The Plan invests in various investment securities. Investment securities are exposed to various risks, such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants’ account balances and the amounts reported in the statements of net assets available for benefits.
