We have performed audits of the financial statements of the Atotech 401(k) & Retirement Plan (the Plan), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C). The financial statements comprise the statements of net assets available for benefits as of December 31, 2023 and 2022, and the related statement of changes in net assets available for benefits for the year ended December 31, 2023, and the related notes to the financial statements.

The effective date of the merger was December 31, 2023 and the transfer of assets occurred on December 29, 2023. Our opinion is not modified with respect to this matter.

### ***Responsibilities of Management for the Financial Statements***

Management is responsible for the preparation and fair presentation of the financial statements in accordance with GAAP, and for the design, implementation, and maintenance of internal control relevant to the preparation and fair presentation of financial statements that are free from material misstatement, whether due to fraud or error. Management's election of the ERISA Section 103(a)(3)(C) audit does not affect management's responsibility for the financial statements.

### 1. Description of Plan

The following description of the Atotech 401(k) & Retirement Plan (the Plan) provides only general information. Participants should refer to the Plan document for a more complete description of the Plan's provisions.

#### *General*

The Plan was a defined contribution plan established February 1, 2017, covering substantially all employees of Atotech USA, LLC (the Company or the Employer), except leased employees, non-resident aliens, interns, and co-op employees. Eligible employees could participate upon date of hire. The Plan was subject to the provisions of the Employee Retirement Income Security Act of 1974, as amended (ERISA). In August 2022, the plan sponsor was acquired by MKS Instruments, Inc. In December 2023, the Plan transferred all the assets to a related plan as more fully described in Note 7.

#### *Trustee and Administration of the Plan*

The trustee and recordkeeper of the Plan was Fidelity Management Trust Company (Fidelity or trustee). The administrator of the Plan was the Company. The trustee held all assets of the Plan in accordance with the service provider contract with the Company. The Investment Committee determined the appropriateness of the Plan's investment offerings and monitored investment performance.

#### *Contributions*

Prior to the plan merger, the amount of contributions during the 2023 plan year was equal to the sum of the following:

- a) Participants could contribute up to 50% of their eligible compensation in the form of pre-tax annual compensation and after-tax compensation, as defined in the Plan and subject to Internal Revenue Code (IRC) limitations. Participants were auto enrolled at 6% of eligible compensation, upon attainment of eligibility requirements unless they affirmatively elected not to participate in the Plan. Participants who had attained age 50 before the end of the Plan year were eligible to make catch-up contributions.
- b) The Employer contributed a Safe Harbor matching contribution totaling 100% of the first 4% of annual eligible compensation that a participant contributed to the Plan. Temporary and part-time employees must have performed 1 year and 1,000 hours of service to be eligible for the matching contributions.
- c) Employees were permitted to make after-tax Roth contributions.
- d) The Employer also contributed a non-elective Employer contribution equal to 2% of eligible compensation per pay period during 2023. During 2023, the Employer contributed approximately \$323,000 in non-elective Employer contributions.
- e) In addition, participants could have contributed amounts representing distributions from other qualified defined benefit or defined contribution plans (rollover contributions).

Contributions were subject to certain Internal Revenue Service (IRS) limitations.

### ***Participant Accounts***

Each participant's account was credited with the participant's contributions, the Employer contributions, and an allocation of net plan earnings or losses. Participant accounts were charged with an allocation of administrative expenses that were paid by the Plan. Allocations were based upon participant earnings, account balances, or specific participant transactions, as defined. The benefit to which a participant was entitled was the benefit that was provided from the participant's vested account.

### ***Vesting***

Participants were immediately vested in their contributions, plus all Employer contributions, and any actual earnings thereon.

### ***Forfeitures***

At December 31, 2023 and 2022, forfeited non-vested accounts totaled \$0 and \$3,338, respectively. These accounts were able to be used to pay administrative expenses and reduce employer contributions, although none were used during the year ended December 31, 2023.

### ***Notes Receivable from Participants***

Participants could borrow from a minimum of \$1,000 up to a maximum of 50% of the participant's vested account balance, not to exceed \$50,000, reduced by the highest outstanding loan balance in their account during the prior 12-month period. Each participant was permitted to have a maximum of one loan outstanding at any time. The maximum term of repayment for loans, other than those utilized to purchase a primary residence, was five years. The loans were secured by the balance in the participant's vested account and bear interest at prime plus 1%. Principal and interest were paid ratably through payroll deductions. These loans were subject to certain restrictions as defined by the Plan Document and applicable restrictions under the IRC.

### ***Benefit Payments***

Participants were permitted to receive benefits upon termination of service, attainment of normal retirement age, death, or disability. A participant could have elected to receive either a lump-sum amount equal to the value of the participant's vested interest in his or her account, or equal annual installments over a period of not more than the participant's assumed life expectancy. For participants who had account balances of less than \$1,000 as of the date of termination of service, the Employer may have automatically distributed the participant's account with a lump-sum payment. Alternatively, for balances between \$1,000 and \$5,000, the Employer may have automatically rolled over the participant's account to a qualified retirement account. Participants may have received in-service withdrawals in the form of hardship distributions from the participant's deferral contribution account only, subject to a \$500 minimum. Participants were permitted to receive in-service withdrawals upon attainment of age 59½ from their vested account balance.

### 2. Summary of Accounting Policies

#### *Basis of Accounting*

The financial statements of the Plan were prepared under the accrual basis of accounting in accordance with accounting principles generally accepted in the United States of America (GAAP).

#### *Investment Valuation and Income Recognition*

The investments of the Plan were reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date (the exit price). Plan management determined the Plan's valuation policies utilizing information provided by investment advisors and the Trustee. See Note 4 for a discussion on fair value measurements.

Purchases and sales of securities were recorded on a trade-date basis. Interest income was recorded on the accrual basis. Dividends were recorded on the ex-dividend date. Net appreciation in the fair value of investments included the Plan's gains and losses on investments bought and sold as well as held during the year.

#### *Notes Receivable from Participants*

Notes receivable from participants are participant loans measured at the unpaid principal balance plus unpaid accrued interest. The Plan considered a loan to be in default if any repayment remained unpaid as of the last business day of the calendar quarter following the calendar quarter in which a loan was initially considered past due. Defaulted notes receivable from participants were deemed distributed and recorded as benefits paid to participants in the statement of changes in net assets available for benefits.

#### *Use of Estimates*

The preparation of financial statements in conformity with GAAP requires Plan management to make estimates and assumptions that affect the reported amounts of assets, liabilities, and changes therein, and disclosure of contingent assets and liabilities. Actual results may differ from those estimates.

#### *Administrative Expenses*

Certain expenses of maintaining the Plan were paid by the Plan, unless otherwise paid by the Company. Expenses that were paid by the Company are excluded from these financial statements. Fees related to participant-initiated transactions were charged directly to the participant's account and were included in administrative expenses. Investment-related expenses are included in net appreciation in fair value of investments.

#### *Benefit Payments*

Benefits were recorded when paid.

### 3. Certified Investment Information

Certain information related to investments and notes receivable from participants disclosed in the accompanying financial statements, including investments and notes receivable from participants held at December 31, 2023 and 2022, and net appreciation in fair value of investments, interest and dividends, and interest income on notes receivable from participants for the year ended December 31, 2023, was obtained by management and agreed to or derived from information certified as complete and accurate by Fidelity, a qualified institution.

### 4. Fair Value Measurements

Accounting Standards Codification (ASC) 820, *Fair Value Measurements*, provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1 measurements) and the lowest priority to unobservable inputs (Level 3 measurements). The three levels of the fair value hierarchy under ASC 820 are described as follows:

**Level 1:** Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

**Level 2:** Inputs to the valuation methodology include:

- quoted prices for similar assets or liabilities in active markets;
- quoted prices for identical or similar assets or liabilities in inactive markets;
- inputs other than quoted prices that are observable for the asset or liability; and
- inputs that are derived principally from, or corroborated by, observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

**Level 3:** Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset or liability's level within the fair value hierarchy was based on the lowest level of any input that was significant to the fair value measurement. Valuation techniques maximize the use of relevant observable inputs and minimize the use of unobservable inputs.

There is not a fair value hierarchy table as of December 31, 2023 since the investments of the Plan were transferred out on December 29, 2023, as more fully described in Note 7. The following was a description of the valuation methodologies used for assets measured at fair value as of December 31, 2022:

**Mutual Funds:** Mutual funds represented investments with various investment managers. The mutual funds were valued at the daily closing net asset value as reported by the fund. Mutual funds held by the Plan were registered with the Securities and Exchange Commission. These funds were required to publish their daily net asset value (NAV) and to transact at that price. The mutual funds held by the Plan were deemed to be actively traded.

**Common/Collective Trust:** Common/collective trusts (CCTs) represented investments with various investment managers. Units held in CCTs were valued at NAV. The NAV, as provided by the trustee, was used as a practical expedient to estimated fair value. The NAV was based on the fair value of the underlying investments held by the fund, which were traded in an active market, less its liabilities. This practical expedient was not used when it was determined to be probable that the fund would sell the investment for an amount different than the reported NAV. There were no unfunded commitments or redemption restrictions on the CCT held by the Plan. The CCT held by the Plan was a direct filing entity.

The preceding methods described above may have produced a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, although the Plan believes its valuation methods were appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could have resulted in a different fair value measurement at the reporting date.

### 5. Risks and Uncertainties

The Plan held various investment securities. Investment securities, in general, are exposed to various risks such as interest rate risk, credit risk, and overall market volatility. Due to the level of risk associated with certain investment securities, it is reasonably possible that changes in the values of investment securities would have occurred in the near term and that such changes could materially affect the amounts reported in the financial statements and participant account balances.

### 6. Related Party and Party-in-Interest Transactions

Certain plan investments were shares of mutual funds managed by Fidelity, the Plan's trustee and recordkeeper. Certain administrative fees were paid to Fidelity (as described in Note 2). These transactions qualified as exempt party-in-interest transactions. In addition, notes receivable from participants were also considered exempt party-in-interest transactions.

### 7. Transfer To Other Qualified Plan

Effective December 31, 2023, the Plan transferred the assets out to a related plan sponsored by MKS Instruments, Inc. The amount transferred out to the MKS Instruments, Inc. Profit Sharing & 401(k) Plan was \$40,729,602, which included participant loans of \$233,230. The funds were transferred out on December 29, 2023 and received by the MKS Instruments, Inc. ### 8. Tax Status

The Plan used a pre-approved plan document sponsored by FMR LLC, which is a part of Fidelity. FMR LLC received an opinion letter from the IRS, dated June 30, 2020, which stated that the pre-approved plan document, as then designed, satisfies the applicable provisions of the IRC. Although the Plan has been amended since the date of the opinion letter, Plan management believed that the Plan was currently designed and being operated in compliance with the applicable requirements of the IRC.

GAAP requires plan management to evaluate tax positions taken by the Plan and recognize a tax liability (or asset) if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.
