

### 1. Description of Plan

The following description of 403(b) Thrift Plan of Amanecer Community Counseling Services (“the Plan”) provides only general information. Participants should refer to the Plan’s agreement for a more complete description of the Plan’s provisions.

#### General

The Plan is a defined contribution 403(b) tax-sheltered annuity plan covering all eligible employees of Amanecer Community Counseling Services (“Amanecer”) except for nonresident aliens with no U.S. source of income, independent contractors, leased employees and those employees who would be eligible to participate in other retirement plans as defined in the Plan. The Plan was established on June 20, 2006 and, amended and restated on September 30, 2014. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (“ERISA”) and Section 403(b) of the Internal Revenue Code.

The Board of Directors is responsible for oversight of the Plan. The appropriateness of the Plan’s investment options, and the investment performance is monitored by the Board of Directors.

#### Plan Administration

Amanecer is the administrator of the Plan and has delegated certain responsibilities for the operation and administration of the Plan. Custodians and recordkeeping services are provided by Mutual of America Life Insurance Company (“MOA”) and Variable Annuity Life Insurance Company (“VALIC”), a subsidiary of American Insurance Group.

#### Contributions

A participant becomes eligible to make contributions to the Plan on the first day of the month following 30 days of employment. Each year, the participants may contribute up to the maximum limit as permitted by the Internal Revenue Code (“the Code”). Additionally, participants with at least 15 years of services are also eligible to make special catch-up contributions. Participants may also contribute amounts representing distribution from other eligible retirement plans.

Amanecer makes matching contributions up to 4% of annual compensation. Participants are eligible for employer matching contributions twelve months after date of hire.

Effective January 1, 2016, all participants who become eligible on or after the effective date will be automatically enrolled in the Plan at a deferral rate of 2% of their eligible compensation.

#### Participant Accounts

Each participant’s account is credited with his or her contributions and earnings and allocations of Amanecer’s contributions and the Plan’s earnings. The benefit to which a participant is entitled is the benefit that can be provided from the participant’s vested account.

### 1. Description of Plan, continued

#### **Vesting**

Participants are immediately vested in their contributions plus actual earnings thereon. Vesting in Amanecer's contributions is based on years of continuous service. A participant is fully vested in matching contributions after three years of credited service.

#### **Investment Options**

Upon enrollment in the Plan, a participant may direct employee contributions in any of the investment options offered by MOA. Participants may change their investment options at any time.

#### **Notes Receivable**

Participants may borrow against their account balances to a maximum loan term of five years. The minimum amount is \$1,000 while the maximum amount is the lesser of \$50,000 or 50% of their vested account balances. The maximum loan term is five years, except for loans for the purchase of a primary residence which may be up to ten years. The loans bear interest at varying rates and principal and interest are paid ratably through semi-monthly payroll deductions.

Loans require the participant to maintain an equal amount of the loan value in loan collateral and loan escrow fund accounts for loans held with VALIC and an amount equal to 120% of the loan value in an interest accumulation general account for loans held with MOA. Principal and interest is paid ratably directly to the custodians.

#### **Payment of Benefit**

Upon termination of service due to retirement, death, disability, or other reasons, a participant may elect to receive an amount equal to the fair value of the participant's vested account balance as: 1) a lump sum or installment distribution, 2) income under an annuity, or 3) transfer to an individual retirement arrangement or another qualified employer plan.

### 2. Summary of Significant Accounting Policies

A summary of the significant accounting policies applied in the preparation of the accompanying financial statements is as follows:

#### **Basis of Presentation**

The accompanying financial statements have been prepared on the accrual basis of accounting.

#### **2. Summary of Significant Accounting Policies, continued**

##### **Investment Valuation and Income Recognition**

Investments are stated at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. Interest income is recorded on the accrual basis. Net appreciation (depreciation) includes the Plan's gains and (losses) on investments bought and sold as well as held during the year.

##### **Payment of Benefits**

Benefits are recorded when paid.

##### **Notes Receivable**

Notes receivable from participants represent participant loans that are recorded at their unpaid balance plus any accrued but unpaid interest. Interest income on notes receivable from participants is recorded when it is earned, and related fees are recorded as administrative expenses and expensed when incurred.

##### **Fair Value Measurements**

Generally accepted accounting principles provide guidance on how fair value should be determined when financial statement elements are required to be measured at fair value. Valuation techniques are ranked in three levels depending on the degree of objectivity of the inputs used with each level:

Level 1 inputs - quoted prices in active markets for identical assets

Level 2 inputs - quoted prices in active or inactive markets for the same or similar assets

Level 3 inputs - estimates using the best information available when there is little or no market

The Plan is required to measure certain investments at fair value. The specific techniques used to measure fair value for the financial statement element is described in the notes below that relates to the element.

##### **Use of Estimates**

The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires the plan administrator to make estimates and assumptions that affect certain reported amounts and disclosures as of the date and for the period presented. Actual results could differ from those estimates.

**Administrative Expenses**

Plan participants pay the fees associated with individual distributions. The plan sponsor absorbs all administrative expenses of the Plan other than contract services charged by the custodians. During the years ending December 31, 2023 and 2022, total contract charges were \$1,023 and \$1,571, respectively.

**Risks and Uncertainties**

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rates, market volatility, and credit risks. Market risks include global events which could impact the value of investments securities, such as a pandemic or international conflict. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities may occur in the near term and that such changes could materially affect participants' account balances and the amount reported in the statement of net assets available for benefits.

**Subsequent Events**

Management has evaluated subsequent events through August 8, 2024, the date which the financial statements were available for issue. No events or transactions have occurred during this period that appear to require recognition or disclosure in the financial statements.

**3. Notes Receivable from Participants**

Loans to participants are repaid through semi-monthly payroll deductions with interest rates ranging from 4.60% to 6.00%. Loans to participants outstanding at December 31, 2023 and 2022, were \$109,130 and \$114,626, respectively.

**7. Related Party and Party-in-Interest Transactions**

Certain administrative functions are performed by officers and employees of Amanecer. No officer or employee received compensation from the Plan for these services.

Fees incurred by the Plan for investment management services are included in net depreciation in fair value of investments, which were not covered by revenue sharing. The Plan also made direct payments to service providers which were not covered by revenue sharing.

**8. Plan Termination**

Although it has not expressed any intent to do so, Amanecer has the right under the Plan to discontinue its contributions at any time and to terminate the Plan, subject to the provisions of ERISA. In the event of plan termination, participants will become 100% vested in their accounts.

**9. Tax Status**

The Plan has been designed to qualify under Section 403(b) of the Code. The terms of the Plan have been prepared to conform with the sample language provided by the Internal Revenue Service ("IRS") in Revenue Procedure 2007-71. The Plan is required to operate in conformity with the Code to maintain the tax-exempt status for plan participants under Section 403(b).

Accounting principles generally accepted in the United States of America require the plan administrator to evaluate tax positions taken by the Plan and recognize a tax liability for any uncertain position that more likely than not would not be sustained upon examination by the IRS. The Plan is subject to routine audits by tax authorities; however, there are currently no audits for any tax periods in progress. The plan administrator believes the Plan is no longer subject to income tax examinations for years prior to 2020.
