**Note 1 - Plan Description**

The following description of Maple Knoll Communities, Inc. 401(k) Plan (the "Plan"), provides only general information. Participants should refer to the plan agreement for a more complete description of the Plan's provisions.

Effective February 1, 2024, the Plan merged into the BHI Senior Living, Inc. Employee Retirement Plan. Accordingly, the descriptions below are provisions of the Plan prior to the merger. See Note 7 for additional information.

***General***

The Plan is a defined contribution 401(k) plan providing eligible employees of Maple Knoll Communities, Inc. and its subsidiaries (collectively, the "Company") a means of accumulating funds for retirement through employee and employer contributions. The Plan is open to substantially all employees who have met certain age and service requirements, as defined in the Plan. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA).

***Contributions***

The Plan includes a cash or deferred arrangement allowed under Section 401(k) of the Internal Revenue Code (IRC). Under this arrangement and subject to plan provisions, participants may elect to defer, up to a maximum amount allowed, their eligible compensation to the Plan. The Plan allows participants age 50 and older to make catch-up contributions. Participants may also contribute amounts representing distributions from other qualified defined benefit or contribution plans and certain individual retirement accounts (IRAs).

Each year, at its discretion, the employer may choose to make a matching contribution. There were no discretionary matching contributions for the period from January 1, 2024 through February 1, 2024 or the year ended December 31, 2023.

The Company also makes a safe harbor nonelective contribution to the Plan in an amount equal to 3 percent of compensation.

In order for a participant to share in the allocation of a safe harbor nonelective contribution, he or she must complete 1,000 hours of service during the plan year and be employed on the last day of the plan year. The Company's nonelective allocation rate group structure is as follows: (1) directors and executives, (2) RN/salaried, and (3) hourly.

Contributions to the Plan were not permissible following December 31, 2023.

***Participant Accounts***

Each participant's account is credited with the participant's contributions and allocations of the Company's discretionary matching and/or nonelective contributions and investment earnings and charged with withdrawals and an allocation of investment losses. Allocations are based on participants' earnings or account balances, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

***Vesting***

Participants are immediately vested in their own contributions, company safe harbor contributions, and rollovers, plus earnings thereon. Vesting in the Company's discretionary matching and/or nonelective contributions portion of their accounts, plus earnings thereon, is based on years of continuous service.

**Note 1 - Plan Description (Continued)**

***Participant Notes Receivable***

Participants may borrow from their accounts a minimum of \$1,000 up to a maximum equal to the lesser of \$50,000 reduced by the excess (if any) of the highest outstanding balance of notes during the one-year period ending on the day before the note is made, over the outstanding balance of notes from the Plan on the date the note is made, or 50 percent of their vested account balances as of the most recent valuation date. The loans are secured by the balance in the participant's account. Interest on the loans is set at the time of loan issuance at a rate commensurate with rates currently being charged by commercial lenders for loans made under similar circumstances. Principal and interest are paid ratably through payroll deductions.

***Benefit Payments***

Participants may withdraw their contributions and the vested portion of the Company's discretionary matching and nonelective contributions upon hardship, retirement, attainment of age 59½, termination of service, disability, or death. In the event of a participant's death, payment will be made to designated beneficiaries. For termination of service, a participant may receive the vested percentage of the account balance in a lump-sum distribution, partial lump-sum distribution and partial installment payments, installment payments, or a joint and survivor annuity that can be provided from the participant's account. Vested account balances not exceeding \$1,000 will be payable in a lump sum as soon as practicable.

***Forfeitures***

If a participant is not fully vested on his or her termination date, the nonvested amount of the account is forfeited. Forfeitures are used to reduce employer contributions.

***Termination***

While it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions set forth in the plan agreement and ERISA.

Upon termination of the Plan, participants became 100 percent vested in their account balances.

Effective February 1, 2024, the Plan merged into the BHI Senior Living, Inc. Employee Retirement Plan (see Note 7). This Plan merger does not represent a termination of the Plan; therefore, plan participants' vesting percentages remained the same.

***Party-in-interest Transactions***

Certain plan assets are in investment funds managed by Reliance Trust Company and Standard Insurance Company or their affiliates. Reliance Trust Company is the custodian of the Plan, and Standard Insurance Company is the recordkeeper of the Plan; therefore, these transactions qualify as party-in-interest transactions, as defined under ERISA guidelines.

**Note 2 - Summary of Significant Accounting Policies**

***Investment Valuation and Income Recognition***

Investments held by the Plan are stated at fair value except as noted below. Fair value is defined as the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See Note 5 for further discussion of fair value measurements.

The fully benefit-responsive unallocated contract is valued at contract value. Contract value is the amount participants normally would receive if they were to initiate permitted transactions under the terms of the Plan. Contract value represents deposits made to the contract, plus earnings at guaranteed crediting rates, less withdrawals and fees.

**Note 2 - Summary of Significant Accounting Policies (Continued)**

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded as earned. Dividends are recorded on the ex-dividend date.

***Participant Notes Receivable***

Participant notes receivable are recorded at their unpaid principal balances plus any accrued interest. Participant notes receivable are written off when deemed uncollectible.

***Benefit Payments***

Benefits are recorded when paid.

***Administrative Expenses***

The Company pays certain administrative expenses on behalf of the Plan.

***Use of Estimates***

The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities and disclosure of contingent assets and liabilities at the date of the financial statements and the reported amounts of additions and deductions during the reporting period. Actual results could differ from those estimates.

***Risks and Uncertainties***

The Plan invests in various investment securities. Investment securities are exposed to various risks, such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the financial statements.

***Subsequent Events***

The financial statements and related disclosures include evaluation of events up through and including October 3, 2024, which is the date the financial statements were available to be issued.

**Note 3 - Certified Information**

Reliance Trust Company (the "Custodian") holds the Plan's investments and executes all investment transactions. The investment balances and related investment income and losses included in the accompanying financial statements and supplemental schedule of assets held at end of year are based solely on information certified by the Custodian. Outstanding participant note receivable balances and related interest are not certified by the Custodian.

**Note 4 - Tax Status**

The Plan uses a preapproved plan. The preapproved plan has received a favorable opinion letter from the Internal Revenue Service (IRS) indicating that the Plan, as designed, is qualified for federal income tax-exempt status. The Plan has received a determination letter from the IRS.

**Note 5 - Fair Value Measurements**

Accounting standards require certain assets and liabilities be reported at fair value in the financial statements and provide a framework for establishing that fair value. The framework for determining fair value is based on a hierarchy that prioritizes the valuation techniques and inputs used to measure fair value.

**Note 5 - Fair Value Measurements (Continued)**

***Level 1***

Fair values determined by Level 1 inputs use quoted prices in active markets for identical assets that the Plan has the ability to access.

***Level 2***

Fair values determined by Level 2 inputs use other inputs that are observable, either directly or indirectly. These Level 2 inputs include quoted prices for similar assets in active markets, quoted prices for identical or similar assets in markets that are not active, and inputs other than quoted prices that are observable for the asset.

***Level 3***

Level 3 inputs are unobservable inputs, including inputs that are available in situations where there is little, if any, market activity for the related asset. These Level 3 fair value measurements are based primarily on management's own estimates using pricing models, discounted cash flow methodologies, or similar techniques taking into account the characteristics of the asset.

In instances where inputs used to measure fair value fall into different levels of the fair value hierarchy, fair value measurements in their entirety are categorized based on the lowest level input that is significant to the valuation. The Plan's assessment of the significance of particular inputs to these fair value measurements requires judgment and considers factors specific to each asset.

The following valuation methodology has been used to value the Plan's investments:

***Mutual Funds***

Mutual funds are valued at closing quoted prices reported in active markets and are classified as Level 1 investments measured at fair value. Mutual funds totaled \$0, \$19,456,849, and \$16,947,950 as of February 1, 2024; December 31, 2023; and December 31, 2022, respectively.

**Note 6 - Investment Contract**

The Plan has a benefit-responsive investment contract with Standard Insurance Company (Standard). Standard maintains the contributions in a general account. The account is credited with earnings on the underlying investments and charged for participant withdrawals and administrative expenses. The investment contract issuer is contractually obligated to repay the principal and a specified interest rate that is guaranteed to the Plan.

Interest is credited on contract balances using a single portfolio rate approach. Under this methodology, a single interest rate is applied to all contributions made to the product, regardless of the timing of those contributions. Interest crediting rates are reviewed on a quarterly basis for resetting. When establishing interest crediting rates for this product, Standard considered many factors, including current economic and market conditions, the general interest rate environment, and both the expected and actual experience of a reference portfolio within the issuer's general account. The minimum crediting rate under the contract is 1.00 percent.

Generally, there are no events that could limit the ability of the Plan to transact at contract value or, in rare circumstances, contract value paid over time. There are no events that allow the issuer to terminate the contract and that require the plan sponsor to settle an amount different than contract value paid either by a lump sum or over time. There was no impact to contract value as a result of the plan merger.

**Note 7 - Plan Merger**

Effective February 1, 2024, the Plan merged into the BHI Senior Living, Inc. Employee Retirement Plan. Accordingly, all assets, participants, and their related account balances were transferred to the BHI Senior Living, Inc. Employee Retirement Plan during 2024.
