We have performed audits of the accompanying financial statements of The Contractors Retirement Plan Sponsored by HC West, LLC dba A & D Fire, an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C). The financial statements comprise the statements of net assets available for benefits as of December 31, 2023 and 2022, and the related statement of changes in net assets available for benefits for the year ended December 31, 2023, and the related notes to the financial statements.

NOTES TO THE FINANCIAL STATEMENTS
December 31, 2023 and 2022

NOTE 1--DESCRIPTION OF PLAN

The following description of The Contractors Retirement Plan Sponsored by HC West, LLC dba A & D Fire, (the Plan) provides only general information. Participants should refer to the plan agreement for a more complete description of the Plan's provisions.

- General : The Plan, which was adopted on March 1, 1995 and amended on January 11, 2021, is a defined contribution plan covering substantially all employees of HC West, LLC dba A & D Fire (the Company). The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA). The Plan Administrator is responsible for oversight of the Plan. The Plan Administrator is responsible for oversight of the Plan and determines the appropriateness and monitors performance of the Plan's investment offerings.
- Contributions : Employer profit-sharing contributions: The Company may make a discretionary profit-sharing contribution to the Plan. The contributions would be allocated to participants account in the same ratio as the participant's compensation bears to total compensation of eligible participants. Each participant will be vested in employer contributions per the vesting schedule. The Company has elected to not make a discretionary profit-sharing contribution for the year ended December 31, 2023.
- Employer prevailing wage contributions: The Company makes a prevailing wage contributions to the Plan. The scheduled prevailing wage contribution shall be an amount equal to the hourly contribution rate of the participant's employment classification. Such contributions are 100% vested and non-forfeitable. The Company made prevailing wage contributions of \$740,492 for the year ended December 31, 2023.
- Participant rollover contributions: Participants may also contribute amounts representing distributions from other qualified defined contribution or defined benefit plans (rollover). Such contributions are 100% vested and non for non-forfeitable.
- Eligibility to participate : Employees are immediately eligible to participate in the Plan as of the next succeeding entry date, which is the date the employee was hired.
- Notes receivable from participants : Participants may borrow from their fund accounts a minimum of \$1,000 up to a maximum equal to the lesser of \$50,000 or 50% of their account balance. The loans are secured by the balance in the participant's account. The loan interest rate is set at 1% above the prime rate. At December 31, 2023, the prime rate was 8.5%.

NOTE 1--DESCRIPTION OF PLAN (Continued)

- Participant accounts : Participants direct the investment of their contributions into various investment options offered by the Plan. If a participant has not elected investment options, contributions will be directed to the default investments as determined by the plan administrator. Individual accounts are maintained for each plan participant. Each participant's account is credited with the participant's contributions, rollover contributions, an allocation of the employer's profit-sharing contributions, prevailing wage contributions and plan earnings. Participant accounts are charged with an allocation of administrative expenses that are paid by the Plan. Allocations are based on participant earnings, account balances, or specific participant transactions, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.
- Payment of benefits : On termination of service due to death, disability, or retirement, a participant may elect to receive a lump sum amount equal to the value of the participant's vested interest in his or her account. For termination of service for other reasons, a participant may receive the value of the vested interest in his or her account as a lump sum distribution. The distribution shall be made to the participant or beneficiary in accordance with the election of the participant.
- Vesting : Participants are vested immediately in their employer prevailing wage contributions and rollover contributions plus actual earnings thereon. Vesting in the remainder of their accounts employer profit sharing contribution is based on years of continuous service. Accrued benefits vest as follows:

3	40%

5	80%
6 or more	100%

For vesting purposes, a year of service is defined as a plan year in which an employee works at least 1,000 hours or the total of an employee's countable periods of service without regard to hours of service.

Participants become fully vested upon termination for reason of retirement, death or disability, or if the Plan is terminated. Non-vested benefits are forfeited by participants upon termination for reasons other than normal retirement, death or disability.

NOTE 2--SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES

- Basis of accounting : The financial statements of the Plan are presented on the accrual basis of accounting.

NOTE 2--SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES (Continued)

- Administrative expenses : Certain expenses of maintaining the Plan are paid directly by the Company and are excluded from these financial statements. Fees related to the administration of notes receivable from participants and to distributions from participant accounts are charged directly to the participant's account and are included in administrative expenses. Investment related expenses are included in net appreciation of fair value of investments.
- Investment valuation and income recognition : Investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See Note 4 for discussion of fair value measurements.
- Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation includes the Plan's gains and losses on investments bought and sold as well as held during the year.
- Notes receivable from participants : Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Interest income is recorded on the accrual basis. Related fees are recorded as administrative expenses and are expensed when incurred. No allowance for credit losses have been recorded as of December 31, 2023 and 2022. If a participant ceases to make loan repayments and the plan administrator deems the participant loan to be in default, the participant loan balance is reduced and a benefit payment is recorded.
- Payment of benefits : Benefits are recorded when paid.
- Subsequent events : The Plan has evaluated subsequent events through October 1, 2024, the date the financial statements were available to be issued.
- Use of estimates : The preparation of financial statements in accordance with accounting principles generally accepted in the United States of America requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities and changes therein, and disclosure of contingent assets and liabilities. Actual results could differ from those estimates.

NOTE 3--CERTIFIED INFORMATION

The Plan administrator has elected the method of annual reporting compliance permitted by ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. Accordingly, ERISA SMART Trust Division, a qualified institution, has certified that the following investment information included in the accompanying financial statements and ERISA-required supplemental schedule is complete and accurate:

- Investments and notes receivable from participants as shown in the statements of net assets available for benefits as of December 31, 2023 and 2022.
- Investment income (loss) and interest income on notes receivable from participants as shown in the statement of changes in net assets available for benefits for the year ended December 31, 2023.

NOTE 3--CERTIFIED INFORMATION (Continued)

- Investment information included in Note 4, and the schedule of assets (held at end of year) as of December 31, 2023, as shown on the ERISA-required supplemental schedule.

At the request of the Plan administrator, the Plan's independent auditors did not perform auditing procedures with respect to this certified investment information, except for comparing such certified investment information to the related investment information included in the financial statements and ERISA-required supplemental schedule.

NOTE 4--FAIR VALUE MEASUREMENTS

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (level 1 measurements) and the lowest priority to unobservable inputs (level 3 measurements). The asset's or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs. The three levels of the fair value hierarchy under FASB ASC 820 and a description of the valuation methodologies used for assets measured at fair value are described as follows:

Level 1 Fair Value Measurements

Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

The Plan held no level 1 assets as of December 31, 2023 and 2022.

Level 2 Fair Value Measurements

Inputs to the valuation methodology include (a) quoted prices for similar assets or liabilities in active markets, (b) quoted prices for identical or similar assets or liabilities in inactive markets, (c) inputs other than quoted prices that are observable for the asset or liability or (d) inputs that are derived principally from or corroborated by observable market data by correlation or other means. If the asset or liability has a specified (contractual) term, the level 2 input must be observable for substantially the full term of the asset or liability.

The Plan held no level 2 assets as of December 31, 2023 and 2022.

Level 3 Fair Value Measurements

Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The Plan held no level 3 assets as of December 31, 2023 and 2022.

The methods described above may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, while plan management believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

In accordance with fair value measurement guidance, certain investments that are measured at fair value using the net asset value per share (or its equivalent) practical expedient have not been classified in the fair value hierarchy.

NOTE 4--FAIR VALUE MEASUREMENTS (Continued)

Master Trust is valued at fair value based on the NAV of units held in the trust. The NAV, as provided by the Master Plan Sponsor is used as a practical expedient to estimate fair value. The NAV is based on the observable market prices of the underlying investments within the trust less liabilities. This practical expedient is not used when it is determined to be probable that the trust will sell the investment for an amount different than the reported NAV.

Investments, at fair value, that are valued using NAV as a practical expedient totaled \$3,659,258 and \$2,757,009, respectively at December 31, 2023 and 2022.

NOTE 5--INVESTMENT IN PLAN TRUST

The Plan invests in a group trust, The Contractors Retirement Plan Master Trust (Master Trust), sponsored by Fringe Benefit Group, Inc. Under the terms of the plan document, all assets of the Plan are maintained in the Master Trust.

The Master Trust files a Form 5500 as a 103-12 Investment Entity.

The plan administrator has elected the method of compliance permitted by 29 CFR 2520.103-12 of the department of Labor Rules and Regulations for Reporting and Disclosure under ERISA. Accordingly, as permitted under such election, the following information was not subjected to any auditing procedures performed by the Plan's independent auditor other than comparing such information provided by the Master Trust to information included in the Plan's financial statements and supplemental schedule:

The Contractors Retirement Plan Master Trust does not meet the definition of a master trust as that term is most commonly used. The Plan's investment in the Master Trust represents the allocated net portion of the Master Trust that is attributable to HC West, LLC dba A & D Fire and includes all of the Plan's investments. The Plan's share of the net assets of the Master Trust is based on the underlying participant account values including the effects of contributions, allocated net investment income, withdrawals, and allocated administrative expenses. Net investment income, gains and losses are allocated to participating plans on a daily basis based on participants' investment choices. On December 31, 2023 and 2022, the Plan's interest in the net assets of the Master Trust was less than 1%.

NOTE 5--INVESTMENT IN PLAN TRUST (Continued)

The investments held in the Master Trust are stated at fair value. Investments are valued based on unit values as reported to the Master Trust by insurance companies holding assets for the Master Trust. Certain agreements with insurance companies holding the Master Trust's assets include provisions for withdrawals/surrender fees of up to 5% for participants with less than three years of participation in the Master Trust. These fees were normally charged against the participant's account immediately prior to withdrawal.

NOTE 6--PLAN TERMINATION

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, participants will become 100% vested in their employer contributions.

NOTE 7--TAX STATUS

The Master Plan obtained its latest opinion letter, dated June 30, 2020, in which the Internal Revenue Service stated that the Master Plan was in compliance with the applicable requirements of the Code. Such an opinion is not a determination as to whether HC West, LLC dba A & D Fire qualifies under Code Section 401(a). However, the Plan Administrator believes that the Plan is currently designed and being operated in compliance with the applicable requirements of the Code. Therefore, they believe the Plan was qualified as of the financial statement date.

The Plan follows the provisions of FASB ASC 740, Accounting for Uncertainty in Income Taxes. The Plan Administrator has analyzed the tax positions taken by the plan, and has concluded that as of December 31, 2023, there are no uncertain positions taken or expected to be taken that would require recognition or disclosure in the financial statements. The Plan is subject to routine audits by taxing jurisdiction; however, there are currently no audits for any tax periods in process.

NOTE 8--PARTY-IN-INTEREST TRANSACTIONS

Investment management services are provided by Fringe Benefit Group, Inc. Fringe Benefit Group, Inc. is the Master Plan Sponsor and, therefore, these transactions qualify as party-in-interest transactions. Fees incurred by the Plan for these services are included in net appreciation in fair value of the investment, as they are paid through revenue sharing, rather than a direct payment. The Plan sponsor pays directly any other fees related to the Plan's operations.

NOTE 9--RISKS AND UNCERTAINTIES

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the Statements of Net Assets Available for Benefits.
