### **Scope and Nature of the ERISA Section 103(a)(3)(C) Audit**

We have performed audits of the financial statements of Piper Aircraft Corporation Pension Plan (the Plan), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). The financial statements comprise the statements of net assets in liquidation as of December 31, 2023 and 2022, and the related statements of changes in net assets in liquidation for the years ended December 31, 2023 and 2022, and the statements of accumulated plan benefits in liquidation as of December 31, 2023 and 2022, and the related statements of changes in accumulated plan benefits in liquidation for the years then ended, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audit of the financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. ***Emphasis of Matter - Terminating Plan and Liquidation Basis of Accounting***

As further discussed in Note 1 to the financial statements, the Board of Directors of the Piper Aircraft, Inc., the Plan's sponsor, voted on June 3, 2022 to terminate the plan and management determined liquidation is imminent. As a result, the Plan changed its basis of accounting from the going-concern basis of accounting used in presenting the 2021 financial statements to the liquidation basis of accounting used in presenting the 2023 and 2022 financial statements. Our opinion is not modified with respect to this matter.

***Responsibilities of Management for the Financial Statements***

Management is responsible for the preparation and fair presentation of the financial statements in accordance with accounting principles generally accepted in the United States of America, and for the design, implementation, and maintenance of internal control relevant to the preparation and fair presentation of financial statements that are free from material misstatement, whether due to fraud or error. Management's election of the ERISA Section 103(a)(3)(C) audit does not affect management's responsibility for the financial statements.

In preparing the financial statements, management is required to evaluate whether there are conditions or events, considered in the aggregate, that raise substantial doubt about the Plan's ability to continue as a going concern for one year after the date that the financial statements are issued.

**(1) Description of Plan**

The following brief description of Piper Aircraft Corporation Pension Plan (the Plan) is provided for general purposes only. Participants should refer to the Plan agreement for more complete information.

**(a) General**

The Plan was established May 18, 1987 and is a defined benefit pension plan covering substantially all employees of Piper Aircraft Corporation and its affiliate, Romeo Charlie, Inc. The Plan was amended and restated effective January 1, 1989. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA).

On April 11, 1991, the Plan Committee, with the consent of the Board of Directors of the Company, elected to freeze the accrual of future pension benefits attributable to Plan participants effective May 1, 1991.

On July 17, 1995, Piper Aircraft, Inc. (formerly The New Piper Aircraft, Inc.) (the Company or Sponsor) assumed sponsorship of the Plan.

The Plan was amended January 1, 2020 for certain technical provisions of the plan.

On June 3, 2022, the Company's Board of Directors has approved a resolution authorizing the termination of the Plan effective December 31, 2022. Accordingly, the 2023 and 2022 financial statements have been presented on the liquidation basis of accounting.

The Plan's assets were fully liquidated as of December 31, 2023 and the Plan has been terminated.

**(b) Benefits**

Benefits were frozen as of April 30, 1991, and accordingly, no credited service may accrue after that date. In addition, effective December 31, 2022 the Plan is being terminated.

Employees were eligible for monthly normal retirement benefits beginning at age 65 on a single-life basis equal to one-twelfth of the following:

- (a) 1.3% times final annual earnings not in excess of covered compensation times years of credited service from July 1, 1985 (or hire date, if later) to normal retirement date (not to exceed 25 years), plus
- (b) 1.8% times final average earnings in excess of covered compensation times years of credited service from July 1, 1985 (or hire date, if later) to normal retirement date (not to exceed 25 years), plus

- (c) The accrued benefit from the Piper Hourly Plan as of June 30, 1985 in the form of a Single Life Annuity, minus
- (d) The accrued benefit from the Lear Siegler, Inc. Pension Plan (the predecessor pension plan) as of May 17, 1987.

The Plan provided for early retirement at age 55 and completion of 10 years of credited service with reduced benefits. Early retirement monthly benefits are the accrued benefit reduced by one-half percent for each month that benefits commence prior to the normal retirement date.

**(c) Administration**

The Plan is administered by the pension committee appointed by the Board of Directors of the Company. All expenses of administering the Plan are paid by the Company and are not reflected in the accompanying financial statements.

**(2) Summary of Significant Accounting Policies****(a) Basis of Accounting**

The financial statements of the Plan have been prepared on the accrual basis of accounting.

In accordance with the termination of the Plan discussed in note 1, the 2023 and 2022 financial statements have been prepared on the liquidation basis of accounting. In accordance with the liquidation basis of accounting, an accrual for estimated Company contributions, estimated earnings, estimated expenses, and estimated termination payments to Participants in either annuity purchases or lump-sum distributions, through final liquidation has been included in the accompanying financial statements as of December 31, 2023 and 2022 and for the years then ended.

**(b) Valuation of Investments**

Investments are stated at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See note 5 for discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade date basis. Net appreciation includes realized gains and losses on investments bought and sold during the year as well as unrealized gains and losses on investments held during the year. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date.

**(c) Actuarial Present Value of Accumulated Plan Benefits and Assumptions**

Accumulated plan benefits are those future periodic payments, including lump-sum distributions that are attributable under the Plan's provisions to the service employees have rendered. Accumulated plan benefits include benefits expected to be paid to (a) retired or terminated employees or their beneficiaries, and (b) present employees or their beneficiaries. Benefits under the Plan are as described in note 1(b). Benefits payable under all circumstances – retirement, death, disability, and termination of employment – are included, to the extent they are deemed attributable to employee service rendered to the valuation date.

The actuarial present value of accumulated plan benefits was determined by consulting actuaries by applying actuarial assumptions to adjust the accumulated Plan benefits to reflect the time value of money (through discounts for interest) and the probability of payment (by means of decrements such as for death, disability, withdrawal, or retirement) between the valuation date and the expected date of payment.

Since the Plan terminated effective December 31, 2022, the significant actuarial assumptions underlying the actuarial computations had incorporated the applicable termination standards as follows:

- Assumed rates of return to value accumulated benefits using the following segments:
  - 1<sup>st</sup> Segment: 5.09%
  - 2<sup>nd</sup> Segment: 5.60%
  - 3<sup>rd</sup> Segment: 5.41%
- Mortality basis – IRS Applicable Table for 2023 for Section 417(e).

During the year ended December 31, 2023, the estimated effect on accumulated plan benefits to terminate the Plan was decreased by \$232,777 as a result of the final composition of lump-sum distributions, annuity purchases, and distribution to PBGC for unconfirmed participants.

**(d) Payment of Benefits**

Benefit payments to participants are recorded upon distribution.

**(e) Use of Estimates**

The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires the Plan administrator to make estimates and assumptions that affect the reported amounts of assets, liabilities, and changes therein; disclosure of contingent assets and liabilities; and the actuarial present value of accumulated plan benefits at the date of the financial statements, and changes therein. Actual results could differ from those estimates.

**(3) Funding Policy**

The Sponsor had agreed to voluntarily contribute such additional amounts as are necessary to provide assets sufficient for the payment of benefits to be paid to Plan members. The Plan's assets were determined to be sufficient to meet such payments in termination and no contributions were required during 2023 or 2022. See note 7.

**(4) Certified Investments (Unaudited)**

All investment information disclosed in the accompanying financial statements and ERISA-required supplemental schedules, including investments held at December 31, 2023 and 2022 and investment income for the years then ended was obtained by management and agreed to or derived from information certified as complete and accurate by Empower Trust Company, LLC, an affiliate of Empower Annuity Insurance Company of America, as of December 31, 2023 and for the year then ended and as of December 31, 2022 and for the period of September 19, 2022 through December 31, 2022, and Reliance Trust Company as of September 20, 2022 and for the period then ended.

**(5) Fair Value of Investments**

The Plan follows the provisions of the Fair Value Measurements and Disclosures Topic of the FASB ASC, which established a framework for measuring fair value. That framework provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1 measurements) and the lowest priority to unobservable inputs (Level 3 measurements).

The three levels of the fair value hierarchy are described below:

Level 1 – Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2 – Inputs to the valuation methodology include: quoted prices for similar assets or liabilities in active markets; quoted prices for identical or similar assets or liabilities in inactive markets; inputs other than quoted market prices that are observable for the asset or liability; and inputs that are derived principally from or corroborated by observable market data by correlation or other means. If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

Level 3 – Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset's or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

The following is a description of the valuation methodologies used for assets measured at fair value:

Pooled Separate Account funds – Valued at the observable unit net asset value of the underlying mutual fund investment.

The methods described above may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, while the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

The Plan's investment assets at fair value consisting of the MassMutual Premier U.S. Government Money Market Fund with balances of \$-0- and \$7,159,294 as of December 31, 2023 and 2022, respectively, were considered Level 2 investments within the fair value hierarchy.

#### **(6) *Party-in-Interest Transactions***

Certain Plan investments are shares of funds managed by Empower Retirement, which acquired the retirement plan business of MassMutual on December 31, 2020. Empower Retirement was the trustee as defined by the Plan and, therefore, these transactions qualify as party-in-interest. The Plan pays administrative expenses to Empower Annuity Insurance Company of America (formerly Great West Life & Annuity Ins. Co.), affiliate of Empower Retirement and contract administrator for the Plan, for investment management services. These expenses amounted to \$325,882 and \$79,450 for the years ended December 31, 2023 and 2022, respectively, and are recorded as administrative expenses.

**(7) *Plan to Plan Transfers***

The Plan's termination resulted in net assets totaling \$492,315 in excess of final participant benefits and distributions, including expense reimbursements subsequently received by the Sponsor. In accordance with applicable DOL regulations, \$419,737 and \$72,578 was transferred in 2023 and 2024, respectively, into the Piper Aircraft, Inc. Retirement Savings Plan.

**(8) *Termination of the Plan***

As discussed in note 1, the Company had authorized the termination of the Plan, effective December 31, 2022. In accordance with the provisions set forth in ERISA, all participants have become 100% vested in benefits earned as of the termination date.

Under the Plan termination, the net assets of the Plan were allocated, as prescribed by ERISA and its related regulations, generally to provide the following benefits in the order indicated:

- (a) Annuity benefits former employees or their beneficiaries have been receiving for at least three years, or that employees eligible to retire for that three-year period would have been receiving if they had retired with benefits in the normal form of annuity under the Plan. The priority amount is limited to the lowest benefit that was payable (or would have been payable) during those three years. The amount is further limited to the lowest benefit that would be payable under Plan provisions in effect at any time during the five years preceding Plan termination.
- (b) Other vested benefits insured by the Pension Benefit Guaranty Corporation (PBGC) (a U.S. governmental agency) up to the applicable limitations as discussed below.
- (c) All other vested benefits not insured by PBGC.
- (d) All nonvested benefits.

Certain benefits under the Plan are insured by PBGC if the Plan terminates. Generally, PBGC guarantees most vested normal age retirement benefits, early retirement benefits, and certain disability and survivor's pensions. However, PBGC does not guarantee all types of benefits under the Plan, and the amount of benefit protection is subject to certain limitations. Vested benefits under the Plan are guaranteed at the level in effect on the date of the Plan's termination. However, there is a statutory ceiling on the amount of an individual's monthly benefit that PBGC guarantees. For plan terminations occurring during 2022, that ceiling, which is adjusted periodically, was \$6,205 per month. This ceiling applies to those pensioners who elect to receive their benefits in the form of a single-life annuity and are at least 65 years old at the time of retirement or plan termination. For younger annuitants or for those who elect to receive their benefits in some form more valuable than a single-life annuity, the corresponding ceilings are actuarially adjusted downward.

**(9) Tax Status**

The Plan was established pursuant to provisions of the Internal Revenue Code (IRC) and ERISA. The Company has received a favorable determination letter from the Internal Revenue Service dated July 8, 2020 regarding the qualification of the Plan's design under Section 401(a) of the IRC and is exempt from income taxes under Section 501(a) of the IRC. The Plan is subject to routine audits by various taxing jurisdictions. The Plan's open audit periods are 2020 through 2023.

The Plan received a favorable determination letter dated April 14, 2023 regarding the termination of the Plan effective December 31, 2022.

The Plan administrator and the Plan's tax counsel believe the Plan is designed and is currently being operated in compliance with the applicable requirements of the Internal Revenue Code. Therefore, no provision for income taxes has been included in the Plan's financial statements.

**(10) Risks and Uncertainties**

The Plan invested in various investment funds that were subject to various risks that determine the value of the fund. Due to the level of risk associated with certain financial instruments and the level of uncertainty related to changes in the value of these investments, it is at least reasonably possible that changes in market conditions in the near term could materially affect participants' account balances and the value of investments reported in the financial statements.

**(11) Reconciliation of the Financial Statements to Form 5500**

As discussed in notes 1 and 2, the financial statements have been prepared on the liquidation basis of accounting, which is different from the presentation in the Form 5500. The difference in the accounting between the financial statements and the Form 5500 are reconciled in the following tables.



