## Independent Auditor's Report

To the Trustees of the Foreland Refining Corporation 401(k) Profit Sharing Plan & Trust:

### **Scope and Nature of the ERISA Section 103(a)(3)(C) Audit**

We have performed an audit of the accompanying financial statements of Foreland Refining Corporation 401(k) Profit Sharing Plan & Trust, an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C). The financial statements comprise the statement of net assets available for benefits as of November 22, 2023 and December 31, 2022, and the related statement of changes in net assets available for benefits for the years then ended, and the related notes to the financial statements. The plan was terminated effective December 31, 2022 and all assets were transferred as of November 22, 2023.

Management, having determined it is permissible in the circumstances, has elected to have the audit of Foreland Refining Corporation 401(k) Profit Sharing Plan & Trust's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. As permitted by ERISA Section 103(a)(3)(C), our audit need not extend to any statements or information related to assets held for investment of the plan (investment information) by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA (qualified institution).

Management obtained a certification from a qualified institution as of and for the year ended December 31, 2022, stating that the certified investment information, as described in Notes 3 and 4 to the financial statements, is complete and accurate. As there were no assets left to certify, no certification was provided for 2023. The information on insurance annuity contracts was not covered by a certification for either year.

### **Opinion**

In our opinion, based on our audit and on the procedures performed as described in the Auditor's Responsibilities for the Audit of the Financial Statements section—

- the amounts and disclosures in the financial statements referred to above, other than those agreed to or derived from the certified investment information, are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America.
- the information in the financial statements referred to above related to assets held by and certified to by a qualified institution agrees to, or is derived from, in all material respects, the information prepared and certified by an institution that management determined meets the requirements of ERISA Section 103(a)(3)(C).

### **Basis for Opinion**

We conducted our audit in accordance with auditing standards generally accepted in the United States of America. Our responsibilities under those standards are further described in the Auditor's Responsibilities for the Audit of the Financial Statements section of our report. We are required to be independent of Foreland Refining Corporation 401(k) Profit Sharing Plan & Trust and to meet our other ethical responsibilities in accordance with the relevant ethical requirements relating to our audit. We believe that the audit evidence we have obtained is sufficient and appropriate to provide a basis for our ERISA Section 103(a)(3)(C) audit opinion.

### **Responsibilities of Management for the Financial Statements**

Management is responsible for the preparation and fair presentation of these financial statements in accordance with accounting principles generally accepted in the United States of America, and for the design, implementation, and maintenance of internal control relevant to the preparation and fair presentation of financial statements that are free from material misstatement, whether due to fraud or error. Management's election of the ERISA Section 103(a)(3)(C) audit does not affect management's responsibility for the financial statements.

In preparing the financial statements, management is required to evaluate whether there are conditions or events, considered in the aggregate, that raise substantial doubt about Foreland Refining Corporation 401(k) Profit Sharing Plan & Trust's ability to continue as a going concern for one year after the date the financial statements are available to be issued.

Management is also responsible for maintaining a current plan instrument, including all plan amendments; administering the plan; and determining that the plan's transactions that are presented and disclosed in the financial statements are in conformity with the plan's provisions, including maintaining sufficient records with respect to each of the participants, to determine the benefits due or which may become due to such participants.

Our audit did not extend to the certified investment information, except for obtaining and reading the certification, comparing the certified investment information with the related information presented and disclosed in the financial statements, and reading the disclosures relating to the certified investment information to assess whether they are in accordance with the presentation and disclosure requirements of accounting principles generally accepted in the United States of America.

Accordingly, the objective of an ERISA Section 103(a)(3)(C) audit is not to express an opinion about whether the financial statements as a whole are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America.

We are required to communicate with those charged with governance regarding, among other matters, the planned scope and timing of the audit, significant audit findings, and certain internal control-related matters that we identified during the audit.

**1 – Description of the Plan**

The following description of the Foreland Refining Corporation 401(k) Profit Sharing Plan & Trust (the "Plan"), provides only general information. The Plan Document would have a more complete description of the Plan's provisions. See note 6 about plan termination which was effective December 31, 2022.

**General** - The Plan was a defined contribution plan covering all full-time employees of Foreland Refining Corporation (the "Plan Sponsor" or the "Company"). It was subject to the provisions of the Employment Retirement Income Security Act of 1974 (ERISA). The administrative committee was responsible for the oversight of the Plan. The investment committee determined the appropriateness of the Plan's investment offerings, monitored investment performance and reported to the administrative committee.

**Eligibility** - Employees of the Company became eligible to participate in the Plan at the age of eighteen and after two months of completed service, provided they were not excluded employees. They could enter the Plan the first day of the month once the above requirements had been met.

**Contributions** - All eligible employees could make elective deferral contributions into the Plan. For each year the Company elected to make a discretionary matching contribution, the Company contributed to the Plan an amount equal to 50% of the participant's contribution that did not exceed 5% of compensation. The Company could elect to make a matching contribution on employee elective deferral contributions in excess of the minimum, but was not obligated to do so per the Plan Document. The Company could also elect to make a discretionary profit sharing contribution. Participants could also contribute amounts representing distributions from other qualified plans (rollover contributions). Eligible participants could make an additional catch-up contribution to the Plan. Contributions were subject to certain Internal Revenue Code limitations.

**Vesting** - A participant's elective deferral account balance was always 100% vested. If the Company made a qualified matching contribution or profit sharing contribution, the participant was 0% vested until three years of service. At three years, the participant became 100% vested. A year of service was defined as 1,000 hours of service during a plan year.

**Participant accounts** - Each participant's account was credited with the participant's contribution and allocation of the Company's contribution, if any, and Plan earnings, if any, and could have been charged with an allocation of administrative expenses paid by the Plan. The Company's contribution was allocated to participants based upon the participant's considered compensation for the Plan year. Allocation of Plan earnings to participants was based on the performance of participant selected investment options as defined in the Plan Document. The benefit to which a participant was entitled was the benefit that could have been provided from the participant's vested account.

The Plan provided that participants could direct how their account balance was invested among the investment alternatives offered by the Plan.

**Payment of benefits** - On termination of service due to death, disability or retirement (defined as reaching your 65th birthday or the 5th anniversary of joining the Plan, if later), a participant could elect to receive either a lump-sum amount equal to the value of the participant's vested benefit or receive the vested benefit in partial withdrawals of at least \$1,000. If the value of the vested account balance was \$5,000 or less the balance would have been distributed in a single lump-sum payment.

**Notes receivable from participants** - Participants could borrow from their fund account balances a minimum of \$1,000 up to a maximum of \$50,000 or 50% of their vested account balance, whichever was less. The loans were secured by the balance in the participant's account and bore interest at a fixed rate equal to 1% above the prime rate. Principal and interest was paid ratably through payroll deductions or by check (for prepayments only).

**Forfeited accounts** - As allowed in the Plan Documents, forfeitures could first be used to pay any administrative expenses. Any remaining forfeitures would have been used by the Company to reduce the employer matching contribution. Forfeited non-vested accounts totaled \$0 and \$15,779 for the years ended

November 22, 2023 and December 31, 2022. Forfeited non-vested accounts applied to administrative expenses or employer contributions was \$0 and \$7,508, respectively. A balance of \$15,931 was converted to the new plan.

**Significant plan amendments** - Effective May 2022, the Plan made a change to the third-party administrator as well as the custodian of the mutual funds. At this time the Plan also went through a name change going from Foreland Refining Corporation 401(k) Plan to Foreland Refining Corporation 401(k) Profit Sharing Plan & Trust. The Sponsor (Foreland Refining Corporation) was sold effective September 30, 2022. The plan remained the same under the new owner until December 31, 2022 when it was terminated. See Note 6 on Plan termination.

In addition, eligibility requirements saw a change from requiring three months of service down to two months of service. The entry date was changed from the first day of the plan quarter following the completion of all eligibility requirements to the first day of the plan month following the completion of all eligibility requirements. Prior to amendment the Plan Sponsor paid for Plan expenses and they were not included in the financials.

## **2 – Significant accounting policies**

**Basis of accounting** - The financial statements of the Plan are prepared using the accrual method of accounting in accordance with generally accepted accounting principles.

**Management estimates** - The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities and changes therein, and disclosure of contingent assets and liabilities. Actual results could differ from those estimates.

**Investment valuation and income recognition** - In 2022, the fair value was used to value the Plan's investments in mutual funds. See note 4 for a discussion of fair value measurements, including account value.

The Plan's investments in insurance annuity contracts and guaranteed investment contracts was reported at contract value, as defined by the contract with the insurance company. Contract value is based on the value of underlying investment subaccounts adjusted for fees associated with account maintenance and surrender charges. See notes 5 and 6 for a discussion of insurance contracts.

Purchases and sales of securities are recorded on a trade-date basis. Interest is recorded on the accrual basis. The Plan presents in the statement of changes in net assets the net appreciation (depreciation) in the fair value of investments, which consists of the realized gains (or losses) and the unrealized appreciation (depreciation) on those investments.

**Notes receivable from participants** - Participant loans were measured at their unpaid principal balances plus any accrued but unpaid interest. Interest income is recorded on the accrual basis. Related fees are recorded as administrative expenses and are expensed when they are incurred; such fees are included in the account value calculated by the custodian. No allowance for credit losses has been recorded as of November 22, 2023 or December 31, 2022. If a participant ceased to make loan repayments and the plan administrator deemed the participant loan to be in default, the participant loan balance would have been reduced and reclassified as distributions based upon the terms of the Plan Document.

**Payment of benefits** - Benefits are recorded when paid. As the Plan was terminated effective December 31, 2022, all assets were distributed by November 22, 2023, with the majority (about 72%) having been distributed or transferred by February 2023 and about 99% by May 2023.

**Operating expenses** - The Plan allowed for administrative expenses to be paid from Plan assets, such expenses are recorded as incurred. During the period ended December 31, 2022, certain expenses of maintaining the Plan were paid directly by the Plan Sponsor and are excluded from these financial

statements. However, this was amended in May 2022 and all Plan expenses were paid by the Plan. Fees related to the administration of notes receivable from participants are charged directly to the participant's account and are included in net appreciation of fair value of investments. Investment related expenses were also included in net appreciation of fair value of investments.

### 4 – Fair value measurements

The Plan's investments in mutual funds were reported at account value in the accompanying statement of net assets available for benefit. Account value generally approximates the fair value of an investment but includes adjustments for dividends and capital gains distributed by the investment as well as the daily administrative charge assessed to the plan. The methods used to measure account value may produce an amount that may not be indicative of net realizable value or reflective of future fair values. Furthermore, although the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

Financial Accounting Standards Board (FASB) Accounting Standards Codification (ASC) 820, Fair Value Measurements and Disclosures, provides the framework for measuring fair value. That framework provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (level 1 measurements) and the lowest priority to unobservable inputs (level 3 measurements). The three levels of the fair value hierarchy under FASB ASC 820 are described as follows:

#### Level 1

Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

**Level 2**

Inputs to the valuation methodology include

- quoted market prices for similar assets or liabilities in active markets;
- quoted prices for identical or similar assets or liabilities in inactive markets;
- inputs other than quoted prices that are observable for the asset or liability;
- inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the level 2 input must be observable for substantially the full term of the asset or liability.

**Level 3**

Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques maximize the use of relevant observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodologies used for assets measured at account value. There have been no changes in the methodologies used at November 22, 2023 and December 31, 2022.

**Mutual Funds** - Valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-end mutual funds that are registered with the SEC. These funds are required to publish their daily net asset value (NAV) and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.

**5 – Insurance annuity contracts**

The insurance contracts held by the plan included variable annuity contracts which provide a method to allocate premium payments and premium credits in one or more subaccounts, each of which invest in a single investment portfolio. The contract value of these accounts varied daily to reflect the investment performance of a selected investment portfolio, less any applicable fees. Annuitants could receive payments from their subaccounts by taking withdrawals or electing to receive annuity payments over a designated period of time.

The insurance contracts were subject to contingent deferred sales charges (hereinafter "surrender charges") if the contract was surrendered before a specified time period. Surrender charges were based on a percentage of each premium payment withdrawn and are calculated based on the amount requested for withdrawal.

Surrender charges were determined based on the length of time participants owned the annuity. Surrender charges for each annuity contract were calculated from the time of the initial premium payment as follows:

During 2022, one annuity contract was distributed from the plan at cash surrender value. No insurance annuity contracts were purchased during 2023 or 2022. All insurance contracts were considered unallocated contracts as of December 31, 2022.

## 6 – Plan termination

The Company has the right under the Plan to terminate the Plan subject to the provisions of ERISA. The Foreland Refining Corporation 401(k) Profit Sharing Plan & Trust was terminated effective December 31, 2022. All assets in that plan were rolled over to new plans or distributed as appropriate leaving \$0 balance as of November 22, 2023 which is the last date of the plan per Form 5500.

## 7 – Income tax status

The Plan received a favorable opinion letter on a prototype plan from the Internal Revenue Service dated March 31, 2014, that it was a qualified Plan under §401(a) of the Internal Revenue Code and as such the Plan was exempt from federal income tax. The Plan had been amended since the latest amendment covered by the determination letter. However, the plan administrator believes that the Plan was designed and operated in compliance with the applicable requirements of the Internal Revenue Code. Therefore, the administrator believes that the Plan was qualified and the related trust was tax-exempt.

Generally accepted accounting principles requires plan management to determine whether a tax position of the Plan is “more likely than not” to be sustained upon examination, based on the technical merits of the position. For tax positions meeting the “more likely than not” threshold, the tax amount recognized in the financial statements is reduced by the largest benefit that has a greater than fifty percent likelihood of being realized upon ultimate settlement with the relevant taxing authority. There are no uncertain tax positions requiring accrual or disclosure at November 22, 2023. Management is not aware of any tax positions for which it is reasonably possible that amounts of unrecognized tax benefits or liabilities will change significantly in the next twelve months. However, management's conclusions may be subject to future reviews based on changes in, or the interpretation of, tax laws and regulations or the accounting standards. The Plan files returns as prescribed by tax laws in the jurisdictions in which it operates. The Plan's returns for the prior three fiscal years generally remain subject to examination.

## 8 – Risks and uncertainties

The Plan invested in various investment securities and insurance contracts that invested in underlying investment securities. Investment securities are exposed to various risks such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the value of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statement of net assets available for benefits.

## 9 – Related party and party-in-interest transactions

Certain Plan administrative expenses have been paid directly by the Plan Sponsor, this practice could be terminated by the Plan Sponsor at its option. Plan participants have the option of investing in funds that are managed by a custodian of the Plan, such investment transactions qualify as party in interest transactions. Fees incurred by the Plan for certain investment and administrative services are included in net appreciation

in fair value of investments, as they are paid, through revenue sharing, rather than a direct payment. Participants may borrow money from their Plan account balances, such loans are included in the Notes Receivable from Participants line item on the financial statements.

**10 – Subsequent events**

Management has evaluated subsequent events or transactions that occurred after November 22, 2023, through October 7, 2024, the date these financial statements were available to be issued. There were no material recognizable subsequent events due to the termination of the plan effective December 31, 2022.
