INDEPENDENT AUDITORS' REPORT

To the Board of Trustees

Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed audits of the financial statements of Metalforms, LTD 401(k) Profit Sharing Plan (the Plan), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). The financial statements comprise the statements of net assets available for benefits as of December 31, 2023 and 2022, and the related statement of changes in net assets available for benefits for the year ended December 31, 2023, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of the Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's (DOL) Rules and Regulations for Reporting and Disclosure under ERISA. As permitted by ERISA Section 103(a)(3)(C), our audits need not extend to any statements or information related to assets held for investment of the Plan (investment information) by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the DOL's Rules and Regulations for Reporting and Disclosure under ERISA (qualified institution).

Management has obtained certifications from a qualified institution as of December 31, 2023 and 2022, and for the year ended December 31, 2023, stating that the certified investment information, as described in Note 3 to the financial statements, is complete and accurate.

Opinion

In our opinion, based on our audits and on the procedures performed as described in the Auditor's Responsibilities for the Audit of the Financial Statements section:

- The amounts and disclosures in the accompanying financial statements, other than those agreed to or derived from the certified investment information, are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America (U.S. GAAP).
- The information in the accompanying financial statements related to assets held by and certified to by a qualified institution agrees to, or is derived from, in all material respects, the information prepared and certified by an institution that management determined meets the requirements of ERISA Section 103(a)(3)(C).

Basis for Opinion

We conducted our audits in accordance with auditing standards generally accepted in the United States of America (GAAS). Our responsibilities under those standards are further described in the Auditor's Responsibilities for the Audit of the Financial Statements section of our report. We are required to be independent of the Plan and to meet our other ethical responsibilities, in accordance with the relevant ethical requirements relating to our audits. We believe that the audit evidence we have obtained is sufficient and appropriate to provide a basis for our ERISA Section 103(a)(3)(C) audit opinion.

Emphasis of Matter

As explained in Note 5 to the financial statements, the Plan Sponsor elected to terminate the Plan as of May 31, 2023. The last distribution occurred on December 26, 2023. Our opinion has not been modified with respect to this matter.

Responsibilities of Management for the Financial Statements

Management is responsible for the preparation and fair presentation of the financial statements in accordance with U.S. GAAP, and for the design, implementation, and maintenance of internal control relevant to the preparation and fair presentation of financial statements that are free from material misstatement, whether due to fraud or error. Management's election of the ERISA Section 103(a)(3)(C) audit does not affect management's responsibility for the financial statements.

In preparing the financial statements, management is required to evaluate whether there are conditions or events, considered in the aggregate, that raise substantial doubt about the Plan's ability to continue as a going concern within one year after the date that the financial statements are issued or available to be issued.

Management is also responsible for maintaining a current plan instrument, including all plan amendments, administering the Plan, and determining that the Plan's transactions that are presented and disclosed in the financial statements are in conformity with the Plan's provisions, including maintaining sufficient records with respect to each of the participants, to determine the benefits due or which may become due to such participants.

Auditor's Responsibilities for the Audit of the Financial Statements

Except as described in the Scope and Nature of the ERISA Section 103(a)(3)(C) Audit section of our report, our objectives are to obtain reasonable assurance about whether the financial statements as a whole are free from material misstatement, whether due to fraud or error, and to issue an auditor's report that includes our opinion. Reasonable assurance is a high level of assurance but is not absolute assurance and therefore is not a guarantee that an audit conducted in accordance with GAAS will always detect a material misstatement when it exists. The risk of not detecting a material misstatement resulting from fraud is higher than for one resulting from error, as fraud may involve collusion, forgery, intentional omissions, misrepresentations, or the override of internal control. Misstatements are considered material if, there is a substantial likelihood that, individually or in the aggregate, they would influence the judgment made by a reasonable user based on the financial statements.

In performing an audit in accordance with GAAS, we:

- Exercise professional judgment and maintain professional skepticism throughout the audit.
- Identify and assess the risks of material misstatement of the financial statements, whether due to fraud or error, and design and perform audit procedures responsive to those risks. Our audits did not extend to the certified investment information, except for obtaining and reading the certification, comparing the certified investment information with the related information presented and disclosed in the financial statements, and reading the disclosures relating to the certified investment information to assess whether they are in accordance with the presentation and disclosure requirements of U.S. GAAP.

Accordingly, the objective of an ERISA Section 103(a)(3)(C) audit is not to express an opinion about whether the financial statements as a whole are presented fairly, in all material respects, in accordance with U.S. GAAP.

We are required to communicate with those charged with governance regarding, among other matters, the planned scope and timing of the audit, significant audit findings, and certain internal control-related matters that we identified during the audit.

(1) **DESCRIPTION OF THE PLAN**

Metalforms, Ltd. adopted the Metalforms, Ltd. 401(k) Profit Sharing Plan (The Plan) effective October 1, 1991. The following description of The Plan provides only general information. Participants should refer to the Plan agreement for a more complete description of the Plan's provisions.

General - The Plan is a defined contribution 401 (k) and profit sharing plan covering employees of Metalforms, Ltd. and certain participating affiliates. Employees will become a participant in the Plan on the first plan entry date coinciding with completion of one year of service and a minimum age of eighteen. Employees begin participating on the first day of the Plan year or the first day of the fourth, seventh and tenth month of the plan year following the first twelve months of employment. The plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA).

Contributions - Each year, participants may contribute up to 20% of pretax annual compensation. However, the total of the participant's contribution may not exceed the maximum allowed by law of pretax annual compensation, as defined in the Plan, up to the IRS limit. Participants may also contribute amounts representing distributions from other qualified defined benefit or contribution plans. Participants who have attained the age of 50 before the end of the calendar year may elect to defer additional amounts (called "catch-up contributions") to the Plan as of January 1 of that year. The maximum "catch-up Contribution" that can be made in 2023 and 2022 is \$7,5000 and \$6,500, respectively. Effective January 1, 2016, the participants are automatically enrolled with a 2% contribution on the first payroll of the next quarter, following one year of service. The percentage of the participants' contribution is increased on the first day of each plan year until the contribution rate reaches a maximum of 6%. Participants can opt out of the automatic enrollment by signing and submitting an election form to Securian Financial Group, the third party administrator used by the Company. The Company authorizes a matching 401(k) contribution, which is completely discretionary. For Plan years ended December 31, 2023 and 2022, matching 401(k) contributions were 0% and 0% of employee deferrals, respectively. Participants must be employed at the end of the year to be eligible for the discretionary contribution. Participants direct the investment of their contributions into various investment options offered by the Plan.

Participant Accounts - Each participant's account is charged or credited with the participant's contribution and allocations of (a) the Company's contribution and (b) Plan earnings, and charged with an allocation of administrative expenses. Allocations are based on participant earnings or account balances as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

Vesting - Participants are immediately vested in their contributions plus actual earnings thereon. Except in the case of severance from employment with the Company due to death, retirement or permanent disability, no vesting occurs until one year of active service. After one year of active service, an employee becomes 25% vested. Thereafter, vesting increases by 25% a year until four years of active service, at which time the employee becomes 100% vested. Non-vested amounts forfeited by terminating participants are used to offset plan expenses and then reduce the employer's matching contributions under the Plan.

(1) **DESCRIPTION OF THE PLAN (CONTINUED)**

Notes Receivable from Employees – Participants may borrow from their fund accounts a minimum of \$1,000, up to a maximum not to exceed \$50,000 or 50% of their vested fund balance. Loan transactions are treated as a transfer to (from) the investment fund from (to) the Participant Notes fund. Loan terms are not to extend beyond five years. The loans are secured by the participant's account balance and bear interest at 1% over the Prime Rate published in the Wall Street Journal on the first business day of the month before the loan is originated. Interest rates at December 31, 2023 and 2022 were 4.52% and 4.19%, respectively.

Payment of Benefits – On termination of service for any reason, a participant is entitled to receive a distribution of the total vested amount credited to their account. If the total vested account balance does not exceed \$1,000, the account balance will be distributed in a lump sum and no participant consent is required to make a distribution. If the total vested account balance exceeds \$5,000, the participant may elect to receive a lump sum distribution or make a direct rollover to an IRA, and consent of the participant is required to make a distribution.

Forfeited Accounts– Forfeited balances of terminated participants' nonvested accounts are used to reduce the Plan expenses and then to reduce the Discretionary Employer Match. At December 31, 2023 and 2022, forfeited non-vested accounts totaled \$0- and \$1,048, respectively. During 2023, \$25 was forfeited by participants who withdrew from the Plan and \$1,073 was used to offset plan expenses.

(2) **SUMMARY OF ACCOUNTING POLICIES**

Basis of Accounting – The financial statements of the Plan are prepared using the accrual basis of accounting.

Estimates – The preparation of financial statements in conformity generally accepted accounting principles requires the plan administrator (management) to make estimates and assumptions that affect certain reported amounts and disclosures. Accordingly, actual results could differ from those estimates.

Investment Valuation and Income Recognition

The Plan's investments are presented at fair value, based on the quoted market prices of the underlying securities within each fund at December 31, 2023 and 2022 as reported by Minnesota Life Insurance Company.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation includes the Plan's gains and losses on investments bought and sold as well as held during the year.

Investment contracts are reported at contract value which is the relevant measurement attribute for that portion of the net assets available for benefits of a defined contribution plan attributable to fully benefit-responsive investment contracts because contract value is the amount participants would receive if they were to initiate permitted transactions under the terms of the plan.

Notes Receivable from Participants – Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Delinquent loans are treated as distributions based upon the terms of the plan document.

Payment of Benefits – Benefits are recorded when paid.

(2) SUMMARY OF ACCOUNTING POLICIES (CONTINUED)

Funding Policy – It is the policy of the Plan’s employer to deposit the participants’ withheld contributions within the ERISA required time limit which is the earliest date they can segregate deferrals from general assets.

Withdrawing Participant Obligations – Amounts allocated to withdrawing participants are claims that have been processed and approved for payment prior to year-end, but not paid as of that date. These amounts were deemed immaterial for the years ended December 31, 2023 and 2022.

(3) INVESTMENTS (UNAUDITED)

The following is a summary of the Plan’s asset information as of December 31, 2023 and 2022, included throughout the Plan’s financial statements and ERISA-required supplemental schedules, obtained by management and agreed to or derived from information certified by Minnesota Life Insurance Company, the trustee of the plan. The Plan Administrator has obtained certifications from Minnesota Life Insurance Company, the trustee, that information provided to the Plan Administrator by Minnesota Life Insurance Company related to the following assets is complete and accurate. Accordingly, as permitted by 29 CFR 2520.103-8 of the Department of Labor’s Rules and Regulations for Reporting and Disclosure under the ERISA, the Plan Administrator instructed the Plan’s independent auditors not to perform any auditing procedures with respect to information which appears throughout the financial statements and ERISA-required supplemental schedules related to the following assets:

Financial Accounting Standards Board (FASB) *Accounting Standards Codification (ASC) 820, Fair Value Measurements*, provides the framework for measuring fair value. That framework provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (level 1 measurements) and the lowest priority to unobservable inputs (level 3 measurements). The three levels of fair value hierarchy are described below:

Level 1 – Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2 - Inputs to the valuation methodology include:

- Quoted prices for similar assets or liabilities in active markets;
- Quoted prices for identical or similar assets or liabilities in inactive markets;
- Inputs other than quoted prices that are observable for the asset or liability;
- Inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

Level 3 - Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset's or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at December 31, 2023 and 2022.

Common stocks, corporate bonds and U.S. government securities: Valued at the closing price reported on the active market on which the individual securities are traded.

Mutual funds: Valued at the net asset value ("NAV") of shares held by the plan at year end.

Pooled separate account: The unit value is calculated using the market value of the assets net of the investment management fee, of each sub-account and the number of outstanding unit.

The methods described above may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, while the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

(4) **STABLE VALUE FUND – FULLY BENEFIT RESPONSIVE INVESTMENT CONTRACT (UNAUDITED)**

The Plan offers as an investment option a benefit-responsive stable value fund with Minnesota Life Insurance Company. Minnesota Life Insurance Company maintains the contributions in a general account. The account is credited with earnings on the underlying investments and charged for participant withdrawals and administrative expenses. Guaranteed Interest Accounts guarantee the return of principal plus compound interest earned over a defined term. The Fund seeks to preserve capital and provide stability of principal while earning current income that exceeds money market rates over the long term. The investment choices have a portfolio investment rate design in which all deposits are credited with the same interest rate, corresponding to the guarantee period chosen, on a daily basis, and with no set maturity. The effective credited interest rate is set monthly or quarterly and effective on the first day of the period. Contract charges may reduce the return. The Fund is not guaranteed by the FDIC or any other government agency. Contract value, as reported to the Plan by Minnesota Life Insurance Company, represents contributions made under the contract, plus earnings, less participant withdrawals and administrative expenses. The contract value for the stable value fund – investment contracts at December 31, 2023 and 2022 totaled \$-0- and \$1,025,012, respectively. There are no reserves against contract value for credit risk of the contract issuer or otherwise.

Although plan participants generally may withdraw assets from the Fund without restrictions, a hold period at the contract level in the event of a full contract discontinuance or partial contract discontinuance may be imposed. Certain events limit the ability of the Plan to transact at contract value with the issuer. Such events include the following: (1) amendments to the Plan documents (including complete or partial Plan termination or merger with another plan), (2) changes to the Plan's prohibition on competing investment options or deletion of equity wash provisions, (3) bankruptcy of the Plan Sponsor or other Plan Sponsor events that cause a significant withdrawal from the Plan, or (4) the failure of the trust to qualify for exemption from federal income taxes or any required prohibited transaction exemption under ERISA. The Plan Administrator does not believe any events which would limit the Plan's ability to transact at contract value with participants are probable. The Fund does not permit the insurance company to terminate the agreement prior to the scheduled maturity date.

(5) **PLAN TERMINATION**

The plan sponsor has the right under the Plan to discontinue its contributions at any time and to terminate the plan subject to the provisions of ERISA. In the event of Plan termination, participants will become 100% vested in their accounts.

The plan sponsor was sold on May 31, 2023. The Plan was terminated with the last distribution on December 26, 2023. Participant accounts that were not fully vested became fully vested on May 31, 2023. All of the Plan assets were either distributed or transferred, as elected by each participant, by December 26, 2023.

(6) **TAX STATUS**

The Plan obtained its latest determination letter on June 30, 2020, in which the Internal Revenue Service stated that the Plan, as then designed, was in compliance with the applicable requirements of the Internal Revenue Code. Therefore, no provision for income taxes has been included in the Plan's financial statements.

The determination letter is in the name of Minnesota Life Insurance Company. Minnesota Life Insurance Company is the author and sponsor of the Non-Standardized Pre-Approved Profit Sharing/Money Purchase/CODA document, so it applies for and is granted the determination letter.

(7) **PARTY IN INTEREST TRANSACTIONS**

Certain Plan investments are shares of separate accounts managed by Minnesota Life Insurance Company. Minnesota Life Insurance Company is the trustee as defined by the Plan and, therefore, these transactions qualify as party-in-interest transactions. Fees paid by the Plan for services provided by the Trustees amounted to \$4,906 and \$2,855 for the years ended December 31, 2023 and 2022, respectively.

(8) **ADMINISTRATIVE AND OTHER EXPENSES**

The Plan administrative fees are allocated to the individual participant accounts. Metalforms, Ltd. absorbs some of the Plan audit costs. Plan audit costs absorbed for the years ended December 31, 2023 and 2022 were \$13,500 and \$12,750, respectively.

(9) **EXCESS CONTRIBUTIONS**

At December 31, 2023 and 2022, payables of \$-0- and \$1,835, respectively, are recorded for amounts refundable by the Plan to certain active participants to return to them excess deferral contributions to satisfy the relevant nondiscrimination provisions of the Plan as required by the Internal Revenue Service.

(10) **RISKS AND UNCERTAINTIES**

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits.
