Notes to Financial Statements

1. Description of Plan

General

Empire Roofing, Inc. Profit Sharing & 401(k) Plan (Plan) was established January 1, 1987, for eligible employees of Empire Roofing, Inc. (Company). The Plan is a defined contribution plan designed to comply with the Employee Retirement Income Security Act of 1974 (ERISA). John Hancock Life Insurance Company (Custodian) acts as Custodian for the Plan pursuant to an agreement between the Custodian and the Company. The following descriptions provide only general information. Participants should refer to the Plan document for a more complete description of the Plan's provisions.

Plan Termination

The Company approved a resolution on July 14, 2021 to freeze the Plan effective July 16, 2021, with the intent to terminate the Plan subject to certain conditions. The Plan was amended to facilitate the termination of the Plan. As a result of the plan amendment, participants became fully vested in their accounts.

Contributions

Eligible employees may contribute pretax annual compensation, not to exceed the maximum permitted by law. Participants may also contribute distributions from other qualified plans. The Company makes safe-harbor matching contributions on elective deferrals up to 4% of annual compensation. Participants direct their share of elective deferrals and safe harbor matching contributions into various investment options available to the Plan.

Each year, the Company may declare a discretionary profit sharing contribution. All employees who are actively employed on the last day of the Plan year and have met the eligibility requirements as defined by the Plan will share in the profit sharing contribution. Profit sharing contributions will be allocated to the eligible participant account balances based on a factor of the individual participant's compensation for the Plan year to total compensation of all eligible participants for the Plan year.

Participant Accounts

Each participant's elective deferral and safe-harbor matching accounts are credited with the participant's elective deferral and the related safe harbor matching contribution and allocations of plan earnings (or losses), and charged with administrative expenses per contractual agreement. Allocations of Plan earnings are based on actual results of individual participant investment balances, as electively designated, and certified by the Custodian.

Each participant's profit sharing account is credited with an allocation of the Company's profit sharing contribution (if any) and Plan earnings, and charged with an allocation of administrative expenses. Allocations are based on participant compensation and contractual agreement, respectively, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

Vesting

Participant and employer safe harbor contributions plus earnings thereon are fully vested. Participants became fully vested in Company discretionary profit sharing contributions due to the Plan termination.

Forfeitures

Forfeitures of unvested Company discretionary profit sharing contributions may be used to offset future Company contributions or to pay administrative expenses of the Plan. During the period ended March 22, 2023 no Plan forfeitures were used to reduce administrative expenses.

Benefit Payments

Upon termination of service for reasons other than death or disability, a participant may elect to receive an amount equal to the value of the participant's vested interest in his or her account in a lump sum amount. For termination of service due to death or disability, the participant will be entitled to 100% of his or her account balance. Payments of death or disability benefits are subject to the same terms as described above.

Administrative Expenses

Administrative expenses paid by the Plan consist of contract administrative fees. Fees related to the administration of benefit payments to participants are charged directly to the participant and are included in administrative expenses.

2. Summary of Significant Accounting Policies

Basis of Accounting

As a result of the election to terminate the Plan, the financial statements are prepared using the liquidation basis of accounting in accordance with accounting principles generally accepted in the United States of America (GAAP).

Estimates and Assumptions

Management uses estimates and assumptions in preparing financial statements in accordance with GAAP. Those estimates and assumptions affect the reported amounts of assets and liabilities and the disclosure of contingent assets and liabilities. Actual results could vary from the estimates used in preparing the accompanying financial statements.

Investment Valuation and Income Recognition

Investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See Note 3 for discussion of fair value measurements. The Plan presents the net change in fair value of mutual funds and individual brokerage accounts, which consists of realized gains or losses, unrealized appreciation (depreciation), and any income or capital gain distributions from such investments, in the accompanying statement of changes in net assets available for benefits.

Purchases and sales of investments are recorded on a trade date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation (depreciation) includes the Plan's gains and losses on investments bought and sold as well as held during the period.

Payment of Benefits

Benefits to participants are recorded when paid.

Risks and Uncertainties

Participant directed investment securities are exposed to various risks such as interest rates, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits.

3. Fair Value Measurements

Under the Fair Value Measurements and Disclosures topic of the Codification, ASC 820, disclosures are required about how fair value is determined for assets and liabilities and a hierarchy for which these assets and liabilities must be grouped is established, based on significant levels of inputs as follows:

- Level 1 quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.
- Level 2 quoted prices for similar assets or liabilities in active markets; quoted prices for identical or similar assets or liabilities in inactive markets; and model-derived valuations in which all significant inputs are observable in active markets.
- Level 3 valuations derived from valuation techniques in which one or more significant inputs are unobservable.

The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodologies used for assets measured at fair value.

Mutual Funds

These investments are public investment vehicles valued using the net asset value (NAV) provided by the administrator of the fund. The NAV is based on the value of the underlying investment owned by the fund, less its liabilities, and then divided by the number of shares outstanding. The NAV is a quoted price in an active market.

The preceding methods described may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, although the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

The investments held by the Plan are measured using Level 1 inputs and consist of mutual funds at December 31, 2022 totaled \$3,221,049.

4. Financial Information Certified by the Plan's Custodian (Unaudited)

The Plan administrator has elected the method of compliance permitted by 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. Accordingly, as permitted under such election, the Plan administrator instructed the independent auditors not to perform any auditing procedures with respect to the following information certified as complete and accurate by the Custodian, a party-in-interest as defined by ERISA, as of March 22, 2023 and December 31, 2022 and for the period ended March 22, 2023, except for comparing such information certified by the Custodian to information included in the Plan's financial statements and supplemental schedule. 5. Tax Status

The Plan is based on a prototype plan developed by Pension Planning Consultants, Inc. which received a favorable opinion letter dated March 31, 2014, from the Internal Revenue Service (IRS) stating that the Plan is qualified under Section 401(a) of the IRC and, therefore, the related trust is exempt from taxation. Once qualified, the Plan is required to operate in conformity with the IRC to maintain its qualification. The Plan administrator believes the Plan is being operated in compliance with the applicable requirements of the IRC and, therefore, believes that the Plan is qualified and the related trust is tax exempt.

GAAP requires Plan management to evaluate tax positions taken by the Plan and recognize a tax liability (or asset) if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS. The Plan administrator has analyzed the tax positions taken by the Plan, and has concluded that as of December 31, 2022 and 2021, there are no uncertain tax positions taken or expected to be taken that would require recognition of a liability (or asset) or disclosure in the financial statements. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress. The Plan's Annual Return/Report of Employee Benefit Plan is subject to examination by the IRS for three years from the date of filing.

6. Related Party Transactions and Party-In-Interest Transactions

Certain Plan investments are shares of mutual funds managed by the Custodian and, therefore, these transactions qualify as party-in-interest transactions. Fees incurred by the Plan for the investment management services are included in net depreciation in fair value of investments.

The Custodian provides certain administrative services to the Plan pursuant to an agreement between the Company and Custodian. The Custodian receives revenue from mutual fund service providers for services the Custodian provides to the funds. This revenue is used to offset certain amounts owed to the Custodian for its administrative services to the Plan.

If the revenue received by the Custodian from such mutual fund service providers exceeds the amount owed under the agreement between the Custodian and the Company, the Custodian remits the excess to the Plan's trust. Such amounts may be applied to pay Plan administrative expenses. The Plan did not receive any excess amounts during the period ended March 22, 2023.

7. Plan Corrections

During the period ended March 22, 2023 the Plan corrected a limited number of isolated operational errors related to the late remittance of employee deferrals.

8. Subsequent Events

Plan management has evaluated subsequent events through August 30, 2024, the date the financial statements were available to be issued and concluded that no additional disclosures are required.
