Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed audits of the accompanying financial statements of Schweitzer Mountain 401(k) Plan (the Plan), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C). The financial statements comprise the statements of net assets available for benefits as of December 31, 2023 and 2022, and the related statements of changes in net assets available for benefits for the years then ended, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of the financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. As permitted by ERISA Section 103(a)(3)(C), our audits need not extend to any statements or information related to assets held for investment of the Plan (investment information) by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA (qualified institution).

Management has obtained certifications from a qualified institution as of and for the years ended December 31, 2023 and 2022, stating that the certified investment information, as described in Note 3 to the financial statements, is complete and accurate.

Opinion

In our opinion, based on our audits and on the procedures performed as described in the Auditor's Responsibilities for the Audit of the Financial Statements section —

- the amounts and disclosures in the financial statements referred to above, other than those agreed to or derived from the certified investment information, are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America.
- the information in the financial statements referred to above related to assets held by and certified to by a qualified institution agrees to, or is derived from, in all material respects, the information prepared and certified by an institution that management determined meets the requirements of ERISA Section 103(a)(3)(C).

Termination of Plan

As discussed in Note 6, the Company terminated the Plan effective December 31, 2023.

Basis for Opinion

We conducted our audits in accordance with auditing standards generally accepted in the United States of America. Our responsibilities under those standards are further described in the Auditor's Responsibilities for the Audit of the Financial Statements section of our report. We are required to be independent of the Plan and to meet our other ethical responsibilities in accordance with the relevant ethical requirements relating to our audits. We believe that the audit evidence we have obtained is sufficient and appropriate to provide a basis for our ERISA Section 103(a)(3)(C) audit opinion.

Responsibilities of Management for the Financial Statements

Management is responsible for the preparation and fair presentation of the financial statements in accordance with accounting principles generally accepted in the United States of America, and for the design, implementation, and maintenance of internal control relevant to the preparation and fair presentation of financial statements that are free from material misstatement, whether due to fraud or error. Management's election of the ERISA Section 103(a)(3)(C) audit does not affect management's responsibility for the financial statements.

In preparing the financial statements, management is required to evaluate whether there are conditions or events, considered in the aggregate, that raise substantial doubt about the Plan's ability to continue as a going concern for one year after the date the financial statements are available to be issued.

Management is also responsible for maintaining a current plan instrument, including all plan amendments, administering the Plan, and determining that the Plan's transactions that are presented and disclosed in the financial statements are in conformity with the Plan's provisions, including maintaining sufficient records with respect to each of the participants, to determine the benefits due or which may become due to such participants.

Accordingly, the objective of an ERISA Section 103(a)(3)(C) audit is not to express an opinion about whether the financial statements as a whole are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America.

We are required to communicate with those charged with governance regarding, among other matters, the planned scope and timing of the audit, significant audit findings, and certain internal control-related matters that we identified during the audit.

Notes to Financial Statements

Note 1 – Description of the Plan

The following description of Schweitzer Mountain 401(k) Plan (the Plan), provides only general information. Participants should refer to the official plan document for important details not included in these notes.

- a. **General** – The Plan was established by Schweitzer Mountain, LLC (the Company), effective January 1, 2005, as a contributory defined contribution plan. Employees who have attained age 18 may enter the Plan on the first entry date immediately following the completion of one year of service (1,000 hours). Employees become eligible for the profit-sharing and matching contributions upon entry date. Entry dates occur on the first payroll of the month following eligibility.

Participating affiliates of the Plan include Schweitzer Mountain Facilities, LLC; Schweitzer Mountain Ski Operations; Schweitzer Mountain Real Estate; Schweitzer Mountain Utility Co., LLC; Resort Water, Inc.; Bottle Bay Restaurant, LLC; and Schweitzer Mountain Properties, LLC. The Plan was terminated as of December 31, 2023. See Note 6.

- b. **Contributions** – Participants make voluntary tax-deferred contributions to the Plan through payroll deductions of up to the Internal Revenue Service (IRS) maximum allowable. Upon enrollment in the Plan, a participant may direct contributions to any of the allowable investment options. Participants may change their investment options daily. Participants who have attained age 50 before the end of the plan year are eligible to make catch-up contributions. The employer may make a matching contribution at its discretion. A participant who receives a distribution from another qualified plan may make a rollover contribution to the Plan provided that certain conditions are met, including the approval of the plan administrator.
- c. **Participant accounts** – Each participant’s account is credited with the participant’s contributions and allocations of the employer’s contributions and plan earnings or losses and charged with an allocation of administrative expenses. Allocations are based on participant earnings or account balances, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant’s vested account.
- d. **Vesting** – Participant contributions and actual earnings thereon are 100% vested. The employer safe harbor contribution is 100% vested. All other employer matching contributions for each plan year vest in accordance with the following schedule:

- e. **Notes receivable from participants** – Participants may borrow from their fund accounts up to a maximum equal to the lesser of \$50,000 or 50% of their nonforfeitable account balance. The loans are secured by the balance in the participant’s account and bear interest at rates which are commensurate with local prevailing rates as determined by the plan administrator. Loan terms can range from one to five years or over a reasonable period of time that may be longer than five years for the purchase of a primary residence. Principal and interest are paid ratably through payroll deductions.

Note 1 – Description of the Plan (Continued)

- e. **Notes receivable from participants (continued)** – Participant loans are reported as notes receivable from participants in the accompanying financial statements as required by current authoritative guidance; however, for Form 5500 purposes, they are shown as investments, as required.
- f. **Payment of benefits** – Normal retirement under the Plan occurs at age 65. Upon retirement or termination of employment, participation in the Plan will cease and benefits will be distributed according to provisions set forth in the plan document. All vested account balances may be distributed in a lump-sum payment or installment payments over a specified period of time. Hardship withdrawals are not permitted by the Plan.
- g. **Forfeited accounts** – As of December 31, 2023 and 2022, forfeited nonvested accounts totaled \$-0- and \$773, respectively. Forfeitures may be first used to pay any administrative expenses, to the extent not paid by the Company, and then to reduce the Company’s matching contributions. For the years ended December 31, 2023 and 2022, forfeitures of \$1,030 and \$-0-, respectively, were used to reduce Plan expenses and matching contributions.
- h. **Administration of the Plan** – Plan assets are held by the Plan’s custodian and trustee, John Hancock Life Insurance Company (John Hancock) for the years ended December 31, 2023 and 2022. Records of participant account activity are processed by John Hancock, which also performs other administrative support services for the Plan. Certain administrative functions are performed by officers or employees of the Company. No such officer or employee receives compensation from the Plan. Administration expenses of the Plan are paid by the Plan or by the Company as provided in the plan document.

Note 2 – Summary of Significant Accounting Policies

- a. **Basis of accounting** – The financial statements of the Plan are prepared under the accrual basis of accounting in accordance with accounting principles generally accepted in the United States of America.
- b. **Investment valuation and income recognition** – Investments are stated at fair value, except for investments in pooled separate accounts, which are reported at net asset value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See Note 4 for discussion of fair value measurements.

Purchases and sales of shares are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation (depreciation) includes the Plan’s gains and losses on investments bought and sold as well as held during the year.

- c. **Payment of benefits** – Benefits are recorded when paid.

- d. **Use of estimates** – The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires the plan administrator to make estimates and assumptions that affect certain reported amounts and disclosures. Actual results could differ.
- e. **Subsequent events** – The Company has evaluated subsequent events through October 3, 2024, the date the financial statements were available to be issued.

Note 3 – Information Certified by the Plan Custodian and Trustee

As permitted by Section 2520.103-8 of the Department of Labor’s Rules and Regulations for Reporting and Disclosure under the Employee Retirement Income Security Act of 1974 (ERISA), the plan administrator has elected that information certified by John Hancock not be subject to any auditing procedures except for comparing such information to the related information contained in the accompanying financial statements. The following information has been certified by John Hancock as complete and accurate:

- (a) Investments as indicated on the statements of net assets available for benefits; and
- (b) Net appreciation (depreciation) in fair value of investments as indicated on the statements of changes in net assets available for benefits.

Note 4 – Fair Value Measurements

The Financial Accounting Standards Board (FASB) *Accounting Standards Codification* (ASC) 820, *Fair Value Measurements and Disclosures*, provides the framework for measuring fair value. That framework provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1 measurements) and the lowest priority to unobservable inputs (Level 3 measurements). The three levels of the fair value hierarchy under FASB ASC 820 are described as follows:

- Level 1* – Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2 – Inputs to the valuation methodology include:

- quoted prices for similar assets or liabilities in active markets;
- quoted prices for identical or similar assets or liabilities in inactive markets;
- inputs other than quoted prices that are observable for the asset or liability; and
- inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

Level 3 – Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset's or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodologies used for assets at fair value. There have been no changes in the methodologies used at December 31, 2023 and 2022.

Level 1 – The Plan has no investments that are classified as Level 1 for either year ended December 31, 2023 or 2022.

Level 2 – The Plan has no investments that are classified as Level 2 for either year ended December 31, 2023 or 2022.

Level 3 – The Plan has no investments that are classified as Level 3 for either year ended December 31, 2023 or 2022.

Investments measured at net asset value (NAV):

The pooled separate accounts are valued at the NAV of units of pooled accounts. The NAV, as provided by the custodian or trustee, is used as a practical expedient to estimate fair value. The NAV is based on the fair value of the underlying investments held by the fund less its liabilities. This practical expedient is not used when it is determined to be probable that the fund will sell the investment for an amount different than the reported NAV. Participant transactions (purchases and sales) may occur daily. Were the Plan to initiate a full redemption of the investment, the investment advisor reserves the right to temporarily delay withdrawal from the trust in order to ensure that securities liquidations will be carried out in an orderly business manner.

The preceding methods may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, although the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

Note 5 — Related-party Transactions

The Plan's Board of Trustees consists of employees of the Plan sponsor. There are no transactions between the parties other than contributions to the Plan, if eligible.

Certain transactions, while considered party-in-interest transactions under ERISA regulations, are permitted under the provisions of the Plan and are specifically exempt from the prohibition of party-in-interest transactions under ERISA.

Note 6 — Plan Termination

The Company was sold on August 22, 2023, and the Plan was terminated as of December 31, 2023, subject to the provisions of ERISA. Prior to plan termination, the participants were given the option of a lump-sum payment or a nontaxable trustee-to-trustee transfer of their 401(k) balance to any qualified, defined contribution plan. Upon plan termination, participant account balances became fully vested.

The plan administrator was authorized to create individual retirement accounts (IRA) in the names of the remaining payees as the sole means of distributing the owed balance. On December 23, 2023, the administrator transferred \$591,995 to Millenium Trust Company to create IRAs for the remaining individual balances.

Note 7 — Tax Status

The trust established under the Plan to hold the Plan's assets is qualified pursuant to the appropriate section of the Internal Revenue Code (IRC) and, accordingly, the trust's net investment income is exempt from income taxes. The Plan has obtained a favorable determination letter from the IRS but has since been amended. However, the plan administrator believes that the Plan is currently designed and being operated in compliance with the applicable requirements of the IRC. Therefore, they believe that the Plan is qualified, and the related trust is tax-exempt as of the financial statement dates. Accordingly, no provision for income taxes has been included in the Plan's financial statements.

Accounting principles generally accepted in the United States of America require plan management to evaluate tax positions taken by the Plan and recognize a tax liability (or asset) if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS. The plan administrator has analyzed the tax positions taken by the Plan and has concluded that as of December 31, 2023 and 2022, there are no uncertain positions taken or expected to be taken that would require recognition of the liability (or asset) or disclosure in the financial statements. The Plan is subject to routine audits by taxing jurisdictions, and the Plan could be subject to income tax if certain issues were found by the IRS that could result in the disqualification of the Plan's tax-exempt status; however, there are currently no audits for any tax periods in progress.

Note 8 – Risks and Uncertainties

The Plan provides for investments in various investment securities. Investment securities, in general, are exposed to various risks, such as interest rate, credit, political, and overall market volatility risk. Due to the level of risk associated with certain investment securities, it is reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect the amounts reported in the statements of net assets available for benefits and participant account balances.

Note 9 – Reconciliation of Financial Statements to Form 5500

Participant loans are reported as notes receivable from participants in the accompanying financial statements as required by current authoritative guidance; however, for Form 5500 purposes they are shown as investments, as required.

Note 10 – Delinquent Participant Contributions

During January, June, and December 2022, participant contributions of \$92,276 were withheld from employee paychecks, but were not remitted as soon as reasonably possible from the date of withholding to the date of deposit. These transactions constituted loans from the Plan to the Company for the amount of time until the deposits were made. In January 2023, the Company contributed additional amounts for lost earnings and applicable taxes related to the late deposits to the Plan.
