Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We believe that the audit evidence we have obtained is sufficient and appropriate to provide a basis for our ERISA Section 103(a)(3)(C) audit opinion.

Responsibilities of Management for the Financial Statements

Management is responsible for the preparation and fair presentation of the financial statements in accordance with accounting principles generally accepted in the United States of America, and for the design, implementation, and maintenance of internal control relevant to the preparation and fair presentation of financial statements that are free from material misstatement, whether due to fraud or error. Management's election of the ERISA Section 103(a)(3)(C) audit does not affect management's responsibility for the financial statements.

In preparing the financial statements, management is required to evaluate whether there are conditions or events, considered in the aggregate, that raise substantial doubt about the Plan's ability to continue as a going concern within one year after the date that the financial statements are issued or available to be issued.

Management is also responsible for maintaining a current plan instrument, including all plan amendments, administering the Plan, and determining that the Plan's transactions that are presented and disclosed in the financial statements are in conformity with the Plan's provisions, including maintaining sufficient records with respect to each of the participants, to determine the benefits due or which may become due to such participants.

Auditors' Responsibilities for the Audit of the Financial Statements

Except as described in the Scope and Nature of the ERISA Section 103(a)(3)(C) Audit section of our report, our objectives are to obtain reasonable assurance about whether the financial statements as a whole are free from material misstatement, whether due to fraud or error, and to issue an auditors' report that includes our opinion. Reasonable assurance is a high level of assurance but is not absolute assurance and therefore is not a guarantee that an audit conducted in accordance with GAAS will always detect a material misstatement when it exists. The risk of not detecting a material misstatement resulting from fraud is higher than for one resulting from error, as fraud may involve collusion, forgery, intentional omissions, misrepresentations, or the override of internal control. Misstatements are considered material if there is a substantial likelihood that, individually or in the aggregate, they would influence the judgment made by a reasonable user based on these financial statements.

In performing an audit in accordance with GAAS, we:

- Exercise professional judgment and maintain professional skepticism throughout the audit.
- Identify and assess the risks of material misstatement of the financial statements, whether due to fraud or error, and design and perform audit procedures responsive to those risks. Such procedures include examining, on a test basis, evidence regarding the amounts and disclosures in the financial statements.

- Obtain an understanding of internal control relevant to the audit in order to design audit procedures that are appropriate in the circumstances, but not for the purpose of expressing an opinion on the effectiveness of the Plan's internal control. Accordingly, no such opinion is expressed.
- Evaluate the appropriateness of accounting policies used and the reasonableness of significant accounting estimates made by management, as well as evaluate the overall presentation of the financial statements.
- Conclude whether, in our judgment, there are conditions or events, considered in the aggregate, that raise substantial doubt about the Plan's ability to continue as a going concern for a reasonable period of time.

Our audits did not extend to the certified investment information, except for obtaining and reading the certifications, comparing the certified investment information with the related information presented and disclosed in the financial statements, and reading the disclosures relating to the certified investment information to assess whether they are in accordance with the presentation and disclosure requirements of accounting principles generally accepted in the United States of America.

Accordingly, the objective of an ERISA Section 103(a)(3)(C) audit is not to express an opinion about whether the financial statements as a whole are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America.

We are required to communicate with those charged with governance regarding, among other matters, the planned scope and timing of the audit, significant audit findings, and certain internal control-related matters that we identified during the audit.

Note 1 - Description of Plan

The following description of Mother Lode Holding Company Savings Plan (the "Plan") provides only general information. Participants should refer to the plan document or summary plan description for a more complete description of the Plan's provisions, which are available from the plan administrator.

General

The Plan was a defined contribution 401(k) retirement plan available to all employees, except collective bargaining employees, non-resident aliens, and leased employees, of Mother Lode Holding Company, Inc., Placer Title Company, North Idaho Title Insurance, Inc., National Closing Solutions, Inc., Montana Title & Escrow, Wyoming Title and Escrow, Inc., NCS Exchange Professionals, Inc., Short Sale Advantage, Inc., Texas National Title, Inc., Wyoming Title and Escrow, Inc., Centric Title and Escrow, LLC and Western Auxiliary, Inc. (collectively, the "Company") who had completed three months of service and have attained a minimum age of twenty-one. To be eligible for discretionary employer matching and profit sharing contributions, participants must be employed on the last day of the plan year. Participants must also have 1,000 hours of service to be eligible for profit sharing contributions. The Plan was subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA), as amended.

Effective, December 29, 2023, the Plan merged into the First American Financial Corporation 401(K) Savings Plan. Accordingly, all participants became 100% vested and the net assets totaling \$70,324,311 were transferred to the successor plan.

Contributions

Participants could elect to defer any amount of annual eligible compensation subject to Internal Revenue Service (IRS) limitations. The Plan allowed for after-tax Roth contributions, as well as catch up contributions for participants over the age of fifty (50). The Plan allowed the Company to make discretionary matching and profit sharing contributions in amounts determined by each participating employer. The Company made a discretionary matching contribution of \$1,075,000 for 2022, which was made up of \$965,000 in cash contributed by the Company and \$110,000 of forfeited funds. The Company did not make such a contribution for 2023. There was no discretionary profit sharing contribution in 2023 or 2022.

Participant investment account options

The Plan allowed participants to direct varying portions of their contributions and account balances among the different mutual fund investment options offered by Empower Trust Company, LLC and Empower Life & Annuity Insurance Company (collectively, "Empower") and until August 2022, the Prudential Guaranteed Income Fund (see note 5).

Note 1 - Description of Plan (continued)

Participant accounts

Each participant's account was credited with the participant's deferral contribution, the Company discretionary matching contribution, and an allocation of the Company discretionary profit sharing contribution, plus a proportionate interest in the investment earnings or losses of the funds in which the contributions are invested and an allocation of administrative expenses. Allocations were based upon the participant's eligible compensation or account balances, as defined. The benefit to which a participant was entitled was the benefit that could be provided from the participant's vested account.

Vesting

Participants were immediately vested in their deferral contributions plus earnings thereon. Participants vested in Company discretionary matching and profit sharing contributions and related earnings and losses based upon years of service with 100% vesting occurring after six years of credited service. In the event of death, disability, normal retirement age (65), or if the Plan is discontinued, participants become 100% vested in all account balances.

Notes receivable from participants

Participants could borrow up to the lesser of \$50,000 or 50% of their vested account balance. The minimum amount that could be borrowed was \$1,000. A participant could only have two outstanding loans at a time and required a six month wait period between loans. The loans were secured by the balance in the participant's account and bore interest at a rate commensurate with local prevailing rates as determined by the plan administrator. Principal and interest was repaid ratably through payroll deductions.

Payment of benefits

Upon termination of service, death, disability or retirement, a participant may elect to receive account distributions in the form of a lump sum payment or installments over a period of time as defined in the plan document. Withdrawals by a participant while employed were limited to those requested due to events of financial hardship as defined by the plan document or upon the attainment of age 65.

Forfeited accounts

If an employee terminated before his or her Company discretionary matching and profit sharing contribution accounts was become fully vested, such portion of the accounts was forfeited. Participant forfeitures were used to pay plan expenses or reduce employer contributions. Forfeitures were \$49,021 during 2023 and \$98,590 during 2022. Forfeitures were used to pay expenses for the period ended December 29, 2023 and the year ended December 31, 2022 in the amount of \$1,250 and \$5,000, respectively. Forfeitures in the amount of \$110,000 were used to reduce employer contributions in 2022. There were no forfeitures used to reduce employer contributions in 2023.

Note 2 - Summary of significant accounting policies

Basis of accounting

The financial statements of the Plan are prepared on the accrual method of accounting.

Use of estimates

The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires the plan administrator to make estimates and assumptions which affect reported amounts of assets and liabilities and changes therein, and disclosures of contingent assets and liabilities. Accordingly, actual results could differ from those estimates.

Investment valuation and income recognition

Investments were reported at fair value (except for the fully benefit-responsive investment contract which was reported at contract value). Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See note 4 for discussion of fair value measurements.

Purchases and sales of securities were recorded on a trade-date basis. Interest income was recorded on the accrual basis. Dividends were recorded on the ex-dividend date. Net appreciation (depreciation) in the fair value of investments includes the Plan's gains and losses on investments bought and sold as well as held during the year.

Notes receivable from participants

Notes receivable from participants were measured at their unpaid principal balances plus any accrued but unpaid interest. Interest income was recorded on the accrual basis. Related fees were recorded as administrative expenses and were expensed when they are incurred. No allowance for credit loss has been recorded as of December 29, 2023 or December 31, 2022. If a participant ceased to make loan repayments and the plan administrator deemed the participant loan to be in default, the participant loan balance was reduced and a benefit payment was recorded.

Payment of benefits

Benefits are recorded when paid.

Administrative expenses

Certain expenses of the Plan were paid by the Company and were not included in the statements of changes in net assets available for benefits. Fees related to the administration of notes receivable from participants and benefits paid to participants were charged directly to the participant's account. Certain investment related expenses were included in net appreciation (depreciation) in fair value of investments.

Note 3 - Information prepared and certified by the trustee

The plan administrator has elected the method of annual reporting compliance permitted by 29 CFR 2520.103-8 of the Department of Labor's (DOL's) Rules and Regulations for Reporting and Disclosure under ERISA. Accordingly, Empower, the trustee of the Plan, has certified that the following data included in the accompanying financial statements is complete and accurate with respect to:

- Investments at fair value
- The fully benefit responsive investment contract at contract value
- Notes receivable from participants
- Net appreciation (depreciation) in fair value of investments
- Interest and dividends
- Interest income on notes receivable from participants

The Plan's independent public accountants did not perform auditing procedures with respect to this information, except for comparing such information to the related information included in the financial statements.

Note 4 - Fair value measurements

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1) and the lowest priority to unobservable inputs (Level 3). The three levels of the fair value hierarchy under FASB ASC 820 are described below.

Level 1: Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2: Inputs to the valuation methodology include quoted prices for similar assets and liabilities in active markets; quoted prices for identical or similar assets and liabilities in inactive markets; inputs other than quoted market prices that are observable for the asset or liability; and inputs that are derived principally from or corroborated by observable market data by correlation or other means. If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

Level 3: Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

Note 4 - Fair value measurements (continued)

The asset or liability's fair value measurement level within the fair value hierarchy is based upon the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodology used for assets measured at fair value.

Mutual funds: Valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-end mutual funds that are registered with the Securities and Exchange Commission. These funds are required to publish their daily net asset value (NAV) and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.

The following table sets forth by level, within the fair value hierarchy, the Plan's investments at fair value as of December 31, 2022. There were no investments as of December 29, 2023 due to the Plan merging into the successor plan.

Note 5 - Guaranteed investment contract

The Plan had a benefit-responsive guaranteed investment contract with Empower. Empower maintained the contributions in a general account. The account was credited with earnings on the underlying investments and charged for participant withdrawals and administrative expenses. The guaranteed investment contract issuer was contractually obligated to repay the principal and a specified interest rate that was guaranteed to the Plan. The crediting rate was based on a formula established by the contract issuer but may not be less than zero percent (0%). The crediting interest rate is reviewed on a quarterly basis for resetting. The guaranteed investment contract did not permit the insurance company to terminate the agreement prior to the schedule maturity date.

Because the guaranteed investment contract was fully benefit-responsive, contract value was the relevant measurement for the guaranteed investment contract. Contract value, as reported to the Plan by Empower, represented contributions made under the contract, plus earnings, less participant withdrawals and administrative expenses. Participants could ordinarily direct the withdrawal or transfer of all or a portion of their investment at contract value.

Note 5 - Guaranteed investment contract (continued)

The Plan's ability to receive amounts due was dependent on the issuer's ability to meet its financial obligations. The issuer's ability to meet its contractual obligations could be affected by future economic and regulatory developments.

Generally, there were no events that could limit the ability of the Plan to transact at contract value paid within 90 days or, in rare circumstances, contract value paid over time. There were no events that allowed the issuer to terminate the contract and which require the plan sponsor to settle at an amount different than contract value paid either within 90 days or over time. In 2022, the Plan exercised its liquidation rights, and the contract became a frozen investment option. The fund was liquidated in August of 2023 for \$4,676,651.

Note 6 - Related party transactions and party-in-interest transactions

Plan investments included interests in certain mutual funds and a guaranteed investment contract offered through Empower. Empower is the trustee as defined by the Plan and therefore, these investments and related investment transactions qualify as party-in-interest transactions. Certain fees incurred by the Plan for the investment management services are included in net appreciation (depreciation) in fair value of investments, as they are paid through revenue sharing, rather than a direct payment. The Plan made direct payments to Empower and other parties-in-interest for plan expenses in the amounts of \$287,228 in 2023 and \$264,265 in 2022. The plan sponsor paid directly any other fees related to the Plan's operations.

Note 8 - Tax status

The IRS has determined that the Non-Standardized Pre-Approved Profit Sharing Plan is designed in accordance with applicable sections of the Internal Revenue Code (IRC) and informed the trustee of such in a letter dated November 14, 2022. Although the Plan has been amended since receiving the determination letter, Plan management believes that the Plan is designed, and is currently being operated, in compliance with the applicable requirements of the IRC.

Note 8 - Tax status (continued)

Accounting principles generally accepted in the United States of America require plan management to evaluate tax positions taken by the Plan and recognize a tax liability (or asset) if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits in progress for any tax periods.

Note 9 - Subsequent events

Plan management has evaluated subsequent events through October 7, 2024, which is the date that the financial statements were available to be issued and noted no items requiring disclosure.
