### Note 1 - Plan Description

The following description of Guidehouse Digital LLC 401(k) Savings Plan (f/k/a Dovel Technologies, LLC Group 401(k) Plan) provides only general information. Participants should refer to the plan document for a more complete description of the Plan's provisions.

The Plan merged (the "Merger") into the Guidehouse Inc. Retirement Plan effective January 2, 2024. Accordingly, the descriptions below are provisions of the Plan prior to the Merger. See Note 7 for additional information.

#### **General**

Prior to the Merger, the Plan was a defined contribution plan covering all employees of Dovel Technologies, LLC; Medical Science & Computing, LLC; and Guidehouse Digital LLC (collectively, the "Company"), excluding union employees, nonresident aliens, or leased employees, who were age 18 or older. The Plan was subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA).

#### **Contributions**

The Plan provided for employee pretax and/or Roth 401(k) contributions up to a maximum of 100 percent of annual compensation, as defined in the plan document. Contributions were made through payroll deductions and were subject to limitations set by the Internal Revenue Code (IRC). Participants may also make contributions to the Plan in the form of a rollover of funds from another qualified plan.

The Company was required to make safe harbor matching contributions of 100 percent of the first 4 percent of compensation deferred by the participant.

The Company could also make discretionary matching and discretionary profit-sharing contributions to the Plan as approved by the Company's board of directors. No such discretionary contributions were made in 2024 or 2023.

#### **Participant Accounts**

Each participant's account was credited with the participant's contributions and allocations of the Company's contributions and plan earnings and charged with an allocation of administrative expenses. Allocations are based on participants' compensation or account balances, as defined. The benefit to which a participant was entitled was the benefit that may have been provided from the participant's vested account. Participants may have direct the investments of their account balances into various investment options offered by the Plan.

#### **Vesting**

Participants were immediately 100 percent vested in employee salary and rollover contributions and the Company's safe harbor match and any income or loss thereon. Vesting in the Company's discretionary contribution portion of their accounts, plus actual earnings thereon, was based on years of service. Participants vest in discretionary contributions made by the Company 25 percent per year after one year of service until they became fully vested after four years of service.

#### **Benefit Payments**

Distributions were payable upon retirement, death, long-term disability, or termination of employment in the form of a lump-sum amount equal to the value of the participant's vested interest in his or her account. Partial withdrawals or installments were only permitted for participants (or the participant's beneficiary in the case of death) who must receive required minimum distributions under IRC § 401(a)(9).

### Note 1 - Plan Description (Continued)

#### ***Forfeitures***

If a participant was not fully vested on his or her termination date, the nonvested amount of the account was forfeited. Forfeitures were used to reduce future company contributions or to pay administrative expenses of the Plan.

#### ***Participant Notes Receivable***

Participants may have borrowed from their accounts a minimum of \$1,000 up to a maximum equal to the lesser of \$50,000 or 50 percent of their vested account balances. The notes receivable were secured by the balance in the participant's account and bore interest at rates that ranged from 4.25 percent to 9.50 percent for the period ended December 31, 2023, which were commensurate with local prevailing rates determined periodically by the plan administrator. Principal and interest were paid ratably through monthly payroll deductions. The Plan allowed two outstanding loans per participant at any time.

#### ***Party-in-interest Transactions***

Certain plan assets were in investment funds managed by Voya Institutional Trust Company, Voya Retirement Insurance and Annuity Company, or their affiliates. Voya Institutional Trust Company was the trustee of the Plan; therefore, these transactions qualified as party-in-interest transactions, as defined under ERISA guidelines.

The Plan provided for loans to participants, which were party-in-interest transactions that were exempt from the prohibited transaction rules.

#### ***Termination***

The Company had the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions set forth in the plan agreement and ERISA. See Note 7 for information related to the Plan's merger into the Guidehouse Inc. Retirement Plan effective January 2, 2024.

### Note 2 - Summary of Significant Accounting Policies

#### ***Basis of Accounting***

The Plan prepared its financial statements on the accrual basis of accounting in conformity with accounting principles generally accepted in the United States of America.

#### ***Investment Valuation and Income Recognition***

Investments held by the Plan were stated at fair value except as noted below. Fair value is defined as the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See Note 5 for further discussion of fair value measurements.

The fully benefit-responsive unallocated contract was valued at contract value. Contract value is the amount participants normally would receive if they were to initiate permitted transactions under the terms of the Plan. Contract value represents deposits made to the contract, plus earnings at guaranteed crediting rates, less withdrawals and fees.

Purchases and sales of securities were recorded on a trade-date basis. Interest income was recorded as earned. Dividends were recorded on the ex-dividend date.

#### ***Participant Notes Receivable***

Participant notes receivable were recorded at their unpaid principal balances plus any accrued interest. Participant notes receivable were written off when deemed uncollectible.

#### **Note 2 - Summary of Significant Accounting Policies (Continued)**

##### ***Benefit Payments***

Benefits were recorded when paid.

##### ***Administrative Expenses***

All administrative costs were paid by the Plan unless otherwise paid by the participant.

##### ***Use of Estimates***

The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America required management to make estimates and assumptions that affected the reported amounts of assets and liabilities and disclosure of contingent assets and liabilities at the date of the financial statements and the reported amounts of additions and deductions during the reporting period. Actual results could have differed from those estimates.

##### ***Risks and Uncertainties***

The Plan invested in various investment securities. Investment securities were exposed to various risks, such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it was at least reasonably possible that changes in the values of investment securities would occur in the near term and that such changes could have materially affected participants' account balances and the amounts reported in the financial statements.

##### ***Subsequent Events***

The financial statements and related disclosures include evaluation of events up through and including September 26, 2024, which is the date the financial statements were available to be issued.

#### **Note 3 - Certified Information**

Voya Institutional Trust Company (the "Trustee") held the Plan's investments and executed all investment transactions. As of December 31, 2023 and 2022 and for the year ended December 31, 2023, the investment balances and related investment income and losses included in the accompanying financial statements were based solely on information certified by the Trustee.

#### **Note 4 - Tax Status**

The Plan used a preapproved plan. The preapproved plan had received a favorable opinion letter from the Internal Revenue Service (IRS) indicating that the Plan, as designed, was qualified for federal income tax exempt status. The Plan had not individually sought its own determination letter.

#### **Note 5 - Fair Value Measurements**

The following valuation methodologies had been used to value the Plan's investments:

##### ***Pooled Separate Accounts***

The pooled separate accounts were valued at net asset value per share or its equivalent of the funds, which was based on the fair value of the funds' net underlying net assets.

- (1) Assets were invested fixed-income securities that had been determined to be appropriate for its investment goal. Investors here were primarily seeking income or growth of income, with less emphasis on capital appreciation. Funds in this asset class varied greatly in their risk profiles. The issuer, credit quality of the underlying investments, and the average duration of the portfolio played important roles in determining the risk profile of the fund. Fixed-income funds were those that had significant investments in below-investment grade bonds (junk bonds) or bonds of foreign issuers that would be categorized as high yield or international bonds. Portfolios consisting of investment-grade corporate bonds; mortgages; government bonds; and, to a lesser degree, preferred stock, foreign bonds, or convertible bonds typically land in the intermediate term bond category. Shorter duration and high credit quality funds were typically categorized as a short-term bond or short-term government funds.
- (2) These funds were also known as LifeStyle or LifeCycle funds. They invested in a combination of assets, such as aggressive stocks, international stocks, large-company stocks, government bonds, foreign bonds, or money markets. The allocation percentage to each asset type may have been fixed, bounded by a range, or determined at the discretion of the manager. Managers of these funds reviewed market conditions regularly and refined the asset allocation mixture they believed will achieve the best risk adjusted performance based on the stated objectives and target allocations of the particular fund. Different constructs could be based on risk tolerance or length of time to investment goal.
- (3) These funds sought to balance growth of principal and current income by investing in a combination of stocks and bonds (generally holding 60-70 percent equity and 30-40 percent fixed income). The investment style used here was either moderate allocation or conservative allocation. Some funds had fixed asset allocations, and others allowed managers discretion to allocate between equities and bonds, depending on their view of return and risk.
- (4) Funds sought long-term growth of capital or a combination of growth and income by investing primarily in stocks of larger, mature companies. The investment styles exhibited were value and blend. Stocks were selected for price appreciation and for the value of the current income provided through dividends. These funds generally exhibited a lower level of price volatility due to the types of companies they favor, such as those able to pay dividends, along with older, more mature companies.
- (5) Large-cap growth funds invested primarily in stocks of larger U.S. companies employing an investment style of growth. A growth fund invested in the stocks of companies that were growing rapidly. Growth companies tended to reinvest all or most of their profits for research and development rather than pay dividends. Growth funds were focused on generating capital gains rather than income. Funds emphasizing growth stocks would typically have higher price/earnings ratios and make little or no dividend payments. Large-capitalization companies tended to be more established, with lower relative volatility, than more aggressive small- and mid-cap stock funds.
- (6) Small-cap, mid-cap, and specialty funds were in this category, employing investment styles of growth, value, or a blend of growth and value. These funds sought capital appreciation by investing primarily in stocks of small- and medium-sized companies. Generally, these companies were striving to develop new products or markets and have above-average earnings growth potential. Because of their smaller size, these companies may have faced greater business risk, and investments in these funds generally carry much higher risk than other domestic equity funds. Specialty or sector funds invest in stocks of companies in a particular industry. This narrow focus could significantly increase the risk and volatility of such funds.

- (7) There were three main types of funds in this category. International funds could have had an investment style of Foreign Large Value, Foreign Large Blend, Foreign Large Growth, Foreign Small/Mid Value, or Foreign Small/Mid Growth. These funds invested in stocks of companies outside of the United States. Global funds had an investment style of World Stock. These funds invested in stocks of companies in the United States and developed countries outside of the United States. Emerging Markets funds invested in securities of developing countries and demonstrated the greatest volatility of performance due to the unstable nature of their economies, political structures, and currencies. International investing may have provided greater diversification benefits to a U.S.-based portfolio than investing in domestic securities alone. However, foreign investing did involve additional risks not present in U.S. securities.

There were no unfunded commitments or redemption restrictions on the investments described above.

#### Note 6 - Investment Contracts

The Plan had a benefit-responsive investment contract with Voya Retirement Insurance and Annuity Company (Voya). Voya maintained the contributions in a general account. The account was credited with earnings on the underlying investments and charged for participant withdrawals and administrative expenses. The investment contract issuer was contractually obligated to repay the principal and a specified interest rate that was guaranteed to the Plan.

Interest was credited on contract balances using a single portfolio rate approach. Under this methodology, a single interest rate was applied to all contributions made to the product, regardless of the timing of those contributions. Interest crediting rates were reviewed on an annual basis for resetting but may not be less than 1.0 percent. When establishing interest crediting rates for this product, Voya considered many factors, including current economic and market conditions, the general interest rate environment, and both the expected and actual experience of a reference portfolio within the issuer's general account.

Generally, there were limited circumstances that could limit the ability of the Plan to transact at contract value. The Company did not believe events that allowed the issuer to terminate the contract and require the plan sponsor to settle an amount different than contract value were probable of occurring. In conjunction with the Plan's merger further discussed in Note 7, the Plan's benefit-responsive investment contract was transferred to the Guidehouse Inc. Retirement Plan at contract value.

#### Note 7 - Plan Merger

Effective January 2, 2024, the Plan merged and combined with the Guidehouse Inc. Retirement Plan (the "New Plan"). In preparation for the merger, all assets of the Plan were liquidated and a transfer initiated to the New Plan.
