We understand that for the purpose of this form submission that a 401K audit is required.

AM LLC had the number of employees to meet the threshold for required audit at the start of calendar year 2023. Very quickly, as the result of significant layoffs due to government contracts ending, we fell below the employee threshold. For calendar year 2024 we currently have less than 15 employees.

We initiated the process to begin the required audit in the spring of 2024. However, the company has been in dire financial straits for several months, essentially insolvent and unable to make payments to external vendors for this type of work. Doing so would result in the immediate closure of the company.

Additionally, we terminated all employee benefits, including health benefits and the 401K program, effective August 1, 2024.

It is my sincere hope that this statement of fact regarding our operations and inability to complete the audit, accompanied by our submission of this form, will be acceptable. Please contact me if necessary.
