## INDEPENDENT AUDITOR'S REPORT

To the Participants and Plan Administrator of the  
Retirement Plan for Union and Non-Union Employees of Schlegel Systems, Inc.

### **Scope and Nature of the ERISA Section 103(a)(3)(C) Audit**

We have performed audits of the financial statements of the Retirement Plan for Union and Non-Union Employees of Schlegel Systems, Inc. (the Plan), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). The financial statements comprise the statements of net assets available for benefits (liquidation basis) as of December 27, 2023 and December 31, 2022, the related statement of changes in net assets available for benefits (liquidation basis) for the period January 1, 2023 to December 27, 2023, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of the Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's (DOL) Rules and Regulations for Reporting and Disclosure under ERISA. As permitted by ERISA Section 103(a)(3)(C), our audits need not extend to any statements or information related to assets held for investment of the Plan (investment information) by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the DOL's Rules and Regulations for Reporting and Disclosure under ERISA (qualified institution).

Management has obtained certifications from a qualified institution as of December 27, 2023 and December 31, 2022, and for the period January 1, 2023 through December 27, 2023, stating that the certified investment information, as described in Note 4 to the financial statements, is complete and accurate.

### **Opinion**

In our opinion, based on our audits and on the procedures performed as described in the Auditor's Responsibilities for the Audit of the Financial Statements section:

- The amounts and disclosures in the accompanying financial statements, other than those agreed to or derived from the certified investment information, are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America (U.S. GAAP).
- The information in the accompanying financial statements related to assets held by and certified to by a qualified institution agrees to, or is derived from, in all material respects, the information prepared and certified by an institution that management determined meets the requirements of ERISA Section 103(a)(3)(C).

**Basis for Opinion**

We conducted our audits in accordance with auditing standards generally accepted in the United States of America (GAAS). Our responsibilities under those standards are further described in the Auditor's Responsibilities for the Audit of the Financial Statements section of our report. We are required to be independent of the Plan and to meet our other ethical responsibilities, in accordance with the relevant ethical requirements relating to our audits. We believe that the audit evidence we have obtained is sufficient and appropriate to provide a basis for our ERISA Section 103(a)(3)(C) audit opinion.

**Emphasis of Matter – Plan Termination and Liquidation Basis**

As described in Note 1 to the financial statements, the Board of Directors of the Plan approved the termination of the Plan effective November 30, 2021, and management commenced its plan to liquidate the assets of the Plan. As of December 27, 2023, all Plan assets have been liquidated. Accordingly, the Plan has presented the financial statements under the liquidation basis. Our opinion is not modified with respect to this matter.

**Responsibilities of Management for the Financial Statements**

Management is responsible for the preparation and fair presentation of the financial statements in accordance with U.S. GAAP, and for the design, implementation, and maintenance of internal control relevant to the preparation and fair presentation of financial statements that are free from material misstatement, whether due to fraud or error. Management's election of the ERISA Section 103(a)(3)(C) audit does not affect management's responsibility for the financial statements.

In preparing the financial statements, management is required to evaluate whether there are conditions or events, considered in the aggregate, that raise substantial doubt about the Plan's ability to continue as a going concern within one year after the date that the financial statements are issued or available to be issued.

Management is also responsible for maintaining a current plan instrument, including all plan amendments, administering the Plan, and determining that the Plan's transactions that are presented and disclosed in the financial statements are in conformity with the Plan's provisions, including maintaining sufficient records with respect to each of the participants, to determine the benefits due or which may become due to such participants.

**Auditor's Responsibilities for the Audit of the Financial Statements**

Except as described in the Scope and Nature of the ERISA Section 103(a)(3)(C) Audit section of our report, our objectives are to obtain reasonable assurance about whether the financial statements as a whole are free from material misstatement, whether due to fraud or error, and to issue an auditor's report that includes our opinion. Reasonable assurance is a high level of assurance but is not absolute assurance and therefore is not a guarantee that an audit conducted in accordance with GAAS will always detect a material misstatement when it exists. The risk of not detecting a material misstatement resulting from fraud is higher than for one resulting from error, as fraud may involve collusion, forgery, intentional omissions, misrepresentations, or the override of internal control. Misstatements are considered material if, there is a substantial likelihood that, individually or in the aggregate, they would influence the judgment made by a reasonable user based on the financial statements.

## **NOTES TO FINANCIAL STATEMENTS DECEMBER 27, 2023 AND DECEMBER 31, 2022**

### ***Note 1*** **Description of the Plan**

The following description of the Retirement Plan for Union and Non-Union Employees of Schlegel Systems, Inc. (the Plan) provides only general information. Participants should refer to the Plan agreement for a more complete description of the Plan's provisions.

#### **General**

The Plan is a non-contributory defined benefit pension plan covering all employees of Schlegel Systems, Inc. (the Company or Plan Sponsor). The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA).

Principal Life Insurance Company (Principal) is the trustee, recordkeeper, and custodian of the Plan.

#### **Plan Termination**

During 2021, the Board of Directors voted to terminate the Plan, effective November 30, 2021. The Company applied for approval for the termination from the Internal Revenue Service (IRS) during 2022 and approval was received during 2023. In September 2023, the Company determined the final termination obligation based on participants electing lump sum distributions or annuity payments.

Lump sum payments made in conjunction with the Plan termination during the period January 1, 2023 through December 27, 2023, were \$5,142,629. These amounts are included in benefits paid to participants in the Statement of Changes in Net Assets Available for Benefits.

In September 2023, a single premium paid-up group annuity contract (Contract) was purchased from Principal in the amount of \$19,786,407.

Retirees and beneficiaries receiving future pension benefits will have such benefits paid by Principal under the Contract and the Company has no further financial obligation. Benefit payments by Principal began as of November 1, 2023.

### ***Note 1* Description of the Plan - Continued**

Prior to the Plan Termination, the following applied:

#### **Eligibility**

All union employees hired after November 22, 2005 are not eligible to participate.

Non-union employees hired after December 17, 2003 are not currently eligible to participate as a result of a December, 2003 amendment that froze the non-union portion of the Plan. Non-union employees hired prior to December 17, 2003 were eligible to participate in the Plan; however, they are not accruing any benefits for service rendered after that date.

#### **Vesting**

All participants in the Plan are fully vested in their benefits.

#### **Pension Benefits**

The Plan provides for normal retirement benefits upon reaching age 65 and has provisions for early retirement benefits. The Plan also provides for benefits upon meeting certain other preconditions. Upon retirement of a union participant, the amount of monthly pension benefit is based on the severance date, as specified by the plan agreement, multiplied by years of benefit service not to exceed 35 years.

Upon retirement of a non-union participant, the monthly pension benefit is computed as 0.9% of average monthly compensation, plus 0.5% of excess average monthly compensation, each multiplied by years of credited service not to exceed 30 years. Effective December 17, 2003, benefit accruals cease after six years of benefit credit is earned. Final average monthly compensation will be determined as of December 31, 2003.

Benefits are payable in the form of joint and survivor annuity, a single life annuity or other optional forms.

Distributions pursuant to the Plan termination will be paid under the Plan termination at the participants' election by (a) purchase of a nontransferable annuity contract; (b) cash distribution of the present value of the participants' accrued benefit; (c) rollover distribution to an eligible retirement plan; or (d) a combination of cash distribution and rollover distribution to an eligible retirement plan; however, option (a) is not available if the participant's accrued benefit is \$5,000 or less.

#### **Funding Policy**

Employees are neither required nor permitted to contribute to the Plan. The Company made contributions to the Plan in accordance with the minimum funding requirements established by the IRS that would ensure that Plan assets were sufficient to pay Plan participants' accrued benefits. The December 31, 2022 Statement of Net Assets Available for Benefits (Liquidation Basis) includes a contribution receivable in the amount of \$3,098,033 that the Company was required to make in order to settle the Plan's termination obligations. This amount was received by the Plan in September 2023.

#### **Administrative Expenses**

Administrative expenses are primarily paid by the Plan. However, the Plan agreement does allow for expenses to be paid by the Company.

### ***Note 2* Summary of Significant Accounting Policies**

#### **Basis of Presentation**

Due to the decision to terminate the Plan during 2021, and ultimately liquidate all plan assets, the financial statements have been prepared using the liquidation basis of accounting.

#### **Subsequent Events**

In preparing the financial statements, the Company has evaluated events and transactions for potential recognition or disclosure through October 7, 2024, the date that the financial statements were available to be issued.

#### **Risks and Uncertainties**

The Plan invests in investment securities which are exposed to various risks, such as interest rate, credit and market volatility. Market risks include global events which could impact the value of investment securities, such as inflation, a pandemic, or international conflict.

Plan contributions are made and the actuarial present value of accumulated plan benefits are reported based on certain assumptions pertaining to interest rates, inflation rates and employee demographics, all of which are subject to change.

#### **Payment of Benefits**

Benefits are recorded when paid.

#### **Investments**

All investments in the statements of net assets available for benefits are reported at liquidation value at December 31, 2022. There were no investments remaining at December 27, 2023.

The pooled separate accounts are valued at the net asset value (NAV) of the units held by the Plan at period end. The NAV is used as a practical expedient to estimate fair value based on the value of the underlying assets in the pooled separate account.

Purchases and sales of securities are recorded on a settlement-date basis. Interest income and dividends are recorded on liquidation basis. Net appreciation includes the Plan's gains and losses on investments bought and sold as well as held during the year.

#### **Use of Estimates**

The preparation of the Plan's financial statements in conformity with accounting principles generally accepted in the United States of America requires management to make estimates and assumptions that affect the reported amounts of assets, liabilities and changes therein, and disclosures of contingent assets and liabilities. Actual results could differ from those estimates. The Plan uses an actuary to determine the actuarial present value of accumulated benefits. A change in the actuarial assumption used could significantly change the amount of actuarial present value of accumulated benefits.

### ***Note 3* Information Certified by the Trustee**

The Plan Administrator has elected the method of compliance permitted by 29 CFR 2520.103-8 of the United States Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. Accordingly, Principal has certified to the completeness and accuracy of all investments reflected on the accompanying statements of net assets available for benefits as of December 27, 2023 and December 31, 2022, the related investment activity reflected in the statement of changes in net assets available for benefits for the period January 1, 2023 through December 27, 2023, and the information reflected on the schedule of reportable transactions for the period January 1, 2023 through December 27, 2023.

### ***Note 4* Tax Status**

The Plan adopted a volume submitter defined benefit plan document sponsored by Principal. The volume submitter defined benefit plan has received an opinion letter from the Internal Revenue Service (IRS), dated March 30, 2018, as to the volume submitter defined benefit plan's qualified status. The volume submitter defined benefit plan opinion letter has been relied upon by the Plan. The Plan has been amended since the volume submitter plan received the opinion letter. The Plan Administrator believes that the Plan is currently designed and being operated in compliance with the applicable requirements of the Internal Revenue Code (IRC).

### ***Note 4* Tax Status - Continued**

The IRS issued a final determination letter dated April 20, 2023, stating that the Plan and related trust are designed in accordance with applicable sections of the IRC and stating that the termination of the Plan does not adversely affect its qualification for federal tax purposes.

Accounting principles generally accepted in the United States of America require plan management to evaluate tax positions taken by the Plan and recognize a tax liability if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS. The Plan is subject to routine audits by taxing jurisdictions; however there are currently no audits for any tax periods in progress.

### ***Note 5* Party-In-Interest Transactions**

Plan investments are shares of pooled separate accounts that are managed by Principal. Principal is the trustee, recordkeeper, and custodian of the Plan and, therefore, transactions involving these investments qualify as party-in-interest transactions.
