Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed audits of the financial statements of D3 401(k) Plan, an employee benefit plan subject to the *Employee Retirement Income Security Act of 1974* (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). The financial statements comprise the statements of net assets available for benefits as of December 31, 2023 (in Liquidation) and 2022 (Ongoing), and the related statements of changes in net assets available for benefits for the years then ended, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of D3 401(k) Plan's financial Statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. As permitted by ERISA Section 103(a)(3)(C), our audits need not extend to any statements or information related to assets held for investment of the plan (investment information) by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA (qualified institution).

Management has obtained a certification from a qualified institution as of and for the year ended December 31, 2023 (in Liquidation) and from a qualified institution and from an agent on behalf of a qualified institution as of and for the year ended December 31, 2022, (Ongoing) stating that the certified investment information, as described in *Note 3* to the financial statements, is complete and accurate.

Opinion

In our opinion, based on our audits and on the procedures performed as described in the Auditor's Responsibilities for the Audit of the Financial Statements section:

- The amounts and disclosures in the accompanying financial statements, other than those agreed to or derived from the certified investment information, are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America.
- The information in the accompanying financial statements related to assets held by and certified to by a qualified institution and by an agent on behalf of a qualified institution agrees to, or is derived from, in all material respects, the information prepared and certified by an institution or an agent on behalf of an institution that management determined meets the requirements of ERISA Section 103(a)(3)(C).

Basis for Opinion

We conducted our audits in accordance with auditing standards generally accepted in the United States of America (GAAS). Our responsibilities under those standards are further described in the Auditor's Responsibilities for the Audit of the Financial Statements section of our report. We are required to be independent of D3 401(k) Plan, and to meet our other ethical responsibilities, in accordance with the relevant ethical requirements relating to our audits. We believe that the audit evidence we have obtained is sufficient and appropriate to provide a basis for our ERISA Section 103(a)(3)(C) audit opinion.

Emphasis of Matter

As discussed in *Note 1* to the financial statements, the governing body of D3 401(k) Plan approved a plan of liquidation on June 29, 2023, and management determined liquidation is imminent. In accordance with accounting principles generally accepted in the United States of America, the Plan has changed its basis of accounting from the ongoing basis used in presenting the 2022 financial statements to the liquidation basis used in presenting the 2023 financial statements. Our opinion is not modified with respect to this matter.

Responsibilities of Management for the Financial Statements

Management is responsible for the preparation and fair presentation of the financial statements in accordance with accounting principles generally accepted in the United States of America, and for the design, implementation, and maintenance of internal control relevant to the preparation and fair presentation of financial statements that are free from material misstatement, whether due to fraud or error. Management's election of the ERISA Section 103(a)(3)(C) audit does not affect management's responsibility for the financial statements.

In preparing the financial statements, management is required to evaluate whether there are conditions or events, considered in the aggregate, that raise substantial doubt about D3 401(k) Plan's ability to continue as a going concern within one year after the date that these financial statements are available to be issued.

Management is also responsible for maintaining a current plan instrument, including all plan amendments, administering the plan, and determining that the plan's transactions that are presented and disclosed in the financial statements are in conformity with the plan's provisions, including maintaining sufficient records with respect to each of the participants, to determine the benefits due or which may become due to such participants.

Note 1. Description of the Plan

General

The following description of D3 401(k) Plan (Plan) provides only general information. Participants should refer to the Plan Document for a more complete description of the Plan's provisions, which is available from the plan administrator.

The Plan is a defined contribution plan sponsored by D3 Technical Services, LLC, d/b/a D3 Technologies (Sponsor), for the benefit of its employees. Employees who are age 18 or older are eligible after completing one month of service. Eligible participants enter the Plan on the first day of the month following the month in which eligibility requirements are met. Effective January 2, 2023, former employees of Mastergraphics.aec, LLC and ECAD, Inc., who are employed by the Sponsor and have met the service and age requirements at that date, can enter the Plan on January 2, 2023.

The Plan is subject to the provisions of the *Employee Retirement Income Security Act of 1974* (ERISA).

Talcott Resolution Life Insurance Company (TRLIC) (formerly known as Hartford Life Insurance Company) held the Plan's annuity contract. During 2022, the Plan converted from the TRLIC annuity contract to a mutual fund investment platform and Empower Trust Company, LLC (formerly known as Great-West Trust Company, LLC), became the Plan's custodian.

Prior to June 18, 2022, Massachusetts Mutual Life Insurance Company (MassMutual) served as the administrative services provider for the TRLIC contract. On December 31, 2020, Empower Annuity Insurance Company of America (formerly known as Great-West Life & Annuity Insurance Company) (Empower) acquired the retirement business of MassMutual. Following a transition period, Empower became the sole administrator of this business and began serving as the TRLIC contract administrator and recordkeeper on June 18, 2022, at which time the Plan migrated from the legacy MassMutual recordkeeping platform to the Empower Retirement LLC recordkeeping platform. As this was a platform migration and not a true transfer of assets to a new custodian, no formal black out period was required.

Effective January 1, 2022, the Plan was restated under a nonstandardized pre-approved adoption agreement in connection with a pre-approved retirement plan document sponsored by Frost PLLC, at which point the plan became a safe harbor plan.

Plan Termination

The Sponsor has the right under the Plan to discontinue its contributions at any time and to terminate the Plan, subject to the provisions of ERISA. However, no such action may deprive any beneficiary under the Plan of any vested right. On June 29, 2023, the members of the plan sponsor, D3 Technical Services, LLC, d/b/a D3 Technologies, voted to terminate the D3 401(k) Plan, effective on July 2, 2023. This was due to the plan sponsor, being acquired by Addnode USA Holding, Co., effective June 1, 2023. As a result, all participants became 100% vested in their accounts and the Plan became frozen and no longer accepted contributions. The Plan made distributions to all participants pursuant to the applicable provisions of ERISA.

Contributions

Prior to July 2, 2023, the Plan permitted eligible employees through a salary deferral election to have the Sponsor make annual pre-tax or Roth contributions up to the maximum allowed by the Internal Revenue Code. Participants who had attained age 50 before the end of the plan year were eligible to make catch-up contributions. Employee rollover contributions were also permitted.

Effective January 1, 2022, the Sponsor was required to make safe harbor matching contributions on behalf of each of its eligible employees of 100% of salary deferrals, up to the first 3% of plan compensation, plus 50% of salary deferrals up to the next 2% of plan compensation. The Sponsor may also elect to make a discretionary matching contribution and qualified nonelective contributions. The Sponsor did not approve to make discretionary matching contributions during 2023 or 2022.

Contributions are subject to certain limitations.

Effective July 2, 2023, the Plan became frozen and no longer accepted contributions.

Participant Investment Account Options

Investment account options available include various funds. Each participant has the option of directing their contributions into any of the separate investment account options offered by the Plan and may change the allocation daily.

Participant Accounts

Each participant's account is credited with the participant's contribution, the Sponsor's contribution, and plan earnings and is charged with an allocation of administrative expenses. Allocations are based on participant earnings or account balances, as defined. The benefits to which a participant is entitled is the benefit that can be provided from the participant's vested account.

Vesting

Participants are immediately vested in their voluntary contributions, rollover contributions, and the Sponsor's matching safe harbor contributions plus earnings thereon. Vesting in the Sponsor's discretionary matching contribution portion of their accounts plus earnings thereon is based on years of continuous service. A participant is fully vested after five years of continuous service. The nonvested balance is forfeited upon termination of service. Forfeitures are used to reduce Sponsor contributions and/or to pay plan expenses.

Effective on January 1, 2023, all participants actively employed on January 1, 2023, were immediately vested in their employer matching contribution account. Any future discretionary employer matching contributions will be subject to the Plan's vesting schedule.

On June 29, 2023, the Plan was amended and became terminated as of July 2, 2023. Therefore, each participant's individual participant account became 100% vested.

Notes Receivable from Participants

Participants may borrow from their fund accounts a minimum of \$1,000 up to a maximum equal to one half of their vested account balance. In addition, the total amount of outstanding loans during any 12-month period may not exceed \$50,000. The loans are secured by the vested balance in the participant's account. All loans are covered by promissory notes and principal and interest are repayable ratably over a period not to exceed five years (except for loans for the purchase of a principal residence) through payroll withholdings. The loan interest rate, determined on the date of loan origination, is set at 1% above the prime rate, as defined.

Payment of Benefits

Upon termination of service due to death, disability, retirement, or termination of employment, a participant may elect to receive either a lump-sum amount equal to the value of their vested account or installments. Upon termination of service for other reasons, a participant may receive to the value of the vested interest in their account (or a portion of it) only as a lump-sum distribution. A participant may also elect a direct rollover to an IRA or another qualified retirement plan. If the participant's account balance is less than \$1,000, the plan administrator may make a lump sum distribution of their vested account balance.

Forfeited Accounts

At December 31, 2023 and 2022, forfeited nonvested accounts totaled \$0 and \$11,649, respectively. These accounts represent employer contributions made to and forfeited from certain participant accounts that will be used to reduce future employer contributions or pay plan administrative expenses. Also, in 2023, employer contributions were reduced by \$12,025 from forfeited nonvested accounts.

Note 2. Summary of Significant Accounting Policies

Basis of Accounting

The accompanying financial statements for 2023 are prepared on the liquidation basis of accounting. The accompanying financial statements for 2022 are prepared on the accrual basis of accounting.

Use of Estimates

The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires management to make estimates and assumptions that affect the reported amounts of net assets and changes in net assets and disclosure of contingent assets and liabilities at the date of the financial statements. Actual results could differ from those estimates.

Investment Valuation and Income Recognition

Investments are reported at fair value. Quoted market prices, if available, are used to value investments. Mutual funds are valued at the net asset value (NAV) of shares held by the Plan at year-end. Pooled separate accounts are valued at estimated fair value as provided by Talcott Resolution Life Insurance Company.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation (depreciation) in the fair value of investments includes the Plan's gains and losses on investments bought and sold as well as held during the year.

Notes Receivable from Participants

Notes receivable from participants are reported at their unpaid principal balance plus any accrued but unpaid interest. Delinquent participant loans are reclassified as distributions based upon the terms of the Plan document.

Payment of Benefits

Benefit payments to participants are recorded upon distribution.

Administrative Expenses

Administrative expenses may be paid by the Sponsor or the Plan, at the Sponsor's discretion.

Note 3. Certification of Plan Custodian and Insurance Sponsor's Agent

The Plan Administrator has elected the method of annual reporting compliance permitted by ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. Accordingly, for the period of January 1, 2022, through December 15, 2022, Empower Annuity Insurance Company of America, as agent for Talcott Resolution Life Insurance Company, and from the period December 15, 2022, through December 31, 2023, Empower Trust Company, LLC, all qualified institutions, certified the following information included in the accompanying financial statements and ERISA-required supplemental schedule is complete and accurate:

- Investments and notes receivable from participants as shown in the statements of net assets available for benefits as of December 31, 2023 and 2022.
- Investment income (loss) and interest income on notes receivable from participants as shown in the statements of changes in net assets available for benefits for the years ended December 31, 2023 and 2022.

The Plan's independent auditors did not perform auditing procedures with respect to this certified investment information, except for comparing such certified investment information to the related investment information included in the financial statements and ERISA-required supplemental schedule.

Note 4. Related-Party and Party-in-Interest Transactions

Party-in-interest transactions include those with fiduciaries or employees of the Plan, any person who provides services to the Plan, an employer whose employees are covered by the Plan, an employee organization whose members are covered by the Plan, a person who owns 50% or more of such an employer or employee association, or relatives of such persons.

The Plan paid \$32,567 and \$363 of direct recordkeeping fees to Empower Annuity Insurance Company of America during 2023 and 2022, respectively.

The Sponsor provides certain administrative services at no cost to the Plan.

Note 5. Disclosures about Fair Value of Plan Assets and Liabilities

Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. Fair value measurements must maximize the use of observable inputs and minimize the use of unobservable inputs. The hierarchy comprises three levels of inputs that may be used to measure fair value:

- Level 1** Quoted prices in active markets for identical assets or liabilities.
- Level 2** Observable inputs other than Level 1 prices, such as quoted prices for similar assets or liabilities; quoted prices in markets that are not active; or other inputs that are observable or can be corroborated by observable market data for substantially the full term of the assets or liabilities.
- Level 3** Unobservable inputs supported by little or no market activity and that are significant to the fair value of the assets or liabilities.

There have been no significant changes in the valuation techniques during the year ended December 31, 2023. The Plan had no liabilities measured at fair value on a recurring basis. In addition, the Plan had no assets or liabilities measured at fair value on a nonrecurring basis.

Investments

Where quoted market prices are available in an active market, securities are classified within Level 1 of the valuation hierarchy and include mutual funds. If quoted market prices are not available, then fair values are estimated by using quoted prices of securities with similar characteristics or independent asset pricing services and pricing models, the inputs of which are market-based or independently sourced market parameters, including, but not limited to, yield curves, interest rates, volatilities, prepayments, defaults, cumulative loss projections, and cash flows. Such securities are classified in Level 2 of the valuation hierarchy and include pooled separate accounts. In certain cases where Level 1 or Level 2 inputs are not available, investments are classified within Level 3 of the hierarchy.

Note 7. Nonexempt Transactions

Defined contribution plans are required to remit employee contributions to the Plan as soon as they can be reasonably segregated from the employer's general assets, but no later than the 15th business day of the month following the month in which the participant contributions are withheld by the employer. While the Sponsor remitted all employee contributions to the Plan, contributions of \$2,158 were not remitted within the required time period for the year ended December 31, 2020. The Sponsor calculated and remitted lost earnings and interest by following the DOL guidelines for the 2020 contributions during 2023. For the year ended December 31, 2023, the Plan had no reportable delinquent remittances.

Note 8. Risks and Uncertainties

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect the participants' account balances and the amounts reported in the statements of net assets available for benefits.

Note 9. Tax Status

The Plan operates under a nonstandardized pre-approved adoption agreement in connection with a pre-approved retirement plan and trust/custodial document sponsored by Frost, PLLC. This pre-approved plan document has been filed with the appropriate agency and has obtained an opinion letter from the Internal Revenue Service stating that the pre-approved plan constitutes a qualified plan under Section 401 of the Internal Revenue Code. The Plan has not obtained or requested a determination letter. However, the Plan Administrator believes the Plan is currently designed and being operated in compliance with the applicable requirements of the Internal Revenue Code and the Plan was qualified, and the related trust was tax exempt as of the financial statement date.

Note 10. Subsequent Events

Subsequent events have been evaluated through October 4, 2024, which is the date the financial statements were available to be issued.


