**INDEPENDENT AUDITOR'S REPORT**

**Opinion**

NOTE A - DESCRIPTION OF THE PLAN

The following description of America's Floor Source, LLC (Company) Employee Health & Welfare Benefit Plan (Plan) provides only general information. Participants should refer to the Plan agreement for a more complete description of the Plan's provisions.

General

The Plan provides health benefits covering substantially all employees of the Company. It is subject to the provisions of the Employee Retirement Income and Security Act of 1974 (ERISA).

Benefits

The Plan provides health benefits (hospital, surgical, major medical, and prescription) covering full-time employees of the Company working 30 hours or more per week. In addition, life and disability benefits are also provided.

Contributions

Contributions to the Plan are made by the Company and the participating employee. The employee's contribution is determined by the employer/plan sponsor. The Company pays the balance of the Plan costs.

Stop Loss Insurance

Eligible medical expenses in excess of \$50,000 per covered person per Plan year are covered by specific excess loss insurance. Amounts necessary to pay the premiums for the specific excess loss insurance are contributed to the plan by the employer. In addition, the plan carries aggregate excess loss insurance coverage to provide benefits when the group's claims exceed the annual aggregate deductible.

Plan Benefits

Plan liabilities for health claims incurred but not paid or reported as of December 31, 2023 and 2022 are based upon actual experience of claims incurred prior to December 31, 2023 and 2022. These claims were paid in the subsequent periods after December 31, 2023 and 2022. The liabilities for death benefits are not shown since the Plan is not at risk with respect to such benefits. The current benefit obligations at December 31, 2023 and 2022 and changes in benefit obligations for the years ended December 31, 2023 and 2022 are as follows:

Use of Estimates

The preparation of financial statements in conformity with generally accepted accounting principles requires management to make estimates and assumptions that affect the amounts reported in the financial statements and accompanying notes. Actual results could differ from those estimates.

Accounts Receivable-Contributions and Reimbursements

Contributions receivable represent amounts due as of December 31, 2023 and 2022, under the terms of the Plan, to cover allowable benefits incurred as of December 31, 2023 and 2022. No allowance for credit losses is required.

NOTE C - INVESTMENTS

The Plan did not hold any investments during the years ended December 31, 2023 and 2022.

NOTE D - TAX STATUS

The Plan is designed to qualify as tax-exempt under the appropriate section of the Internal Revenue Code. There is no determination letter program for Health and Welfare Plans provided by the Internal Revenue Service. Therefore, a determination letter for tax exemption has never been received. The Plan Sponsor and Administrator believe that the Plan is currently designed and being operated in compliance with the applicable requirements of the Internal Revenue Code. The Plan administrator believes the Plan is no longer subject to income tax examinations for years prior to December 31, 2020.

Administrative expenses paid to BAC, Inc. (TPA) amounted to \$235,358 for the year ended December 31, 2023.

These transactions are not deemed prohibited party-in-interest transactions because they are covered by the statutory or administrative exceptions from the Internal Revenue Code's and ERISA's rules on prohibited transactions.
