**INDEPENDENT AUDITOR'S REPORT**

To the Plan Administrator

***Scope and Nature of the ERISA Section 103(a)(3)(C) Audit***

**NOTE 1**  
**DESCRIPTION OF PLAN**

---

The following description of the Evansville Surgery Center 401(k) Retirement Plan (the Plan) provides only general information. Participants should refer to the Plan agreement for a more complete description of the Plan's provisions.

**General:**

The Plan is a defined contribution plan available to all employees of Evansville Surgery Center Associates, LLC (the Company) who are age eighteen or older, except casual or PRN employees. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA). Subsequent to the end of the year, in September 2024, the Plan sponsor was changed to Evansville Surgery Services, LLC. All employees of Evansville Surgery Center Associates, LLC became employees of Evansville Surgery Services, LLC with no impact on eligibility.

**Contributions:**

The Plan provides that participants may contribute up to 100% of pretax annual compensation up to limits prescribed in the Internal Revenue Code (IRC). Participants who have attained age 50 before the end of the plan year are eligible to make catch-up contributions. Participants may also contribute amounts representing distributions from other qualified retirement plans. Participants direct the investment of their contributions into various investment options offered by the Plan. The Plan includes an auto-enrollment provision whereby all newly eligible employees are automatically enrolled in the Plan, unless they affirmatively elect not to participate, with a default deferral rate set at 6% of eligible compensation. The Company contributes a matching contribution equal to 50% of the participants' contributions up to 6% of eligible compensation. The Company may also contribute a discretionary profit-sharing contribution. Contributions are subject to certain IRC limitations.

**Participant accounts:**

Each participant's account is credited with the participant's contribution and Company contributions, as well as allocations of Plan earnings. Participant accounts are charged with an allocation of administrative expenses that are paid by the Plan. Allocations are based on participant earnings, account balances, or specific participant transactions, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

**DESCRIPTION OF PLAN**

---

**Vesting:**

Participants are immediately vested in their contributions plus actual earnings thereon and in the Company matching contributions plus actual earnings thereon over a six year vesting schedule. Vesting in the Company's discretionary contribution portion of their accounts, plus actual earnings thereon, is based on years of credited service. A participant is 100% vested after six years of credited service.

**Payment of benefits:**

Benefits begin at retirement age, termination of employment, total and permanent disability or death of the participant. Distribution of benefits may be made as a qualified joint and survivor annuity with installment payments or in one lump sum as requested by the participant.

**Forfeitures:**

Forfeitures of non-vested accounts may be used to pay administrative expenses of the Plan. If forfeitures exceed those expenses, they may then be applied to reduce the employer's contribution. At December 31, 2023 and 2022, there were \$2,131 and \$1,793, respectively, of unallocated forfeitures. No forfeitures were used to pay administrative expenses in 2023.

**NOTE 2**  
**SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES**

---

A summary of the Plan's significant accounting policies follows:

**Basis of accounting:**

The financial statements of the Plan are prepared on the accrual basis of accounting.

**Use of Estimates:**

The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America (GAAP) requires the management to make estimates and assumptions that affect the reported amounts of assets and liabilities and changes therein, and disclosures of contingent assets and liabilities. Accordingly, actual results may differ from those estimates.

**SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES**

---

**Investments valuation and income recognition:**

Investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See *Note 4* for discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation includes the Plan's gains and losses on investments bought and sold as well as held during the year.

**Notes receivable from participants:**

Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Interest income is recorded on the accrual basis. Related fees are charged directly to the borrowing participant's account and are included in administrative expenses when incurred. No allowance for credit losses has been recorded as of December 31, 2023 or 2022. If a participant ceases to make loan repayments and the plan administrator deems the participant loan to be in default, the participant loan balance is reduced, and the delinquent participant note receivable is recorded as a benefit payment based on the terms of the plan document.

**Payment of benefits:**

Benefits are recorded when paid.

**Administrative expenses:**

The expenses that are paid from Plan assets are either shared by all participants or charged directly to the account of the participant on whose sole behalf the expense is incurred. Investment related expenses are included in net appreciation in fair value of investments.

**Subsequent events:**

Plan management has evaluated subsequent events through October 9, 2024, the date which the financial statements were available to be issued.

**NOTE 3**  
**INFORMATION CERTIFIED AND PROVIDED BY THE TRUSTEE**

---

The plan administrator has elected the method of compliance permitted by 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. Therefore, certain information related to investments disclosed in the accompanying financial statements and the supplemental schedule of assets (held at end of year), including investments held at December 31, 2023 and 2022, and investment income for the year ended December 31, 2023, was obtained or derived from information supplied to the plan administrator and certified as complete and accurate by Fidelity Management Trust Company ("Fidelity"), the trustee of the Plan.

**NOTE 4**  
**FAIR VALUE MEASUREMENTS**

---

The fair value measurement accounting literature establishes a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. This hierarchy consists of three broad levels: Level 1 inputs consist of unadjusted quoted prices in active markets for identical assets and have the highest priority. Level 2 inputs consist of observable inputs other than quoted prices for identical assets (Level 1). Level 3 inputs are unobservable and have the lowest priority. The Plan uses appropriate valuation techniques based on the available input to measure the fair value of its investments. When available, the Plan measures fair value using Level 1 inputs because they generally prove the most reliable evidence of fair value. Level 2 inputs are used for investments for which Level 1 inputs were not available. Level 3 inputs would only be used if Level 1 or Level 2 inputs were not available. There are no plan assets requiring the use of Level 2 or Level 3 inputs for the periods presented.

**Level 1 fair value investments:**

The fair value of mutual funds is based on quoted net asset values of the shares as reported by the fund. The mutual funds held by the Plan are open-end mutual funds registered with the U.S. Securities and Exchange Commission. The funds must publish their daily net asset value and transact at that price. The mutual funds held by the Plan are considered to be actively traded. The fair value of the money market fund is valued at NAV of the respective fund, which approximates fair value.

**RELATED PARTY TRANSACTIONS**

Certain Plan investments are managed by Fidelity. Fidelity is the trustee as defined by the Plan and therefore, these transactions qualify as party-in-interest transactions. Fees paid by the Plan for investment management services are included in net appreciation in fair value of investments.

**NOTE 6**  
**PLAN TERMINATION**

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, participants would become 100% vested in their accounts.

**NOTE 7**  
**TAX STATUS**

---

Although the Plan has not requested determination from the Internal Revenue Service as to the Plan's tax-exempt status, the master prototype plan from which the Plan was drafted has received a favorable determination from the IRS. Plan management believes that the Plan is designed to operate in accordance with all applicable provisions of the Internal Revenue Code. Therefore, management believes that the Plan is qualified and that the related trust is exempt from taxation under the Internal Revenue Code.

Accounting principles generally accepted in the United States of America require the plan administrator to evaluate tax positions taken by the Plan and recognize a tax liability for any uncertain position that more likely than not would not be sustained upon examination by the IRS. The Plan is subject to routine audits by tax authorities; however, there are currently no audits for any tax periods in progress. The Plan administrator believes the Plan is no longer subject to income tax examinations for years prior to 2020.

**NOTE 8**  
**RISKS AND UNCERTAINTIES**

---

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits.

**NOTE 9**  
**PROHIBITED TRANSACTIONS**

---

During 2023, the plan sponsor inadvertently failed to deposit participant deferrals within the required timeframe as stated by the United States Department of Labor (DOL). The DOL considers late deposits to be prohibited transactions. Untimely remittances totaled \$18,681 and were corrected by the plan sponsor in 2023. Additionally, the plan sponsor has compensated participants for lost earnings resulting from the delay in contributions.
