Opinion

Our objectives are to obtain reasonable assurance about whether the financial statements as a whole are free from material misstatement, whether due to fraud or error, and to issue an auditors' report that includes our opinion. Reasonable assurance is a high level of assurance but is not absolute assurance and therefore is not a guarantee that an audit conducted in accordance with GAAS will always detect a material misstatement when it exists. - Evaluate the appropriateness of accounting policies used and the reasonableness of significant accounting estimates made by management, as well as evaluate the overall presentation of the financial statements.
- Conclude whether, in our judgment, there are conditions or events, considered in the aggregate, that raise substantial doubt about the plan's ability to continue as a going concern for a reasonable period of time.

We are required to communicate with those charged with governance regarding, among other matters, the planned scope and timing of the audit, significant audit findings, and certain internal control-related matters that we identified during the audit.

NOTE 1 DESCRIPTION OF PLAN

The following description of The Hagadone Corporation Employee Benefit Trust (the Plan) provides only general information. Participants should refer to the Plan document for a more complete description of the Plan's provisions.

General

The Plan was established by The Hagadone Corporation and related companies (collectively, the Company) to provide benefits for eligible employees and their dependents whether through self-funded or insured programs or both. Benefits provided include medical coverage, dental, vision, life, and accidental death and dismemberment insurance and long-term disability or sickness coverage, and other benefits as determined by the trustees. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA), as amended.

Eligibility

Permanent employees of the Company, who meet the eligibility requirements, including length of service and minimum hours, may participate in the benefits provided by the Plan. In general, all employees scheduled to work at least 30 hours per week on a regular basis are eligible to participate after a 60-day waiting period. The Plan is subject to the provisions of ERISA, as amended.

Administration of the Plan

The Plan is administered by a Board of Trustees consisting of employees of The Hagadone Corporation. The Board of Trustees receives assistance from a contract administrator, which processes and pays the medical claims. Administrative expenses are ordinarily borne by the Plan.

Contributions

The Board of Trustees establishes monthly contributions to be provided by both the participating companies and by employees who elect to cover dependents under the Plan. All contributions to the Plan are irrevocable. Contributions and earnings thereon are used exclusively for benefits for employees and dependents as provided in the Plan agreement. In the event that reported claims exceed cash available to pay such claims, the Company contributes an amount sufficient to restore the Plan to a positive cash position.

Benefits

The Plan provides benefits after two months of employment for full-time employees. The Plan provides health benefits (medical, dental, vision, and prescription drugs), life insurance, short and long-term disability benefits, and accidental death and dismemberment benefits to eligible members and to their beneficiaries and dependents. The Plan also provides continuation of certain benefits upon termination of employment through the Consolidated Omnibus Budget Reconciliation Act (COBRA).

NOTE 1 DESCRIPTION OF PLAN (CONTINUED)

Insured Benefits

The Plan fully insures the life insurance benefits (basic, supplemental, and dependent), accidental death and disability benefits (basic, supplemental, and spousal), dental, vision, and long-term disability benefits. The Company purchases annual insurance contracts for these insured benefits. Premiums are paid to the insurance company from the general assets of the Company.

Stop-Loss Coverage

The Plan has entered into a stop-loss insurance arrangement in an effort to limit its exposure for self-insured benefits (individual participant claims over a specific dollar amount, as well as its aggregate exposure for all claims).

Healthcare Clinic

The Plan pays a third-party for administrative costs to run The Hagadone Medical Clinic that opened in August 2023. The clinic provides a range of medical services to employees and their dependents. The clinic is staffed by licensed healthcare professionals and offers services including primary care, preventative care, and wellness programs.

NOTE 2 SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES

Basis of Accounting

The financial statements of the Plan are prepared on the accrual basis of accounting.

Use of Estimates

The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires the Plan administrator to make estimates and assumptions that affect the reported amounts of assets, liabilities, benefit obligations and changes therein, incurred but not reported claims (IBNR), claims payable, and disclosure of contingent assets and liabilities at the date of the financial statements. Actual results could differ from those estimates.

Concentration of Credit Risk

Cash is maintained in deposit accounts which at times may exceed federally insured limits. No losses in such accounts have been experienced or are expected.

Expenses

Certain benefit related expenses are paid by the Plan. All other expenses are paid by the Company.

NOTE 2 SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES (CONTINUED)

Payment of Benefits

Claim payments are recorded when reimbursed by the Plan to the third-party claims processor. Amounts due to claims processors that have yet to be reimbursed by the Plan are recorded as payable to claims administrators in the accompanying statements of net assets available for benefits and benefit obligations.

Premiums paid by the Plan are recorded as premium payments in the accompanying the statements of changes in net assets available for benefits and benefit obligations.

Stop-Loss

Premiums for stop-loss insurance are included in insurance premium payments in the accompanying statements of changes in net assets available for benefits and benefit obligations. Stop-loss refunds totaling \$1,334,228 for the year ended December 31, 2023, have been netted with claims paid for participants in the accompanying statements of changes in net assets and benefit obligations.

Refunds

Refunds are recorded when received, as not reasonably estimable, and are netted against claims paid to participants. Prescription refunds totaled approximately \$284,817 for the year ended December 31, 2023.

Subsequent Events

In preparing these financial statements, the Plan has evaluated events and transactions for potential recognition or disclosure through September 30, 2024, the date the financial statements were available to be issued.

NOTE 3 BENEFIT OBLIGATIONS

The Plan “self-funds” the majority of the benefits provided to participants but insures life, accidental death and dismemberment, dental, vision and long-term disability benefits. As of each December 31, there are many self-funded claims that have been incurred on which benefit payments will be made subsequent to that date. The liability for claims IBNR and claims payable at December 31, 2023 and 2022 was estimated using Plan provisions, the number of eligible participants, and the actual claims lag patterns of the Plan. The Plan does not provide any retiree benefits.

The Plan’s deficiency of net assets over benefit obligations will be funded through future increases in contributions.

NOTE 4 TAX STATUS

The Plan is placing reliance on an opinion letter received from the Internal Revenue Service (IRS) indicating that the Plan is qualified under the Internal Revenue Code (IRC) and is therefore not subject to tax under current income tax law. The Plan has been amended since receiving the opinion letter. However, the Plan administrator believes that the Plan is designed, and is currently being operated, in compliance with the applicable requirements of the IRC and, therefore, believes that the Plan is qualified, and the related trust is tax-exempt.

Accounting principles generally accepted in the United States of America require Plan management to evaluate tax positions taken by the Plan and recognize a tax liability (or asset) if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

NOTE 5 PLAN TERMINATION

The Company has the right to amend, in whole or in part, any or all of the provisions of the Plan at any time. No modification or amendment shall divest an employee of a right to which he or she is entitled under the Plan. Additionally, the Company also retains the right to terminate the Plan at any time, although it has no intention to do so. Upon such termination of the Plan, the assets will be used to pay claims and expenses until exhausted. No assets will revert to the Company.

NOTE 6 RISKS AND UNCERTAINTIES

The liability for claims IBNR and claims payable at December 31, 2023 and 2022 was estimated using Plan provisions, the number of eligible participants, and the actual lag patterns of the Plan. Due to uncertainties inherent in the estimations and assumptions process, it is at least reasonably possible that changes in these estimates and assumptions in the near term would be material to the financial statements.

NOTE 7 PARTY-IN-INTEREST TRANSACTIONS

As described in Notes 1 and 2, the Plan has several arrangements with service providers. These transactions are party-in-interest transactions under ERISA.
