NOTES TO FINANCIAL STATEMENTS (IN LIQUIDATION)

For the Period January 1, 2023 through December 19, 2023

NOTE 1 – DESCRIPTION OF THE PLAN

The following description of the Wendel Rosen 401(k) Profit Sharing Plan & Trust (the “Plan”) provides only general information. Participants should refer to the Plan Agreement for a complete description of the Plan’s provisions.

Plan Termination – The Executive Committee of Wendel Rosen LLP, the Plan sponsor (the “Company”), voted on November 21, 2022 to terminate the Plan effective December 31, 2022. As of the date of termination, participants became 100% vested in their account balances and had an option to rollover their vested balances to the defined contribution plan sponsored by Fennemore Craig, P.C. In 2023, there were transfers of \$129,039 out of the Plan. All plan assets were distributed from or transferred out of the Plan by December 19, 2023.

General – The Plan was originally established to provide benefits for the employees of the Company as a voluntary defined contribution plan covering all employees of the Company age 21 years or older who had met the eligibility requirements. The Plan was subject to the provisions of the Employee Retirement Income Security Act of 1974 (“ERISA”) and certain provisions of the Internal Revenue Code (“IRC”). Effective January 1, 2022, the Plan was amended and restated to Vanguard’s pre-approved defined contribution plan. There were no significant changes to the Plan’s provisions as a result of this change.

Participants were able to contribute to the Plan effective the first day of the month following their hire and satisfaction of the service and age requirements. The Plan provided for automatic enrollment of all new eligible participants at a 4% pre-tax elective deferral rate and their contributions were invested in a designated balanced fund until changed by the participant. On the first day of each Plan year, the deferral rate would increase 1% until it reached a maximum of 15%. Eligible participants were able to affirmatively elect to “opt out” of these automatic features or elect a different deferral rate. The service requirement to be eligible for employer matching and profit-sharing contributions was 1,000 hours. Employees governed under a collective bargaining agreement, non-resident aliens and leased employees were excluded from participating in the Plan.

The Plan provided for a plan administrator who was responsible for keeping accurate and complete records with regard to the Plan’s operations, informing participants of changes or amendments to the Plan, ensuring that the Plan conforms to the law and government regulations, and providing participants with any reports and documents required by law. The Plan’s 401(k) Committee was responsible for oversight of the Plan, which included determining the appropriateness of the Plan’s investment offerings and monitoring investment performance.

Participant Contributions – Prior to the Plan termination, participants were able to voluntarily contribute any combination of pre-tax elective deferrals and post-tax (“Roth”) elective deferrals from 1% to 100% of their eligible earnings, as defined in the Plan document, with maximum contributions of \$20,500 for the year ended December 31, 2022. Participants who were 50 years of age or older by the end of the calendar year and who were making contributions to the Plan were able to make a catch-up contribution of up to \$6,500 for 2022. The Plan allowed for participants to elect a separate deferral election for bonuses. Participants were able to also contribute amounts representing rollovers from other eligible retirement plans.

NOTE 1 – DESCRIPTION OF THE PLAN (Continued)

Employer Contributions – Prior to the Plan termination, the Company was able to make discretionary profit-sharing contributions for employees who had met the service requirement. Effective July 1, 2022, the Plan was amended to exclude employer matching contributions and to remove the minimum service requirement for employer contributions. For the year ended December 31, 2022, the Company made a profit-sharing contribution of up to 3.00% of eligible compensation for professional staff and the lesser of 9.00% of eligible compensation or \$15,000 for partners. Participants had to be employed on the last day of the Plan year to receive matching or profit-sharing contributions. Qualified nonelective contributions of approximately \$2,600 were contributed to the Plan in 2023 (see Note 8).

Participant Accounts – The Plan maintained an account for each participant which was credited with the participant’s contributions and allocations of the Company’s contributions and Plan investment earnings or losses, and charged with an allocation of administrative expenses that were paid by the Plan. Allocations were based on participant earnings, account balances, or specific participant transactions, as defined in the Plan document. The benefit to which a participant was entitled was the benefit that can be provided from the participant’s vested account balance.

Vesting – Effective December 31, 2022, all participants became fully vested in their accounts as a result of the Plan termination. Previously, participants were immediately vested in their voluntary contributions, rollover contributions, plus actual earnings thereon. Vesting in the Company’s discretionary matching and profit-sharing contributions and actual earnings thereon was based on years of continuous service. To earn a year of service for vesting purposes, a participant had to be credited with at least 1,000 hours of service during the Plan year. A participant was 100% vested after six years of credited service.

Participants became fully vested upon retirement, death, disability, or plan termination.

Investment Options – Prior to the Plan termination, upon enrollment in the Plan, participants were able to direct the investment of their account balance among the funds available under the Plan or elect a self-directed brokerage account option.

NOTE 1 – DESCRIPTION OF THE PLAN (Continued)

Notes Receivable from Participants – Prior to the Plan termination, participants were able to borrow from their vested accounts a minimum of \$1,000 up to a maximum equal to the lesser of \$50,000 or 50% of their vested account balance. The loans were secured by the vested balance in the participant’s account and bore a fixed interest rate as determined by the Plan administrator. Loan terms ranged from one to five years, except for loans used to finance the purchase of a primary residence, which could be for a longer period. Principal and interest was paid through substantially equal payroll deductions. Any outstanding loans will become due and payable upon the earlier of maturity date, termination of employment or death.

Payment of Benefits – Prior to the Plan termination, upon termination of service due to death, disability, retirement or other reasons, a participant was able to receive a lump-sum distribution, partial payments, installment distribution, a direct rollover distribution, or a combination of cash and a direct rollover distribution equal to the value of the participant’s vested interest in his or her account. If the value of the participant’s account was less than \$5,000, the payment would be made in a lump-sum distribution upon completion of required Plan documentation. In service distributions were able to be made to a participant who had not separated from service, provided that the participant had attained age 59 ½. A participant could also be eligible for a withdrawal due to financial hardship in certain circumstances. For all participants, minimum required distributions had to be made by April 1st following the year the participant retires or reaches the age 72.

Forfeitures – Prior to the Plan termination, any portion of the participant’s account that was not vested was forfeited upon separation of employment. Forfeitures were able to be used to pay Plan fees or to reduce employer contributions. At December 19, 2023, there were no forfeited non-vested accounts. At December 31, 2022, forfeited non-vested accounts totaled \$46,316. In 2023, forfeitures of \$449 and \$47,468 were used to pay Plan fees and offset profit-sharing contributions, respectively.

NOTE 2 – SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES

Basis of Accounting – In accordance with accounting principles generally accepted in the United States of America, the 2023 financial statements are presented using the liquidation basis of accounting. Liquidation basis of accounting is considered Generally Accepted Accounting Principles (“GAAP”) for entities in liquidation or for which liquidation is imminent.

Use of Estimates – The preparation of financial statements in accordance with accounting principles generally accepted in the United States of America requires management to make estimates and assumptions that affected the reported amounts of assets and liabilities and disclosure of contingent assets and liabilities at the date of the financial statements and the reported amounts of changes in net assets available for benefits in liquidation during the reporting period. Actual results may differ from those estimates.

NOTE 2 – SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES (Continued)

Investment Valuation and Income Recognition – Investments are reported at liquidation basis, which is substantially equivalent to fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. Plan management determines the Plan's valuation policies utilizing information provided by the investment adviser and custodian. See Note 3 for further discussion of fair value measurements.

Purchases and sales of securities were recorded on a trade-date basis. Interest income was recorded on the accrual basis. Dividends were recorded on the ex-dividend date. Net appreciation (depreciation) included the Plan's gains and losses on investments bought and sold, as well as held, during the period, and has been reflected in the Statement of Changes in Net Assets Available for Benefits (In Liquidation).

Contributions – Prior to the Plan termination, participant contributions were recorded in the Plan year which coincides with the payroll pay date.

Notes Receivables from Participants – Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Interest income was recorded on the accrual basis. Related fees were recorded as administrative fees and were expensed when they were incurred. No allowance for credit losses were recorded as of December 31, 2022.

Concentrations – As of December 31, 2022, two investment funds made up approximately 26% of the Plan's investment assets. Additionally, as of December 31, 2022, the aggregate of the target date funds was 27% of total investments.

Payments of Benefits – Benefits were recorded when paid.

Administrative Expenses – Certain expenses of maintaining the Plan were paid directly by the Company and are excluded from these financial statements. Certain expenses paid by the Plan were proportionately allocated to the accounts of all participants in the Plan or were funded from forfeitures. Such expenses included fees for investment advisory and recordkeeping services. Fees related to the administration of notes receivable from participants were charged directly to the related participant's account and are included in administrative expenses. Investment related expenses are included in net appreciation or depreciation of fair value of investments.

NOTE 3 – FAIR VALUE MEASUREMENTS

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1) and the lowest priority to unobservable inputs (Level 3). The three levels of the fair value hierarchy under the *Fair Value Measurements and Disclosures* topic of the Financial Accounting Standards Board Accounting Standards Codification are described as follows:

Level 1: Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2: Inputs to the valuation methodology include:

- quoted prices for similar assets or liabilities in active markets;
- quoted prices for identical or similar assets or liabilities in inactive markets;
- inputs other than quoted prices that were observable for the asset or liability;
- inputs that were derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

Level 3: Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset or liability's fair value measurement level within the fair value hierarchy was based on the lowest level of any input that was significant to the fair value measurement. Valuation techniques maximized the use of relevant observable inputs and minimized the use of unobservable inputs.

Following was a description of the valuation methodologies used for assets measured at fair value at December 31, 2022.

Mutual Funds and Money Market Funds: Valued at the daily closing price as reported by the fund. Mutual funds and money market funds held by the Plan were open-end mutual funds that were registered with the Securities and Exchange Commission. These funds are required to publish their daily net asset value ("NAV") and to transact at that price. The mutual funds held by the Plan were deemed to be actively traded.

Self-Directed Brokerage Accounts: Accounts consisted of mutual funds, money market funds, common stock, exchange-traded funds and fixed income instruments. The mutual funds and money market funds were valued as described above and the common stock and exchange-traded funds were valued at the closing price reported on the active market on which the individual securities are traded. Fixed income instruments were valued using pricing models maximizing the use of observable inputs for similar securities. This includes basing values on yields currently available on comparable securities of issues with similar credit ratings. These accounts also included cash and cash equivalents which were valued at their face value.

The preceding methods described may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, although the Plan believed its valuation methods were appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

NOTE 4 – INFORMATION CERTIFIED BY THE TRUSTEE OF THE PLAN

The Plan administrator has elected the method of compliance as permitted by 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. Accordingly, Vanguard Fiduciary Trust Company ("Vanguard") has certified the completeness and accuracy of all investments and notes receivable from participants presented on the accompanying Statements of Net Assets Available for Benefits (In Liquidation) as of December 19, 2023 and December 31, 2022, and the related investment income or loss, interest and dividend income, and interest income on notes receivable from participants presented on the Statement of Changes in Net Assets Available for Benefits (In Liquidation) for the period January 1, 2023 through December 19, 2023.

The Plan's independent public accountants did not perform auditing procedures with respect to this information, except for comparing such information to the related information included in the financial statements and supplemental schedule.

NOTE 5 – RELATED PARTY AND PARTIES-IN-INTEREST TRANSACTIONS

Certain Plan investments are funds managed by an affiliate of Vanguard. Vanguard was the trustee as defined by the Plan and, therefore, these transactions with the affiliate qualify as party-in-interest transactions. Fees incurred by the Plan for certain investment management and administrative services are included in net appreciation or depreciation in fair value of investments, as they were paid through revenue sharing, rather than a direct payment.

NOTE 6 – TAX STATUS

Effective January 1, 2022, the Plan was amended and restated to Vanguard's pre-approved defined contribution plan. The pre-approved defined contribution plan received an opinion letter dated June 30, 2020, in which the IRS stated that the plan, as then designed, was in accordance with the applicable requirements of the IRC. The Plan has not filed for a separate determination letter; however, the Plan administrator believes that the Plan was designed and was being operated in compliance with the applicable requirements of the IRC.

Accounting principles generally accepted in the United States of America require plan management to evaluate tax positions taken by the Plan and recognize a tax liability if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by taxing authorities. The Plan was subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

NOTE 7 – DELINQUENT PARTICIPANT CONTRIBUTIONS

During the year ended December 31, 2022, there were unintentional delays by the Company in remitting employee contributions amounting to \$401 within the period prescribed by the Department of Labor's regulations. The Company is currently researching this matter, and if necessary, will remit lost earnings to the affected participant's account.

NOTE 8 – PLAN OPERATIONAL ERRORS

Potential operational errors regarding the auto-enrollment for certain participants during the 2022 Plan year were discovered. Corrective contributions, including lost earnings, of approximately \$2,600 were remitted to the affected participants during 2023.

NOTE 9 – SUBSEQUENT EVENTS

The Plan's management has evaluated subsequent events through October 7, 2024, which was the date the financial statements were available to be issued.
