#### YEARS ENDED DECEMBER 31, 2023 AND 2022

##### NOTE 1 Description of plan

The following description of Penn Foster, Inc. 401(k) Plan (the "Plan") provides only general information. Participants should refer to the Plan agreement for a more complete description of the Plan's provisions.

During 2022, the Board of Directors of Career Step, LLC, Plan Sponsor of the Carrus 401(k) Plan, approved merging the Plan into the Penn Foster, Inc. 401(k) Plan effective August 31, 2023. The transfer was recorded in the statements of changes in net assets available for benefits as assets transferred in from other plan due to merger in the amount \$6,926,734. As a result, all investments in the amount of \$6,908,010 and notes receivable from participants in the amount of \$18,724 were transferred from the Plan into the Penn Foster, Inc. 401(k) Plan on that date.

##### General

The Plan is a defined contribution plan covering substantially all employees of Penn Foster, Inc., (the "Company") who have reached age 21. All full-time non-union employees are eligible to participate in the Plan on date of hire. Local 5652-05 employees are eligible after 60 days of service. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 ("ERISA"). The Board of Trustees is responsible for oversight of the Plan. The Investment Committee determines the appropriateness of the Plan's investment offerings and monitoring investment performance.

##### Contributions

Each year, Local 5652-05 participants may contribute up to 16% of compensation and participants in the Plan other than Local 5652-05 participants may contribute a percentage of pre-tax annual compensation limited to the maximum amount allowed by the Internal Revenue Code ("IRC"). Participants who have attained age 50 before the end of the Plan year are eligible to make catch-up contributions. Participants may elect two types of salary deferrals, regular 401(k) deferrals and Roth 401(k) deferrals. In addition, highly compensated participants making deferrals in excess of certain amounts established by law may elect an after-tax voluntary contribution in lieu of a distribution, as defined. Participants may also contribute amounts representing distributions from other qualified defined benefit and defined contribution plans (rollovers). The Company will contribute up to 50% of the first 6% of annual compensation that a participant, other than a Local 5652-05 participant, contributes. The Company will contribute up to 100% of the first 3% and 50% of the next 2% of annual compensation that a Local 5652-05 participant contributes. Each year the Company, at the sole discretion of its Board of Directors, determines the amount of any discretionary profit-sharing contribution to be made. There was no discretionary profit-sharing contribution for 2023 and 2022. Contributions are subject to certain Internal Revenue Service ("IRS") limitations. Participants direct the investment of their contributions into various investment options offered by the Plan.

Participant accounts

A separate account is maintained for each participant. Each participant's account is credited with the participant's contributions, including rollovers, company matching contributions, as well as allocations of the Company's discretionary profit-sharing contribution, if any, and Plan earnings (losses). Each participant's account is also charged with an allocation of net realized and unrealized appreciation (depreciation) in fair value of investments, if any, and certain administrative expenses paid by the Plan. Allocations are based on participant earnings, account balances, or specific participant transactions, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account. Participants self-direct the investment of their accounts into various investment options offered by the Plan.

Vested interest

Participants are immediately vested in their contributions, including rollover contributions, plus actual earnings thereon. Vesting in the Company's contribution portion of their account is based on years of continuous service. Participant vesting is as follows:

1	25%
2	50%
3	75%

Notes receivable from participants

Participants may borrow from their account balance a minimum of \$1,000 up to a maximum of \$50,000 or 50% of their vested account balance, whichever is less. The loans are secured by the balance in the participant's account and bear an interest rate equal to the prime rate as published in the Wall Street Journal plus one percentage point. Principal and interest is paid ratably through payroll deductions. Terms range from one to five years or greater for the purchase of a primary residence.

Payment of benefits

Participants are eligible to receive a distribution from their vested account balance following their separation from service due to retirement, total and permanent disability, death, or termination of employment. A participant will automatically receive a lump sum payment if the total of their vested account balance does not exceed \$1,000. If the vested account balance exceeds \$1,000 but is less than \$5,000, the assets will automatically be rolled over into an Individual Retirement Account with Charles Schwab Bank. However, terminated participants may elect to receive their salary deferral accounts in the year following termination. In addition, the Plan allows for hardship distributions if certain criteria are met.

Forfeited accounts

At December 31, 2023 and 2022, forfeited non-vested accounts totaled \$64,555 and \$21,463 respectively. These accounts will be used to reduce future contributions of the Company or pay administrative expenses of the Plan. In 2023 and 2022, Company administrative expenses and contributions were reduced by \$42,368 and \$45,134, respectively, from forfeited non-vested accounts.

SECURE 2.0 Act

President Biden signed the Consolidated Appropriations Act (CAA), including the SECURE 2.0 Act, into law on December 29, 2022. SECURE 2.0 builds on changes made by the SECURE Act of 2019 and the Plan document has been amended for provisions required to be effective in 2023 and will be amended in accordance with the required timeline of the act to meet the applicable provisions effective after December 31, 2023.

NOTE 2 Summary of significant accounting policies

Basis of accounting

The financial statements of the Plan are prepared under the accrual basis of accounting.

Use of estimates

The preparation of financial statements in accordance with accounting principles generally accepted in the United States of America requires management to make estimates and assumptions. Such estimated and assumptions affect the reported amounts of assets and liabilities and disclosure of contingent assets and liabilities at the date of the financial statements and the reported amounts of additions and deductions during the reporting period. Actual results could differ from those estimates.

Investment valuation and income recognition

Investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. The Plan's Compensation and Fiduciary Committee determines the Plan's valuation policies utilizing information provided by the investment advisors and trustee. See Note 4 for a discussion of fair value measurements.

Purchases and sales of investments are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation (depreciation) includes the gains and losses on investments bought and sold as well as held during the year.

#### Notes receivable from participants

Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Related fees are recorded as administrative expenses and are expensed when they are incurred. Interest income is recorded on the accrual basis. If a participant does not make loan repayments and the plan administrator considers the participant loan to be in default, the loan balance is reduced, and the delinquent participant note receivable is recorded as a benefit payment based on the terms of the Plan document.

#### Expenses

Certain expenses of maintaining the Plan are paid by the Plan, unless otherwise paid by the Company. Expenses that are paid by the Company are excluded from these financial statements. Fees related to the administration of notes receivable from participants are charged directly to the participant's account and are included in administrative expenses. Investment related expenses are included in net appreciation (depreciation) of fair value of investments.

#### Payment of benefits

Benefits are recorded when paid.

#### Risks and uncertainties

The Plan provides for various investment securities. Investment securities are exposed to various risks, such as interest rate, market and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits.

#### NOTE 3 Fair value measurements

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (level 1) and the lowest priority to unobservable inputs (level 3). The three levels of the fair value hierarchy under FASB ASC 820 are described below:

Level 1 – Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2 – Inputs to the valuation methodology include

- quoted prices for similar assets or liabilities in active markets;
- quoted prices for identical or similar assets or liabilities in inactive markets;
- inputs other than quoted prices that are observable for the asset or liability;
- inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specific (contractual) term, the level 2 input must be observable for substantially the full term of the asset or liability.

Level 3 – Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques maximize the use of relevant observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at December 31, 2023 and 2022.

*Mutual funds:* Valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-ended mutual funds that are registered with the U.S. Securities and Exchange Commission. These funds are required to publish their daily net asset value ("NAV") and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.

*The money market fund:* Valued at the quoted NAV of shares held by the Plan at year end.

The plan's policy is to recognize transfers of investments into or out of level three as of the date of the event or change in circumstances that caused the transfer. For the years ended December 31, 2023 and 2022, there were no transfers of investments into or out of level three. There are no plans assets requiring the use of level three inputs for the periods presented.

The methods described above may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, while the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

NOTE 4 Plan termination

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, participants will become 100% vested in the employer portion of their accounts.

NOTE 5 Tax status

The IRS had determined and informed the Company by a letter dated March 17, 2016, that the Plan and related trust are designed in accordance with the applicable sections of the Internal Revenue Code (IRC). Although the Plan has been amended since receiving the determination letter, the plan administrator and the Plan's tax counsel believe that the Plan is designed and is currently being operated in compliance with the applicable requirements of the IRC and, therefore, believes that the Plan is qualified and the related trust is tax exempt.

Accounting principles generally accepted in the United States of America require Plan management to evaluate tax positions taken by the Plan and recognize a tax liability if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the Internal Revenue Service. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

NOTE 6 Certified investments

Certain information related to cash, investments and notes receivable from participants disclosed in the accompanying financial statements and ERISA-required supplemental schedule, including cash, investments and notes receivable from participants held at December 31, 2023 and 2022, and net appreciation (depreciation) in fair value of investments, interest and dividends and interest income on notes receivable from participants for the years ended December 31, 2023 and 2022, was obtained by management and agreed to or derived from information certified as complete and accurate by Charles Schwab Bank (the trustee of the Plan).

The following information included in the accompanying financial statements and supplemental schedules were obtained from data that had been prepared and certified to as complete and accurate by Charles Schwab Bank.
