The financial statements comprise the statement of net assets available for benefits as of December 31, 2023 and 2022, and the related statement of changes in net assets available for benefits for the years then ended, and the related notes to the financial statements.

As permitted by ERISA Section 103(a)(3)(C), our audit need not extend to any statements or information related to assets held for investment of the Plan (investment information) by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA (qualified institution).

Management has obtained certifications from qualified institutions as of and for the years ended December 31, 2023 and 2022, stating that the certified investment information, as described in Note 3 to the financial statements, is complete and accurate.

### **Opinion**

In our opinion, based on our audit and on the procedures performed as described in the Auditors' Responsibilities for the Audit of the Financial Statements section:

- The amounts and disclosures in the financial statements referred to above, other than those agreed to or derived from the certified investment information, are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America (GAAP).
- The information in the financial statements referred to above related to assets held by and certified to by a qualified institution agrees to, or is derived from, in all material respects, the information prepared and certified by an institution that management determined meets the requirements of ERISA Section 103(a)(3)(C).

***Basis for Opinion***

We conducted our audit in accordance with auditing standards generally accepted in the United States of America (GAAS). Our responsibilities under those standards are further described in the Auditors' Responsibilities for the Audit of the Financial Statements section of our report. We are required to be independent of the Plan and to meet our other ethical responsibilities in accordance with the relevant ethical requirements relating to our audit. We believe that the audit evidence we have obtained is sufficient and appropriate to provide a basis for our ERISA Section 103(a)(3)(C) audit opinion.

***Responsibilities of Management for the Financial Statements***

Management is responsible for the preparation and fair presentation of the financial statements in accordance with GAAP, and for the design, implementation, and maintenance of internal control relevant to the preparation and fair presentation of financial statements that are free from material misstatement, whether due to fraud or error. Management's election of the ERISA Section 103(a)(3)(C) audit does not affect management's responsibility for the financial statements.

In preparing the financial statements, management is required to evaluate whether there are conditions or events, considered in the aggregate, that raise substantial doubt about the Plan's ability to continue as a going concern within one year after the date the financial statements are issued or available to be issued.

Management is also responsible for maintaining a current Plan instrument, including all Plan amendments; administering the Plan; and determining that the Plan's transactions that are presented and disclosed in the financial statements are in conformity with the Plan's provisions, including maintaining sufficient records with respect to each of the participants, to determine the benefits due, or which may become due, to such participants.

***Auditors' Responsibilities for the Audit of the Financial Statements***

Except as described in the Scope and Nature of the ERISA Section 103(a)(3)(C) Audit of the Financial Statements section of our report, our objectives are to obtain reasonable assurance about whether the financial statements as a whole are free from material misstatement, whether due to fraud or error, and to issue an auditors' report that includes our opinion. Reasonable assurance is a high level of assurance but is not absolute assurance and, therefore, is not a guarantee that an audit conducted in accordance with GAAS will always detect a material misstatement when it exists. The risk of not detecting a material misstatement resulting from fraud is higher than for one resulting from error, as fraud may involve collusion, forgery, intentional omissions, misrepresentations, or the override of internal control. Misstatements are considered material if there is a substantial likelihood that, individually or in the aggregate, they would influence the judgment made by a reasonable user based on the financial statements.

In performing an audit in accordance with GAAS, we:

- Exercise professional judgment and maintain professional skepticism throughout the audit.
- Identify and assess the risks of material misstatement of the financial statements, whether due to fraud or error, and design and perform audit procedures responsive to those risks. Accordingly, no such opinion is expressed.
- Evaluate the appropriateness of accounting policies used and the reasonableness of significant accounting estimates made by management, as well as evaluate the overall presentation of the financial statements.
- Conclude whether, in our judgment, there are conditions or events, considered in the aggregate, that raise substantial doubt about NetAtWork, Inc. 401(k) Profit Sharing Plan's ability to continue as a going concern for a reasonable period of time.

Our audit did not extend to the certified investment information, except for obtaining and reading the certification, comparing the certified investment information with the related information presented and disclosed in the financial statements, and reading the disclosures relating to the certified investment information to assess whether they are in accordance with the presentation and disclosure requirements of accounting principles generally accepted in the United States of America.

Accordingly, the objective of an ERISA Section 103(a)(3)(C) audit is not to express an opinion about whether the financial statements as a whole are presented fairly, in all material respects, in accordance with GAAP.

We are required to communicate with those charged with governance regarding, among other matters, the planned scope and timing of the audit, significant audit findings, and certain internal control-related matters that we identified during the audit.



**NOTE 1 DESCRIPTION OF PLAN**

The following brief description of the NetAtWork, Inc. 401(k) Profit Sharing Plan (the Plan) is provided for general information purposes only. More complete information is provided in the Summary Plan Description and Plan Document, both of which are available from the Company. Five affiliated employers have adopted the Plan as part of a controlled group: NetAtWork, Inc., Docutrend, Inc., Pixafy Services LLC, Swype Integrated Technologies LLC, and Network Cloud Solutions LLC (collectively, “the Company,” and individually, “the Employers”). Additionally, NetAtWork, Inc. (the Plan Sponsor, the Plan administrator) has acquired certain assets and employees from other companies since the Plan’s inception and has amended the Plan to recognize the years of service of these acquired employees on a case-by-case basis as determined in the respective acquisition agreements.

**General**

The Plan is a voluntary, participant-directed, defined-contribution plan that became effective January 1, 2009. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA), as restated.

**Eligibility**

Certain employees are eligible to participate in the Plan, except for union employees, leased employees, and nonresident aliens, immediately upon date of hire. Eligible employees may enter the Plan on the first day of the Plan year quarter immediately following their date of employment.

**Contributions**

Participants may make voluntary pretax contributions and Roth 401(k) contributions to the Plan, up to the annual Internal Revenue Service (IRS) dollar limit. Participants can change their voluntary contributions on the first day of any payroll period. Participants may elect to roll over contributions that were received from another qualified plan. Participants, age 50 or older, may make additional pretax catch-up contributions in accordance with, and subject to, IRS limitations.

The Employers may, at their discretion, elect to contribute, on behalf of each of their respective eligible participants, a discretionary matching contribution equal to a percentage of the participant’s elected deferrals. Participants are eligible for employer discretionary matching contributions immediately upon date of hire and are employed on the last day of the Plan year. For the years ended December 31, 2023 and 2022, discretionary matching contributions made by the Employers were \$308,655 and \$251,355, respectively. The Company may also make discretionary nonelective profit-sharing contributions to all eligible participants who have completed at least one year of service and are enrolled in the Plan on the last day of the Plan year. The service requirements are waived for eligible employees employed as of January 1, 2009. There were no discretionary nonelective profit-sharing contributions made by the Employers for the years ended December 31, 2023 and 2022.

**Investment Options**

Upon enrollment in the Plan, participants may direct their employee and Organization contributions by percentages into any of the investment options available. A separate account is maintained for each participant, and interest and dividends earned by each fund are reinvested in that fund. Participants may change their investment options at their discretion.

**Participant Accounts**

Each participant's account is credited with the participant's contribution and allocation of (a) the Company's contribution, if any, (b) Plan earnings, gains or losses, and (c) charged with fees associated with transactions initiated by participants, and any administrative and investment expenses paid by the Plan. Allocations are based on a participant's earnings or account balance, as defined in the Plan Document. The Plan permits participants to self-direct the investments in their accounts in a variety of investment options. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

**Vesting**

Participants are immediately vested in their voluntary employee contributions and rollover contributions plus actual earnings thereon. Discretionary employer-matching contributions and discretionary nonelective profit-sharing contributions vest on a six-year graded vesting schedule. Participants with less than two years of credited service are 0% vested. Vesting increases annually by 20% from years two through five. Participants become 100% vested upon attainment of their sixth year of service.

**Notes Receivable from Participants**

Participants may borrow from their accounts a minimum of \$1,000 up to a maximum of the lesser of one-half of their vested account balances or \$50,000 (reduced by the highest value of any outstanding loan balance in the preceding 12 months), whichever is less. Loans bear interest at prime plus 1%. The interest rate will remain fixed throughout the duration of the loan. Terms depend on the type of note; a general note must be repaid within five years, while notes used to acquire a primary residence shall be repaid over a maximum period of 20 years. Loans will be secured by one-half of the participant's vested balance reduced by any outstanding loans on the date the loan was issued. Notes must be repaid through payroll deductions and are secured by the balances in the participants' accounts. If a participant is terminated prior to repayment of the loan balance, the remaining balance on the loan is considered to be a deemed distribution to the participant. Only one loan per participant can be outstanding at a time.

**Benefit Payments**

After retirement, death, or disability, participants are entitled to receive a lump-sum distribution or installments. Participants have the option to leave amounts in the Plan up to the mandatory distribution date, which is defined as the later of April 1 following the calendar year of attaining the age of 72 or age at retirement. If participants are still employed by the age 72, the mandatory distribution date generally is April 1 following the termination date of employment.

**Benefit Payments (Continued)**

Upon termination, vested benefits can be rolled over to another qualified plan or an individual retirement account (IRA), or distributed in a lump-sum payment or partial withdrawals. If the vested balance is \$5,000 or less, any amount exceeding \$1,000 will be distributed to an IRA for the participant's benefit. If the participant's vested balance is \$1,000 or less, the participant will receive a lump-sum distribution without consent.

Hardship withdrawals are subject to approval by the Plan administrator and also subject to income tax withholding and penalties.

**In-Service Withdrawals**

Participants attaining the age of 59½ may request a withdrawal of all or part of the vested portion of their account.

**Retirement**

The Plan's normal retirement age is 65. There is no early retirement provision under the Plan.

**Forfeitures**

Forfeitures are used to offset employer-matching contributions or pay administrative expenses. There was a balance of \$596 and \$9,649 in the forfeiture account as of December 31, 2023 and 2022, respectively. The Plan used \$-0- during the years ended December 31, 2023 and 2022 to reduce employer-matching contributions and \$22,393 and \$2,824 during the years ended December 31, 2023 and 2022 to pay administrative expenses. There is a balance of \$10,595 and \$2,965 in the suspense account as of December 31, 2023 and 2022, to be used in accordance with the Plan Document.

**NOTE 2 SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES**

**Basis of Accounting**

The financial statements have been prepared on the accrual basis of accounting in accordance with accounting principles generally accepted in the United States of America.

**Use of Estimates**

The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires the Plan administrator to make estimates and assumptions that affect certain reported amounts of assets and liabilities and changes therein, and disclosure of contingent assets and liabilities. Accordingly, actual results may differ from those estimates.

**Excess Contributions Payable**

In order to be in compliance with the nondiscrimination rules of ERISA, the Plan returns excess contributions to certain highly compensated employees. Excess contributions payable as of December 31, 2023 and 2022 were \$78 and \$3,200. Amounts were fully returned in the year succeeding the Plan years 2023 and 2022.

**Investment Valuation and Income Recognition**

Investments are reported at fair value (except for fully benefit-responsive investment contracts, which are reported at contract value). Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See Note 4 for fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Dividend income is recorded on the ex-dividend date. Interest income is recorded as earned on the accrual basis. Net appreciation includes the Plan's gains and losses on investments bought and sold, as well as held, during the year.

**Notes Receivable from Participants**

Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Interest income is recorded on the accrual basis. Related fees are recorded as administrative expenses and are expensed when they are incurred. Delinquent notes receivable from participants are recorded as a distribution based upon the terms of the Plan Document. No allowance for credit losses has been recorded as of December 31, 2023 and 2022.

**Payment of Benefits**

Benefits are recorded when paid.

**Administrative Expenses**

Certain expenses of maintaining the Plan are paid directly by the Company and are excluded from these financial statements. Fees related to the administration of notes receivable from participants, investment fees, and certain administrative fees not covered by the Company are charged directly to the participant's account and are included in administrative expenses. Investment-related expenses are included in net appreciation of fair value of investments.

**Mutual Fund Fees**

Investments in mutual funds are subject to sales charges in the form of front-end loads, back-end loads, or 12b-1 fees. Allowable fees under Section 12b-1 of the Investment Company Act of 1940 are annual fees deducted to pay for marketing and distribution costs of the funds. These fees are deducted prior to the allocation of the Plan's investment earnings activity and, thus, not separately identifiable as an expense.

**Subsequent Events**

The Plan has evaluated its subsequent events and transactions occurring after December 31, 2023, through October 8, 2024, the date that the financial statements were available to be issued.

**NOTE 3 INFORMATION CERTIFIED BY THE CUSTODIAN**

Certain information related to investments and notes receivable from participants disclosed in the accompanying financial statements and ERISA-required supplemental schedule, including investments and notes receivable from participants held at December 31, 2023 and 2022, and net appreciation in fair value of investments, interest and dividends, and interest income on notes receivable from participants for the years ended December 31, 2023 and 2022, was obtained by management and agreed to or derived from information certified as complete and accurate by the Voya Retirement Insurance and Annuity Company (VRIAC), the Custodian of the Plan prior to transfer to the Vanguard platform on August 17, 2022, and Ascensus, LLC an affiliate of Ascensus Trust Company, the Trustee of the Plan following the transfer to the new platform.

**NOTE 4 FAIR VALUE MEASUREMENTS**

**Fair Value Measurements**

Fair value measurements establish a framework for measuring fair value. That framework provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1 measurements) and the lowest priority to unobservable inputs (Level 3 measurements). The three levels of the fair value hierarchy are described below:

*Level 1* – Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

*Level 2* – Inputs to the valuation methodology include:

- Quoted prices for similar assets or liabilities in active markets;
- Quoted prices for identical or similar assets or liabilities in inactive markets;
- Inputs other than quoted prices that are observable for the asset or liability; and
- Inputs that are derived principally from, or corroborated by, observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

*Level 3* – Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset's or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

**Fair Value Measurements (Continued)**

Following is a description of the valuation methodology used for assets measured at fair value. There have been no changes in the methodologies used at December 31, 2023 and 2022.

*Mutual Funds* – Valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-end mutual funds that are registered with the Securities and Exchange Commission. These funds are required to publish their daily net asset value (NAV) and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded (Level 1 Input).

**NOTE 5 TAX STATUS**

The Plan Sponsor obtained an opinion letter from the IRS on June 30, 2020, in which the IRS stated that the volume submitter Plan Document was in compliance with applicable requirements of the IRC. The Plan has since been amended; however, the Plan administrator believes the Plan is being designed and operated in compliance with the Plan Document and applicable requirements of the IRC.

Accounting principles generally accepted in the United States of America require Plan management to evaluate the tax positions taken by the Plan and recognize a tax liability (or asset) if the Plan has taken an uncertain tax position that more likely than not would not be sustained upon examination by the IRS. The Plan administrator has analyzed the tax positions taken by the Plan and has concluded that, as of December 31, 2023 and 2022, there are no uncertain positions taken, or expected to be taken, that would require recognition of a liability (or asset) or disclosure in the financial statements. The Plan has recognized no interest or penalties related to uncertain tax positions. The Plan is subject to routine audits by taxing jurisdictions; however, there are no audits for any periods in progress.

**NOTE 6 PARTY-IN-INTEREST TRANSACTIONS**

The Plan's investments are held by the Vanguard Group, the Custodian, and Ascensus Trust Company, the Trustee, and therefore, those transactions are considered as party-in-interest transactions. Additionally, administrative expenses are paid to the Custodian/Trustee who acts as the recordkeeper of the Plan. These transactions with the Custodian/Trustee qualify as party-in-interest transactions.

Notes receivable from Plan participants qualify as party-in-interest transactions.

**NOTE 7 PLAN TERMINATION**

Although the Company has not expressed intent to terminate the Plan, it may do so at any time under the provisions of ERISA. Upon termination of the Plan, participants will become 100% vested and entitled to their full account balance, including all Company contributions and earnings thereon, as of the termination date.

**NOTE 8 RISKS AND UNCERTAINTIES**

The Plan invests in various investment securities. Investment securities are exposed to various risks, such as interest rate, market, and credit risks. Market risks include global events which could impact the value of investment securities, such as pandemic or international conflict. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statement of net assets available for benefits.
