INDEPENDENT AUDITOR'S REPORT

To the Administrative Committee and Management of ADCOM Employees' Savings Plan

Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed audits of the accompanying financial statements of **ADCOM Employees' Savings Plan**, an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C). The financial statements comprise the statement of net assets available for benefits (in liquidation) as of December 31, 2023, and the related statement of changes in net assets available for benefits (in liquidation) for the year then ended, the statement of net assets available for benefits (on-going) as of December 31, 2022, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of ADCOM Employees' Savings Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. As permitted by ERISA Section 103(a)(3)(C), our audits need not extend to any statements or information related to assets held for investment of the Plan (investment information) by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA (qualified institution).

Management has obtained certifications from a qualified institution as of December 31, 2023 and 2022, and for the year ended December 31, 2023, stating that the certified investment information, as described in Note 5 to the financial statements, is complete and accurate.

Opinion

In our opinion, based on our audits and on the procedures performed as described in the Auditor's Responsibilities for the Audit of the Financial Statements section:

- The amounts and disclosures in the financial statements referred to above, other than those agreed to or derived from the certified investment information, are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America.
- The information in the financial statements referred to above related to assets held by and certified to by a qualified institution agrees to, or is derived from, in all material respects, the information prepared and certified by an institution that management determined meets the requirements of ERISA Section 103(a)(3)(C).

Basis for Opinion

We conducted our audits in accordance with auditing standards generally accepted in the United States of America. Our responsibilities under those standards are further described in the Auditor's Responsibilities for the Audit of the Financial Statements section of our report. We are required to be independent of ADCOM Employees' Savings Plan and to meet our other ethical responsibilities in accordance with the relevant ethical requirements relating to our audits. We believe that the audit evidence we have obtained is sufficient and appropriate to provide a basis for our ERISA Section 103(a)(3)(C) audit opinion.

Emphasis of Matter – Basis of Accounting

As discussed in Note 1 to the financial statements, the governing body of ADCom Employees' Savings Plan approved a plan termination on July 31, 2023, and management determined liquidation was imminent. As a result, the Plan has changed its basis of accounting for periods subsequent to December 31, 2022 from the going concern basis to the liquidation basis. Our opinion is not modified with respect to that matter.

Responsibilities of Management for the Financial Statements

Management is responsible for the preparation and fair presentation of these financial statements in accordance with accounting principles generally accepted in the United States of America, and for the design, implementation, and maintenance of internal control relevant to the preparation and fair presentation of financial statements that are free from material misstatement, whether due to fraud or error. Management's election of the ERISA Section 103(a)(3)(C) audit does not affect management's responsibility for the financial statements.

In preparing the financial statements, management is required to evaluate whether there are conditions or events, considered in the aggregate, that raise substantial doubt about ADCOM Employees' Savings Plan's ability to continue as a going concern for one year after the date the financial statements are available to be issued.

Management is also responsible for maintaining a current plan instrument, including all plan amendments; administering the plan; and determining that the plan's transactions that are presented and disclosed in the financial statements are in conformity with the plan's provisions, including maintaining sufficient records with respect to each of the participants, to determine the benefits due or which may become due to such participants.

Auditor's Responsibilities for the Audit of the Financial Statements

Except as described in the Scope and Nature of the ERISA Section 103(a)(3)(C) Audit section of our report, our objectives are to obtain reasonable assurance about whether the financial statements as a whole are free from material misstatement, whether due to fraud or error, and to issue an auditor's report that includes our opinion. Reasonable assurance is a high level of assurance but is not absolute assurance and therefore is not a guarantee that an audit conducted in accordance with generally accepted auditing standards will always detect a material misstatement when it exists. The risk of not detecting a material misstatement resulting from fraud is higher than for one resulting from error, as fraud may involve collusion, forgery, intentional omissions, misrepresentations, or the override of internal control. Misstatements are considered material if there is a substantial likelihood that, individually or in the aggregate, they would influence the judgment made by a reasonable user based on the financial statements.

In performing an audit in accordance with generally accepted auditing standards, we:

- Exercise professional judgment and maintain professional skepticism throughout the audit.
- Identify and assess the risks of material misstatement of the financial statements, whether due to fraud or error, and design and perform audit procedures responsive to those risks. Such procedures include examining, on a test basis, evidence regarding the amounts and disclosures in the financial statements.
- Obtain an understanding of internal control relevant to the audit in order to design audit procedures that are appropriate in the circumstances, but not for the purpose of expressing an opinion on the effectiveness of ADCOM Employees' Savings Plan's internal control. Accordingly, no such opinion is expressed.

- Evaluate the appropriateness of accounting policies used and the reasonableness of significant accounting estimates made by management, as well as evaluate the overall presentation of the financial statements.
 - Conclude whether, in our judgment, there are conditions or events, considered in the aggregate, that raise substantial doubt about ADCOM Employees' Savings Plan's ability to continue as a going concern for a reasonable period of time.

Our audits did not extend to the certified investment information, except for obtaining and reading the certifications, comparing the certified investment information with the related information presented and disclosed in the financial statements, and reading the disclosures relating to the certified investment information to assess whether they are in accordance with the presentation and disclosure requirements of accounting principles generally accepted in the United States of America.

Accordingly, the objective of an ERISA Section 103(a)(3)(C) audit is not to express an opinion about whether the financial statements as a whole are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America.

We are required to communicate with those charged with governance regarding, among other matters, the planned scope and timing of the audit, significant audit findings, and certain internal control-related matters that we identified during the audit.

Notes to Financial Statements

1. Description of Plan

The following description of the ADCOM Employees' Savings Plan (the "Plan") provides only general information. Participants should refer to the Plan Agreement and Summary for a more complete description of the Plan's provisions.

General

The Plan was established January 1, 1995 as a defined contribution plan and is sponsored by Atlanta DataCom, Inc. (the "Company"). It is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA).

Plan Termination and Transfer Out

On July 31, 2023, the Plan Committee adopted an amendment to suspend all contributions and to terminate the Plan. No new participants are able to enter the Plan and all participants are fully vested. As part of the Plan termination, all remaining Plan assets have been either distributed to participants or transferred out to other plans as of December 31, 2023. Assets totaling \$2,143,203 were transferred out to the Johnson Architectural Metal Company 401(k) Plan.

Participation

Prior to termination, employees are eligible to enter the Plan as a participant and to make elective deferrals upon attainment of age 18.

Contributions

Prior to termination, contributions to the Plan could come from employee salary reduction contributions, rollover contributions from other qualified retirement plans, and employer matching contributions.

Prior to termination, the Plan provided for automatic deferral provisions that allowed the employer to withhold 3% of compensation for each payroll period with an escalation feature unless the participant elected out. The escalation feature allowed for a 1% annual increase up to a maximum of 6%. A participant could have elected to contribute through salary deferrals between 1% and 90% of compensation on a pretax or after-tax Roth basis in any Plan year, subject to certain limitations. Participants who had attained age 50 before the end of the Plan year are eligible to make catch-up contributions. Participants directed the investment of their contributions into various investment options offered by the Plan.

Prior to termination, the Company could make a matching contribution equal to a discretionary percentage of the participant's elective deferrals. In determining the matching contribution, only elective deferrals up to 4% of a participant's compensation would have been matched. The matching contributions were made on behalf of all participants who are actively employed by the Company at the end of the Plan year. The Company did not make any matching contributions in 2023.

Prior to termination, participants could also rollover amounts from other qualified retirement plans into their accounts. There were \$40,179 in rollovers from other qualified plans in 2023.

1. Description of Plan (Continued)

Participant Accounts

Prior to termination, each participant's account was credited with the participant's contributions, employer matching contributions and plan earnings. Participant accounts were charged with an allocation of administrative expenses. Allocations were pro rata based on participant account balances, as defined by the Plan. The benefit to which a participant was entitled was the benefit that can be provided from the participant's vested account balance.

Vesting

Prior to termination, participants were immediately vested in their own contributions as well as employer matching contributions and the investment earnings thereon.

Allocation of Plan Income Earned

Prior to termination, net income earned and unrealized gains or losses on investments were allocated to the participant accounts based on the ratio that the individual account bears to all participants in the same investment as of each valuation date. Accounts were valued on a daily basis.

Notes Receivable from Participants

Prior to termination, participants could borrow up to 50% of their vested account balances with a minimum loan request of \$1,000 and a maximum of \$50,000 reduced by the excess (if any) of (i) the highest outstanding balance of loans from the Plan during the twelve (12) month period ending on the day before the loan is made, over (ii) the outstanding balance of loans from the Plan on the date the loan is made. Loan terms could not exceed five years except when used for the purchase of a primary residence. The loans were secured by the balance in the participant's account and bear an annual interest rate of prime plus 1%. The interest rate was fixed on the day the loan was processed and remained constant during the term of the loan. Principal and interest were paid ratably through payroll deductions.

Prior to termination, the initial loan application fee was \$100, which was deducted from the Participant's account balance in the Plan and did not reduce the proceeds of the loan. For each loan, an administrative fee of \$25 per year was deducted from the participant's account until the loan is paid in full.

Hardship Withdrawals

Prior to termination, a participant could elect to withdraw the balance of their account attributable to their salary reduction election provided such withdrawal was to meet their immediate and significant needs.

Excess Contributions Payable

Prior to termination, amounts payable to participants for contributions in excess of amounts allowed by the IRS were recorded as a liability with a corresponding reduction to contributions. The Plan distributed the 2022 excess contributions to the applicable participants prior to March 15, 2023.

Payment of Benefits

Prior to termination, upon a participant's death, disability, normal retirement, or other termination of employment from the Company, a participant could elect to receive the value of the vested interest in his or her account as a lump sum distribution. The Plan also allowed in-service distributions to a participant who has not separated from service provided the participant has attained the age of 59 1/2.

2. Summary of Significant Accounting Policies

Basis of Accounting

The Plan Committee approved a plan liquidation on July 31, 2023 and management determined liquidation is imminent. As a result, the Plan changed its basis of accounting to the liquidation basis used in presenting the 2023 financial statements. The 2022 financial statements were maintained on the accrual basis of accounting. During 2023, final distributions were determined based on all participants being 100% vested and were made as soon as possible after the termination date.

Notes Receivable from Participants

Prior to termination, notes receivable from participants were measured at their unpaid principal balance. Delinquent notes receivable from participants were reclassified as distributions based on the terms of the Plan document.

Use of Estimates

The preparation of financial statements in conformity with generally accepted accounting principles in the United States of America requires the Plan administrator to make estimates and assumptions that affect certain reported amounts and disclosures. Actual results may differ from those estimates.

Investment Valuation and Income Recognition

Prior to termination, the Plan's investments are stated at fair value except for the investment in a group annuity contract which is stated at contract value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at a measurement date. Shares of registered investment companies and mutual funds are valued at quoted market prices which represent the net asset value of shares held by the Plan at year end. See Note 4 for discussion of fair value measurements and Note 8 for discussion on the group annuity contract.

Prior to termination, purchases and sales of securities were recorded on a trade-date basis. Interest income on investments and notes receivable from participants were recorded on the cash basis. Dividends were recorded on the ex-dividend date. Net appreciation included the Plan's gains and losses on investments bought and sold as well as being held during the year.

Payment of Benefits

Prior to termination, benefits were recorded when paid.

Expenses

Prior to termination, certain expenses for maintaining the Plan were paid by the Company and were therefore excluded from these financial statements. Investment-related expenses were included in net appreciation in fair value of investments. Administrative expenses of the Plan were allocated to participant accounts.

3. Subsequent Events

The Plan sponsor has evaluated subsequent events through September 30, 2024, the date the financial statements were available to be issued and has determined there are no subsequent events requiring disclosure.

4. Fair Value Measurements

The Plan's investments were reported at fair value in the accompanying statements of net assets available for benefits. The methods used to measure fair value may produce an amount that may not be indicative of net realizable value or reflective of future fair values. Furthermore, although the Plan believed its valuation methods were appropriate and consistent with other market participants, the use of different methodologies or assumptions to measure the fair value of certain financial instruments could result in a different fair value at the reporting date.

The fair value measurement according to accounting literature establishes a fair value hierarchy that prioritizes the use of observable inputs in measuring fair value. The level of a fair value measurement is determined entirely by the lowest level input that is significant to the measurement.

The three levels are:

Level 1 – Quoted prices in active markets for identical assets or liabilities, accessible to the entity at the measurement date.

Level 2 – Inputs other than quoted prices included within Level 1 that are observable for the asset or liability, either directly or indirectly.

Level 3 – Unobservable inputs that are not corroborated by market data.

The following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at December 31, 2023 and 2022.

Mutual funds – Valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-end mutual funds that are registered with the SEC. These funds are required to publish their daily net asset value (NAV) and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.

Within the fair value hierarchy, the following table sets forth by level the Plan's investments at fair value as of December 31, 2023 and 2022:

5. Financial Information Certified by the Custodians

The Plan Administrator has elected the method of compliance permitted by 29 CFR 2520.103-8 of the Department of Labor (DOL) Rules and Regulations for Reporting and Disclosure under ERISA. Accordingly, as permitted under such election, the Plan management instructed the Plan's independent auditors not to perform any auditing procedures with respect to the following information certified by Empower Trust Company, LLC (FKA Great-West Trust Company, LLC) and Empower Annuity Insurance Company of America (FKA Great-West Life & Annuity Insurance Company) except for comparing such information certified by the custodians with information included in the Plan's financial statements:

6. Transactions with Parties in Interest

The Plan allowed for transactions with certain parties who may perform services or have fiduciary responsibilities to the Plan, including the Company. Certain Plan investments were managed by the Custodians as defined by the Plan. Therefore, these transactions qualified as party-in-interest transactions. Certain fees related to the administration of the Plan, including advisory services, were paid by the Plan which totaled \$49,916 in 2023.

7. Tax Status

The Company adopted a prototype standardized profit sharing plan with a cash deferral arrangement that received a favorable opinion letter from the Internal Revenue Service on June 30, 2020. The letter stated that the Plan and related trust are designed in accordance with the applicable sections of the Internal Revenue Code. The Plan has been amended since receiving the determination letter. However, the Plan administrator and the Plan's tax counsel believe that the Plan is designed and currently being operated in compliance with the applicable provisions of the Internal Revenue Code.

Participants in the Plan were not subject to income taxes on their contributions, earnings, or appreciation on investments held in the Plan until withdrawn by the participant or distributed to the participant's named beneficiary in the event of death.

The Plan administrator believes that the Plan does not have any material uncertain tax positions at the date of Plan termination; however, the Plan's tax returns for the year ended December 31, 2020 and subsequent years are subject to examination by relevant taxing authorities.

8. Group Annuity Contract

In 2017, the Plan entered into a group annuity contract with Empower Annuity Insurance Company of America (EAICA) that invests contributions in the Key Guaranteed Portfolio Fund. The Key Guaranteed Portfolio Fund is a general account product of EAICA. This account is credited with earnings on the underlying investments and charged for participant withdrawals and administrative expenses. The guaranteed investment contract issuer is contractually obligated to repay the principal and a specified interest rate that is guaranteed to the Plan.

Because the group annuity contract is fully benefit-responsive, contract value is the relevant measurement attribute for that portion of the net assets available for benefits attributable to the guaranteed investment contract. The guaranteed investment contract is presented at contract value on the face of the statements of net assets available for benefits. Contract value, as reported to the Plan by EAICA, represents contributions made under the contract, plus earnings, less participant withdrawals and administrative expenses. Participants may ordinarily direct the withdrawal or transfer of all or a portion of their investment at contract value.

There are no reserves against contract value for credit risk of the contract issuer or otherwise. The fund credits interest to the contract holder on a portfolio basis. The crediting interest is based on a formula agreed upon with the issuer and may not be less than 0%. Such interest rates are reviewed on a quarterly basis for resetting.

Certain events may limit the ability of the Plan to transact at contract value with the issuer. Such events include (a) amendments to the Plan document (including complete or partial plan termination or merger with another plan); (b) changes to the Plan's prohibition on competing investment options or deletion of equity wash provisions; (c) bankruptcy of the Plan sponsor or other Plan sponsor events that cause a significant withdrawal from the Plan; or (d) the failure of the trust to qualify for exemption from federal income taxes or any required prohibited transactions exemption under ERISA. As part of the termination of the Plan (See Note 1), this contract was terminated, and the funds were distributed by December 31, 2023.
