Emphasis of Matter – Plan Termination and Basis of Accounting

As discussed in Note B to the financial statements, T&D Moravits and Company 401(k) Plan approved a plan of liquidation on January 4, 2023 as management determined liquidation is imminent. All assets were transferred to another benefit Plan on March 8, 2023. As a result, the Plan has changed its basis of accounting from the going concern basis of accounting used in presenting the 2022 financial statements to the liquidation basis of accounting used in presenting the 2023 financial statements. Our opinion is not modified with respect to this matter.

Responsibilities of Management for the Financial Statements

Management is responsible for the preparation and fair presentation of these financial statements in accordance with accounting principles generally accepted in the United States of America, and for the design, implementation, and maintenance of internal control relevant to the preparation and fair presentation of financial statements that are free from material misstatement, whether due to fraud or error. Management's election of the ERISA Section 103(a)(3)(C) audit does not affect management's responsibility for the financial statements.

Management is also responsible for maintaining a current Plan instrument, including all Plan amendments; administering the Plan; and determining that the Plan's transactions that are presented and disclosed in the financial statements are in conformity with the Plan's provisions, including maintaining sufficient records with respect to each of the participants, to determine the benefits due or which may become due to such participants.

NOTE A – SIGNIFICANT ACCOUNTING POLICIES

Basis of Presentation: The financial statements of the T&D Moravits and Company 401(k) Plan ("Plan") are prepared on the accrual method of accounting in accordance with U.S. generally accepted accounting principles.

The Plan Sponsor adopted a resolution to terminate the Plan on January 4, 2023. Net Plan assets of \$2,771,508 were distributed from the Plan on March 8, 2022. As a result, the Plan's financial statements as of and for the period ended March 8, 2023 have been prepared on the liquidation basis of accounting. See Note B.

Recognition of Income: The basis of investments held by the Plan is adjusted daily to the closing market value and unrealized gains and losses are recorded as part of this adjustment. Realized gains and losses on investments are computed using this adjusted basis. Security transaction expenses are considered in computing realized gains and losses on investments.

Investments: Mutual fund investments held in pooled separate accounts are valued at unit value based on the observable net asset value (NAV) of the underlying investment. Gains and losses (realized and unrealized) included in changes in net assets are reported in net appreciation (depreciation) in fair value of investments in the statement of changes in net assets available for benefits. Dividends are considered in the fair market value determination. Money market funds are interest bearing cash and report at cost plus accrued interest.

Participants' Notes Receivable: Participants' notes receivables are stated at their unpaid principal balance plus accrued interest. Interest is recognized as accrued. An allowance was not required at either year end. If a participant ceases to make a loan repayment and the Plan Administrator deems the participant loan to be in default, the loan balance is reduced and a benefit payment to the participant is recorded.

Payment of Benefits: Benefit payments are recorded when paid.

Administrative Expenses: Administrative expenses incurred in connection with the general administration of the Plan are paid by the Plan and are recorded in the accompanying statement of changes in net assets available for benefits. Other Plan expenses may be paid by the Plan Sponsor.

Subsequent Events: Subsequent events have been evaluated by management through the date of the independent auditor's report. Material subsequent events, if any, are disclosed in a separate footnote to these financial statements.

Use of Estimates: The preparation of financial statements in conformity with U.S. generally accepted accounting principles requires estimates and assumptions that affect the reported amounts of net assets available for benefits and disclosure of contingent assets and liabilities at the date of financial statements, and the reported amounts of changes in net assets available for benefits during the reporting period. Actual results could differ from those estimates.

NOTE B – PLAN TERMINATION AND LIQUIDATION BASIS OF ACCOUNTING

Plan management adopted a resolution on to terminate the Plan on January 4, 2023. Accordingly, the Plan's 2023 financial statements have been prepared on the liquidation basis. On March 8, 2023, Plan assets of \$2,771,508 were transferred to another benefit plan.

The liquidation basis of accounting is considered appropriate when, among other things, liquidation of an entity is probable, and the net realizable value of assets are reasonably determinable. Under the liquidation basis of accounting, assets are stated at their estimated net realized cash value and liabilities are stated at their anticipated settlement amounts. The Plan had no assets as of March 8, 2023 as liquidation had taken place.

NOTE C – DESCRIPTION OF PLAN

The following description of the T&D Moravits and Company 401(k) Plan provides only general information. Participants should refer to the Plan Agreement for a more complete description of the Plan's provisions.

General: The Plan was a defined contribution plan subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA) and covered substantially all employees of T&D Moravits Company (Plan Sponsor) who had sixty days of service and were age eighteen or older.

Terminated Plan: The Plan Sponsor held the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. See Note B.

Contributions: Each year participants could elect to contribute up to 100% of pretax and after-tax annual compensation, subject to IRS limitations, as defined in the Plan. Participants who had attained age 50 before the end of the Plan year were eligible to make catch-up contributions. Participants could also contribute amounts representing distributions from other qualified defined benefit or defined contribution plans (rollover). Participants directed the investment of their contributions to various investment options offered by the Plan. The Plan Sponsor contributed a safe harbor match equal to 100% of a participant's contribution up to 1% of the participant's eligible compensation and 50% of a participant's next 6% of eligible compensation. Contributions were subject to certain limitations. Participants also directed the investment of any matching contribution received.

The Plan included an auto-enrollment provision whereby all newly eligible employees were automatically enrolled unless they affirmatively elected not to participate. Automatically enrolled participants had their initial deferral rate set at 3% in the first year of participation. Each year thereafter, unless changed by the participant, the deferral increased by 1% per year to a maximum of 7% of eligible compensation.

Participant Accounts: Each participant's account was credited with the participant's contribution and allocation of (a) the Plan Sponsor's contributions and (b) Plan earnings and charged with an allocation of administrative expenses. Allocations were based on the participant contributions or account balances, as defined. The benefit to which a participant was entitled was the benefit that could be provided from the participant's vested account.

Vesting: Participants were immediately vested in their contributions and employer safe harbor contributions plus actual earnings thereon.

Participants' Notes Receivable: Participants could borrow from their fund accounts a minimum of \$1,000 up to a maximum equal to the lesser of \$50,000 or 50% of their vested account balance. Note terms generally ranged from one to five years. The notes were secured by the balance in the participant's account and bore interest at a reasonable rate as determined by the Plan Administrator. Principal and interest were repaid no less frequently than quarterly by payroll deductions.

Payment of Benefits: On termination of service due to death, disability, or retirement, a participant could elect to receive a lump-sum distribution equal to the value of the participant's vested interest in their account. Any balance under \$1,000 was automatically paid out as soon as administratively possible. Hardship withdrawals were subject to a \$500 minimum and in-service distributions were allowed from deferred contributions.

Plan Termination: The Plan Sponsor held the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. See Note B.

Forfeited Accounts: Unallocated forfeitures totaled \$0 at March 8, 2023 and \$15,390 at December 31, 2022. The Plan allowed available forfeiture balances to reduce future employer contributions and pay the expenses of the Plan.

Administrative Expenses: Administrative expenses are paid by either the Plan Sponsor or the Plan, as provided in the Plan document.

NOTE D – INVESTMENTS CERTIFIED BY THIRD PARTY (unaudited)

As permitted by Department of Labor CFR 2520.103-8, investments and participants' notes receivable at December 31, 2022 and the related investment earnings and interest on participants' notes for the period ended March 8, 2023 and year then ended December 31, 2022, were certified and held by AXA Equitable Life Insurance Company, the Custodian, and were not audited by the independent auditor.

NOTE E – TRANSACTIONS WITH PARTIES-IN-INTEREST

The Plan's administrative expenses were paid either by the Plan or the Plan Sponsor as allowed by the Plan document. Expenses paid directly by the Plan Sponsor are excluded from these financial statements. Certain expenses incurred in connection with the general administration of the Plan that were paid by the Plan were recorded as deduction in the accompanying statement of changes in net assets available for benefits. In addition, certain investment-related expenses were included in net appreciation (depreciation) of fair value of investments.

NOTE F – INCOME TAX STATUS

The Plan is a pre-approved non-standardized 401(k) plan sponsored by the AXA Equitable Life Insurance Company. The pre-approved non-standardized 401(k) plan received a favorable opinion letter from the Internal Revenue Service on June 30, 2020. Although the Plan has been amended, the administrator believes that the Plan is designed and is currently being operated in compliance with the applicable requirements of the Internal Revenue Code and, therefore, believes that the Plan is qualified for tax-exempt status. The Plan Administrator is not aware of any tax positions that would have a significant impact on its financial position. Its federal tax returns for the last four years remain subject to examination.

The Plan has not completed non-discrimination testing for the period ended March 8, 2023 and year ended December 31, 2022. The Plan Committee believes the Plan is operating in accordance with the required rules and regulations. Management is not aware of any instances where the Plan would not be in compliance with the applicable discrimination testing. Its federal tax returns since inception are subject to examination.

NOTE G - FAIR VALUE MEASUREMENTS

In accordance with U.S. generally accepted accounting principles, the Plan utilizes a fair value hierarchy that prioritizes the inputs for the valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1) and the lowest priority to unobservable inputs (Level 3). The three levels of the fair value hierarchy are as follows:

- Level 1: Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.
- Level 2: Inputs to the valuation methodology include:
- quoted prices for similar assets or liabilities in active markets
 - quoted prices for identical or similar assets or liabilities in inactive markets
 - inputs other than quoted prices that are observable for the asset or liability
 - inputs that are derived principally from or corroborated by observable market data by correlation or other means
 - if the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability
- Level 3: Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

As of March 8, 2023, the Plan had no investments as it terminated and liquidated on that date. The following table sets forth by level, within the fair value hierarchy, investments measured at fair value as of December 31, 2022:
