**Opinion**

NOTE 1 - TRUST DESCRIPTION

The following description of the K&L Gates Voluntary Employees' Beneficiary Association (Trust) provides only general information. Participants should refer to the Trust document for a complete description of the Trust's provisions. Effective December 13, 2023, the Trust was amended to appoint a new co-trustee.

General - The Trust is a noncontributory, non-participant-directed trust. Assets are held in a voluntary employees' beneficiary association (VEBA) trust, which provides assets to fund certain health benefits in accordance with Internal Revenue Code (IRC) Section 419 and 419(a) for any employee or equity partner or former employee or equity partner of K&L Gates LLP, a Delaware limited liability partnership (Firm), from the K&L Gates Group Benefits Plan (Plan).

Trust Administration - The Trust is sponsored by the Firm. Trustees are fiduciaries with respect to administration of the Trust. The Bank of New York Mellon, N.A. (BNY Mellon) serves as custodian of the Trust and has overall responsibility for custody and safekeeping of the assets of the Trust that it holds. Trustees have sole authority to fund the Plan from the Trust assets.

Contributions - Only the Firm is permitted to make contributions to the Trust, which may be in the form of money or property at a time as determined by the Firm.

Payment of Benefits - Upon receipt of written direction from the Trustees, the Trust will make payments from its assets fund to Trust entities or accounts, including any claims administrator on the Trust's behalf, in such manner and in such amounts as the Trustees would direct. Amounts paid pursuant to such direction thereafter will no longer constitute a part of the Trust fund.

Trust Termination - Although it has not expressed any intent to do so, the Firm has the right under the Trust to terminate the Trust.

NOTE 2 - SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES

A summary of significant accounting policies consistently applied by management in the preparation of the accompanying statements of net assets available for benefits and related statements of changes in net assets available for benefits and the related notes to the financial statements (financial statements) follows:

Basis of Accounting - The financial statements of the Trust are prepared under the accrual basis of accounting.

Use of Estimates - The preparation of financial statements in accordance with accounting principles generally accepted in the United States of America (U.S. GAAP) requires management to make estimates and assumptions that affect the reported amounts of assets, liabilities and changes therein and disclosure of contingent assets and liabilities at the dates of the financial statements. Actual results could differ from those estimates.

Investment Valuation - The Trust's investments are stated at fair value, which is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See Note 4 for further discussion of fair value measurement.

NOTE 2 - SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES (Continued)

Interest income is recorded on the accrual basis.

Payment of Benefits - Benefit payments are recorded when paid.

Expenses - Trust expenses are paid either by the Trust or the Firm, as provided by the Trust document. Expenses paid by the Firm are excluded from these financial statements. Certain expenses incurred in connection with the general administration of the Trust that are paid by the Trust are recorded as deductions in the accompanying statements of changes in net assets available for benefits.

Subsequent Events - The Trustees have evaluated subsequent events through September 26, 2024, the date on which the financial statements were available to be issued.

NOTE 3 - TAX STATUS

The Trust established is qualified pursuant to Section 501(c)(9) of the IRC and, accordingly, the Trust's net investment income is exempt from income taxes. The Trust has obtained a favorable tax exemption letter from the Internal Revenue Service (IRS) dated June 7, 2017 with an effective date of November 29, 2016. The trustees believe the Trust continues to qualify and to operate as designed.

U.S. GAAP require the Trustees to evaluate tax positions taken by the Trust and recognize a tax liability (or asset) if the Trust has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS. The Trustees have analyzed the tax positions taken by the Trust, and have concluded that as of December 31, 2023 and 2022, there are no uncertain positions taken or expected to be taken that would require recognition of a liability (or asset) or disclosure in the financial statements. The Trust is subject to routine audits by taxing jurisdictions, however there are currently no audits for any tax periods in progress. The trustees believe the Trust is no longer subject to income tax examinations for years prior to 2020.

NOTE 4 - FAIR VALUE MEASUREMENT

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1) and the lowest priority to unobservable inputs (Level 3). The three levels of the fair value hierarchy under the Financial Accounting Standards Board Accounting Standards Codification 820 are described as follows:

Level 1 - Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Trust has the ability to access.

Level 2 - Inputs to the valuation methodology include:

- quoted prices for similar assets or liabilities in active markets;
- quoted prices for identical or similar assets or liabilities in inactive markets;
- inputs other than quoted prices that are observable for the asset or liability; and
- inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

Level 3 - Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset's or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques maximize the use of relevant observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodologies used for assets measured at fair value:

Interest-Bearing Cash - Values based on the actual observable value of the underlying money; priced daily.
