Management, having determined it is permissible in the circumstances, has elected to have the audit of the 2023 financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's (DOL's) Rules and Regulations for Reporting and Disclosure under ERISA. As permitted by ERISA Section 103(a)(3)(C), our audit need not extend to any statements or information related to assets held for investment of the Plan (investment information) by a bank or similar institution or insurance carrier that is regulated, supervised and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the DOL's Rules and Regulations for Reporting and Disclosure under ERISA (qualified institution).

Management has obtained a certification from a qualified institution as of and for the year ended December 31, 2023, stating that the certified investment information, as described in Note 3 to the financial statements, is complete and accurate.

The financial statements of the Plan as of December 31, 2022, were audited by predecessor auditors. In accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the DOL's Rules and Regulations for Reporting and Disclosure under ERISA, the prior year audit did not extend to any statements or information related to assets held for investment of the Plan that were certified by a qualified institution. Their report dated October 16, 2023, indicated that in their opinion (a) the amounts and disclosures in the 2022 financial statements, other than those agreed to or derived from the certified investment information, were presented fairly, in all material respects, in accordance with GAAP, and (b) the information in the 2022 financial statements related to assets held by and certified to by a qualified institution agrees to, or is derived from, in all material respects, the information prepared and certified by an institution that management determined meets the requirements of ERISA Section 103(a)(3)(C). Their report also indicated that the form and content of the 2022 supplemental schedule, other than the information in the 2022 supplemental schedule that agrees to or is derived from the certified investment information, were presented, in all material respects, in conformity with the DOL's Rules and Regulations for Reporting and Disclosure under ERISA, and the information in the 2022 supplemental schedule related to assets held by and certified to by a qualified institution agrees to, or is derived from, in all material respects, the information prepared and certified by an institution that management determined meets the requirements of ERISA Section 103(a)(3)(C).

1. DESCRIPTION OF THE PLAN

The following description of the Sabrosura Foods, LLC Retirement Savings Plan (the Plan) provides only general information. Participants should refer to the plan document for a more complete description of the Plan's provisions.

General

The Plan is a defined contribution plan sponsored by Sabrosura Foods, LLC (the Company or Plan Sponsor). Effective January 1, 2021, the Plan was restated and renamed from the Wisconsin Cheese Group Savings Plan (Wisconsin Cheese Plan). Also, effective January 1, 2021, the Reynaldo's Mexican Food Company LLC Savings Plan (the Reynaldo's Plan), was merged into the Plan.

The Plan covers all employees of the Company with the exception of employees covered by a collective bargaining agreement, nonresident aliens and leased employees. Each employee becomes a participant on the first day of the month coinciding with or next following the attainment of age 21 and the completion of a minimum service requirement. All eligible full-time employees must complete 30 days of service and eligible part-time employees must complete one year of service, as defined in the plan document. The Plan is subject to the provision of the Employee Retirement Income Security Act of 1974 (ERISA), as amended.

Contributions

Each year, participants may contribute 100% of their annual compensation as pre-tax or Roth after-tax contributions, as defined in the plan document, subject to certain limitations under the Internal Revenue Code (IRC). Participants who have attained age 50 before the end of the plan year are eligible to make catch-up contributions. Participants may also contribute amounts representing distributions from other qualified defined benefit or defined contribution plans (rollover). In addition, the Company makes discretionary matching contributions to the Plan of 50% of the first 6% of eligible compensation. All contributions during a plan year are subject to maximum dollar limitations established by the IRC. Participants direct the investment of their contributions into various investment options offered by the Plan.

Any employee hired who has completed the eligibility requirements of the Plan and who fails to make an affirmative election to participate in the Plan will be automatically enrolled in the Plan, and an election of 3% of the employee's annual compensation will be contributed to the Plan. Each year the automatic deferral amount will increase by 1%, not to exceed 6% of the employee's annual compensation.

Participant Accounts

Each participant's account is credited with the participant's contributions, Company discretionary matching contributions and an allocation of the Plan's net investment earnings or losses. Participant accounts are charged with an allocation of administrative expenses that are paid by the Plan. Allocations are based on participant earnings, account balances or specific participant transactions, as defined. The benefit to which a participant is entitled is the benefit that can be provided from a participant's vested balance.

Vesting

Participants are immediately vested in their contributions plus actual earnings thereon. Participants hired prior to January 1, 2021, under the Wisconsin Cheese Plan or the Reynaldo's Plan, are vested in Company matching contributions plus actual earnings thereon as follows: 20% vested after one year of credited service, 20% after two years of credited service and 100% vested after three years of credited service.

Participants hired after January 1, 2021, are vested in Company matching contributions plus actual earnings thereon as follows:

Notes Receivable from Participants

A participant may borrow from their account balance a minimum of \$1,000 up to a maximum equal to the lesser of \$50,000 or 50% of their vested account balance. The loans are secured by the balance in the participant's account and bear interest at rates commensurate with local prevailing rates at the date of issuance. Principal and interest are paid ratably through payroll deductions. Participants are allowed to have two outstanding loans at any time. The maximum term of repayment for a loan is five years, except if the loan is used for the purchase of a principal residence, then the term may be extended to 30 years.

Payment of Benefits

Upon termination of service, as defined, or upon attaining age 59½ while still employed (in-service), a participant may elect to distribute an amount equal to the value of the participant's vested interest in their account as a lump-sum payment or rollover payment into another qualified plan or account.

A participant may also withdraw money from their account in the event of financial hardship. Hardship withdrawals may not exceed the amount of the participant's cumulative deferrals.

A participant with an account balance less than or equal to \$5,000 will receive a rollover payment into an individual retirement account, unless the participant otherwise instructs the third-party administrator and receives a lump-sum payment, as soon as practicable following termination.

Forfeitures

The unvested portion of Company matching contributions in a terminated participant's account may be subject to forfeiture. Any accumulated benefits forfeited during a plan year due to a

participant withdrawal prior to full vesting will be used to reduce future Company contributions or pay administrative expenses, as specified by the Plan. As of December 31, 2023 and 2022, forfeited nonvested accounts totaled \$26,269 and \$37,252, respectively. During December 2023, forfeitures totaling approximately \$44,754 were used to reduce Company matching contributions. During 2022, no forfeitures were used to reduce Company matching contributions or pay administrative expenses.

2. SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES

Basis of Accounting

The financial statements of the Plan are prepared on the accrual basis of accounting in accordance with accounting principles generally accepted in the United States of America (GAAP).

Use of Estimates

The preparation of financial statements in accordance with GAAP requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities and changes therein, and disclosure of contingent assets and liabilities. Actual results could differ from those estimates.

Risks and Uncertainties

The Plan provides for investment options in a variety of investment securities. Investment securities, in general, are exposed to various risks, such as interest rate, market volatility and credit risks. Due to the level of risk associated with certain investment securities, it is reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect the amounts reported in the financial statements.

Investment Valuation and Income Recognition

The Plan's investments are stated at fair value, except for the fully benefit-responsive group annuity contract, which is reported at contract value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See Note 4 for discussion of fair value measurements.

Purchases and sales are recorded on a trade-date basis. Net appreciation (depreciation) in the fair value of investments represents realized and unrealized gains and losses on investments bought and sold as well as held during the year.

Payment of Benefits

Benefits are recorded when paid.

Administrative Expenses

Administrative expenses are paid by the Plan as permitted by the Plan's provisions. Fees related to the administration of distributions and notes receivable from participants are charged directly to the corresponding participant's account and are included in administrative expenses.

Investment related expenses are included in net appreciation (depreciation) in fair value of investments.

3. INFORMATION CERTIFIED BY PLAN CUSTODIAN

Certain information related to investments from participants disclosed in the accompanying financial statements and the ERISA-required supplemental schedule, including investments held as of December 31, 2023 and 2022, and net appreciation (depreciation) in fair value of investments for the years ended December 31, 2023 and 2022, was obtained by management and agreed to or derived from information certified as complete and accurate by Lincoln National Life Insurance Company, the custodian of the Plan, and furnished to the plan administrator.

4. FAIR VALUE MEASUREMENTS

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1) and the lowest priority to unobservable inputs (Level 3). The three levels of the fair value hierarchy under Financial Accounting Standards Board (FASB), Accounting Standards Codification (ASC) 820, *Fair Value Measurement*, are described as follows:

- Level 1 – Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.
- Level 2 – Inputs to the valuation methodology include: quoted prices for similar assets or liabilities in active markets; quoted prices for identical or similar assets or liabilities in inactive markets; inputs other than quoted prices that are observable for the asset or liability; and inputs that are derived principally from or corroborated by observable market data by correlation or other means. If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.
- Level 3 – Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

The following is a description of the valuation methodology used for assets measured at fair value:

Mutual funds: Valued at quoted market prices at year-end.

The method described above may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, while Plan management believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different estimate of fair value at the reporting date.

5. LINCOLN STABLE VALUE FUND

The Plan invests in the Lincoln Stable Value Fund which is a group annuity product issued by Lincoln Financial Group Trust Company (Lincoln). Under the group annuity contract, participants may ordinarily permit withdrawals or transfers of all or a portion of their account balance at contract value. This contract is fully benefit-responsive and is therefore reported at contract value. The Plan owns a promise from Lincoln to pay interest at crediting rates which are guaranteed for a specified period of time, as outlined within the group annuity contract. The contract value of the investment is based upon contributions made to the fund, plus earnings at guaranteed crediting rates, less participant withdrawals. Upon discontinuance of the contract, contract value would be paid no later than 90 days from the date the Company provides notice to discontinue.

When establishing interest crediting rates for this product, Lincoln considers many factors including current economic and market conditions, the general interest rate environment, and both the expected and actual experience of a reference portfolio within the issuer's general account. These rates are established without the use of a specific formula. The minimum crediting rate under the contract is 1.00%.

The Plan's ability to receive amounts due is dependent on the issuer's ability to meet its financial obligations. The issuer's ability to meet its contractual obligations may be affected by future economic and regulatory developments.

Certain events might limit the ability of the Plan to transact at contract value with the issuer. Such events include: (1) amendments to the Plan documents (including complete or partial Plan termination or merger with another plan, (2) changes to the Plan's prohibition on competing investment options or deletion of equity wash provisions, (3) bankruptcy of the Plan sponsor or other Plan sponsor events (for example, divestitures or spinoffs of a subsidiary) that cause a significant withdrawal from the Plan, (4) the failure of the trust to qualify for exemption from federal income taxes or any required prohibited transaction exemption under ERISA, or (5) premature termination of the contract. No events are probable of occurring that might limit the ability of the Plan to transact at contract value with the contract issuers and that also would limit the ability of the Plan to transact at contract value with the participants.

In addition, certain events allow the issuer to terminate the contract with the Plan and settle at an amount different from contract value. Such events include: (1) an uncured violation of the Plan's investment guidelines, (2) a breach of material obligation under the contract, (3) a material misrepresentation, or (4) a material amendment to the agreement without the consent of the issuer.

6. PARTY-IN-INTEREST TRANSACTIONS

The Plan invests in a stable value fund managed by Lincoln National Life Insurance Company, the custodian of the Plan; therefore, these transactions qualify as party-in-interest transactions. Administrative fees paid by the Plan to Lincoln National Life Insurance Company are included in administrative expenses in the statements of changes in net assets available for benefits.

7. PLAN TERMINATION

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of plan termination, participants would become 100% vested in their Company matching contributions, if any.

8. TAX STATUS

The Company adopted a nonstandardized pre-approved profit-sharing plan document sponsored by CCH Incorporated which received an opinion letter from the IRS dated June 30, 2020, indicating that the prototype plan and trust are designed in accordance with the applicable sections of the IRC. The Plan administrator believes that the Plan is designed, and is currently being operated, in compliance with the applicable requirements of the IRC, and therefore, believes that the Plan is tax-exempt as of the financial statement date. Accordingly, no provision for income taxes has been included in the Plan's financial statements.

GAAP requires Plan management to evaluate tax positions taken by the Plan and recognize a tax liability if the Plan has taken an uncertain position that more likely than not would not be

sustained upon examination by the IRS. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.
