Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed audits of the financial statements of the ARCO Companies Retirement Plan (formerly ARCO/Murray Group Profit Sharing Plan and Trust) (the Plan), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). The financial statements comprise the statements of net assets available for benefits as of December 31, 2023 and 2022, the related statement of changes in net assets available for benefits for the year ended December 31, 2023, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of the Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's (DOL) Rules and Regulations for Reporting and Disclosure under ERISA. As permitted by ERISA Section 103(a)(3)(C), our audits need not extend to any statements or information related to assets held for investment of the Plan (investment information) by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the DOL's Rules and Regulations for Reporting and Disclosure under ERISA (qualified institution).

Management has obtained certifications from a qualified institution as of December 31, 2023 and 2022, and for the year ended December 31, 2023, stating that the certified investment information, as described in Note 3 to the financial statements, is complete and accurate.

Opinion

In our opinion, based on our audits and on the procedures performed as described in the Auditor's Responsibilities for the Audit of the Financial Statements section:

- The amounts and disclosures in the accompanying financial statements, other than those agreed to or derived from the certified investment information, are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America (U.S. GAAP).
- The information in the accompanying financial statements related to assets held by and certified to by a qualified institution agrees to, or is derived from, in all material respects, the information prepared and certified by an institution that management determined meets the requirements of ERISA Section 103(a)(3)(C).

Basis for Opinion

We conducted our audits in accordance with auditing standards generally accepted in the United States of America (GAAS). Our responsibilities under those standards are further described in the Auditor's Responsibilities for the Audit of the Financial Statements section of our report. Accordingly, the objective of an ERISA Section 103(a)(3)(C) audit is not to express an opinion about whether the financial statements as a whole are presented fairly, in all material respects, in accordance with U.S. GAAP.

Notes to Financial Statements

Note 1. Description of the Plan

The following brief description of ARCO Companies Retirement Plan (formerly ARCO/Murray Group Profit Sharing Plan and Trust) (the Plan) provides only general information. Participants should refer to the Plan agreement for a more complete description of the Plan's provisions.

General: The Plan is a defined contribution plan covering eligible employees of ARCO Business Services, Inc, ARCO Construction Company, Inc, ARCO Design/Build, Inc, ARCO National Construction Company, Inc, ARCO/Murray Construction Company, Inc, ARCO/Murray Consulting, Inc, AM Mechanical, Inc, ARCO/Murray Associates, Inc, ARCO/Murray National Dallas, Inc, ARCO/Murray National Denver, Inc, ARCO/Murray National Nashville, Inc, ARCO/Murray National Norcal, Inc, and Thru-Put Partners, LLC (the Employers). The Board of Trustees is responsible for oversight of the Plan. The Investment Committee determines the appropriateness of the Plan's investment offerings, monitors investment performance and reports to the Plan's Board of Trustees. The Plan was most recently amended on March 1, 2024.

Eligibility: Eligible employees include employees who have attained the age of 18, completed 30 consecutive days of service, and are not represented by a collective bargaining agreement. An employee may enter the Plan on the first day of the month coinciding with or subsequent to meeting the eligibility requirements. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA) and the applicable current Internal Revenue Code (IRC) provisions.

Eligible employees for the Employers' profit sharing contributions include employees who have attained the age of 18, have completed one year of service with a minimum of 1,000 hours, and are not represented by a collective bargaining agreement.

Contributions and investment options: The Plan provides that each eligible participant may enter into a written salary reduction agreement whereby the participant may contribute up to the maximum allowed by the IRC. Participants can elect to contribute on a pre-tax basis, an after-tax basis (Roth) or a combination of the two. Additionally, participants age 50 or older, who are making contributions to the Plan are allowed to make catch-up contributions as defined in the Plan. Each Employer may make profit sharing contributions equal to a discretionary percentage of each participant's eligible compensation. Employers may also make a special safe harbor contribution equal to a percentage of select participant's eligible compensation. No special safe harbor contributions were made during the year ended December 31, 2023. Participants may also contribute amounts representing distributions from other qualified defined benefit or defined contribution plans.

Participants direct the investment of their contributions and any Employers' contributions into various investments offered by the Plan, which include mutual funds and collective trust funds. Participants may change their investment options daily.

Participant accounts: Each participant's account is credited with the participant's contribution and allocations of (a) the Employers' profit sharing and safe harbor contributions and (b) Plan earnings, and is charged with an allocation of administrative expenses. Allocations are based on participant earnings or account balances, as defined in the Plan document. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

Payment of benefits: Participants, or their beneficiaries, are eligible for benefits upon termination of employment, death or disability. If the value of the participant's vested balance is less than \$5,000, a participant may roll the amount into another qualified plan or receive a mandatory lump-sum distribution upon termination of service.

Note 1. Description of the Plan (Continued)

Vesting: Participants are immediately vested in their voluntary contributions, safe harbor contributions and rollovers plus actual earnings thereon. Vesting for profit sharing contributions occurs ratably over five years of service, at 20% per year. Participants who reach normal retirement age (65) or terminate employment due to total disability or death become fully vested in all accounts.

Forfeited accounts: Forfeited amounts may first be used to pay Plan expenses and to reduce employers' contributions with the remainder being allocated to participants as a percentage of each participant's eligible compensation. There were \$86,183 of forfeitures used to pay Plan expenses for the year ended December 31, 2023. At December 31, 2023 and 2022, available forfeited non-vested accounts totaled \$57,113 and \$89,949, respectively.

Note 2. Summary of Significant Accounting Policies

Basis of accounting: The financial statements of the Plan are prepared on the accrual basis of accounting.

Contributions: Contributions from Plan participants and any matching contributions from the employer are recorded in the year in which employee contributions are withheld from compensation.

Investment valuation and income recognition: The Plan's investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. The Plan's Investment Committee determines the Plan's valuation policies utilizing information provided by the investment advisers and custodians. See Note 4 for a discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation includes the Plan's gains and losses on investments bought and sold, as well as held, during the year.

Administrative expenses: Certain administrative functions applicable to the Plan are performed by employees of the Employers. No such employees receive compensation from the Plan. Administrative expenses may be paid by the Employers or the Plan, at the Employers' discretion.

Payment of benefits: Benefits are recorded when paid.

Use of estimates: The preparation of financial statements in accordance with accounting principles generally accepted in the United States of America requires management to make estimates and assumptions that affect the reported amounts of asset, liabilities and changes therein, and disclosure of contingent assets and liabilities. Actual results could differ from those estimates.

Subsequent events: Subsequent events have been evaluated through October 8, 2024, which is the date the financial statements were available to be issued.

Note 3. Information Certified or Provided by John Hancock Trust Company LLC, the Trustee

The Plan Administrator has obtained certifications from the trustee that information provided to the Plan Administrator by the trustee related to the following assets is complete and accurate. Accordingly, as permitted by 29 CFR 2520.103-8 of the Department of Labor's (DOL) Rules and Regulations for Reporting and Disclosure under ERISA, the Plan Administrator instructed the Plan's independent auditors not to perform any auditing procedures with respect to the information which appears throughout the financials statements and ERISA-required supplemental schedules related to the following assets:

Note 4. Fair Value Measurements

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1 measurements) and the lowest priority to unobservable inputs (Level 3 measurements). The three levels of the fair value hierarchy are described below:

Level 1: Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2: Inputs to the valuation methodology include:

- Quoted prices for similar assets or liabilities in active markets
- Quoted prices for identical or similar assets or liabilities in inactive markets
- Inputs other than quoted prices that are observable for the asset or liability
- Inputs that are derived principally from or corroborated by observable market data by correlation or other means

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

Level 3: Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

Note 4. Fair Value Measurements (Continued)

The asset's or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

The following are descriptions of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at December 31, 2023 and 2022.

Mutual funds: Mutual funds are valued at the daily closing price, as reported by the fund. Mutual funds held by the Plan are open-end mutual funds that are registered with the Securities and Exchange Commission. These funds are required to publish their daily net asset value and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.

Collective trust funds: Collective trust funds are composed primarily of investments in equities, bonds and guaranteed investment contracts issued by life insurance companies, banks and other financial institutions. For all collective trust funds, the net asset value (NAV) is used as a practical expedient to estimate fair value. This practical expedient would not be used if it is determined to be probable that the fund will sell the investment for an amount different from the reported NAV. Participant transactions (purchases and sales) may occur immediately. If the Plan initiates a full redemption of the collective trust, no notice to the issuer is required.

The methods described above may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, although the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

Note 4. Fair Value Measurements (Continued)

To assess the appropriate classification of investments within the fair value hierarchy, the availability of market data is monitored. Changes in economic conditions or valuation techniques may require the transfer of investments from one fair value level to another. In such instances, the transfer is reported at the end of the reporting period. For the year ended December 31, 2023, the Plan did not make any transfers in or out of Level 3 assets or liabilities.

There are no participant redemption restrictions for these investments; the redemption notice period is applicable only to the Plan. Note 5. Plan Termination

Although they have not expressed any intent to do so, the Employers reserve the right to terminate the Plan at any time, subject to Plan provisions and ERISA. In the event of Plan termination, participants would become 100% vested in their Employers' contributions, and the interest of each participant would be distributed as prescribed by the Plan terms and the IRC.

Note 6. Tax Status

The Plan has adopted a preapproved plan document that has received an opinion letter from the Internal Revenue Service (IRS) dated June 30, 2020, stating that the form of the preapproved plan document was in compliance with applicable requirements of the IRC. The Plan has been amended since adopting the preapproved plan document; however, the Plan Administrator believes the Plan is designed, and is being operated, in compliance with the applicable requirements of the IRC and the related trust is tax-exempt.

Accounting principles generally accepted in the United States of America require plan management to evaluate tax positions taken by the plan and recognize a tax liability if the plan has taken an uncertain position that more likely than not would be sustained upon examination by the U.S. federal, state and local tax authorities. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

Note 7. Risks and Uncertainties

The Plan invests in various investment securities. Investment securities are exposed to various risks, such as interest rate, market and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the 2023 statement of net assets available for benefits.

Note 8. Related-Party and Party-in-Interest Transactions

The Plan incurs expenses related to general administration and recordkeeping. Certain accounting and auditing fees related to the Plan are paid by the Employers while other fees are being paid indirectly by participants to the Plan's third-party administrators based on a percentage of Plan assets. Expenses that are paid directly by the Company that are not reimbursed by the Plan are not included in these financial statements. These transactions are party-in-interest transactions as defined under ERISA. Administrative expenses paid by the Plan to parties in interest amounted to \$258,670 in 2023.

Note 9. Delinquent Participant Contributions

During 2023, the Plan sponsor inadvertently failed to deposit \$33,876 of participant contributions within the required timeframe as stated by the United States DOL regulations. The Plan Sponsor deposited lost earnings in the amount totaling approximately \$125 to correct this failure in 2023 and 2024. The Plan Sponsor filed Form 5330 and paid applicable excise tax to the IRS. The correction will be made from the Plan Sponsor's assets and not from assets of the Plan.
