We have performed audits of the financial statements of Pinnacle Solutions 401(k) and Profit-Sharing Plan (Plan), an employee benefit plan subject to the *Employee Retirement Income Security Act of 1974* (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). The financial statements comprise the statements of net assets available for benefits as of December 31, 2023 (in liquidation) and 2022 (ongoing), and the related statements of changes in net assets available for benefits for the years then ended, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, elected to have the audits of the Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C), pursuant to 29 CFR 2520.103-8 of the Department of Labor's (DOL) Rules and Regulations for Reporting and Disclosure under ERISA. As permitted by ERISA Section 103(a)(3)(C), our audits need not extend to any statements or information related to assets held for investment of the Plan (investment information) by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the DOL's Rules and Regulations for Reporting and Disclosure under ERISA (qualified institution).

Management has obtained certifications from a qualified institution as of and for the years ended December 31, 2023 (in liquidation) and 2022 (ongoing), stating that the certified investment information, as described in Note 3 to the financial statements, is complete and accurate.

Opinion

In our opinion, based on our audits and on the procedures performed as described in the *Auditor's Responsibilities for the Audit of the Financial Statements* section:

- The amounts and disclosures in the accompanying financial statements, other than those agreed to or derived from the certified investment information, are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America.
- The information in the accompanying financial statements related to assets held by and certified to by a qualified institution agrees to, or is derived from, in all material respects, the information prepared and certified by an institution that management determined meets the requirements of ERISA Section 103(a)(3)(C).

Basis for Opinion

We conducted our audits in accordance with auditing standards generally accepted in the United States of America (GAAS). Emphasis of Matter – Plan Termination and Liquidation Basis of Accounting

As discussed in Note 6 to the financial statements, the Board of Directors of Pinnacle Solutions, Inc., the Plan's sponsor, voted on April 10, 2023, to terminate the Plan, and management determined liquidation was imminent. As a result, the Plan has changed its basis of accounting from the going concern basis used in presenting the 2022 financial statements to the liquidation basis used in presenting the 2023 financial statements. Our opinion is not modified with respect to this matter.

Responsibilities of Management for the Financial Statements

Management is responsible for the preparation and fair presentation of the financial statements in accordance with accounting principles generally accepted in the United States of America, and for the design, implementation, and maintenance of internal control relevant to the preparation and fair presentation of financial statements that are free from material misstatement, whether due to fraud or error. Management's election of the ERISA Section 103(a)(3)(C) audit does not affect management's responsibility for the financial statements.

In preparing the financial statements, management is required to evaluate whether there are conditions or events, considered in the aggregate, that raise substantial doubt about the Plan's ability to continue as a going concern within one year after the date that these financial statements are available to be issued.

Management is also responsible for maintaining a current Plan instrument, including all Plan amendments, administering the Plan, and determining that the Plan's transactions that are presented and disclosed in the financial statements are in conformity with the Plan's provisions, including maintaining sufficient records with respect to each of the participants, to determine the benefits due or which may become due to such participants.

Auditor's Responsibilities for the Audit of the Financial Statements

Except as described in the *Scope and Nature of the ERISA Section 103(a)(3)(C) Audit of the Financial Statements* section of our report, our objectives are to obtain reasonable assurance about whether the financial statements as a whole are free from material misstatement, whether due to fraud or error, and to issue an auditor's report that includes our opinion. Reasonable assurance is a high level of assurance but is not absolute assurance and therefore is not a guarantee that an audit conducted in accordance with GAAS will always detect a material misstatement when it exists. The risk of not detecting a material misstatement resulting from fraud is higher than for one resulting from error, as fraud may involve collusion, forgery, intentional omissions, misrepresentations, or the override of internal control. Misstatements are considered material if, there is a substantial likelihood that, individually or in the aggregate, they would influence the judgment made by a reasonable user based on the financial statements.

In performing an audit in accordance with GAAS, we:

Accordingly, the objective of an ERISA Section 103(a)(3)(C) audit is not to express an opinion about whether the financial statements as a whole are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America.

We are required to communicate with those charged with governance regarding, among other matters, the planned scope and timing of the audit, significant audit findings, and certain internal control-related matters that we identified during the audit.

Note 1. Description of the Pinnacle Solutions 401(k) and Profit-Sharing Plan

The following description of the Pinnacle Solutions 401(k) and Profit-Sharing Plan (Plan) provides only general information. Participants should refer to the Plan document for a more complete description of the Plan's provisions.

General

The Plan was a defined contribution Plan sponsored by Pinnacle Solutions, Inc. (Company) for the benefit of its employees. The Plan was subject to the provisions of the *Employee Retirement Income Security Act of 1974* (ERISA). The Plan was effective January 1, 2008, and was amended May 5, 2016 to allow employees covered by a collective bargaining agreement to participate in the Plan and only receive safe harbor matching contributions and/or discretionary nonelective employer contributions to the extent indicated within each such collective bargaining agreement. Effective September 2, 2019, the Plan was amended to provide fixed formula nonelective employer contributions for eligible employees who perform services covered by the *Davis-Bacon Act*.

The Plan was administered by the Company. Certain officers of the Company were appointed as members of the benefits administration committee of the Plan. The assets were governed by a trust agreement with Fidelity Management Trust Company (Fidelity) who served as Plan trustee.

As further described in Note 6, on April 10, 2023, the Plan sponsor's board of directors resolved to terminate the Plan, with such termination effective December 31, 2023.

Contributions

The Plan permitted eligible employees through a salary deferral election to have the Company make annual contributions up to 90% of eligible compensation. The Plan also allowed employees to designate all or a portion of their contributions as Roth, after-tax, contributions. Participants who had attained age 50 before the end of the Plan year were eligible to make catch-up contributions. Employee rollover contributions were also permitted. The Company made safe harbor matching contributions in an amount equal to 100% of the first 3% of eligible compensation and 50% of the next 2% of eligible compensation contributed to the Plan as deferral contributions. The Company could also make discretionary contributions, as defined by the Plan document. Discretionary contributions, if made, were allocated to eligible participants and based upon the percentage of each participant's compensation to the total compensation of all eligible participants. Participants were required to be employed at the end of the year and earn at least 1,000 hours of service to share in allocations of discretionary contributions. No discretionary contributions were made during the years ended December 31, 2023 (in liquidation) and 2022 (ongoing). Contributions were subject to certain limitations.

Participant Investment Account Options

Each participant had the option of directing their contributions into any of the various investment options offered by the Plan and could change the allocation daily.

Participant Accounts

Each participant's account was credited with the participant's contribution, the Company's contribution (if any), and Plan earnings, and was charged with an allocation of administrative expenses. Allocations were based on account balances, as defined. The benefits to which a participant is entitled were the benefits that can be provided from the participant's vested account.

Vesting

Participants were immediately vested in their voluntary contributions, plus earnings thereon, and the Company's safe harbor matching contributions, plus earnings thereon. The Company's discretionary contributions vested ratably, 25% over four years of service. Amounts not vested at the time a covered participant ceases to participate in the Plan were forfeited.

Notes Receivable from Participants

Participants could borrow from their fund accounts a minimum of \$1,000 up to a maximum equal to the lesser of \$50,000 or 50% of their vested account balance. The loans were secured by the balance in the participant's account and bore interest rates of 4.25% to 8.00%, which were commensurate with local prevailing rates and determined by the plan administrator at the time of issuance. Principal and interest were paid ratably through bi-weekly payroll deductions.

Payment of Benefits

Upon termination of service due to death, disability, or retirement, a participant could elect to receive any portion of the distributable vested interest in their account in either a lump-sum amount or in a systemic withdrawal plan. For vested accounts under \$5,000, participants were paid in a single lump-sum.

Forfeited Accounts

At December 31, 2023 (in liquidation) and 2022 (ongoing), forfeited nonvested accounts totaled \$0 and \$13, respectively. These accounts were used to pay administrative expenses or to reduce Company contributions. During the years ended December 31, 2023 (in liquidation) and 2022 (ongoing), employer contributions were reduced by \$1,998 and \$1,651, respectively, from forfeited nonvested accounts.

Transfer from Pinnacle Solutions, Inc. Employee Stock Ownership Plan

During the year ended December 31, 2022, the ESOP offered distributions to terminated participants. For participants who did not provide information on where to distribute their funds to, the ESOP transferred the funds to the participant's account in the 401(k) and Profit-Sharing Plan. The amount from this transfer is included in the "Transfer from Pinnacle Solutions, Inc. Employee Stock Ownership Plan" in the 2022 Statement of Changes in Net Assets Available for Benefits.

Note 2. Summary of Significant Accounting Policies

Basis of Accounting

The accompanying 2023 financial statements are prepared on the liquidation basis of accounting. The accompanying 2022 financial statements are prepared on the accrual basis of accounting.

Use of Estimates

The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires management to make estimates and assumptions that affect the reported amounts of net assets and changes in net assets and disclosure of contingent assets and liabilities at the date of the financial statements. Actual results could differ from those estimates.

Investment Valuation and Income Recognition

Investments are reported at fair value. Quoted market prices, if available, are used to value investments. Mutual funds are valued at the quoted market prices of shares held by the Plan at year-end.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation (depreciation) in the fair value of investments includes the Plan's gains and losses on investments bought and sold, as well as held during the year.

Notes Receivable from Participants

Notes receivable from participants are measured at their unpaid principal balance, plus any accrued but unpaid interest. Delinquent participant loans are reclassified as distributions based upon the terms of the Plan document.

Payment of Benefits

Benefit payments to participants were recorded upon distribution.

Administrative Expenses

Administrative expenses could be paid by the Company or the Plan, at the Company's discretion.

Note 3. Certification of Plan Trustee

The Plan administrator elected the method of annual reporting compliance permitted by ERISA Section 103(a)(3)(C), pursuant to 29 CFR 2520.103-8 of the Department of Labor's (DOL) Rules and Regulations for Reporting and Disclosure under ERISA. Accordingly, Fidelity, a qualified institution, has certified the following investment information included in the accompanying financial statements is complete and accurate:

- Investments and notes receivable from participants as shown in the statements of net assets available for benefits as of December 31, 2023 (in liquidation) and 2022 (ongoing).
- Investment income (loss) and interest income from notes receivable from participants as shown in the statements of changes in net assets available for benefits for the years ended December 31, 2023 (in liquidation) and 2022 (ongoing).

The Plan's independent auditors did not perform auditing procedures with respect to this certified investment information, except for comparing such certified investment information to the related investment information included in the financial statements and ERISA-required supplemental schedule.

Note 4. Related-Party and Party-in-Interest Transactions

Party-in-interest transactions include those with fiduciaries or employees of the Plan, any person who provides services to the Plan, an employer whose employees are covered by the Plan, an employee organization whose members are covered by the Plan, a person who owns 50% or more of such, an employer or employee association, or relatives of such persons.

Certain Plan investments were shares of mutual funds managed by Fidelity. Fidelity is the trustee as defined by the Plan and, therefore, these transactions qualify as party-in-interest transactions.

The Plan paid \$57,497 and \$70,744 of recordkeeping fees to Fidelity during 2023 (in liquidation) and 2022 (ongoing), respectively. The Company provided certain administrative services at no cost to the Plan.

Note 5. Disclosures About Fair Value of Plan Assets and Liabilities

Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. Fair value measurements must maximize the use of observable inputs and minimize the use of unobservable inputs. There is a hierarchy of three levels of inputs that may be used to measure fair value:

- Level 1** Quoted prices in active markets for identical assets or liabilities.
- Level 2** Observable inputs other than Level 1 prices, such as quoted prices for similar assets or liabilities, quoted prices in markets that are not active, or other inputs that are observable or can be corroborated by observable market data for substantially the full term of the assets or liabilities.
- Level 3** Unobservable inputs supported by little or no market activity and are significant to the fair value of the assets or liabilities.

Such securities are classified in Level 2 of the valuation hierarchy. In certain cases where Level 1 or Level 2 inputs are not available, securities are classified within Level 3 of the hierarchy.

Note 6. Plan Termination

On April 10, 2023, the Plan sponsor's board of directors resolved to terminate the Plan, with such termination effective December 31, 2023. All participants became 100% vested in their benefits at this time. The Plan was terminated and fully liquidated as of December 31, 2023.

Note 7. Tax Status

The Plan operated under an adoption agreement in connection with a volume submitter defined contribution Plan document sponsored by Fidelity. The volume submitter Plan document had been filed with the appropriate agency. The Plan had not obtained or requested a determination letter. However, the Plan administrator believed that the Plan was currently designed and operating in compliance with the applicable requirements of the Internal Revenue Code and that the Plan was qualified and the related trust was tax exempt as of the financial statement date.
