**Note 1. Description of the Plan**

The following description of American Thermal Instruments, Inc. / Microtek Laboratories, Inc. 401(k) Profit Sharing Plan (the Plan) provides only general information. Participants should refer to the Summary Plan Description or the Plan Document for a more complete description of the Plan's provisions.

General

The Plan is a defined contribution plan that covers substantially all employees of TSTO Corporation, including those leased to American Thermal Instruments, Inc. (the Plan Sponsor), Microtek Laboratories, Inc., Advanced Electronic Tracking, LLC, TSTO Corporation, ATI Farms, LLC, Latent Heat Solutions, and Greene Farms (collectively, the Company) who have attained the age of 21 or seasonal employees who have attained the age of 21 and completed one year of eligible service. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA).

Contributions

Participants may voluntarily contribute up to certain limitations as stipulated by applicable IRS Code Sections. Catch-up contributions are also permitted by the Plan. Participants may also contribute amounts representing distributions from other qualified plans or accounts.

The Company makes a matching safe harbor contribution which is equal to 3% of each eligible employee's compensation. The Organization may also provide discretionary matching and profit sharing contribution amounts. There were no discretionary or profit sharing contributions in 2023.

Participant accounts

Each participant's account is credited with the participant's contributions, Company contributions, and actual earnings thereon. Each participant's account is charged with his or her withdrawals and an allocation of administrative expenses. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

Vesting

Participants are immediately 100% vested in individual accounts derived from their voluntary contributions and safe harbor matching contributions. Participants vest 20% per year of service, starting after two years of credited service and are 100% vested in individual accounts derived from employer discretionary contributions after six years of service. Earlier vesting may occur upon death or disability.

Forfeitures

Forfeited, non-vested accounts totaled \$0 at December 31, 2023 and 2022, respectively. Forfeited amounts can be used to pay administrative expenses or to offset future employer contributions. During 2023 forfeited, non-vested accounts of \$0 were used to reduce employer contributions or pay administrative expenses.

Payment of benefits

The Plan provides for payment of normal retirement benefits of accumulated vested amounts upon reaching age 65 and has provisions for early withdrawals of vested benefits in instances of early retirement, death, disability, termination of employment, and financial hardship. A participant may elect to receive a lump-sum amount equal to the value of the participant's vested interest in his or her account.

Notes receivable from participants

Participants may borrow from their fund accounts a minimum of \$1,000 up to a maximum amount of \$50,000 or 50% of a participant's vested account balance, whichever is less. Each loan is collateralized by the remaining balance in the participant's account and bear interest at prevailing market rates as set by the Plan. Interest rates on participant loans ranged from 4.25% to 9.5% as of December 31, 2023. The term of such loans is generally not to exceed five years. Principal and interest are paid ratably through payroll deductions.

Investment options

Participants may direct the investment of their accounts into various investment options offered under the Plan. Participants may change their investment choices on a daily basis.

**Note 2. Significant Accounting Policies**

Basis of accounting

The financial statements of the Plan are prepared on the accrual basis of accounting in accordance with accounting principles generally accepted in the United States of America (U.S. GAAP). The Accounting Standards Codification (ASC) as produced by the Financial Accounting Standards Board (FASB) is the sole source of authoritative U.S. GAAP.

Use of estimates

The preparation of financial statements in accordance with accounting principles generally accepted in the United States of America requires the Plan administrator to make estimates and assumptions that affect certain reported amounts and disclosures. Actual results could differ from estimates as additional information becomes available in the future.

Investment valuation and income recognition

Investments held by the Plan are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation includes the Plan's gains and losses on investments bought and sold as well as held during the Plan year.

Notes receivable from participants

Notes receivable from participants are reported at their unpaid principal balance plus any accrued but unpaid interest, with no allowance for credit losses, as repayments of principal and interest are received through payroll deductions and the notes are collateralized by the participants' account balances.

Payment of benefits

Benefits are recorded when paid.

Administrative expenses

Administrative expenses of the Plan are paid by the Company or Plan participants, as defined in the Plan agreement.

Investment management fees and operating expenses

Investment management fees and operating expenses charged to the Plan for investments in the various funds are deducted from income earned on a daily basis and are reflected as a component of net appreciation in fair value of investments.

Date of management's review

Subsequent events have been evaluated by management through September 23, 2024, the date the statements were available to be issued.

**Note 3. Information Certified by the Plan's Custodian**

The plan administrator has elected the method of compliance permitted by 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. Accordingly, Matrix Trust Company, the custodian of the Plan, has certified to the completeness and accuracy of all investment information reflected on the accompanying statements of net assets available for benefits as of December 31, 2023 and 2022, the schedule of assets (held at end of year) at December 31, 2023, and the related dividends and net appreciation in fair value of investments information reflected in the statement of changes in net assets available for benefits for the year ended December 31, 2023.

**Note 4. Fair Value Measurement**

FASB ASC 820, Fair Value Measurements and Disclosures, provides the framework for measuring fair value. That framework provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (level 1 measurements) and the lowest priority to unobservable inputs (level 3 measurements). The three levels of the fair value hierarchy under FASB ASC 820 are described as follows:

Level 1	Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.
Level 2	Inputs to the valuation methodology include quoted prices from similar assets or liabilities in active markets; quoted prices for identical or similar assets or liabilities in inactive markets; inputs other than quoted prices that are observable for the asset or liability; inputs that are derived principally from or corroborated by observable market data by correlation or other means. If the asset or liability has a specified (contractual) term, the level 2 input must be observable for substantially the full term of the asset or liability.
Level 3	Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

The following is a description of the valuation methodology used for assets measured at fair value. There have been no changes in the methodologies used at December 31, 2023 and 2022.

Mutual funds: Valued at the closing price reported on the active market on which the individual securities are traded. Mutual funds held by the Plan are open-end mutual funds that are registered with the Securities and Exchange Commission. These funds are required to publish their daily net asset value (NAV) and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.

Collective Trust Fund: Valued at the daily net asset value (NAV) of units held by the Plan at year end provided by the issuer of the fund. The NAV is used as a practical expedient to estimate fair value and is based on the value of the underlying investment assets owned by the fund, minus its liabilities. Participant transactions (purchases and sales) may occur daily. Were the Plan to initiate a full redemption of the collective trust, the issuer reserves the right to temporarily delay withdrawal from the trust in order to ensure that securities liquidations will be carried out in an orderly business manner. There are currently no redemption restrictions or unfunded commitments on these investments.

The preceding method described may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, although the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

**Note 5. Party-in-Interest Transactions**

Certain administrative services are provided by the Company at no cost to the Plan and certain administrative costs incurred by the Plan are paid by the Company.

The Plan's administrative fees result from services rendered by parties-in-interest.

**Note 6. Tax Status**

The Internal Revenue Service has determined and informed the Company by a letter dated March 31, 2014, that the Plan and related trust are designed in accordance with the applicable sections of the Internal Revenue Code (IRC) for use by employers for the benefit of their employees. Although the Plan has been amended since receiving the determination letter, the plan administrator believes that the Plan is designed and is currently being operated in compliance with the applicable requirements of the IRC and therefore believes that the Plan is qualified and the related trust is tax-exempt.

U.S. GAAP requires Plan management to evaluate tax positions taken by the Plan and recognize a tax liability (or asset) if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS. The plan administrator has analyzed the tax positions taken by the Plan, and has concluded that as of December 31, 2023 and 2022, there are no uncertain tax positions taken or expected to be taken that would require recognition of a liability (or asset) or disclosure in the financial statements. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

**Note 7. Plan termination**

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA and its related regulations. In the event of Plan termination, participants will become 100% vested in their accounts.

**Note 8. Risks and Uncertainties**

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits.

**Note 9. Subsequent Event**

Effective September 1, 2024, the Plan was amended to transfer the sponsorship of the Plan from American Thermal Instruments, Inc. (ATI) to Microtek Laboratories, Inc. resulting in a partial termination of the Plan as all ATI participants were transferred out of the Plan.


