#### **Scope and Nature of the ERISA Section 103(a)(3)(C) Audit**

We have performed the audits of the financial statements of **SiteLock 401(k) Plan** ("the Plan"), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 ("ERISA"), as permitted by ERISA Section 103(a)(3)(C) ("ERISA Section 103(a)(3)(C) audit"). The financial statements comprise the statements of net assets available for benefits as of December 31, 2022 and 2021, the related statement of changes in net assets available for benefits for the year ended December 31, 2022, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of the Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. As permitted by ERISA Section 103(a)(3)(C), our audits need not extend to any statements or information related to assets held for investment of the Plan ("investment information") by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA ("qualified institution").

Management has obtained certifications from a qualified institution as of December 31, 2022 and 2021 and for the year ended December 31, 2022, stating that the certified investment information, as described in Note 4 to the financial statements, is complete and accurate.

#### **Opinion**

### (1) Description of the Plan

The following description of the SiteLock 401(k) Plan (the "Plan") provides only general information. Participants should refer to the Plan agreement for a more complete description of the Plan's provisions.

- A. General** - The Plan, established as of January 1, 2019, is a 401(k) profit sharing defined contribution plan sponsored by SiteLock, LLC (the "Company" or "Sponsor"). The Plan covers all eligible employees of the Company. The Plan is available to all employees of the Company, regardless of age or service time, except individuals classified as members of a collective bargaining unit and non-resident aliens. The Plan provides for an automatic enrollment percentage of 3%. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 ("ERISA"). The Company serves as the Plan administrator. The Plan has appointed John Hancock Life Insurance Company (U.S.A) ("John Hancock") as the custodian.
- B. Contributions** - Employees of the Company may elect to contribute to the Plan through tax-deferred salary deferrals or after-tax Roth deferrals up to 100% of their annual compensation, as defined by the Plan, up to a statutory maximum determined by the Internal Revenue Service. The maximum elective deferral for the year ended December 31, 2022 was \$20,500. Participants who have attained age 50 before the end of the Plan year are also eligible to make catch-up contributions up to \$6,500 for the year ended December 31, 2022. Participants direct the investments of their contributions into various investment options offered by the Plan. The Plan permits participants to make certain tax-free transfers (rollovers) of lump sum distributions received from other tax-qualified plans.

The Company makes certain safe-harbor matching contributions to the Plan for employees with one year of service. The Company matches 100% of the first 3% of base compensation that a participant contributes to the Plan and 50% of the next 2%. Additionally, the Company may elect to make an annual profit-sharing contribution and/or a qualified non-elective contribution. For the year ended December 31, 2022, the Company did not elect to make a profit-sharing contribution or a qualified non-elective contribution.

- C. Participant accounts** - Each participant's account is credited with the participant's contributions, safe-harbor matching contributions and allocations of the Company's profit sharing or qualified non-elective contributions, if any, and Plan earnings. Each participant's account is also charged with administrative expenses, in accordance with the Plan agreement. Allocations are based on participant earnings or account balances, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.
- D. Vesting** - Participants are immediately vested in the amounts they elect to defer, rollover contributions, Company safe-harbor matching contributions, qualified non-elective contributions, and any earnings or losses on such contributions. Any Company discretionary profit-sharing contribution vests as follows:

Participants become 100% vested in their account balance upon reaching normal retirement age, total and permanent disability, death, or plan termination.

### (1) Description of the Plan (continued)

- E. Forfeitures** - At December 31, 2022 and 2021, there were not material amounts of forfeited non-vested amounts in the Plan. Any forfeited non-vested amounts will be used to pay reasonable Plan expenses or reduce future Company contributions, to the extent made by the Company. During the year ended December 31, 2022, there were not material forfeited amounts used to pay Plan expenses.
- F. Notes receivable from participants** - Participants may borrow the lesser of \$50,000 or 50 percent of their vested account balances, with a minimum loan amount of \$1,000. The loans are secured by the vested balances in the participants' accounts and bear interest at a fixed rate based on the U.S. prime rate at the time the loan is distributed. Loan repayments must be made through an established repayment schedule, not to exceed 5 years unless the entire proceeds are used to purchase the participant's primary residence, in which case the repayment period may extend to 20 years.
- G. Payment of benefits** - Upon termination of employment with the Company, participants are entitled to the vested portion of their account balances. If the participant's vested balance is not more than \$5,000, the Plan administrator shall distribute the benefit in a lump sum either by cash distribution or rollover distribution. If the value of a terminated participant's vested account balance exceeds \$5,000, the participant has the option to keep the vested amount in the Plan until the earlier of: (1) the date the participant reaches normal retirement age, (which is age 62 years), as defined in the Plan; (2) the date the participant consents in writing to receive a distribution (in a lump-sum or installments); or (3) termination of the Plan. These accounts share in the allocation of Plan income or loss. Participants are allowed to make hardship withdrawals from the Plan in certain situations, as defined in the Plan agreement.
- H. Termination of the Plan** - Subsequent to year-end, the Company merged the participants and Plan assets into a pooled-employer plan. Upon termination of the Plan, participants became 100% vested in their account balances.

### (2) Significant accounting policies

The significant accounting policies followed by the Plan are as follows:

**Basis of accounting** - The accompanying financial statements of the Plan have been prepared on the accrual method of accounting in accordance with accounting principles generally accepted in the United States of America.

**Use of estimates** - The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires management to make estimates and assumptions that affect reported amounts of assets and liabilities and changes therein, and disclosures of contingent assets and liabilities. Accordingly, actual results may differ from those estimates.

**Investment valuation and income recognition** - Investments are reported at fair value as more fully described in Note 3. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date.

Purchases and sales of investments are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Net appreciation or depreciation in fair value of investments includes the Plan's gain and losses on investments bought and sold as well as held during the year.

**Payment of benefits** - Benefit payments to participants are recorded when paid.

### (2) Significant accounting policies (continued)

**Risks and uncertainties** - The Plan provides for various investment fund options, which invest in a variety of combinations of investment instruments. These investments are exposed to various risks, such as interest rate, credit and overall market volatility risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in risks in the near term could materially affect participants' account balances and the amounts reported in the financial statements.

**Subsequent events** - The Plan administrator has evaluated subsequent events through June 13, 2024, which is the date the financial statements of the Plan were available to be issued. Subsequent to year-end, the Company merged the participants and Plan assets into a pooled-employer plan.

### (3) Fair value measurements

Financial Accounting Standards Board ("FASB") Accounting Standards Codification ("ASC") 820, *Fair Value Measurement*, establishes a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1 measurements) and the lowest priority to unobservable inputs (Level 3 measurements). The three levels of the fair value hierarchy under FASB ASC 820 are described below:

Level 1: Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets.

Level 2: Inputs to the valuation methodology include quoted prices for similar assets and liabilities in active markets; quoted prices for identical or similar assets and liabilities in inactive markets; inputs other than quoted market prices that are observable for the asset or liability; inputs that are derived principally from or corroborated by observable market data by correlation or other means. If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

Level 3: Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

A financial instrument's level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement.

Following is a description of the valuation methodology used for assets measured at fair value.

*Pooled separate accounts:* Investments in sub-accounts of the Plan's group annuity contract with John Hancock are valued at unit value, which is based on the aggregate fair value of the underlying assets in relation to the total number of units outstanding. Unit value is the equivalent of net asset value ("NAV"), which is a practical expedient for estimating the fair values of these investments. Each of these investments may be redeemed daily with a notice period of one day and had no unfunded commitments as of December 31, 2022 and 2021. The Plan's investments in pooled separate accounts, measured at NAV as a practical expedient, with fair value of \$1,843,266 and \$2,362,979 as of December 31, 2022 and 2021, respectively, are therefore not included within the fair value levels described above.

### (4) Information certified by the custodian

The Plan administrator has elected the method of annual reporting compliance permitted by ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. Accordingly, the Plan's custodian has certified that the following information included in the accompanying financial statements and supplemental schedule are complete and accurate with respect to investments:

- Investments
- Notes receivable from participants
- Interest income on notes receivable from participants
- Net depreciation in fair value of investments
- Schedule of assets (held at end of year)

The Plan's independent public accountants did not perform auditing procedures with respect to this information, except for comparing such information to the related information included in the financial statements and supplemental schedule.

### (5) Party-in-interest transactions

Certain Plan investments are managed by John Hancock; therefore, transactions with John Hancock qualify as party-in-interest transactions. Fees paid by the Plan to John Hancock, the custodian of the Plan, were approximately \$14,000 during the year ended December 31, 2022. There was also approximately \$4,000 paid for administrative services and approximately \$8,000 paid for investment advisory services to other parties during the year ended December 31, 2022.

### (6) Tax status

The Internal Revenue Service has determined that the prototype 401(k) profit sharing plan is designed in accordance with applicable sections of the Internal Revenue Code ("IRC") and informed the custodian of such in a letter dated June 30, 2020. The Plan administrator has adopted the prototype plan and although the Plan has been amended since receiving the letter, the Plan administrator and Sponsor believe that the Plan is currently being operated in compliance with the applicable requirements of the IRC.
