Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed audits of the financial statements of On Target Staffing, LLC 401(k) Profit Sharing Plan, an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). Notes to Financial Statements

NOTE 1: DESCRIPTION OF PLAN

The following description of On Target Staffing, LLC 401(k) Profit Sharing Plan (the “Plan”) provides only general information. Participants should refer to the Plan agreement for a more complete description of the Plan’s provisions.

General

The Plan was established on January 1, 2017, and is a defined contribution plan covering all eligible employees of On Target Staffing, LLC (the “Company”), as defined in the Plan document. Eligible employees are those who have completed three months of service and have attained the age of twenty-one. The Plan does not allow union employees, leased employees, non-resident aliens, or temporary employees. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (“ERISA”). The Plan is administered by the who has the sole responsibility for the administration of the Plan, as defined in the Plan’s provisions. The Plan is managed through AuguStar Life Insurance Company (“AuguStar”).

The Plan was restated effective January 1, 2022, to make highly compensated employees eligible and to establish a safe harbor matching contribution.

Contributions

Each year, participants may contribute up to the maximum Internal Revenue Service (“IRS”) limitations during the Plan year, as no limits on elective deferrals are set in the Plan. For the calendar year 2023, the applicable dollar amount was \$22,500. Participants who have attained age 50 before the end of the Plan year are eligible to make catch-up contributions. The maximum catch-up contribution was \$7,500 for 2023. Participants may also contribute amounts representing distributions from other qualified defined benefit or defined contribution plans (rollover). Participants direct the investment of their contributions into various investment options offered by the Plan. Contributions are made to the Plan by the Company.

The Company, at its sole discretion, may make employer matching contributions based on a uniform percentage of employee contributions. In addition, the Company may make a non-elective contribution to participants who were employed on the last day of the Plan year. For the year ended December 31, 2023, there were no discretionary employer matching contributions or discretionary non-elective contributions.

Effective January 1, 2022 the Company also makes a safe harbor matching contribution of 100% of the employee’s elective deferral up to 3% of the contributing participant’s salary plus 50% of the employee’s elective deferrals over 3%, up to a maximum of 5% of each participating employee’s salary. For the year ended December 31, 2023, safe harbor matching contributions totaled \$99,156.

Participant Accounts

Each participant’s account is credited with the participant’s contributions and Company’s matching contributions, as well as allocations of the Company’s discretionary contributions and Plan earnings. Participant accounts are charged with an allocation of administrative expenses that are paid by the Plan. Allocations are based on participant earnings, account balances, or specific participant transactions, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant’s vested account.

Vesting

Participants are immediately vested in their own contributions plus actual earnings, and the participant is 100% vested in the Company's safe harbor matching contribution immediately.

Participants are immediately 100% vested upon death or total and permanent disability.

Forfeitures

Forfeitures are used to pay for administrative expenses or reduce employer discretionary contributions. The balance in the forfeiture account at December 31, 2023 and 2022, totaled \$-0- and \$2,977, respectively. During the year ended December 31, 2023, forfeitures totaling \$1,625 were used to pay for administrative expenses and \$8,720 was used to reduce employer discretionary contributions.

Notes Receivable from Participants

Participants may borrow from their fund accounts a minimum of \$1,000 up to a maximum amount of the lesser of: a) 50% of the participant's vested account, reduced by any outstanding loan balance, or b) \$50,000, reduced by the highest outstanding loan balance during the one-year period ending on the day before the loan is made. No more than one loan can be outstanding at a time. The loans are secured by the balance in the participant's account and bear interest at rates equal to prime plus 1%. Note terms generally range one to five years. Principal and interest are repaid through monthly payroll deductions.

Payment of Benefits

Upon termination of service due to death, disability, retirement, or other reasons, the plan only permits participants to receive a lump sum amount equal to the value of the participant's vested interest in his or her account. Upon termination of employment, the Plan has a mandatory cash-out provision for participants with less than \$5,000 in their account, which does not require consent from the participant. Hardship withdrawals from accounts which are fully vested are permitted by the Plan. In-service distributions are allowed for participants after reaching age 65.

NOTE 2: SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES

Basis of Accounting

The financial statements of the Plan are prepared using the accrual method of accounting in accordance with accounting principles generally accepted in the United States of America.

Use of Estimates

The preparation of financial statements in accordance with U.S. GAAP requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities and changes therein, and disclosure of contingent assets and liabilities. Actual results could differ from those estimates.

Investment Valuation and Income Recognition

Investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. The Plan's management determines the Plan's valuation policies utilizing information provided by AuguStar. See Note 4 for a discussion of fair value measurement.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation in fair value of investments includes the Plan's gains and losses on investments bought and sold, as well as held during the year.

Notes Receivable from Participants

Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Interest income is recorded on the accrual basis. Related fees are recorded as administrative expenses and are expensed when incurred. No allowance for credit losses has been recorded as of December 31, 2023 and 2022.

Payment of Benefits

Benefits are recorded when paid.

Administrative Expenses

Certain expenses of maintaining the Plan are paid by the Plan, unless otherwise paid by the Company. Expenses that are paid by the Company are excluded from these financial statements. Fees related to the administration of notes receivable from participants are charged directly to the participant's account and are included in administrative expenses. Investment related expenses are included in net appreciation in fair value of investments.

Subsequent Events

The Plan has evaluated subsequent events through October 3, 2024, the date the financial statements were available to be issued.

NOTE 3: INFORMATION CERTIFIED BY AUGUSTAR

Certain information related to investments disclosed in the accompanying financial statements and supplemental schedule, including investments held at December 31, 2023 and 2022, and net appreciation in fair value of investments, interest and dividends for the year ended December 31, 2023, was obtained or derived from information supplied to the Plan administrator and certified as complete and accurate by AuguStar.

Accordingly, as permitted by 29 CFR 2520.103-8 of the Department of Labor's ("DOL") Rules and Regulations for Reporting and Disclosure under ERISA, the Plan Administrator instructed the Plan's independent auditors not to perform any auditing procedures with respect to the above information which appears throughout the financial statements and supplemental schedule.

NOTE 4: FAIR VALUE MEASUREMENTS

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (level 1) and the lowest priority to unobservable inputs (level 3). The three levels of the fair value hierarchy under Financial Accounting Standards Board (FASB) Accounting Standards Codification 820 are described as follows:

Level 1	Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.
Level 2	Inputs to the valuation methodology include <ul style="list-style-type: none">• quoted prices for similar assets or liabilities in active markets;• quoted prices for identical or similar assets or liabilities in inactive markets;• inputs other than quoted prices that are observable for the asset or liability;• inputs that are derived principally from or corroborated by observable market data by correlation or other means. If the asset or liability has a specified (contractual) term, the level 2 input must be observable for substantially the full term of the asset or liability.
Level 3	Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques maximize the use of relevant observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodologies used for investments measured at fair value. There have been no changes in the methodologies used at December 31, 2023 and 2022.

Registered Investment Companies: Investments in registered investment companies consist of shares of mutual funds that are valued at quoted market prices which represent the net asset value ("NAV") of shares held by the Plan at year-end.

Money Market Funds: Valued at the quoted NAV of shares held by the Plan at year end.

NOTE 5: TAX STATUS

The Plan Sponsor obtained an IRS determination letter from the Internal Revenue Service on June 30, 2020, in which the IRS stated that the Plan Document was in compliance with applicable requirements of the Internal Revenue Code (“IRC”). The Plan has since been amended; however, the Plan Administrator believes the Plan is designed and operated in compliance with the Plan Document and applicable requirements of the IRC.

Accounting principles generally accepted in the United States of America require management to evaluate tax positions taken by the Plan and recognize a tax liability if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS. The Plan administrator has analyzed the tax positions taken by the Plan and has concluded that as of December 31, 2023 and 2022, there are no uncertain positions taken, or expected to be taken, that would require recognition of a liability or disclosure in the financial statements. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

NOTE 6: PLAN TERMINATION

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and terminate the Plan subject to the provisions of ERISA. The Company also reserves the right to amend, modify, suspend or terminate the Plan permanently or temporarily, at such time as they deem appropriate. In the event of Plan termination or if the Company elects to discontinue contributions, the total value of each participant’s account will be fully vested.
