Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed audits of the financial statements of the National Surgical Hospitals 401(k) Plan (the "Plan"), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA 103(a)(3)(C) audit). The financial statements comprise the statements of net assets available for benefits as of December 31, 2023 and 2022, and the related statements of changes in net assets available for benefits for the years then ended, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of the Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's (DOL) Rules and Regulations for Reporting and Disclosure under ERISA. As permitted by ERISA Section 103(a)(3)(C), our audits need not extend to any statements or information related to assets held for investment of the Plan (investment information) by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the DOL's Rules and Regulations for Reporting and Disclosure under ERISA (qualified institution).

Management has obtained certifications from a qualified institution as of and for the years ended December 31, 2023 and 2022, stating that the certified investment information, as described in Note 3 to the financial statements, is complete and accurate.

Opinion

In our opinion, based on our audits and on the procedures performed as described in the *Auditors' Responsibilities for the Audit of the Financial Statements* section of our report,

- the amounts and disclosures in the accompanying financial statements, other than those agreed to or derived from the certified investment information, are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America ("GAAP").
- the information in the accompanying financial statements related to assets held by and certified to by a qualified institution agrees to, or is derived from, in all material respects, the information prepared and certified by an institution that management has determined meets the requirements of ERISA Section 103(a)(3)(C).

Basis for Opinion

Notes to the Financial Statements

December 31, 2023 and 2022

(1) Description of plan

The following description of the National Surgical Hospitals 401(k) Plan (the "Plan") provides only general information. Participants should refer to the plan agreement for a more complete description of the Plan's provisions.

(a) General

The Plan was a multiple-employer plan which was established to provide retirement benefits for employees of Surgery Partners, Inc. (the "Plan Sponsor") and certain affiliated entities as defined in the plan document. The Plan covered substantially all employees who had completed sixty days of service ("participants"). The Plan was subject to the provisions of the Employee Retirement Income Security Act of 1974 ("ERISA").

Employees eligible to participate in the Plan were those employees of Arizona Spine & Joint Hospital, LLC, Aspen Surgery Center, Brazos Valley, Brentwood Surgery Center, Canyon Ambulatory Surgery, LLC, Coastal Bend Surgery Center Community Hospital Holding Company, LLC, Fairfield Surgery Center, Lafayette Surgical Specialty Hospital, North Carolina Specialty Hospital, LLC, Northwest Specialty Hospital, Optim, Screven County Hospital, LLC, Sequoia Surgical Center, LP, Skyway Surgery Center, South Texas Spine & Surgical Hospital, South Texas Surgical Hospital, The Physicians Centre, and West Bloomfield Surgery Center, LLC - Lake Surgery Center, (collectively, the "Employers"). Participants should refer to the Plan document of each Employer to determine the eligibility requirements of the Plan as adopted by the respective Employer.

Effective December 31, 2023, the Plan merged into the Surgery Partners 401(k) Plan and transferred assets totaling \$134,671,673. In December 2023, \$105,739,272 transferred into the Surgery Partners 401(k) Plan. In January 2024, \$25,263,973 transferred into the Surgery Partners 401(k) Plan. In April and May 2024, the remaining \$195,349 and \$3,473,079 related to National Surgical Hospitals 401(k) Plan employee and employer receivable were remitted to the Surgery Partners 401(k) Plan, respectively.

(b) Contributions

Eligible participants could voluntarily make qualified retirement contributions to the Plan which are deductible by the participants for federal income tax purposes under Section 401(k) of the Internal Revenue Code ("IRC") or may be made after-tax in the form of a Roth 401(k) contribution. Participants could also contribute amounts representing distributions from other qualified defined benefit or defined contribution plans. Participant contributions were permitted up to 90% of compensation, subject to certain IRC limits. Newly eligible and rehired employees were automatically enrolled in the Plan at a deferral rate of 6% of their compensation unless the employee elected not to participate.

The Plan Sponsor could decide to make a discretionary matching elective contribution to the Plan each year equal to an amount determined by the Plan Sponsor. To receive the discretionary match, participants must complete sixty days of service and have made an employee contribution to the Plan. During 2023 and 2022, the Plan Sponsor made discretionary matching contributions of 25% of the first 5% of each participants contributions, with the exception of the following company subsidiaries or affiliates:

- The Physicians Centre, Brazos Valley, South Texas Surgical Hospital, Fairfield Surgery Center, and Coastal Bend Surgery Center - 50% of participant contributions, not to exceed 3% of compensation.
- Northwest Specialty Hospital and North Carolina Specialty Hospital - 50% of participant contributions, not to exceed 4% of compensation.
- Sequoia Surgical Pavilion - 50% of participant contributions, not to exceed 5% compensation.
- Optim, Community Hospital Holding Company, LLC, Screven County Hospital, LLC, Lafayette Surgical Hospital - 100% of participant contributions, not to exceed 3% of compensation.
- Arizona Spine & Joint Hospital and Canyon Ambulatory Surgery, LLC - 100% of participant contributions, not to exceed 4% of compensation.
- Aspen Surgery Center, National Surgical Hospital, Corporate office, Skyway Surgery Center, South Texas Spine & Surgical Center - 25% of participant contributions, not to exceed 5% of compensation.
- Lakes Surgery Center - 25% of participant contributions, not to exceed 1.25% of compensation.

The discretionary matching contributions totaled \$3,369,061 for the year ended December 31, 2022. No discretionary matching contributions were made during 2023.

The Plan Sponsor may make a discretionary profit-sharing contribution, as determined annually by the Plan Sponsor's management. To receive a discretionary profit-sharing contribution, participants must complete sixty days of service and have made an employee contribution to the Plan. No discretionary profit-sharing contributions were made in 2023 or 2022.

Plan Sponsor contributions may not exceed the maximum amount deductible for federal income tax purposes.

(c) Participant accounts

Each participant's account was credited (charged) with the participant's contributions, Plan Sponsor contributions, allocations of investment earnings (losses) and administrative expenses. Allocations were based on participant compensation or account balances as defined in the plan agreement. The benefit to which a participant was entitled was the benefit that can be provided from the participant's vested account balance.

(d) Vesting

Participants were immediately vested in their elective salary deferral contributions plus actual earnings (losses) thereon. Vesting in Plan Sponsor discretionary contributions were generally based on years of continuous service. Participants' Plan Sponsor discretionary contributions vested 20% after one year of service and 20% each year thereafter until they become 100% vested after five years of service.

(e) Notes receivable from participants

Each participant could borrow from their fund accounts a minimum of \$1,000 up to a maximum amount equal to the lesser of \$50,000 or 50% of his or her nonforfeitable account balance. The maximum length of a loan is five years unless the loan was related to a mortgage on a principal residence. The notes were secured by the balances in the participants' respective accounts and bore interest at fixed rates ranging from 4.25% to 9.50%, which were commensurate with local prevailing rates as determined quarterly by the Plan Administrator. Principal and interest were collected ratably through payroll deductions.

(f) Payment of benefits

On termination of service due to death, permanent disability, or retirement, a participant with an account balance that exceeded \$5,000 could elect to receive a lump-sum payment equal to his or her entire account. For termination of service due to other reasons, a participant with an account balance that exceeded \$5,000 would be entitled to receive only the vested interest in his or her account as a lump-sum distribution. If the vested value of a participant's account was less than \$5,000, the vested value of the participant's account could be rolled into an individual retirement account on behalf of the participant.

(g) Forfeited accounts

Forfeitures are created when participants terminate employment prior to becoming fully vested in the Plan Sponsor's discretionary contributions portion of their accounts. Such forfeitures are utilized to reduce Plan expenses or reduce the Plan Sponsor's future contributions to the Plan. As of December 31, 2022, forfeited nonvested accounts totaled approximately \$312,000. There were no forfeited nonvested accounts as of December 31, 2023. Forfeitures of approximately \$213,000 and \$198,000 were used to reduce Plan Sponsor contributions in 2023 and 2022, respectively.

(h) Hardship withdrawals

The Plan permitted distributions in the event of a hardship, as defined in the Plan agreement. These distributions were taxable and subject to a tax penalty equal to 10% of the hardship distribution amount if a participant is younger than age 59½. Hardship withdrawals were limited to the participant's elective account.

(i) Administrative expenses

Certain expenses of maintaining the Plan were paid directly by the Plan Sponsor and were excluded from these financial statements. Fees related to the processing of distributions and notes receivable from participants were included in administrative expenses and charged directly to the applicable participants' accounts. Investment related expenses were included in net appreciation (depreciation) in fair value of investments.

(2) Summary of significant accounting policies

(a) Basis of accounting

The accompanying financial statements have been prepared on the accrual basis of accounting.

(b) Investment valuation and income recognition

The Plan's investments are stated at fair value as reported by Reliance Trust Company ("Reliance"). Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See Note 4 for discussion of fair value measurements.

Purchases and sales of securities were recorded on a trade-date basis. Interest income was recorded on the accrual basis. Dividend income was recorded on the ex-dividend date. Net appreciation (depreciation) included the Plan's gains and losses on investments bought and sold as well as held during the year.

(c) Notes receivable from participants

Notes receivable from participants were measured at their unpaid principal balances plus any accrued but unpaid interest. Delinquent participant notes were reclassified as distributions based upon the terms of the plan agreement.

(d) Payment of benefits

Benefits were recorded when paid.

(e) Use of estimates

The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America ("GAAP") requires management to make estimates and assumptions that affect the reported amounts of net assets available for benefits and changes therein, and disclosure of contingent assets and liabilities. Actual results could differ from those estimates.

(f) Events occurring after reporting date

The Plan Sponsor has evaluated events and transactions that occurred between December 31, 2023 and October 9, 2024, which is the date that the financial statements were available to be issued, for possible recognition or disclosure in the financial statements.

(3) Certified information

Certain information related to investments and notes receivable from participants reported and disclosed in the accompanying financial statements, including the fair value of investments and notes receivable from participants held at December 31, 2023 and 2022, and net appreciation (depreciation) in fair value of investments, interest and dividend income, and interest income on notes receivable from participants for the years ended December 31, 2023 and 2022, was obtained or derived from information supplied to the Plan administrator and certified as complete and accurate by Reliance.

(4) Fair value measurements

The Financial Accounting Standards Board ("FASB") Accounting Standards Codification ("ASC") 820, *Fair Value Measurements*, provides the framework for measuring fair value. That framework provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1 measurements) and the lowest priority to unobservable inputs (Level 3 measurements). The three levels of the fair value hierarchy under FASB ASC 820 are described below:

Level 1 - Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2 - Inputs to the valuation methodology include:

- Quoted prices for similar assets or liabilities in active markets;
- Quoted prices for identical or similar assets or liabilities in inactive markets;
- Inputs other than quoted prices that are observable for the asset or liability;
- Inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

Level 3 - Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset's or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

The following is a description of the valuation methodology used for assets measured at fair value. There has been no change in the methodology used at December 31, 2023 and 2022.

- (i) *Mutual funds and money market fund*: Valued at the net asset value ("NAV") of shares held by the Plan at year-end in an active market.

The method described above may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, while the Plan's management believes its valuation method is appropriate and consistent with other market participants, the use of a different methodology or assumption to determine fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

(5) Income tax status

The Plan obtained a favorable determination letter on March 29, 2018 in which the Internal Revenue Service ("IRS") stated that the Plan was in compliance with the applicable requirements of the IRC. The Plan is required to operate in conformity with the IRC to maintain its qualification. The Plan has been amended since receiving the determination letter. However, the plan administrator believes that the Plan is designed and is currently being operated in compliance with the applicable provisions of the IRC.

(6) Untimely remittance of participant contributions

The Plan Sponsor is required by Department of Labor regulation to remit participant contributions and participant loan repayments as soon as practicable, but by no later than the fifteenth business day following the end of the month in which the amounts were withheld from wages. For certain contributions withheld in 2023 and 2022, the funds were not remitted timely. As of December 31, 2023, only a portion of the late contributions have been corrected.

(7) Party-in-interest transactions

As described in Note 1, the Plan paid expenses to various service providers and held notes receivable from participants which also qualify as party-in-interest transactions.
