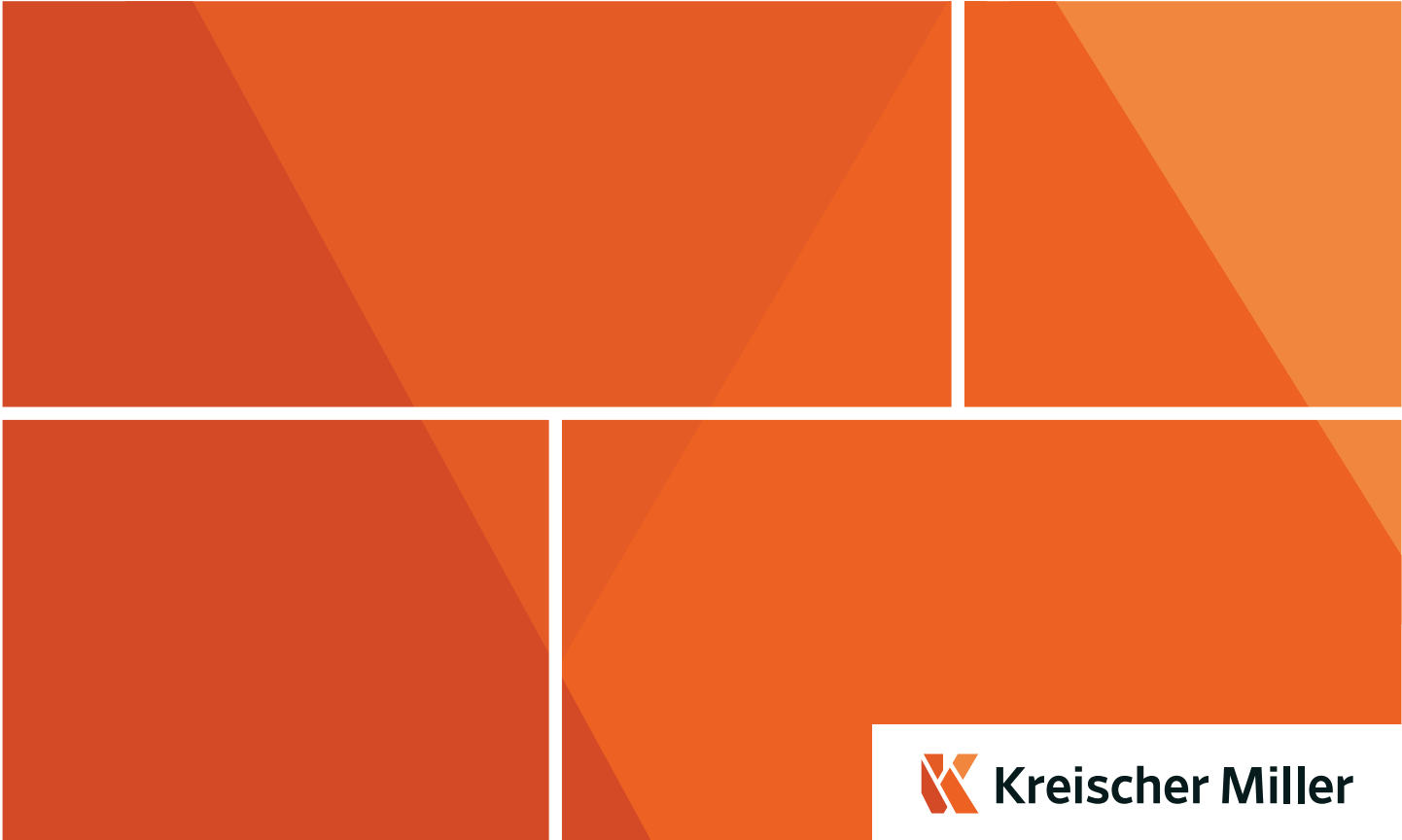

Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed audits of the financial statements of the Pension Plan of the Pennsylvania Medical Society (the Plan), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). The financial statements comprise the statements of net assets in liquidation available for benefits as of December 31, 2023 and 2022, and the related statements of changes in net assets in liquidation available for benefits for the years then ended, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of the Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. As permitted by ERISA Section 103(a)(3)(C), our audits need not extend to any statements or information related to assets held for investment of the plan (investment information) by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA (qualified institution).

Management has obtained certifications from a qualified institution as of December 31, 2023 and 2022, and for the years then ended, stating that the certified investment information, as described in Note 5 to the financial statements, is complete and accurate.

Opinion

In our opinion, based on our audits and on the procedures performed as described in the Auditors' Responsibilities for the Audit of the Financial Statements section

- the amounts and disclosures in the accompanying financial statements, other than those agreed to or derived from the certified investment information, are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America.

- the information in the accompanying financial statements related to assets held by and certified to by a qualified institution agrees to, or is derived from, in all material respects, the information prepared and certified by an institution that management determined meets the requirements of ERISA Section 103(a)(3)(C).

Basis for Opinion

We conducted our audits in accordance with auditing standards generally accepted in the United States of America (GAAS). Our responsibilities under those standards are further described in the Auditors' Responsibilities for the Audit of the Financial Statements section of our report. We are required to be independent of the Plan and to meet our other ethical responsibilities, in accordance with the relevant ethical requirements relating to our audits. We believe that the audit evidence we have obtained is sufficient and appropriate to provide a basis for our ERISA Section 103(a)(3)(C) audit opinion.

Responsibilities of Management for the Financial Statements

Management is responsible for the preparation and fair presentation of the financial statements in accordance with accounting principles generally accepted in the United States of America, and for the design, implementation, and maintenance of internal control relevant to the preparation and fair presentation of financial statements that are free from material misstatement, whether due to fraud or error. Management's election of the ERISA Section 103(a)(3)(C) audit does not affect management's responsibility for the financial statements.

In preparing the financial statements, management is required to evaluate whether there are conditions or events, considered in the aggregate, that raise substantial doubt about the Plan's ability to continue as a going concern for one year after the date that the financial statements are issued.

Management is also responsible for maintaining a current plan instrument, including all plan amendments, administering the plan, and determining that the plan's transactions that are presented and disclosed in the financial statements are in conformity with the plan's provisions, including maintaining sufficient records with respect to each of the participants, to determine the benefits due or which may become due to such participants.

Auditors' Responsibilities for the Audit of the Financial Statements

Except as described in the Scope and Nature of the ERISA Section 103(a)(3)(C) Audit section of our report, our objectives are to obtain reasonable assurance about whether the financial statements as a whole are free from material misstatement, whether due to fraud or error, and to issue an auditors' report that includes our opinion. Our audits did not extend to the certified investment information, except for obtaining and reading the certifications, comparing the certified investment information with the related information presented and disclosed in the financial statements, and reading the disclosures relating to the certified investment information to assess whether they are in accordance with the presentation and disclosure requirements of accounting principles generally accepted in the United States of America.

Accordingly, the objective of an ERISA Section 103(a)(3)(C) audit is not to express an opinion about whether the financial statements as a whole are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America.

We are required to communicate with those charged with governance regarding, among other matters, the planned scope and timing of the audit, significant audit findings, and certain internal control-related matters that we identified during the audit.

Such information is the responsibility of management and was derived from and relates directly to the underlying accounting and other records used to prepare the financial statements.

The information included in the supplemental schedules, other than that agreed to or derived from the certified investment information, has been subjected to auditing procedures applied in the audits of the financial statements and certain additional procedures, including comparing and reconciling such information directly to the underlying accounting and other records used to prepare the financial statements or to the financial statements themselves, and other additional procedures in accordance with GAAS. For information included in the supplemental schedules that agreed to or is derived from the certified investment information, we compared such information to the related certified investment information.

(1) Description of Plan

The following brief description of the Pension Plan of the Pennsylvania Medical Society (the Plan) is provided for general information purposes only. Participants should refer to the plan document for more complete information.

General

The Plan was a defined benefit pension plan covering certain employees who have completed 1,000 hours of service in a 12-month period. Employees include those of the Pennsylvania Medical Society (the Society), PennMed Member Services Company (PMSCO) and the Foundation of the Pennsylvania Medical Society (the Foundation) (together, the Employers). The Plan was subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA), as amended. The Plan was administered by the Society's Finance Committee, which is a committee of the Board of Trustees of the Society, the plan sponsor. The Finance Committee had overall responsibility for the operation and administration of the Plan. The Finance Committee determined the appropriateness of the Plan's investment offerings, monitored investment performance and reported to the Society's Board of Trustees.

Plan Termination and Transfers

On October 12, 2022, the Society's Board of Directors approved the termination of the Plan effective December 31, 2022 (Plan Termination). In connection with the Plan Termination, participants had the option to receive their benefit in the form of an annuity or lump sum distribution. Participants with vested accrued benefits of \$5,000 or less were required to receive their benefit as a lump sum distribution. In July 2023, the Plan purchased an annuity contract from United of Omaha Life Insurance Company for \$23,539,494 to provide for future benefits of participants electing the annuity option. Plan assets amounting to \$2,526,182 were transferred to the Pennsylvania Medical Society 401(k) Retirement Savings Plan.

Eligibility

Employees of PMSCO had to be employed prior to January 1, 2007 and employees of the Society and the Foundation had to be employed prior to January 1, 2008 in order to have been eligible to participate in the Plan. The Plan was amended on October 7, 2014 to freeze benefit accruals for all participants effective December 31, 2014. As a result of the amendment, a participant's accrued benefit at equaled the amount of his or her accrued benefit under the Plan as of December 31, 2014.

(1) Description of Plan, Continued

Funding Policy

The Plan was funded each plan year by contributions from the Employers determined pursuant to funding methods and actuarial assumptions sufficient to satisfy the Plan's minimum funding requirements under ERISA. During 2023 and 2022, a portion of the Plan's prefunding balance was used to satisfy the minimum required contributions and no contributions were made to the Plan. Contributions to the Plan by employees were not permitted.

Pension Benefits

The normal retirement date for participants was the first day of the month coincident with or next following the attainment of age 65. Participants may retire on the normal retirement date or may continue employment and retire on the first day of any month thereafter. Early retirement provisions were also available to participants who had attained the age of 55 and had 10 years of service. Participants who had reached age 62 and had completed 30 years of service were eligible for unreduced benefits.

The normal retirement benefit at December 31, 2022 was an annual lifetime pension, payable on a monthly basis, equal to 1.6 percent of a participant's final average compensation, as defined, plus 0.5 percent of final average compensation in excess of covered compensation, as defined, for each year of employment up to 30 years.

Disability and Death Benefits

A participant who commenced receipt of disability benefits under a long-term disability plan maintained by the Employers remained a participant of the Plan. If the participant continued to receive such disability benefits until he attained age 65, the participant was entitled to his normal retirement benefit, as defined. If a participant recovered prior to attaining the age of 65, determination of the monthly annuity at normal retirement was dependent upon whether the participant resumed employment with the Employers.

A death benefit for a participant was paid in accordance with the plan document as summarized below:

- Automatic post-retirement benefits in the form of a qualified joint and percentage-based survivor annuity provided the participant or former participant satisfied the Plan requirements, as defined. Other optional forms of benefit payment were available. If married, the participant's spouse must consent to any option other than the joint and survivor option.

Disability and Death Benefits, Continued

- Pre-retirement spousal death benefit if a vested participant died before his benefits commenced to be paid to him provided the participant or former participant satisfied the Plan requirements, as defined. Generally, the pre-retirement death benefit was equal to 50 percent of the actuarially reduced normal retirement benefits to which the participant or former participant otherwise would have been entitled had he retired under the terms of the Plan on the day before the date of death, or earliest retirement date if later, and begun to receive benefits in the form of the automatic joint and survivor annuity as defined.

Vesting

In connection with the Plan Termination, all participants became fully vested in their accrued benefit effective December 31, 2022.

(2) Summary of Significant Accounting Policies

Basis of Accounting

The accompanying financial statements were prepared on the liquidation basis of accounting.

Investment Valuation and Income Recognition

Investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. The Finance Committee determined the Plan's valuation policies utilizing information provided by its investment advisers and trustee. See Note 6 for a discussion of fair value measurements.

Purchases and sales of securities were recorded on a trade-date basis. Interest income was recorded on the accrual basis. Dividends were recorded on the ex-dividend date. Net appreciation (depreciation) included the Plan's gains and losses on investments bought and sold as well as held during the year.

Pension Benefits

Benefit payments to participants were recorded upon distribution.

Subsequent Events

The Plan has evaluated subsequent events through August 13, 2024, the date the financial statements were available to be issued.

(3) Actuarial Present Value of Accumulated Plan Benefits

Accumulated plan benefits are those future periodic payments, including lump-sum distributions that were attributable under the Plan's provisions to the service employees had rendered. Accumulated plan benefits included benefits expected to be paid to (a) retired or terminated employees or their beneficiaries, (b) beneficiaries of employees who had died, and (c) present employees or their beneficiaries. Benefits under the Plan were accumulated based on employees' compensation during each year of credited service. The accumulated plan benefits for active employees equaled the accumulation, with interest, of the annual benefit accruals as of the benefit information date.

Benefits payable under all circumstances – retirement, death, disability, and termination of employment – were included, to the extent they were deemed attributable to employee service rendered to the valuation date.

The actuarial present value of accumulated plan benefits was determined by an independent actuary and was that amount that results from applying actuarial assumptions to adjust the accumulated plan benefits to reflect the time value of money (through discounts for interest) and the probability of payment (by means of decrements such as for death, disability, withdrawal or retirement) between the valuation date and the expected date of payment. Accumulated plan benefits were valued as of the beginning of the year.

The significant actuarial assumptions used in the January 1, 2022 valuation were as follows:

(5) Financial Information Certified by a Qualified Institution

Certain information related to investments disclosed in the accompanying financial statements, including investments at fair value, except for hedge funds and separately managed accounts which were held with Morgan Stanley (MS Uncertified Plan Investments) at December 31, 2023 and 2022, and net appreciation (depreciation) in fair value of investments, except as it relates to the hedge funds and the MS Uncertified Plan Investments, interest and dividend income, excluding hedge funds and MS Uncertified Plan Investments, for the years ended December 31, 2023 and 2022, were obtained by management and agreed to or derived from information certified as complete and accurate by Manufacturers and Traders Trust Company, a qualified institution.

(6) Fair Value Measurements

Financial Accounting Standards Board (FASB) *Accounting Standards Codification* (ASC) 820, *Fair Value Measurements and Disclosures*, provides the framework for measuring fair value. That framework provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (level 1 measurements) and the lowest priority to unobservable inputs (level 3 measurements).

The three levels of the fair value hierarchy under FASB ASC 820 are described as follows:

Level 1: Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2: Inputs to the valuation methodology include

- quoted prices for similar assets or liabilities in active markets;
- quoted prices for identical or similar assets or liabilities in inactive markets;
- inputs other than quoted prices that are observable for the assets or liability;
- inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the level 2 input must be observable for substantially the full term of the asset or liability.

Level 3: Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at December 31, 2023 and 2022.

Money market fund: Valued at the net asset value (NAV) of shares held by the Plan at year end.

U.S. government securities: Valued using pricing models maximizing the use of observable inputs for similar securities.

Corporate, municipal, and foreign bonds: Valued using pricing models maximizing the use of observable inputs for similar securities. This includes basing value on yields currently available on comparable securities of issuers with similar credit ratings.

Hedge funds: Valued at NAV of units held. The NAV is used as a practical expedient to estimate fair value. The NAV is based on the fair value of the underlying investments held by the fund less its liability. This practical expedient is not used when it is determined to be probable that the fund will sell the investment for an amount different than the reported NAV.

Following are the investment objectives of the hedge funds:

- The fund is a feeder fund in a master-feeder structure. The master fund is global and highly diversified, with a focus on investment strategies that seek to deliver absolute returns by exploiting market inefficiencies.
- The fund seeks capital appreciation by investing in financial instruments that are perceived to be inefficiently priced because of business, financial, or legal uncertainties.
- The fund seeks capital appreciation through investment in other third-party managed funds utilizing alternative investment strategies.

(7) Related Party Transactions and Party-In-Interest Transactions

Certain plan investments were shares of a money market fund managed by Wilmington Trust. Wilmington Trust Corporation is a wholly-owned subsidiary of M&T Bank Corporation. Manufacturers and Traders (M&T) Trust Company was the trustee of the Plan and, therefore, these transactions qualified as party-in-interest transactions. Morgan Stanley held a portfolio of separately managed accounts of the Plan and provided investment advisory services to the Plan. Transactions with Morgan Stanley qualified as party-in-interest transactions.

The Plan's expenses were paid either by the Plan or the Society, as provided by the plan document. Expenses that were paid directly by the Society are excluded from these financial statements. Certain expenses incurred in connection with the general administration of the Plan that were paid by the Plan were recorded as deductions in the accompanying statements of changes in net assets in liquidation available for benefits. In addition, certain investment related expenses are included in net appreciation (depreciation) in fair value of investments presented in the accompanying statements of changes in net assets in liquidation available for benefits.

(8) Tax Status

Effective January 1, 2020, the Plan adopted a prototype plan document sponsored by Conrad M. Siegel, Inc (Conrad Siegel). The Internal Revenue Service (IRS) has determined and informed Conrad Siegel by a letter dated March 30, 2018, that the prototype plan was then designed in accordance with the applicable sections of the Internal Revenue Code (IRC). The Plan has been amended since receiving the opinion letter. However, the plan administrator believes that the Plan is designed and is currently being operated in compliance with the applicable requirements of the IRC, and, therefore, believes that the Plan is qualified and the related trust is tax exempt.

Accounting principles generally accepted in the United States of America require plan management to evaluate tax positions taken by the Plan and recognize a tax liability if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.
