## INDEPENDENT AUDITOR'S REPORT

To the Participants and Plan Administrator of the  
Duke Energy Active Health & Welfare Benefit (Financed) Plans

### *Scope and Nature of the ERISA Section 103(a)(3)(C) Audit*

We have performed audits of the financial statements of the Duke Energy Active Health & Welfare Benefit (Financed) Plans (the Plan), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). The financial statements comprise the statements of net assets available for benefits and of benefit obligations as of December 31, 2023 and 2022, the related statements of changes in net assets available for benefits and of changes in benefit obligations for the year ended December 31, 2023, and the related notes to the financial statements (collectively, the financial statements).

Plan management (Management), having determined it is permissible in the circumstances, has elected to have the audits of the financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's (DOL) Rules and Regulations for Reporting and Disclosure under ERISA. As permitted by ERISA Section 103(a)(3)(C), our audits need not extend to any statements or information related to assets held for investment of the Plan (investment information) by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the DOL's Rules and Regulations for Reporting and Disclosure under ERISA (qualified institution).

Management has obtained certifications from a qualified institution as of December 31, 2023 and 2022, and for the year ended December 31, 2023, stating that the certified investment information, as described in Note 3 to the financial statements, is complete and accurate.

### *Opinion on the Financial Statements*

In our opinion, based on our audits and on the procedures performed as described in the *Auditor's Responsibilities for the Audit of the Financial Statements* section:

- the amounts and disclosures in the accompanying financial statements, other than those agreed to or derived from the certified investment information, are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America (US GAAP).
- the information in the accompanying financial statements related to assets held by and certified to by a qualified institution agrees to, or is derived from, in all material respects, the information prepared and certified by an institution that Management determined meets the requirements of ERISA Section 103(a)(3)(C).



## ***Basis for Opinion***

We conducted our audits in accordance with auditing standards generally accepted in the United States of America (US GAAS). Our responsibilities under those standards are further described in the *Auditor's Responsibilities for the Audit of the Financial Statements* section of our report. We are required to be independent of the Plan and to meet our other ethical responsibilities, in accordance with the relevant ethical requirements relating to our audits. We believe that the audit evidence we have obtained is sufficient and appropriate to provide a basis for our ERISA Section 103(a)(3)(C) audit opinion.

## ***Responsibilities of Management for the Financial Statements***

Management is responsible for the preparation and fair presentation of the financial statements in accordance with US GAAP, and for the design, implementation, and maintenance of internal control relevant to the preparation and fair presentation of financial statements that are free from material misstatement, whether due to fraud or error. Management's election of the ERISA Section 103(a)(3)(C) audit does not affect Management's responsibility for the financial statements.

Reasonable assurance is a high level of assurance but is not absolute assurance and therefore is not a guarantee that an audit conducted in accordance with US GAAS will always detect a material misstatement when it exists. The risk of not detecting a material misstatement resulting from fraud is higher than for one resulting from error, as fraud may involve collusion, forgery, intentional omissions, misrepresentations, or the override of internal control. Accordingly, the objective of an ERISA Section 103(a)(3)(C) audit is not to express an opinion about whether the financial statements as a whole are presented fairly, in all material respects, in accordance with US GAAP.

We are required to communicate with those charged with governance regarding, among other matters, the planned scope and timing of the audits, significant audit findings, and certain internal control-related matters that we identified during the audits.

**Note 1: Description of the Plan**

The following description of the Duke Energy Active Health & Welfare Benefit (Financed) Plans (the “Plan”) is provided for general information purposes only and, except as otherwise noted herein, describes the provisions of the Plan as in effect immediately prior to the close of December 31, 2023. Effective as of the close of December 31, 2023 (the “Merger Effective Time”), the Plan, and the active health and welfare benefit programs maintained thereunder, were merged with and into the Duke Energy Active Health & Welfare Benefit Plans (the “Non-Financed Plan”). Participants should refer to individual Plan documents for more complete information. In the event of any inconsistencies, the Plan documents shall control.

***Participation and Purpose***

Prior to the Merger Effective Time, Duke Energy Corporation, a Delaware corporation (the “Company”) maintained the Plan to consolidate the Company’s funded active health and welfare benefit programs under one plan document. The Plan components included benefits for active medical, active dental, and active basic life insurance.

Prior to the Merger Effective Time, the Plan was funded in part by a voluntary employee beneficiary association (“VEBA”) trust. The Duke Energy Corporation Welfare Benefits Trust VEBA I (“VEBA I”) funded the medical, dental, and basic life insurance benefits under the Plan. Immediately prior to the Merger Effective Time, no amounts remained in the subaccounts under VEBA I used to fund medical, dental, and basic life insurance benefits under the Plan. As a result, the Plan ceased to be funded by VEBA I at the Merger Effective Time and, contemporaneously therewith, the Plan and the active health and welfare benefit programs maintained thereunder were merged with and into the Non-Financed Plan.

The investment of the assets held in VEBA I prior to the Merger Effective Time was administered by the Duke Energy Investment Committee and each of the component plans under the Plan was administered by the Duke Energy Benefits Committee. The Board of Directors of the Company, or its delegate, appointed the Chair of the Duke Energy Investment Committee, who, then in turn, appointed the other members of the Investment Committee. The Board of Directors of the Company, or its delegate, appointed the Chair of the Benefits Committee, who, then in turn, appointed the other members of the Benefits Committee. The Plan was subject to the provisions of the Employee Retirement Income Security Act of 1974, as amended (“ERISA”).

***Contributions***

Prior to the Merger Effective Time, eligible employees participating in the Plan were required to contribute specified amounts, determined periodically by the Company in consultation with the Plan’s actuary, for their own coverage and to extend coverage to their eligible dependents. The Company contributed specified amounts, determined by the Plan’s insurance provider, to purchase basic life insurance coverage. The Company also contributed specified amounts towards medical and dental coverage as determined by the Company in consultation with the Plan’s actuary.

***Plan Management***

The Bank of New York Mellon/BNY Mellon, N.A ("Mellon") maintains VEBA I under the terms of a trust agreement between Mellon and the Company.

***Benefits***

VEBA I is intended to meet the requirements of Section 501(c)(9) of the Internal Revenue Code (the "Code") and , prior to the Merger Effective Time, to fund the payments of benefits on behalf of the Plan. Prior to the Merger Effective Time, responsibility for payment of medical and dental benefits to participants and providers generally resided with the Plan. However, medical benefits for active employees residing in Hawaii are covered under a policy with UnitedHealthcare. Death benefits for active employees are covered under policies with certain insurance companies. These benefits are described in the applicable "Summary Plan Descriptions" and Plan documents, which may be obtained from the Duke Energy Benefits Committee.

***Eligibility***

Generally, but subject to certain exclusions, individuals listed as employees of participating companies in and paid through the Company's payroll system who are classified by the employing participating company as "regular" or "fixed term," and their eligible dependents, were eligible to participate in the Plan prior to the Merger Effective Time. Continuation of medical and dental coverage under the Plan was available in accordance with the terms and provisions of the Plan and the rules contained in the Consolidated Omnibus Budget Reconciliation Act of 1985.

***Plan Termination***

The Company reserves the right to amend or terminate the Plan at any time. As described above, the Plan and the active health and welfare benefit programs maintained thereunder were merged with and into the Non-Financed Plan at the Merger Effective Time. Immediately prior to the Merger Effective Time, no amounts remained in the subaccounts under VEBA I used to fund medical, dental, and basic life insurance benefits under the Plan.

**Note 2: Summary of Significant Accounting Policies**

***Basis of Accounting***

The accompanying financial statements are prepared on the accrual basis of accounting in conformity with accounting principles generally accepted in the United States of America ("US GAAP").

***Use of Estimates***

The preparation of financial statements in conformity with US GAAP requires Plan management to make estimates and assumptions that affect certain reported amounts of assets, liabilities, benefit obligations and changes therein, claims incurred but not reported, claims payable, and disclosure of contingent assets and liabilities. Actual results could differ from those estimates.

***Risks and Uncertainties***

The Plan utilizes various investment instruments. Investment securities, in general, are exposed to various risks, such as interest rate, credit, and overall market volatility. Due to the level of risk associated with certain investment securities, it is reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect the amounts reported in the financial statements.

The actuarial present value of benefit obligations is reported based on certain assumptions pertaining to interest rates, health care inflation rates and employee demographics, all of which are subject to change. Due to uncertainties inherent in the estimations and assumptions process, it is at least reasonably possible that changes in these estimates and assumptions in the near term could be material to the financial statements.

***Claims Payable and Claims Incurred but not Reported***

Plan obligations at December 31, 2023 for claims payable and claims incurred but not reported at that date are estimated by the Plan's actuary using actuarial methods that use historical trend information.

***Payment of Benefits***

Premiums paid by either the Company or the VEBA trust are recorded as premium payments in the accompanying statement of changes in net assets available for benefits. Claim payments are recorded when paid by the third-party claims processor. Amounts due to claims processors that have yet to be reimbursed by the Plan are recorded as payable to claims administrators in the accompanying statements of net assets available for benefits.

***Refunds Due From Third Party Administrators***

Refunds received from the Plan's pharmacy benefit manager ("PBM") are recorded in the period that the refunds were received by the PBM from pharmaceutical companies ("PCs") and are based on the amount of a particular drug the PBM purchased on the Plan's behalf from the PCs. These refunds are presented in the "Claims paid" line of the *Statement of Changes in Net Assets Available for Benefits*. The Plan recorded \$11.8M and \$12.6M of prescription drug refunds due from third party administrators in the 2023 and 2022 plan years, respectively.

***Investment Valuation and Income Recognition***

Plan investments are recorded at fair value. Fair values are determined based upon quotations obtained from national securities exchanges at the financial statement date, if available. Investments that are not listed on an exchange are valued based upon quotations obtained from brokerage firms and investment managers. Common/collective trust funds are valued at the net asset value ("NAV") of units of a bank collective trust. The NAV, as provided by the trustee, is used as a practical expedient to estimate fair value. The NAV is based on the fair value of the underlying investments held by the fund less its liabilities. This practical expedient is not used when it is determined to be probable that the fund will sell the investment for an amount different than the reported NAV. Money market funds are valued at the daily closing price as reported by the fund.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation includes the Plan's gains and losses on investments bought and sold as well as held during the year.

Management fees are operating expenses charged to the Plan for common/collective trust funds held by the Plan, and are deducted from income earned on a daily basis and are not separately reflected. Consequently, certain management fees and operating expenses are reflected as an investment return for such investments.

***Plan Management's Review of Subsequent Events***

In preparing the accompanying financial statements, Plan management has reviewed all known events that have occurred after December 31, 2023, and through October 9, 2024, the date the financial statements were available to be issued, for inclusion in the financial statements and footnotes.

**Note 3: Investments (Certified by Trustee) and Fair Value Measurements**

Information related to investments as of December 31, 2023 and 2022, and the related investment income for the year ended December 31, 2023, was certified by Mellon, the trustee, as permitted by 29 CFR 2520.103-8 of the Department of Labor rules under ERISA.

Financial Accounting Standard Board ("FASB") Accounting Standards Codification ("ASC") Topic No. 820, *Fair Value Measurement* ("FASB ASC 820") defines fair value, establishes a framework for measuring fair value in US GAAP and expands disclosure requirements about fair value measurements. Under FASB ASC 820, fair value is considered to be the exchange price in an orderly transaction between market participants to sell an asset or transfer a liability at the measurement date. The fair value definition under FASB ASC 820 focuses on an exit price, which is the price that would be received by the Plan to sell an asset or paid to transfer a liability versus an entry price, which would be the price paid to acquire an asset or received to assume a liability. Although FASB ASC 820 does not require additional fair value measurements, it applies to other accounting pronouncements that require or permit fair value measurements.

The Plan determines fair value of financial assets and liabilities based on the following fair value hierarchy, as prescribed by FASB ASC 820, which prioritizes the inputs to valuation techniques used to measure fair value into three levels:

*Level 1*

Unadjusted quoted prices in active markets for identical assets or liabilities that the Plan has the ability to access. An active market for the asset or liability is one in which transactions for the asset or liability occurs with sufficient frequency and volume to provide ongoing pricing information.

*Level 2*

Inputs other than quoted market prices included in Level 1 that are observable, either directly or indirectly, for the asset or liability. Level 2 inputs include, but are not limited to, quoted prices for similar assets or liabilities in an active market, quoted prices for identical or similar assets or liabilities in markets

that are not active and inputs other than quoted market prices that are observable for the asset or liability, such as interest rate curves and yield curves observable at commonly quoted intervals, volatilities, credit risk and default rates.

*Level 3*

Unobservable inputs for the asset or liability. Unobservable inputs reflect the Plan's own assumptions about the factors that other market participants would use in pricing an investment that would be based on the best information available in the circumstances.

A financial instrument's level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement.

See Note 2 for a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at December 31, 2023.

**Note 4: Income Tax Status**

In a letter dated August 2008, VEBA I was determined by the Internal Revenue Service ("IRS") to be tax-exempt under the provisions of Section 501(c)(9) of the Code. However, the VEBA was subject, under the Code, to unrelated business income tax. Historically, the trust has not had any liability, and thus, had the full amount of estimated and previously paid unrelated business income tax refunded. Therefore, the unrelated business income tax will not be paid unless there is a change in the year over year funding status. As of December 31, 2023, refunds in the amount of \$2,784,430, which included 2019 and 2020 tax payments and interest, were expected to be received by and allocated to the remaining open subaccounts under VEBA I.

US GAAP requires the Plan administrator to evaluate tax positions taken by the Plan and recognize a tax liability (or asset) if the Company has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS. The Plan administrator has analyzed the tax positions taken by the Plan, and has concluded that as of December 31, 2023, there are no uncertain positions taken or expected to be taken that would require recognition of a liability (or asset) or disclosure in the financial statements. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

**Note 5: Exempt Party-In-Interest Transactions**

Plan investments prior to the Merger Effective Time, were shares of common/collective trust funds, non-interest bearing cash, and a money market fund managed by Mellon. Mellon is the trustee, and, therefore, transactions with Mellon and the funds it manages qualify as exempt party-in-interest transactions as defined by the prohibited transaction rules of ERISA. Fees paid by the Plan to Mellon were \$12,919 for the year ended December 31, 2023.
