Our audits did not extend to the certified investment information, except for obtaining and reading the certifications, comparing the certified investment information with the related information presented and disclosed in the financial statements, and reading the disclosures relating to the certified investment information to assess whether they are in accordance with the presentation and disclosure requirements of GAAP.

Accordingly, the objective of an ERISA Section 103(a)(3)(C) audit is not to express an opinion about whether the financial statements as a whole are presented fairly, in all material respects, in accordance with GAAP.

We are required to communicate with those charged with governance regarding, among other matters, the planned scope and timing of the audit, significant audit findings, and certain internal control-related matters that we identified during the audit.

## **Other Matter - Supplemental Schedules Required by ERISA**

The supplementary information, as listed in the accompanying table of contents, is presented for purposes of additional analysis and is not a required part of the financial statements but is required by the DOL's Rules and Regulations for Reporting and Disclosure under ERISA. Such information is the responsibility of management and was derived from and relates directly to the underlying accounting and other records used to prepare the financial statements. The information included in the supplementary information, other than that agreed to or derived from the certified investment information, has been subjected to auditing procedures applied in the audit of the financial statements and certain additional procedures, including comparing and reconciling such information directly to the underlying accounting and other records used to prepare the financial statements or to the financial statements themselves, and other additional procedures in accordance with GAAS. For information included in the supplementary information that agreed to or is derived from the certified investment information, we compared such information to the related certified investment information.

In forming our opinion on the supplementary information, we evaluated whether the supplementary information, other than the information agreed to or derived from the certified investment information, including its form and content, are presented in conformity with the DOL's Rules and Regulations for Reporting and Disclosure under ERISA.

In our opinion:

- The form and content of the supplementary information, other than the information in the supplementary information that agreed to or is derived from the certified investment information, is presented, in all material respects, in conformity with the DOL's Rules and Regulations for Reporting and Disclosure under ERISA.
- The certified investment information in the supplementary information agrees to, or is derived from, in all material respects, the information prepared and certified by a qualified institution that management determined meets the requirements of ERISA Section 103(a)(3)(C).

**Note 1 - Description of the Plan**

The following description of the Alaska Airlines, Inc. Pilots Investment and Savings Plan (the Plan) is provided for general information purposes only. More complete information regarding the Plan's provisions may be found in the plan document.

**General** - The Plan is a defined contribution and deferred compensation plan established by Alaska Airlines, Inc. (the Company) under the provisions of Section 401(a) of the Internal Revenue Code (IRC), which includes a qualified cash or deferred arrangement as described in Section 401(k) of the IRC for the benefit of eligible pilots of the Company. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA), as amended.

**Plan Administration** - The Plan is administered by a committee consisting of certain employees of the Company. Fidelity Management Trust Company (Fidelity) serves as the trustee of the Plan.

**Eligibility** - Pilots are eligible to enroll on the first day of the month following 30 days of service. Effective October 2, 2023, the Plan was amended to remove the 30 days of service requirement and to allow Pilots to enter the Plan immediately.

**Contributions** - Participants may elect to defer up to 100% of eligible compensation as pre-tax, Roth after-tax, and/or traditional after-tax contributions. Participants who have attained age 50 before the close of the plan year are eligible to make catch-up contributions. Participants may also contribute amounts representing distributions from other eligible retirement plans. The Plan also permits Pilots to contribute an additional lump sum after-tax cash contribution one time per year outside of payroll deductions. The Plan includes a provision whereby all newly eligible pilots are automatically enrolled at a 3% pre-tax deferral rate unless they elect a different deferral rate or not to participate in the Plan.

Employer contributions are made to the Plan as specified in the pilots' collective bargaining agreement. Participants hired or transferred to the Company after December 31, 2009 were not eligible to participate in the Alaska Airlines, Inc. Fixed Income Retirement Plan for Pilots (the defined benefit plan). These participants receive an employer contribution of 16.0% of eligible earnings. Beginning January 1, 2024, the employer contribution amount increased to 17.0% of eligible earnings for this group.

An eligible participant whose employment commencement date was before January 1, 2010 was eligible to make a choice election with the following options:

- Option 1 Status Quo Formula: continue in their defined benefit plan at current levels and receive employer contribution of 3.5% of eligible earnings. Effective January 1, 2024, the employer contribution amount for Pilots who elected the status quo formula increased to 4.5% of eligible earnings.
- Option 2 Rebalance Formula: reduce future benefits earned under the defined benefit plan and increase employer contributions in the Plan to a level between 8.5% to 11.5% of eligible earnings based on years of credited service as of December 31, 2009. Effective January 1, 2024, the employer contribution amount for Pilots who elected the rebalance formula increased to a range of 9.5% to 12.5% of eligible earnings based on years of credited service as of December 31, 2009.

- Option 3 Voluntary Soft Freeze Formula: freeze their defined benefit as of January 1, 2010 and receive an employer contribution of 14.5% of eligible earnings to the Plan. Effective January 1, 2024, the employer contribution amount for Pilots electing the voluntary soft freeze formula increased to 15.5% of eligible earnings.

Contributions are subject to certain Internal Revenue Service (IRS) limitations.

**Participant Accounts** - Each participant's account is credited with the participant's and employer's contributions, as well as allocations of plan earnings or losses and administrative expenses that are paid by the Plan. Allocations are based on participant earnings, account balances, or specific participant transactions, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

**Vesting** - Participants immediately vest in all contributions.

**Benefits and Withdrawals** - Participants are eligible to receive benefits upon death, disability, retirement, or termination of employment. The automatic form of payment for an unmarried participant is a single life annuity and the automatic form of payment for a married participant is a 50% qualified joint & survivor annuity. Optional forms of payment are available if certain conditions are met. Optional forms of payment include lump-sum payments, installment payments, and annuities. Participants who have attained age 59 ½ may also elect to receive a distribution of all or any portion of their account balance prior to termination of employment (in-service withdrawals). The Plan allows for hardship withdrawals in accordance with provisions specified in the plan document. Participants may also elect to receive in-service withdrawals from balances rolled into the Plan or their traditional after-tax contribution account at any time.

**Notes Receivable From Participants** - Participants may borrow from their accounts a minimum of \$1,000 up to a maximum equal to the lesser of \$50,000, 50% of their vested account balance, or the value of their employee contributions accounts. Loan terms range from one to five years or up to 10 years for the purchase of a primary residence. The interest rate is set at 2.0% above the prime rate, as defined. Principal and interest are paid ratably through payroll deductions.

**Investment Management and Administrative Expenses** - Certain expenses of maintaining the Plan are paid by the Plan, unless otherwise paid by the Company. Expenses that are paid by the Company are excluded from these financial statements. Transaction based fees for notes receivable from participants and distributions are charged directly to participant accounts. Certain investment related expenses are charged directly against the fund's investment performance and, therefore, are not separately disclosed in the accompanying financial statements.

**Plan Termination** - Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA and the collective bargaining agreement with the pilots' union.

**Note 2 - Significant Accounting Policies**

**Basis of Accounting and Use of Estimates** - The accompanying financial statements are prepared under the accrual method of accounting. Benefits are recorded when paid. The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires the Plan's management to use estimates and assumptions that affect the accompanying financial statements and disclosures. Actual results could differ from those estimates.

**Investment Valuation** - Investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date.

**Income Recognition** - Interest income is recorded on an accrual basis. Dividend income is recorded on the ex-dividend date. Purchases and sales of securities are recorded on a trade-date basis.

**Net Appreciation (Depreciation) in Fair Value of Investments** - Net appreciation (depreciation) in fair value of investments represents the change in unrealized appreciation and depreciation of assets from one period to the next and realized gains and losses.

**Notes Receivable From Participants** - Notes receivable from participants are measured at their unpaid principal balance. Accrued but unpaid interest, if any, would not have a material impact on the Plan's financial statements. Related fees are recorded as administrative expenses and are expensed when they are incurred. If a participant ceases to make loan repayments and the plan administrator deems the participant loan to be in default, the participant loan balance is reduced and a benefit payment is recorded. No allowance for credit losses has been recorded as of December 31, 2023 and 2022.

**Fair Value of Financial Instruments** - The framework for measuring fair value defines fair value as the exchange price the Plan would receive upon selling an investment in the principal or most advantageous market in an orderly transaction between market participants on the measurement date. The fair value hierarchy requires the Plan to maximize the use of observable inputs and minimize the use of unobservable inputs when measuring fair value. The three levels of inputs that may be used to measure fair value are:

Level 1 - Quoted prices in active markets for identical assets;

Level 2 - Quoted prices for similar assets in active markets; quoted prices for identical or similar assets in markets that are not active; inputs other than quoted prices that are observable for the asset; and market-corroborated inputs; or

Level 3 - Unobservable inputs for the assets.

Following is a description of the valuation methodologies used for assets measured at fair value.

Registered Investment Company Funds - Valued at the daily closing price as reported by the fund. Registered investment company funds held by the Plan are open-end mutual funds that are registered with the Securities and Exchange Commission. These funds are required to publish their daily Net Asset Value (NAV) and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.

Self-Directed Brokerage Accounts - Accounts primarily consist of registered investment company funds, common stocks, and cash. Registered investment company funds consist of exchange-traded funds and mutual funds. Exchange-traded funds are valued at their last sale or official closing price on the exchange on which they are principally traded. Mutual funds are valued according to the methodology described above. Common stocks are valued at the closing price reported on the active market on which the individual securities are traded. Cash is valued at cost plus accrued interest which approximates fair value.

Collective Trust Funds - Valued at the NAV provided by the funds' trustee. These funds trade on a regular basis, have a published price that the Plan can obtain at any time and are valued based on this published price. In unusual market conditions, the funds' investment adviser may, in its sole discretion, impose restrictions on issues and redemption of units.

Alaska Air Group, Inc. Common Stock - Valued based on the quoted market price of shares held by the Plan at the end of the year.

**Note 3 - Tax Status**

The Plan was amended and restated as of January 1, 2015. The Plan received a favorable determination letter from the IRS dated June 14, 2016. Although the Plan has been amended since receiving the determination letter, the plan administrator and the Plan's tax counsel believe that the Plan is designed, and is currently being operated, in compliance with the applicable requirements of the IRC and, therefore, believe that the Plan is qualified and the related trust is tax-exempt.

Accounting principles generally accepted in the United States of America require plan management to evaluate tax positions taken by the Plan and recognize a tax liability (or asset) if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS. The plan administrator has analyzed the tax positions taken by the Plan, and has concluded that as of December 31, 2023, there are no uncertain positions taken or expected to be taken that would require recognition of a liability (or asset) or disclosure in the financial statements. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

**Note 4 - Related Party and Party-in-Interest Transactions**

Certain plan investments are managed by Fidelity or its affiliates. Fidelity is the trustee as defined by the Plan, and therefore, transactions with these investments and fees charged by Fidelity and its affiliates qualify as party-in-interest transactions. The Plan pays certain expenses related to plan operations to various services providers and issues loans to participants. These transactions are party-in-interest transactions. Transactions involving Alaska Air Group, Inc. common stock (AAG stock) held by the Plan are related party and party-in-interest transactions.

**Note 5 - Certified Information**

The plan administrator has elected the method of compliance permitted by 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. Investments held at December 31, 2023 and 2022, and investment income or loss for the year ended December 31, 2023, that is disclosed in the accompanying financial statements and supplementary information, was obtained or derived from information supplied to the plan administrator and certified as complete and accurate by Fidelity Management Trust Company.

**Note 6 - Investments**

The Plan invests in various investment securities. Investment securities are exposed to various risks, such as interest rate, market, and credit risks. Market risks include global events such as a pandemic or international conflict which could impact the value of investment securities. Due to the level of risk associated with certain investment securities, it is reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits.

Participants may direct their contributions into the investment options offered under the Plan. For participants that are automatically enrolled, their contributions are automatically invested in a Fidelity Freedom Index Target Date Fund based on the year the employee will turn age 65. Participants may change their investment elections and make transfers between investment options daily.

Participants may also access a number of investment securities outside the Plan's investment options via Fidelity's brokerage option, a self-directed brokerage tool. Participants may invest up to 100% of their account balance through the brokerage option. Eligible securities are defined under the Plan and are generally limited to most publicly traded securities.

Investment options are shares of funds held and managed by various investment companies, including Fidelity. AAG stock held by the Plan represents investments transferred from the Horizon Air Savings Investment Plan (Horizon Plan) for pilots who transferred employment to the Company. New investment in AAG stock is not permitted.

**Note 7 - Fund Transfer From Horizon Air Savings Investment Plan**

The Plan allows pilots who transferred from Horizon Air Industries, Inc. to Alaska Airlines, Inc. to transfer their assets from the Horizon Plan to the Plan. During 2023, transfers from the Horizon Plan to the Plan were approximately \$2,815,000.

**Note 8 - Delinquent Contributions**

The Company determined there were pay dates during 2021, 2022 and 2023 in which participant deferral contributions and loan repayments totaling \$7,623,508 were not deposited by the Company as plan assets within the time limitation stipulated under the Department of Labor's regulations. Delinquent contributions are prohibited party-in-interest transactions under ERISA and also represent related party transactions between the Plan and the plan sponsor. The Company is in the process of calculating and remitting lost earnings for all delinquent contributions.

Lost earnings for all late contributions from 2021, 2022, and 2023 were calculated and restored to the Plan in 2024.

### **Scope and Nature of the ERISA Section 103(a)(3)(C) Audit**

We have performed audits of the financial statements of Alaska Airlines, Inc. Pilots Investment and Savings Plan (the Plan), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C). The financial statements comprise the statements of net assets available for benefits as of December 31, 2023 and 2022, and the related statement of changes in net assets available for benefits for the year ended December 31, 2023, and the related notes to the financial statements.

Management has obtained certifications from a qualified institution as of December 31, 2023 and 2022, and for the year ended December 31, 2023, stating that the certified investment information, as described in Note 5 to the financial statements, is complete and accurate.

Accordingly, the objective of an ERISA Section 103(a)(3)(C) audit is not to express an opinion about whether the financial statements as a whole are presented fairly, in all material respects, in accordance with GAAP.

**Note 1 - Description of the Plan**

The following description of the Alaska Airlines, Inc. Pilots Investment and Savings Plan (the Plan) is provided for general information purposes only. More complete information regarding the Plan's provisions may be found in the plan document.

**General** - The Plan is a defined contribution and deferred compensation plan established by Alaska Airlines, Inc. (the Company) under the provisions of Section 401(a) of the Internal Revenue Code (IRC), which includes a qualified cash or deferred arrangement as described in Section 401(k) of the IRC for the benefit of eligible pilots of the Company. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA), as amended.

**Plan Administration** - The Plan is administered by a committee consisting of certain employees of the Company. Fidelity Management Trust Company (Fidelity) serves as the trustee of the Plan.

**Eligibility** - Pilots are eligible to enroll on the first day of the month following 30 days of service. Effective October 2, 2023, the Plan was amended to remove the 30 days of service requirement and to allow Pilots to enter the Plan immediately.

**Contributions** - Participants may elect to defer up to 100% of eligible compensation as pre-tax, Roth after-tax, and/or traditional after-tax contributions. Participants who have attained age 50 before the close of the plan year are eligible to make catch-up contributions. Participants may also contribute amounts representing distributions from other eligible retirement plans. The Plan also permits Pilots to contribute an additional lump sum after-tax cash contribution one time per year outside of payroll deductions. The Plan includes a provision whereby all newly eligible pilots are automatically enrolled at a 3% pre-tax deferral rate unless they elect a different deferral rate or not to participate in the Plan.

Employer contributions are made to the Plan as specified in the pilots' collective bargaining agreement. Participants hired or transferred to the Company after December 31, 2009 were not eligible to participate in the Alaska Airlines, Inc. Fixed Income Retirement Plan for Pilots (the defined benefit plan). These participants receive an employer contribution of 16.0% of eligible earnings. Beginning January 1, 2024, the employer contribution amount increased to 17.0% of eligible earnings for this group.

An eligible participant whose employment commencement date was before January 1, 2010 was eligible to make a choice election with the following options:

- Option 1 Status Quo Formula: continue in their defined benefit plan at current levels and receive employer contribution of 3.5% of eligible earnings. Effective January 1, 2024, the employer contribution amount for Pilots who elected the status quo formula increased to 4.5% of eligible earnings.
- Option 2 Rebalance Formula: reduce future benefits earned under the defined benefit plan and increase employer contributions in the Plan to a level between 8.5% to 11.5% of eligible earnings based on years of credited service as of December 31, 2009. Effective January 1, 2024, the employer contribution amount for Pilots who elected the rebalance formula increased to a range of 9.5% to 12.5% of eligible earnings based on years of credited service as of December 31, 2009.

- Option 3 Voluntary Soft Freeze Formula: freeze their defined benefit as of January 1, 2010 and receive an employer contribution of 14.5% of eligible earnings to the Plan. Effective January 1, 2024, the employer contribution amount for Pilots electing the voluntary soft freeze formula increased to 15.5% of eligible earnings.

Contributions are subject to certain Internal Revenue Service (IRS) limitations.

**Participant Accounts** - Each participant's account is credited with the participant's and employer's contributions, as well as allocations of plan earnings or losses and administrative expenses that are paid by the Plan. Allocations are based on participant earnings, account balances, or specific participant transactions, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

**Vesting** - Participants immediately vest in all contributions.

**Benefits and Withdrawals** - Participants are eligible to receive benefits upon death, disability, retirement, or termination of employment. The automatic form of payment for an unmarried participant is a single life annuity and the automatic form of payment for a married participant is a 50% qualified joint & survivor annuity. Optional forms of payment are available if certain conditions are met. Optional forms of payment include lump-sum payments, installment payments, and annuities. Participants who have attained age 59 ½ may also elect to receive a distribution of all or any portion of their account balance prior to termination of employment (in-service withdrawals). The Plan allows for hardship withdrawals in accordance with provisions specified in the plan document. Participants may also elect to receive in-service withdrawals from balances rolled into the Plan or their traditional after-tax contribution account at any time.

**Notes Receivable From Participants** - Participants may borrow from their accounts a minimum of \$1,000 up to a maximum equal to the lesser of \$50,000, 50% of their vested account balance, or the value of their employee contributions accounts. Loan terms range from one to five years or up to 10 years for the purchase of a primary residence. The interest rate is set at 2.0% above the prime rate, as defined. Principal and interest are paid ratably through payroll deductions.

**Investment Management and Administrative Expenses** - Certain expenses of maintaining the Plan are paid by the Plan, unless otherwise paid by the Company. Expenses that are paid by the Company are excluded from these financial statements. Transaction based fees for notes receivable from participants and distributions are charged directly to participant accounts. Certain investment related expenses are charged directly against the fund's investment performance and, therefore, are not separately disclosed in the accompanying financial statements.

**Plan Termination** - Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA and the collective bargaining agreement with the pilots' union.

**Note 2 - Significant Accounting Policies**

**Basis of Accounting and Use of Estimates** - The accompanying financial statements are prepared under the accrual method of accounting. Benefits are recorded when paid. The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires the Plan's management to use estimates and assumptions that affect the accompanying financial statements and disclosures. Actual results could differ from those estimates.

**Investment Valuation** - Investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date.

**Income Recognition** - Interest income is recorded on an accrual basis. Dividend income is recorded on the ex-dividend date. Purchases and sales of securities are recorded on a trade-date basis.

**Net Appreciation (Depreciation) in Fair Value of Investments** - Net appreciation (depreciation) in fair value of investments represents the change in unrealized appreciation and depreciation of assets from one period to the next and realized gains and losses.

**Notes Receivable From Participants** - Notes receivable from participants are measured at their unpaid principal balance. Accrued but unpaid interest, if any, would not have a material impact on the Plan's financial statements. Related fees are recorded as administrative expenses and are expensed when they are incurred. If a participant ceases to make loan repayments and the plan administrator deems the participant loan to be in default, the participant loan balance is reduced and a benefit payment is recorded. No allowance for credit losses has been recorded as of December 31, 2023 and 2022.

**Fair Value of Financial Instruments** - The framework for measuring fair value defines fair value as the exchange price the Plan would receive upon selling an investment in the principal or most advantageous market in an orderly transaction between market participants on the measurement date. The fair value hierarchy requires the Plan to maximize the use of observable inputs and minimize the use of unobservable inputs when measuring fair value. The three levels of inputs that may be used to measure fair value are:

Level 1 - Quoted prices in active markets for identical assets;

Level 2 - Quoted prices for similar assets in active markets; quoted prices for identical or similar assets in markets that are not active; inputs other than quoted prices that are observable for the asset; and market-corroborated inputs; or

Level 3 - Unobservable inputs for the assets.

Following is a description of the valuation methodologies used for assets measured at fair value.

Registered Investment Company Funds - Valued at the daily closing price as reported by the fund. Registered investment company funds held by the Plan are open-end mutual funds that are registered with the Securities and Exchange Commission. These funds are required to publish their daily Net Asset Value (NAV) and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.

Self-Directed Brokerage Accounts - Accounts primarily consist of registered investment company funds, common stocks, and cash. Registered investment company funds consist of exchange-traded funds and mutual funds. Exchange-traded funds are valued at their last sale or official closing price on the exchange on which they are principally traded. Mutual funds are valued according to the methodology described above. Common stocks are valued at the closing price reported on the active market on which the individual securities are traded. Cash is valued at cost plus accrued interest which approximates fair value.

Collective Trust Funds - Valued at the NAV provided by the funds' trustee. These funds trade on a regular basis, have a published price that the Plan can obtain at any time and are valued based on this published price. In unusual market conditions, the funds' investment adviser may, in its sole discretion, impose restrictions on issues and redemption of units.

Alaska Air Group, Inc. Common Stock - Valued based on the quoted market price of shares held by the Plan at the end of the year.

**Note 3 - Tax Status**

The Plan was amended and restated as of January 1, 2015. The Plan received a favorable determination letter from the IRS dated June 14, 2016. Although the Plan has been amended since receiving the determination letter, the plan administrator and the Plan's tax counsel believe that the Plan is designed, and is currently being operated, in compliance with the applicable requirements of the IRC and, therefore, believe that the Plan is qualified and the related trust is tax-exempt.

Accounting principles generally accepted in the United States of America require plan management to evaluate tax positions taken by the Plan and recognize a tax liability (or asset) if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS. The plan administrator has analyzed the tax positions taken by the Plan, and has concluded that as of December 31, 2023, there are no uncertain positions taken or expected to be taken that would require recognition of a liability (or asset) or disclosure in the financial statements. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

**Note 4 - Related Party and Party-in-Interest Transactions**

Certain plan investments are managed by Fidelity or its affiliates. Fidelity is the trustee as defined by the Plan, and therefore, transactions with these investments and fees charged by Fidelity and its affiliates qualify as party-in-interest transactions. The Plan pays certain expenses related to plan operations to various services providers and issues loans to participants. These transactions are party-in-interest transactions. Transactions involving Alaska Air Group, Inc. common stock (AAG stock) held by the Plan are related party and party-in-interest transactions.

**Note 5 - Certified Information**

The plan administrator has elected the method of compliance permitted by 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. Investments held at December 31, 2023 and 2022, and investment income or loss for the year ended December 31, 2023, that is disclosed in the accompanying financial statements and supplementary information, was obtained or derived from information supplied to the plan administrator and certified as complete and accurate by Fidelity Management Trust Company.

**Note 6 - Investments**

The Plan invests in various investment securities. Investment securities are exposed to various risks, such as interest rate, market, and credit risks. Market risks include global events such as a pandemic or international conflict which could impact the value of investment securities. Due to the level of risk associated with certain investment securities, it is reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits.

Participants may direct their contributions into the investment options offered under the Plan. For participants that are automatically enrolled, their contributions are automatically invested in a Fidelity Freedom Index Target Date Fund based on the year the employee will turn age 65. Participants may change their investment elections and make transfers between investment options daily.

Participants may also access a number of investment securities outside the Plan's investment options via Fidelity's brokerage option, a self-directed brokerage tool. Participants may invest up to 100% of their account balance through the brokerage option. Eligible securities are defined under the Plan and are generally limited to most publicly traded securities.

Investment options are shares of funds held and managed by various investment companies, including Fidelity. AAG stock held by the Plan represents investments transferred from the Horizon Air Savings Investment Plan (Horizon Plan) for pilots who transferred employment to the Company. New investment in AAG stock is not permitted.

**Note 7 - Fund Transfer From Horizon Air Savings Investment Plan**

The Plan allows pilots who transferred from Horizon Air Industries, Inc. to Alaska Airlines, Inc. to transfer their assets from the Horizon Plan to the Plan. During 2023, transfers from the Horizon Plan to the Plan were approximately \$2,815,000.

**Note 8 - Delinquent Contributions**

The Company determined there were pay dates during 2021, 2022 and 2023 in which participant deferral contributions and loan repayments totaling \$7,623,508 were not deposited by the Company as plan assets within the time limitation stipulated under the Department of Labor's regulations. Delinquent contributions are prohibited party-in-interest transactions under ERISA and also represent related party transactions between the Plan and the plan sponsor. The Company is in the process of calculating and remitting lost earnings for all delinquent contributions.

Lost earnings for all late contributions from 2021, 2022, and 2023 were calculated and restored to the Plan in 2024.

**Note 1 - Description of the Plan**

The following description of the Alaska Airlines, Inc. Pilots Investment and Savings Plan (the Plan) is provided for general information purposes only. More complete information regarding the Plan's provisions may be found in the plan document.

**General** - The Plan is a defined contribution and deferred compensation plan established by Alaska Airlines, Inc. (the Company) under the provisions of Section 401(a) of the Internal Revenue Code (IRC), which includes a qualified cash or deferred arrangement as described in Section 401(k) of the IRC for the benefit of eligible pilots of the Company. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA), as amended.

**Plan Administration** - The Plan is administered by a committee consisting of certain employees of the Company. Fidelity Management Trust Company (Fidelity) serves as the trustee of the Plan.

**Eligibility** - Pilots are eligible to enroll on the first day of the month following 30 days of service. Effective October 2, 2023, the Plan was amended to remove the 30 days of service requirement and to allow Pilots to enter the Plan immediately.

**Contributions** - Participants may elect to defer up to 100% of eligible compensation as pre-tax, Roth after-tax, and/or traditional after-tax contributions. Participants who have attained age 50 before the close of the plan year are eligible to make catch-up contributions. Participants may also contribute amounts representing distributions from other eligible retirement plans. The Plan also permits Pilots to contribute an additional lump sum after-tax cash contribution one time per year outside of payroll deductions. The Plan includes a provision whereby all newly eligible pilots are automatically enrolled at a 3% pre-tax deferral rate unless they elect a different deferral rate or not to participate in the Plan.

Employer contributions are made to the Plan as specified in the pilots' collective bargaining agreement. Participants hired or transferred to the Company after December 31, 2009 were not eligible to participate in the Alaska Airlines, Inc. Fixed Income Retirement Plan for Pilots (the defined benefit plan). These participants receive an employer contribution of 16.0% of eligible earnings. Beginning January 1, 2024, the employer contribution amount increased to 17.0% of eligible earnings for this group.

An eligible participant whose employment commencement date was before January 1, 2010 was eligible to make a choice election with the following options:

- Option 1 Status Quo Formula: continue in their defined benefit plan at current levels and receive employer contribution of 3.5% of eligible earnings. Effective January 1, 2024, the employer contribution amount for Pilots who elected the status quo formula increased to 4.5% of eligible earnings.
- Option 2 Rebalance Formula: reduce future benefits earned under the defined benefit plan and increase employer contributions in the Plan to a level between 8.5% to 11.5% of eligible earnings based on years of credited service as of December 31, 2009. Effective January 1, 2024, the employer contribution amount for Pilots who elected the rebalance formula increased to a range of 9.5% to 12.5% of eligible earnings based on years of credited service as of December 31, 2009.

**Note 1 - Continued**

- Option 3 Voluntary Soft Freeze Formula: freeze their defined benefit as of January 1, 2010 and receive an employer contribution of 14.5% of eligible earnings to the Plan. Effective January 1, 2024, the employer contribution amount for Pilots electing the voluntary soft freeze formula increased to 15.5% of eligible earnings.

Contributions are subject to certain Internal Revenue Service (IRS) limitations.

**Participant Accounts** - Each participant's account is credited with the participant's and employer's contributions, as well as allocations of plan earnings or losses and administrative expenses that are paid by the Plan. Allocations are based on participant earnings, account balances, or specific participant transactions, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

**Vesting** - Participants immediately vest in all contributions.

**Benefits and Withdrawals** - Participants are eligible to receive benefits upon death, disability, retirement, or termination of employment. The automatic form of payment for an unmarried participant is a single life annuity and the automatic form of payment for a married participant is a 50% qualified joint & survivor annuity. Optional forms of payment are available if certain conditions are met. Optional forms of payment include lump-sum payments, installment payments, and annuities. Participants who have attained age 59 ½ may also elect to receive a distribution of all or any portion of their account balance prior to termination of employment (in-service withdrawals). The Plan allows for hardship withdrawals in accordance with provisions specified in the plan document. Participants may also elect to receive in-service withdrawals from balances rolled into the Plan or their traditional after-tax contribution account at any time.

**Notes Receivable From Participants** - Participants may borrow from their accounts a minimum of \$1,000 up to a maximum equal to the lesser of \$50,000, 50% of their vested account balance, or the value of their employee contributions accounts. Loan terms range from one to five years or up to 10 years for the purchase of a primary residence. The interest rate is set at 2.0% above the prime rate, as defined. Principal and interest are paid ratably through payroll deductions.

**Investment Management and Administrative Expenses** - Certain expenses of maintaining the Plan are paid by the Plan, unless otherwise paid by the Company. Expenses that are paid by the Company are excluded from these financial statements. Transaction based fees for notes receivable from participants and distributions are charged directly to participant accounts. Certain investment related expenses are charged directly against the fund's investment performance and, therefore, are not separately disclosed in the accompanying financial statements.

**Plan Termination** - Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA and the collective bargaining agreement with the pilots' union.

**Note 2 - Significant Accounting Policies**

**Basis of Accounting and Use of Estimates** - The accompanying financial statements are prepared under the accrual method of accounting. Benefits are recorded when paid. The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires the Plan's management to use estimates and assumptions that affect the accompanying financial statements and disclosures. Actual results could differ from those estimates.

**Investment Valuation** - Investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date.

**Income Recognition** - Interest income is recorded on an accrual basis. Dividend income is recorded on the ex-dividend date. Purchases and sales of securities are recorded on a trade-date basis.

**Net Appreciation (Depreciation) in Fair Value of Investments** - Net appreciation (depreciation) in fair value of investments represents the change in unrealized appreciation and depreciation of assets from one period to the next and realized gains and losses.

**Notes Receivable From Participants** - Notes receivable from participants are measured at their unpaid principal balance. Accrued but unpaid interest, if any, would not have a material impact on the Plan's financial statements. Related fees are recorded as administrative expenses and are expensed when they are incurred. If a participant ceases to make loan repayments and the plan administrator deems the participant loan to be in default, the participant loan balance is reduced and a benefit payment is recorded. No allowance for credit losses has been recorded as of December 31, 2023 and 2022.

**Fair Value of Financial Instruments** - The framework for measuring fair value defines fair value as the exchange price the Plan would receive upon selling an investment in the principal or most advantageous market in an orderly transaction between market participants on the measurement date. The fair value hierarchy requires the Plan to maximize the use of observable inputs and minimize the use of unobservable inputs when measuring fair value. The three levels of inputs that may be used to measure fair value are:

Level 1 - Quoted prices in active markets for identical assets;

Level 2 - Quoted prices for similar assets in active markets; quoted prices for identical or similar assets in markets that are not active; inputs other than quoted prices that are observable for the asset; and market-corroborated inputs; or

Level 3 - Unobservable inputs for the assets.

Following is a description of the valuation methodologies used for assets measured at fair value.

Registered Investment Company Funds - Valued at the daily closing price as reported by the fund. Registered investment company funds held by the Plan are open-end mutual funds that are registered with the Securities and Exchange Commission. These funds are required to publish their daily Net Asset Value (NAV) and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.

Self-Directed Brokerage Accounts - Accounts primarily consist of registered investment company funds, common stocks, and cash. Registered investment company funds consist of exchange-traded funds and mutual funds. Exchange-traded funds are valued at their last sale or official closing price on the exchange on which they are principally traded. Mutual funds are valued according to the methodology described above. Common stocks are valued at the closing price reported on the active market on which the individual securities are traded. Cash is valued at cost plus accrued interest which approximates fair value.

Collective Trust Funds - Valued at the NAV provided by the funds' trustee. These funds trade on a regular basis, have a published price that the Plan can obtain at any time and are valued based on this published price. In unusual market conditions, the funds' investment adviser may, in its sole discretion, impose restrictions on issues and redemption of units.

Alaska Air Group, Inc. Common Stock - Valued based on the quoted market price of shares held by the Plan at the end of the year.

**Note 3 - Tax Status**

The Plan was amended and restated as of January 1, 2015. The Plan received a favorable determination letter from the IRS dated June 14, 2016. Although the Plan has been amended since receiving the determination letter, the plan administrator and the Plan's tax counsel believe that the Plan is designed, and is currently being operated, in compliance with the applicable requirements of the IRC and, therefore, believe that the Plan is qualified and the related trust is tax-exempt.

Accounting principles generally accepted in the United States of America require plan management to evaluate tax positions taken by the Plan and recognize a tax liability (or asset) if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS. The plan administrator has analyzed the tax positions taken by the Plan, and has concluded that as of December 31, 2023, there are no uncertain positions taken or expected to be taken that would require recognition of a liability (or asset) or disclosure in the financial statements. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

**Note 4 - Related Party and Party-in-Interest Transactions**

Certain plan investments are managed by Fidelity or its affiliates. Fidelity is the trustee as defined by the Plan, and therefore, transactions with these investments and fees charged by Fidelity and its affiliates qualify as party-in-interest transactions. The Plan pays certain expenses related to plan operations to various services providers and issues loans to participants. These transactions are party-in-interest transactions. Transactions involving Alaska Air Group, Inc. common stock (AAG stock) held by the Plan are related party and party-in-interest transactions.

**Note 5 - Certified Information**

The plan administrator has elected the method of compliance permitted by 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. Investments held at December 31, 2023 and 2022, and investment income or loss for the year ended December 31, 2023, that is disclosed in the accompanying financial statements and supplementary information, was obtained or derived from information supplied to the plan administrator and certified as complete and accurate by Fidelity Management Trust Company.

**Note 6 - Investments**

The Plan invests in various investment securities. Investment securities are exposed to various risks, such as interest rate, market, and credit risks. Market risks include global events such as a pandemic or international conflict which could impact the value of investment securities. Due to the level of risk associated with certain investment securities, it is reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits.

Participants may direct their contributions into the investment options offered under the Plan. For participants that are automatically enrolled, their contributions are automatically invested in a Fidelity Freedom Index Target Date Fund based on the year the employee will turn age 65. Participants may change their investment elections and make transfers between investment options daily.

Participants may also access a number of investment securities outside the Plan's investment options via Fidelity's brokerage option, a self-directed brokerage tool. Participants may invest up to 100% of their account balance through the brokerage option. Eligible securities are defined under the Plan and are generally limited to most publicly traded securities.

Investment options are shares of funds held and managed by various investment companies, including Fidelity. AAG stock held by the Plan represents investments transferred from the Horizon Air Savings Investment Plan (Horizon Plan) for pilots who transferred employment to the Company. New investment in AAG stock is not permitted.

**Note 7 - Fund Transfer From Horizon Air Savings Investment Plan**

The Plan allows pilots who transferred from Horizon Air Industries, Inc. to Alaska Airlines, Inc. to transfer their assets from the Horizon Plan to the Plan. During 2023, transfers from the Horizon Plan to the Plan were approximately \$2,815,000.

**Note 8 - Delinquent Contributions**

The Company determined there were pay dates during 2021, 2022 and 2023 in which participant deferral contributions and loan repayments totaling \$7,623,508 were not deposited by the Company as plan assets within the time limitation stipulated under the Department of Labor's regulations. Delinquent contributions are prohibited party-in-interest transactions under ERISA and also represent related party transactions between the Plan and the plan sponsor. The Company is in the process of calculating and remitting lost earnings for all delinquent contributions.

Lost earnings for all late contributions from 2021, 2022, and 2023 were calculated and restored to the Plan in 2024.
