March 13, 2024 (Liquidation basis), December 31, 2023 (Liquidation basis) and 2022 (Ongoing basis)

#### 1. Description of the Plan

The following description of the TVR Communications 401(k) Retirement Savings Plan (the "Plan") is provided for general information purposes only. More complete information regarding the Plan's provisions may be found in the plan document.

##### ***Plan Termination***

During 2023, TVR Communications, LLC was acquired by Uniguest, Inc., as a result the Directors of TVR Communications LLC, resolved to terminate the Plan effective December 31, 2023. TVR Communications, LLC worked with Empower Retirement, LLC to develop a plan for liquidation and all Participants' balances were distributed by March 13, 2024. As a result of the Plan's termination, the Plan changed its basis of accounting from the Ongoing basis of accounting as of December 31, 2022 to the Liquidation basis of accounting for the period January 1, 2024 through March 13, 2024 and for the year ended December 31, 2023. The Liquidation basis of accounting presents assets as amounts expected to be realized in liquidation and liabilities at amounts expected to be paid. There was no material difference between amounts presented on the Ongoing basis and those that would have been presented on the Liquidation basis.

##### ***General***

The Plan was established, effective January 1, 1996, and amended and restated as of January 1, 2019. The Plan is a defined contribution plan covering substantially all the employees of TVR Communications, LLC (the "Company" or the "Employer") who have completed 30 days of service and are at least 21 years of age, except for employees covered by a collective bargaining agreement and non-resident aliens, as defined, (the "Participants"). Great West Trust Company and Great West Life & Annuity Insurance Company of New York served as the plan's custodian and insurance provider in 2022. These institutions rebranded to Empower Life & Annuity Insurance Company of New York and Empower Trust Company, LLC (collectively referred to as "Empower") and served as the plan's insurance provider and custodian in 2023 and 2024. Empower Retirement, LLC provides recordkeeping services for the Plan. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 ("ERISA"). All investments are participant-directed.

##### ***Plan Administration***

The Employer is the plan sponsor and named plan administrator and has the authority to appoint person(s) or entities to carry out the operation of the Plan. Individual Participant accounts may be charged directly for all administrative expenses, if not paid by the Employer. Individual Participant accounts are charged directly for loan recordkeeping or transaction processing, if applicable.

##### ***Participant Contributions***

Each year, Participants may elect to make pre-tax or Roth deferrals up to 100% of their eligible compensation subject to a dollar limit established by the internal revenue code ("IRC"). Participants who have attained age 50 before the end of the Plan year are eligible to make catch-up contributions. Participants may also contribute amounts representing distributions from other qualified plans ("Rollover Contributions").

#### 1. Description of the Plan *(continued)*

##### ***Employer Contributions***

The Employer may make a discretionary matching contribution to the Plan on behalf of eligible Plan Participants. Employer matching contributions are equal to a discretionary percentage of each tier of the Participants' elective deferrals. For the period January 1, 2024 through March 13, 2024 (Liquidation basis) the Employer elected not to make an employer matching contribution. For the year ended December 31, 2023 (Liquidation basis), the employer elected to make an employer matching contribution in the amount of \$160,232.

The Employer, at its discretion, may elect to make a nonelective contribution to the Plan. Employer nonelective contributions are allocated pro rata based on the ratio that each eligible Participant's compensation bears to the total of all eligible Participants' compensations for the Plan year. For the period ended January 1, 2024 through March 13, 2024 (Liquidation basis), and for the year ended December 31, 2023 (Liquidation basis), the Employer elected not to make an employer nonelective contribution.

##### ***Participant Accounts***

Each Participant's account is credited with the Participant's contributions, the respective employer contributions, an allocation of the Plan's investment earnings (losses), and is charged with an allocation of certain expenses, as applicable. The benefit to which a Participant is entitled is the benefit that can be provided from the Participant's vested account.

##### ***Vesting***

##### ***Participant Contributions***

Participants are immediately vested in their voluntary contributions plus actual earnings thereon.

##### ***Employer Contributions***

Effective December 31, 2023, due to the Plan's termination, participants became 100% vested in their accounts. #### 1. Description of the Plan *(continued)*

##### ***Notes Receivable from Participants***

Participants may borrow from their accounts a minimum of \$1,000 and up to a maximum equal to the lesser of \$50,000 or 50% of their account balance, reduced by any outstanding loan balance. Loan terms range from one to five years (or longer for the purchase of a primary residence). Loans are secured by the balance in the Participant's account, and bear interest at the Prime Rate (as published by the Wall Street Journal) plus two percentage points. Participants are allowed a maximum of two outstanding loans at any one time. Principal and interest is paid ratably through payroll deductions. If a Participant ceases to make loan repayments and the Plan administrator deems the loan to be in default, the Participant's loan balance is reduced and a benefit payment is made in accordance with the Plan document. Interest rates for outstanding loans ranged from 5.25% to 10.50 % as of December 31, 2023 and 5.25% and 9.00% as of December 31, 2022. Outstanding loans as of December 31, 2023 mature at various dates through 2027.

##### ***Payment of Benefits***

Upon termination of service due to death, disability, termination or retirement, a Participant may elect to receive either a lump-sum distribution in an amount equal to the value of the Participant's interest in his or her account or installment payments for purposes of required minimum distributions. Participants may leave their account balance in the Plan if their vested account balance is more than \$5,000. Upon termination, if a Participant's account balance is less than \$1,000, the plan administrator, after notification, may distribute to the Participant his or her entire account balance. If a balance is less than \$5,000 but greater than \$1,000, the plan administrator, after notification, may deposit the balance into an individual retirement account.

In-service withdrawals from all of the Participant's vested account balances are permitted upon reaching age 59½. In-service withdrawals are also permitted due to financial hardship. Participants must have obtained all distributions, other than the hardship withdrawals, before financial hardship withdrawals are allowed. Hardship withdrawals may be taken from the Participant's fully vested accounts subject to a \$1,000 minimum amount.

##### ***Forfeited Accounts***

A participant who no longer is employed by the Employer forfeits any non-vested balance. Non-vested forfeited account balances are used to reduce future Employer contributions. If the forfeitures exceed the discretionary Employer Contribution they are allocated to Participants as an additional discretionary contribution. Forfeited non-vested accounts at December 31, 2023 amounted to \$3,940. There were no forfeited account balances at March 13, 2024 and December 31, 2022.

#### 2. Summary of Significant Accounting Policies

##### ***Basis of Accounting***

The accompanying financial statements have been prepared on the accrual basis of accounting in conformity with accounting principles generally accepted in the United States of America ("GAAP"). For the period January 1, 2024 through March 13, 2024 and the year ended December 31, 2023, the Plan's transactions are reported on the Liquidation basis of accounting. For the year ended December 31, 2022, the Plan's transactions are reported on the Ongoing basis of accounting.

## 2. Summary of Significant Accounting Policies *(continued)*

### ***Use of Estimates***

The preparation of financial statements in conformity with GAAP requires Plan management to make estimates and assumptions that affect certain reported amounts and disclosures. Accordingly, actual results could vary from the estimates that were used.

### ***Investments, Investment Valuation and Income Recognition***

The Plan follows GAAP guidance on Fair Value Measurements which defines fair value and establishes a fair value hierarchy organized into three levels based upon the input assumptions used in pricing assets. Level 1 inputs have the highest reliability and are related to assets with unadjusted quoted prices in active markets. Level 2 inputs relate to assets with other than quoted prices in active markets which may include quoted prices for similar assets or liabilities or other inputs which can be corroborated by observable market data. Level 3 inputs are unobservable and are used to the extent that observable inputs do not exist.

Mutual funds: As of December 31, 2023 and 2022, mutual funds amounted to \$7,939,268 and \$7,121,295, and are valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-end mutual funds that are registered with the Securities and Exchange Commission. These funds are required to publish their daily net asset value ("NAV") and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded and are classified as Level 1 investments.

Investments are reported at fair value, except for the Key Guaranteed Portfolio Fund, which is reported at contract value (See Note 4). Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation in fair value of investments included the Plan's gains and losses on investments bought and sold as well as held during the year.

### ***Notes Receivable from Participants***

Notes receivable from Participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Interest income on notes receivable from Participants is recognized on the accrual basis of accounting. Related fees are recorded as administrative fees and expensed when incurred.

### ***Payments of Benefits***

Benefit payments to Participants are recorded during the period in which the Participant is paid.

#### 3. Information Certified (Unaudited)

Certain information related to investments and notes receivable from participants disclosed in the accompanying financial statements and ERISA-required Schedule H, Part IV, Line 4(i) – Schedule of Assets (Held at End of Year) including investments and notes receivable from participants held at December 31, 2023 (Liquidation basis) and 2022 (Ongoing basis), and net appreciation in value of investments, interest and dividends on investments, and interest on notes receivable from participants for the period January 1, 2024 through March 13, 2024 (Liquidation basis) and the year ended December 31, 2023 (Liquidation basis), was obtained by management and agreed to or derived from information certified as complete and accurate by Empower, qualified institutions.

#### 4. Key Guaranteed Portfolio Fund

The Plan has a group annuity contract with Empower that invests contributions in the Key Guaranteed Portfolio Fund. The Key Guaranteed Portfolio Fund is a general account product. The methodology for calculating the interest crediting rate is based on the earnings of the underlying assets in the entire medium-long term new portfolio compared to the minimum interest crediting rate, as stated in the contract, and prevailing market conditions. The interest crediting rate is reset quarterly. The account is credited with earnings on the underlying investments and charged for participant withdrawals and administrative expenses. The contract meets the fully benefit-responsive investment contract criteria and therefore is reported at contract value. Contract value is the relevant measure for fully benefit-responsive investment contracts because this is the amount received by participants if they were to initiate permitted transactions under the terms of the Plan.

Contract value represents contributions made under each contract, plus earnings, less participant withdrawals, and administrative expenses. Participants may ordinarily direct the withdrawal or transfer of all or a portion of their investment at contract value. The guaranteed investment contract issuer is contractually obligated to repay the principal and a specified interest rate that is guaranteed to the Plan. There are no reserves against contract value for credit risk of the contract issuer or otherwise. The crediting interest is based on a formula agreed upon with the issuer but may not be less than 0%. For the year ended December 31, 2023 (Liquidation basis) and 2022 (Ongoing basis), the average and actual yield interest rate was 1.34% and .93%, respectively. Such interest rates are reviewed on a quarterly basis for resetting.

The Plan or the contract issuer may, upon 60 days advance written notice to the other party, declare a contract termination date which shall be any date on or after the expiration of the 60-day notification period. The contract issuer may declare a contract termination date for any reason.

Certain events limited the ability of the Plan to transact at contract value with the issuer. Such events included the following: (a) Amendments to the Plan document (including complete or partial Plan termination or merger with another plan), (b) Bankruptcy of the Plan sponsor or other Plan sponsor events that caused a significant withdrawal from the Plan, (c) The failure of the Plan to qualify for exemption from federal income taxes or any required prohibited transaction exemption under ERISA and other events as specified in the guaranteed investment contract. The Plan administrator does not believe that any event which would limit the Plan's ability to transact at contract value with Participants are probable of occurring.

#### 5. Risks and Uncertainties

The Plan invests in various investment securities, which are exposed to various risks such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term, and that such changes could materially affect the Participants' account balances and the amounts reported in the Statements of Net Assets Available for Benefits.

#### 6. Plan Termination

The Employer has the right under the Plan to discontinue its contributions at any time and terminate the Plan, subject to the provision of ERISA. The Plan was terminated effective December 31, 2023 (See Note 1).

#### 7. Tax Status

The underlying volume submitter profit sharing plan has received an opinion letter from the Internal Revenue Service, dated June 30, 2020, stating that the form of the plan is qualified under section 401(a) of the Code. Any employer adopting this form of the plan will be considered to have a plan qualified under section 401(a) of the Code. Once qualified, the plan is required to operate in conformity with the Code to maintain its qualification. The Plan has been amended since receiving the opinion letter, however, the plan administrator believes the Plan is currently designed and being operated in compliance with the applicable requirements of the Code and that the Plan is qualified and the related trust is tax-exempt as of the financial statement dates.

GAAP requires plan management to evaluate tax positions taken by the Plan and recognize a tax liability if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the Internal Revenue Service. It is the Plan's policy to account for any uncertainties as described under the income tax laws. Under the income tax laws, the tax-exempt status of an entity is considered a tax position. No such uncertain tax positions have been recognized by the Plan.

The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

#### 8. Party-In-Interest Transactions

Certain plan investments are managed by Empower. The Plan paid administrative expenses totaling \$21,223 and \$46,649 to Empower or affiliates of Empower for the period January 1, 2024 through March 13, 2024 (Liquidation basis) and the year ended December 31, 2023 (Liquidation basis), respectively, which qualifies as party-in-interest transactions.

Notes receivable from participants also qualify as exempt party-in-interest transactions as defined by ERISA.
