## **BASIS FOR OPINION**

Our audits did not extend to the certified investment information, except for obtaining and reading the certification, comparing the certified investment information with the related information presented and disclosed in the financial statements, and reading the disclosures relating to the certified investment information to assess whether they are in accordance with the presentation and disclosure requirements of accounting principles generally accepted in the United States of America.

Accordingly, the objective of an ERISA Section 103(a)(3)(C) audit is not to express an opinion about whether the financial statements as a whole are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America.

We are required to communicate with those charged with governance regarding, among other matters, the planned scope and timing of the audits, significant audit findings, and certain internal control-related matters that we identified during the audits.

**NOTE 1** DESCRIPTION OF PLAN

The following brief description of the Dataprise, LLC 401(k) Plan (Plan) is provided for general information purposes only. Participants should refer to the Plan document or the Summary Plan Description for more complete information.

**GENERAL**

The Plan is a defined-contribution plan that covers employees of Dataprise, LLC (Company). Employees who are at least 21 years old are eligible to participate in the Plan after completing one month of service with the Company. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA).

**CONTRIBUTIONS**

Participants contribute to the Plan, through payroll deductions, up to a maximum of 100% of their compensation subject to certain Internal Revenue Service limits. The Plan adopted an automatic enrollment feature with an initial contribution amount of 5%. The Company may make discretionary contributions by matching a uniform percentage applied to a participant's compensation. Additional amounts may be contributed at the Company's discretion.

**VESTING**

Participants are immediately vested in their contributions plus actual earnings thereon. Additionally, participants vest 100% in Company matching contributions after five years of service.

**PAYMENT OF BENEFITS**

Upon retirement, disability, death, or termination of employment, a participant or beneficiary may elect to receive the vested balance of the participant's account in a lump-sum distribution.

**PARTICIPANT ACCOUNTS**

Each participant's account is credited with the participant's contributions and allocations of the Company's contributions and Plan earnings or losses and charged with an allocation of administrative expenses. Allocations are based on participant earnings or account balances, as defined.

**INVESTMENT OPTIONS**

Upon enrollment in the Plan, a participant may direct contributions into various investment options offered by the Plan.

**NOTES RECEIVABLE FROM PARTICIPANTS**

Participants may borrow from their accounts a minimum of \$1,000 up to a maximum that is equal to half of a participant's vested balance limited to \$50,000. Loan terms require amortization of principal and interest over a period not to exceed five years. Loans are collateralized by the balance in the participant's account.

**ADMINISTRATIVE EXPENSES**

Certain administrative expenses of the Plan are paid by the Company. In addition, the Company provides services to the Plan without charge.

**FORFEITED ACCOUNTS**

At December 31, 2023 and 2022, forfeited non-vested accounts totaled \$113,561 and \$65,117, respectively. These amounts will be used to pay Plan expenses or reduce future Company contributions in accordance with the Plan document.

**NOTE 2 SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES**

**BASIS OF ACCOUNTING**

The accompanying financial statements are prepared on the accrual basis of accounting.

**ACCOUNTING STANDARDS CODIFICATION**

All references in the financial statements to the Codification refer to the Accounting Standards Codification and the Hierarchy of Generally Accepted Accounting Principles (GAAP) issued by the Financial Accounting Standards Board. The Codification is the single source of authoritative GAAP in the United States.

**USE OF ESTIMATES**

The preparation of financial statements in conformity with GAAP requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities and disclosure of contingent assets and liabilities at the date of the financial statements and the reported amounts of revenue and expenses during the reporting period. Actual results could differ from those estimates.

#### INVESTMENTS

Investments are reported at fair value. See Note 3 for a discussion of fair value measurements.

#### INCOME RECOGNITION

Interest income, including interest on notes receivable from participants, is recorded as earned on the accrual basis. Dividend income is recorded on the ex-dividend date.

#### PAYMENT OF BENEFITS

Benefits are recorded when paid.

#### RISK AND UNCERTAINTIES

The Plan provides for investments in various investment securities, which are exposed to various risks, such as interest rate, credit, and overall volatility. Due to the level of risk associated with certain investment securities, it is reasonably possible that changes in the values of investment securities will occur in the near term, and such changes could materially affect the amounts reported in the Statements of Net Assets Available for Benefits.

#### NOTES RECEIVABLE FROM PARTICIPANTS

Notes receivable from participants are carried at their unpaid principal balance plus accrued interest. Delinquent participant loans are reclassified as distributions based upon the terms of the Plan document.

#### **NOTE 3** VALUATION OF INVESTMENTS

Investments are recorded at fair value in accordance with the provisions of the Fair Value Measurements and Disclosures Topic of the Codification, which establishes a framework for measuring fair value. The framework provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1 measurements) and the lowest priority to unobservable inputs (Level 3 measurements). The three levels of the fair value hierarchy are described below:

Level 1 Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2 Inputs to the valuation methodology include:

Quoted prices for similar assets or liabilities in active markets;

Quoted prices for identical or similar assets or liabilities in inactive markets;

Inputs other than quoted prices that are observable for the asset or liability;

Inputs that are derived principally from or corroborated by observable market data by correlation or other means;

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

Level 3 Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset's or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

Below is a description of the valuation methodology used for assets measured at fair value. There were no changes in the methodology used at December 31, 2023 and 2022.

Mutual Funds: Valued at the net asset value (NAV) of shares held by the Plan at year end. NAV is based on the value of the underlying assets owned by the fund, minus its liabilities, and then divided by the number of shares outstanding. NAV is a quoted price in an active market.

The method described above may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, while the Plan believes its valuation method is appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

The Plan’s investments were held by the Trustee, Ascensus Trust Company, at December 31, 2023 and 2022. **NOTE 5** INCOME TAX STATUS

The Plan adopted a prototype non-standardized profit-sharing plan with a cash or deferred arrangement developed by Ascensus, Inc. The pre-approved plan received an opinion letter from the Internal Revenue Service dated June 30, 2020 regarding the prototype plan’s qualified status. The Plan was amended and restated. The Plan Administrator believes the Plan is designed and operating in compliance with the applicable provisions of the Internal Revenue Code.

GAAP requires Plan management to evaluate uncertain tax positions for recognition in the financial statements. The Plan Administrator concluded there were no uncertain tax positions as of December 31, 2023.

**NOTE 6** RELATED-PARTY TRANSACTIONS

Certain Plan investments are managed by the Trustee of the Plan. These transactions qualify as party-in-interest transactions. The Plan pays investment management and recordkeeping fees to parties in interest. The Plan paid direct fees of \$112,058 to parties in interest for the

year ended December 31, 2023. These party-in-interest transactions are exempt from the prohibited transaction rules of ERISA.

In addition, administrative fees were paid indirectly through revenue sharing and are included in the net appreciation in fair value of investments.

**NOTE 7**   **SUBSEQUENT EVENTS**

The Plan evaluated subsequent events and transactions for potential recognition or disclosure in the financial statements through October 8, 2024, the date the financial statements were available to be issued.

In 2023, the Plan sponsor was acquired by Pentegra Services, Inc. Effective June 2024, the Plan merged with the 401(k) plan. Participants had the option to rollover their account balance into the acquiring company's 401(k) plan or receive another form of distribution.
